CALLED MEETING OF THE SYNOD.

GREENSBORO, N. C., Thursday, March 21, 1918.

The Synod of North Carolina met in extraordinary session in the First Presbyterian church, Greensboro, N. C., at 1:00 p. m., under the following call of the Stated Clerk, the Moderator having died since the regular meeting:

Reilsville, N. C., March 6, 1918.

The constitutional requirements having been complied with, I hereby call a pro-re-nata meeting of the Synod of North Carolina to meet in the First Presbyterian church, Greensboro, N. C., on Thursday the 21st day of March, 1918, at 1:00 o'clock p. m., to transact the following business, if the way be clear, viz.:

"To take action on a recommendation of the Synod's Executive Committee of Education that Peace Institute at Raleigh and Queens College at Charlotte be consolidated into a Synodical College for Women, at such place as shall offer the best inducements, and as the committee, taking all things into consideration, shall consider most advantageous; and to act on any other matters affecting Presbyterian education in the Synod that may arise in connection with the recommendation."

The call for the meeting was read and found in order.

All of the members of the Executive Committee of Christian Education and also Mr. John Webb of the Oxford church and Dr. A. J. Crowell of Second church Charlotte, were accorded the privileges of the floor.

Rev. W. McC. White, D. D., was excused from attending after 4 p. m., and requested Rev. C. M. Richards, D. D., to act as Moderator during the remainder of the session.

The Executive Committee of Education through Rev. J. H. Henderlite, D. D., chairman, submitted and read the following report, which was received:

Report of the Executive Committee of Christian Education to the Synod of North Carolina called to meet in Greensboro March twenty first, 1918.

Your Committee respectfully submits the following report:

There has been only one meeting of the committee since last meeting of Synod. This meeting was held at the Guilford Hotel in Greensboro, at the call of one of the members, Rev. J. H. Henderlite, Thursday, February 28, at 1 p. m. All the members were present except Mr. Geo. W. Watts, who was in California. Mr. Henderlite stated that he had called the meeting in response to a request from the Board of Trustees of Queens College; this being in accordance with the action of the Synod at Salisbury in 1916. (See Minutes, p. 464, par. f.)

The meeting was led in prayer by Dr. A. D. McClure and organized by the election of J. H. Henderlite, chairman, and C. M. Richards, secretary.

Rev. A. A. McGeachy, D. D., Rev. H. E. Gurney and Mr. Jno. R. Pharr, representing the Board of Trustees of Queens College, and Rev. W. McC. White, Dr. D. H. Hill and Dr. — — Kilgore, representing Peace Institute, appeared before the committee for the purpose of submitting certain information regarding these institutions for consideration and appropriate action by the committee. Full and detailed statements were made by them as to the present condition, financial and otherwise, and the future prospects of Queens College and Peace Institute. They announced the willingness and desire of the controlling bodies of these institutions to place the schools in the hands of Synod, with a view to their consolidation into a Synodical College for Women.

After very free and thorough conference and discussion the committee unanimously passed the following resolution:

“That the Stated Clerk of Synod be requested to call the Synod to meet within the next thirty days, to hear the report of this committee and act upon its recommendation that Peace Institute at Raleigh, N. C., and Queens College at Charlotte, N. C., be consolidated into a Synodical College for Women at such place as shall offer the best inducements and as the committee, taking all things into consideration, shall deem most advantageous.

“And to act on any and all other matters affecting Presbyterian education in the Synod that may arise in connection with this recommendation.”

The secretary was instructed to make out the request for the calling of Synod at once, and after giving all those present an opportunity to sign it, to forward it to the Stated Clerk. The committee then adjourned.

The committee herewith, accordingly, submits this report to the Synod with the recommendation that the offers of the controlling bodies of Queens College and Peace Institute to place these institutions in the hands of Synod for future control and ownership, with a view to their consolidation and the establishment of a Synodical College for Women be accepted: Said College to be located at such place as shall offer the best inducements, and as the committee, taking all things into consideration, shall deem most advantageous.

A motion was made to adopt the above report, but various substitutes and resolutions were offered, in order, and pending the consideration of these the Synod took recess until 7:30 o'clock p. m.

Synod met again at 7:30 p. m., and resumed the discussion. Other substitutes and papers were offered, but all were lost, in turn, and finally the original motion itself to adopt the

report was also lost. This last action, however, was re-considered and the following paper, being a modification of and addition to the recommendation of the Committee, was adopted. It is as follows:

The Committee herewith accordingly submits this report to the Synod, with the recommendation that the offers of the controlling bodies of Queens College and Peace Institute to place these institutions in the hands of Synod for future control and ownership, with a view to their consolidation and the establishment of a Synodical College for Women, be accepted; said College to be located at such place as shall offer the best inducements, and as the Synod, taking all things into consideration, shall deem most advantageous.

That the Executive Committee be authorized to secure such offers and report to the Synod at a meeting to be called by the Stated Clerk at such time and place as shall be requested by the Executive Committee.

And that either institution be permitted, with the consent of the Executive Committee, to continue the work of the institution for one or more years, the institution to be responsible for all contracts necessary thereto.

After the minutes were read, and approved as read, Synod adjourned at 12:30 a. m., with prayer by Rev. D. I. Craig, D. D.

The call for the meeting was read and found in order.

The Executive Committee of Education of the Synod made its report, which is as follows:

REPORT OF THE COMMITTEE OF CHRISTIAN EDUCATION.

At its extraordinary meeting held in this church on March 21 last, the Synod adopted a resolution accepting the offers of the controlling bodies of Queens College and Peace Institute, to place these institutions in the hands of Synod for the purpose of consolidating them into a Synodical College for Women, to be located at the point offering the best inducements, and as the Synod, taking all things into consideration, should deem most advantageous; and instructing this committee to secure offers for the location of the Synodical College, and such offers being secured to call a meeting of the Synod to consider and act upon them.

In accordance with these instructions, the committee herewith submits its report to the Synod:

It will be realized by all that the Synod by the above action laid upon the committee a serious and difficult task, for several reasons.

In the first place, a large work had to be done in a short time. It was necessary that speedy action should be taken. The board of Queens College gave notice that unless something was done by the Synod to relieve the situation in a very short time that institution would close its doors and be sold to meet its obligations, thus being finally and completely lost to Synodical and Presbyterian education. They informed the chairman of this committee that some action must be taken by June or the property would be sold.

Furthermore, it was highly desirable for the welfare of other institutions that this matter be settled at the earliest possible date. The uncertainty was injurious. It was vitally important that definite information be in hand as to the future status of the schools in order that plans be made for next session.

It is not an easy matter to secure proper bids for such an institution in a short time. A considerable period is desirable in order to formulate plans and go through the necessary preliminaries to such a campaign.

Second, the committee had no funds to meet expenses with. The Synod adjourned without making any provisions for this, and its faith-

ful and vigilant Stated Clerk and Treasurer promptly notified the chairman that he had no funds available, and gave warning against the creation of an expense account. All that has been done has been at the personal expense of the chairman and the members of the committee.

Furthermore, the committee has been so located as to render it difficult to work together. The members are scattered all the way from Wilmington to Durham and from Raleigh to Charlotte. To hold a meeting of the committee entailed upon its seven busy members the loss of two days time and considerable personal expense, in these days when there are unprecedented demands upon both time and money.

The chairman realized that a double burden of work and responsibility would fall upon him. He has endeavored to keep as far as possible under these circumstances in touch with the whole committee in all that has been undertaken and to secure their advice and approval in every step of any consequence that has been taken. He feels especially indebted to the secretary of the committee, Dr. Richards, for his wise counsel and cheerfully rendered assistance whenever called upon. The other members have been equally willing but Dr. Richards living nearby has been more accessible.

In order to carry out the instructions of the Synod it was necessary that the matter be brought to the attention of the whole State, giving all points an equal opportunity to bid for the proposed college and to secure worthy and adequate offers to be submitted to the Synod. To get the proposition advertised throughout the State and to stimulate a lively interest in such an undertaking in these war times was not an easy task. It called for extensive and continual correspondence. The Synod's purpose of establishing a Synodical College for women was published in all the leading dailies of the State and in the Presbyterian Standard. Letters were promptly written to all our female schools, laying the proposition before them, also to ten or a dozen secretaries of Chambers of Commerce in the cities most likely to be interested in securing the college. These efforts have been followed up by the chairman as closely as possible by correspondence, and in several cases he has been able by personal visits to keep in touch with the situation. He has had throughout all this three things especially before him; that all points interested should have a clear understanding of Synod's proposition; that each place should have an equal opportunity to make an offer for the college; that the best offers possible under the circumstances might be obtained to be submitted to Synod at this meeting.

At the risk of being tedious we have gone into these details in order that the Synod might not only be acquainted with exactly what the committee has done in its earnest endeavor to meet the responsibility placed upon it in handling this most important matter which offers such an unusual opportunity for the advancement of female education, but also that the Synod might clearly recognize the spirit in which the committee has gone about the task and its sincere and candid purpose of discharging the duties laid upon it without prejudice or special favor.

Through the religious press and by letters from the chairman, all interested points have been carefully notified that the Synod would meet at this time and place, regular official notice of the meeting having been sent out to the members of Synod by its Stated Clerk. Notice was given that all offers should be made to the committee by June 1st. This was necessary in order that the Stated Clerk might be notified in time to call the meeting of Synod ten days in advance. However, as soon as the chairman was assured that some offers would be in hand in time for the meeting of the Synod, with the concurrence of the committee, he gave notice to all interested points that they might have until June 10, to complete their campaigns and perfect their bids for the college. This was done primarily for the accommodation of those places, which had had such short time in which to do their work, and also in the interest of the proposed college, in order to secure the best offers possible.

We herewith respectfully submit to the Synod for its consideration the following offers that have been placed in our hands: From Charlotte, N. C., Greensboro, N. C., Red Springs, Statesville.

Furthermore, while we had no regular accredited offer from Raleigh, there were present representatives from Peace Institute, with an offer which they desire to place before the Synod, and we recommend that they be permitted to do so at this time. We have also an offer from Henderson which we desire to have read.

We recommend that Synod hear the representatives of the places making offers for the Synodical College for thirty minutes each, if so desired by them, they being heard in the alphabetical order of the towns they represent.

The representatives of Peace Institute were permitted to make their offer directly to the Synod, which was that they would turn over Peace Institute to the Synod free from debt, provided the Synod should make that institution the Synodical College. The offer from Henderson was also read.

The privileges of the floor were accorded to the representatives of the towns and colleges who are not members of the Synod.

The report of the Executive Committee was received and the recommendations adopted.

The following paper presented by Rev. Peter McIntyre, D. D., was received and adopted:

Whereas, The action of the trustees of Peace Institute in offering to the Synod of North Carolina the property of Peace for the purpose of establishing a Woman's Synodical College within the bounds of the Synod was taken in haste and therefore without full and due consideration; and whereas, there is strenuous opposition from Albemarle Presbytery, from the Alumnae of Peace, from the woman's auxiliary, from the congregation of the First Presbyterian church, Raleigh, and generally from all Eastern Carolina to the removal of Peace Institute from Raleigh, and whereas, such removal would be a serious blow to the power and growth of our church in East Carolina, therefore be it

Resolved, That the Synod release the trustees of Peace Institute from any obligation, to place the Peace property at the disposal of Synod to be disposed of according to the judgment of the Synod.

Before the vote on this resolution or paper was taken the Moderator ruled that its adoption would not nullify the action of Synod on March 21 in regard to the establishment of a Synodical College, and that the bids made here today would be in force.

On motion, the Trustees of Queens College were now allowed to withdraw their original offer of March 21, 1918, with reference to the consolidation of Peace Institute and Queens College, in view of the fact that Peace Institute has been allowed to do so.

Synod took recess from 7 to 8:30 p. m.

Synod met at 8:30 p. m.

Representatives of colleges and towns making bids for the Synodical College were granted thirty minutes each for speeches.

On motion a committee of three was appointed by the Moderator to nominate a committee of fifteen to consider all bids for the Synodical College and to recommend the place for its location. This nominating committee, consisting of Rev. T. M. McConnell, D. D., Rev. W. T. Walker and Ruling Elder A. L. Bullock, recommended the following committee of fifteen, who were appointed: A. M. Scales, E. P. Wharton, E. T. Cansler, Dr. A. J. Crowell, A. R. McEachern, J. W. McLaughlin, Rev. C. E. Raynal, Rev. J. M. Clark, R. Y. McPherson, Rev. A. J. Crane, Rev. C. M. Richards, J. H. Kennedy, Rev. W. E. Hall, Rev. C. P. Coble, and Walter Bullock. This committee was directed to report tomorrow at 11 a. m.

The following resolution, presented by Rev. J. S. Sibley, D. D., was adopted:

The Synod of North Carolina desires hereby to express its high appreciation of the kind hospitality of the members of the Presbyterian churches of the city of Greensboro.

After prayer by Rev. George F. Robertson, D. D., Synod adjourned to meet at 11 a. m. tomorrow.

WEDNESDAY, JUNE 12, 1918.

Synod met at 11 a. m., and was opened with prayer by Rev. H. J. Mills.

The minutes of yesterday were read, amended and approved.

The committee on location of the Synodical College made the following report :

To the Synod of North Carolina: Your committee respectfully recommends that Queens College at Charlotte be chosen as the Synodical College of this Synod, provided that Mecklenburg Presbytery shall within a reasonable time present to the Trustees of Synod a good and sufficient deed in fee simple with warranty for the present plant and present campus of twenty-five acres and a proper bill of sale for all the personal property of the college, all to be absolutely free of debt.

Pending a motion to adopt and after much discussion, recess was taken to 3 p. m.

Synod met a 3 p. m.

Rev. O. G. Jones, D. D., was granted permission to withdraw his amendment to the committee's recommendation. It was ordered that the vote on the committee's report be taken by roll-call which was done and resulted as follows: ayes 34, noes 27.

A rising vote of thanks was tendered to the Moderator for his efficient services throughout the perplexing business of the meeting.

After singing "Bless be the tie that binds" and prayer and the benediction by the Moderator, Synod adjourned sine die.

MINUTES OF THE REGULAR MEETING.

RALEIGH, N. C., Tuesday, Nov. 12, 1918.

The Synod of North Carolina met in its 105th annual session on Tuesday, November 12, 1918, at 8:00 p. m., in the First Presbyterian church, Raleigh, N. C., and was called to order and opened with prayer by Rev. J. N. H. Summerell, D. D., the last Moderator present.

On motion the opening sermon was omitted for the reason that on account of the prevailing epidemic of "Spanish Influenza" a full and regular meeting of the Synod appeared to be impracticable, and it was understood this brief session was held to transact necessary business only.

The following Ministers and Ruling Elders were present and were enrolled:

From Orange Presbytery—Rev. D. I. Craig, D. D., Rev. E. C. Murray, D. D., Rev. A. W. Crawford, Rev. H. S. Turner and G. H. Beall of First church, Durham.

From Fayetteville Presbytery—Rev. H. G. Hill, D. D., Rev. C. G. Vardell, D. D., Rev. R. M. McQueen, Rev. D. M. McGeachy and Elders James McBryde and W. A. Munroe, from Center and Sanford churches.

From Mecklenburg Presbytery—Rev. W. R. Coppedge.

From Albemarle Presbytery—Rev. W. McC. White, D. D., Rev. J. N. H. Summerell, D. D., Rev. Peter McIntyre, D. D., Rev. H. N. McDairmid, Rev. A. J. Crane, Rev. T. P. Allen, Rev. S. B. Lyerly and Elders Dr. W. A. Withers of Raleigh First church and R. Y. Smith of Willow Springs church.

The following ad interim minutes were read by the Stated Clerk, amended and approved; and the notice published in the

papers by the Clerk relative to the present meeting was ordered to be appended to these minutes for record.

AD-INTERIM MINUTES.

Since the last regular meeting of Synod six ministers have died, viz: D. H. Ralston, D. D., W. D. Morton, D. D., M. N. Melver, A. J. McKelway, D. D., E. E. Pressly, and H. J. Mills.

The Stated Clerk, in accordance with Standing Rule No. 9, appointed, respectively, the Rev. Messrs. J. R. Bridges, D. D., J. N. H. Summerell, D. D., H. G. Hill, D. D., Walter L. Lingle, D. D., S. L. Cathey and V. R. Gaston, to prepare Memorial Sketches of the life and labors of these deceased brethren to be read at this meeting of Synod, and these brethren have been duly notified of their appointment.

The Stated Clerk also, together with Dr. W. McC. White, pastor of the First Presbyterian church, Raleigh, N. C., under the direction of Synod, fixed the date of this meeting of Synod for October 15, 1918, at 8:00 o'clock p. m. Afterwards, owing to the wide-spread epidemic of the "Spanish Influenza," throughout the State and country, and especially in Raleigh, the Stated Clerk, in consultation with Dr. White, Dr. Summerell, the last ex-Moderator, and others, and in accordance with the Book of Church Order, postponed the meeting, giving due notice, until November 12, 1918, at 8:00 o'clock p. m., the present time.

Since the action of this postponement until now, while the epidemic is abating but not disappeared, the present and after conditions have made it impossible for the Synod to meet in a full body anywhere in the State. Your Clerk has received numerous letters expressing as many different and conflicting opinions as to what to do. Finally he caused to be published in the Standard of November 6th, a notice recommending and suggesting that at least a quorum meet at the time and place appointed, elect a Moderator and transact necessary business only.

No temporary appointments have been made to fill vacancies on the Board of Directors of Union Theological Seminary.

Two Extraordinary or Called Meetings of the Synod have been held since we last met. These meetings were called and held in due form and order according to the Book of Church Order.

THE SYNOD OF NORTH CAROLINA .

The time and place for the meeting of Synod, as scheduled, in Raleigh, November 12, 1918, at 8 o'clock p. m., will stand, but as has been stated in the Standard of last week, owing to present conditions in Raleigh, and owing to general conditions following the influenza epidemic, it is a settled fact that a full Synod cannot be entertained in Raleigh, or elsewhere. The Synod ought not to expect to be entertained; therefore, those of us who go to Synod this year, must expect to provide for ourselves.

The Stated Clerk has no authority to make a program in advance, not even for a quorum, but he would strongly urge that a full quorum of seven ministers and three elders be present; and he would suggest that the Synod be organized by electing a moderator: that certain vacancies in our boards be filled: that the Superintendent of Home Missions and Evangelists be elected or re-elected: that other necessary appointments be made: that provision be made for increasing our finances to meet the necessary expenses of the Synod, and that any other absolutely necessary work, and none other, be done.

Your clerk would then suggest, and he is supported in the suggestion by a number of the brethren, that Synod adjourn to meet in regular session next year.

Perhaps all this necessary work can be done on Tuesday night.

Rev. D. I. Craig, D. D., was elected Moderator by acclamation, and Rev. A. J. Crane, Temporary Clerk.

On motion the Synod resolved to transact only necessary business, and then adjourn to meet at the call of the Moderator, if found necessary.

On motion the Synod proceeded to the nomination and election of men to fill vacancies. The following were elected Directors of Union Theological Seminary to succeed Rev. D. H. Rolston, D. D., Rev. W. D. Morton, D. D., deceased, and Ruling Elder James Sprunt, resigned: Rev. J. R. Bridges, D. D., Rev. W. McC. White, D. D., and Mr. W. H. Sprunt.

The following Regents of the Orphans' Home were re-elected: Ruling Elders W. H. Belk and Dr. C. E. Adams and Rev. C. M. Richards, D. D.

The apportionment of \$40,000 among the Presbyteries for the support of the Home was ordered to remain the same for the ensuing year.

The report of the Regents was admitted to record in the minutes without being read, as follows:

THE REPORT OF REGENTS FOR THE YEAR TO OCTOBER 1, 1918:

Some difficulties have been encountered during the year in securing workers in the different departments of the Home. The increased demand for men and women in every line of work has made it difficult to keep our places filled. More teachers than usual have resigned and repeated efforts to secure a man to be principal of the graded school and to act as Assistant Superintendent have so far failed. We have felt seriously the high cost of everything to be bought for the Home. It is gratifying to state, however, that despite hindrances the work of the Home has been conducted with a reasonable degree of success. We have succeeded in maintaining an average of 230 children under our care, in comfort and have closed another year without encumbrance. The support fund has been steadily maintained throughout the year without repeated appeals for funds. The health of the Home has been good and the few cases of scarlet fever and pneumonia have been successfully treated without loss of life. Our children are generally healthy and robust. The work of the Home has gone forward with a good measure of satisfaction in all departments.

THE FARM.

Having acquired more land we have begun a better rotation of crops. A larger acreage of land was sowed down last fall in grain and cover crops than ever before, and these have yielded well. These lands were again planted in peas and corn for ensilage and both silos will be filled this fall, and a good crop of hard corn gathered.

An abundance of vegetables has been gathered from our garden, which has also supplied canned food for coming winter. Though the fruit crop has not been abundant in this region, our orchard has yielded well, and has furnished ample fruit for daily use and for canning purposes.

THE DAIRY.

We have realized more than usual from the dairy this year and are in a position to render it more than ever a help to the Home. Six or eight cows, of our own raising, will be added to the herd, bringing the number of milch cows to about forty-five. We have, too, a number of nice heifers coming on to replenish the herd. In addition to milk and butter from the dairy we have sold cows and calves amounting to \$1000.00. A constant demand for calves at a good price materially increases the profits of the dairy. A large percentage of our herd are either registered or entitled to registration, and a still larger number are high grade Holsteins, thus increasing the value of the herd or their price when sold. We have received from the herd beef for Home amounting to \$300.00.

THE MECHANICAL DEPARTMENT.

The head of this department, Mr. Grier, is proving efficient. Much repair work has been done on the buildings as needed. This department affords great help to the Home. While it furnishes no revenue to the Home from products sold, it saves a large amount of money for repair work done and of time in having it finished. It also gives boys training in mechanical employment.

POULTRY AND HOGS.

This department is not as well developed as we hope to have it. But it helps in providing eggs and meat for the children. We have 20 lare shoats for killing this fall and about 35 good pigs for sale. We sold hogs and pigs during the year amounting to \$161.28.

THE PRESS.

This department furnishes a useful business training for the boys and a valuable means of advertising the interests of the Home to our constituency. The most of the printing for the Home is done in our own office in addition to publishing "The Fatherless Ones" weekly. The value of the printing department to the Home it is difficult to estimate.

IMPROVEMENTS MADE.

Three tracts of land were secured for the Home last fall, aggregating 115 acres and making the total acreage owned by the institution about 390. This will greatly aid in rotating and making crops and in maintaining the herd of cattle needed.

PROPOSED IMPROVEMENTS.

It is gratifying to know that the women of the church have undertaken the erection of a new dining room and kitchen for the Home. Plans have been made for securing the necessary funds for said building in the course of the next three years. We have reason to believe that these plans will be realized and the building provided in the near future, as the women have entered upon the enterprise with much enthusiasm. The Superintendent urges that a barn for the horses be erected as soon as possible. This will greatly facilitate the work of the Home in the proper care of the horses and of tools used on the farm, and at the same time provide more room for the storage of products made. It is also important to enlarge and modify the Industrial Plant as suggested in last year's report, as soon as possible. Another dormitory, too is proposed, and is greatly needed, as we are constantly pressed to admit other children for whom we now have no room.

GIFTS IN KIND.

These prove of material help to our cause. Practically all of the children of the Home have their clothing provided by individuals or societies. Other valuable gifts are received from time to time, the aggregate values of which amounts this year to \$6,290.00.

HOME TRAINING.

A constant effort is made to render the training of the Home distinctly Christian and to develop the spiritual nature of those under our care. Our children are carefully instructed in the Word of God in their cottage homes, in the school where the Bible is a part of the course of study, and in the public exercises regularly conducted. The children are encouraged to commit God's word to memory and also the catechisms of the Church. Continued effort is made to bring them up in "the nurture of the Lord." While there is much that we would see corrected and modified, yet we believe the training given is making an impress and will influence the children's future lives. Few of the children who reach the age of discretion fail to make a profession of their faith in Christ and there have been 18 professions during the year. An evidence of their interest in spiritual things is found in the religious contributions of the church consisting of the children and our workers.

The request of Fayetteville Presbytery for the transfer of the Spring Hill church from Albemarle to Fayetteville was granted, Albemarle having already concurred.

The Synod of South Carolina having consented to the transfer of Six Mile Hill church from Bethel Presbytery to Mecklenburg. This Synod also gives its consent, provided the Presbytery of Mecklenburg concurs.

The report of the Synodical Home Mission Committee was read in part, and the recommendations were read and adopted, and the report as a whole was ordered admitted to record in the minutes, and is as follows:

SYNODICAL HOME MISSIONS.

The Home Mission Committee of the Synod of North Carolina has completed the thirtieth year of the work committed to their trust and would submit the following report:

THE GENERAL EVANGELISTIC WORK .

God has given to us the labours of his servant the Rev. William Black, as General Evangelist of the Synod, throughout the year, completing 25 years of continuous service for the Synod. He submits the following report:

From October 1st, 1917 to October 1st, 1918 he has conducted 20 series of evangelistic services within the bounds of the Synod. He preached in these services 314 times and conducted more than a hundred prayer meetings and other religious services.

In these meetings there were 845 professions of faith and 355 additions to the Presbyterian Church. 87 persons promised to establish family worship and 2,495 to read the Bible and to pray daily. He assisted in the organization of one church and one Sunday school, aiding in the ordination and installation of two elders and two deacons. In these services \$1687.63 was contributed for the Synod's mission work, and \$1984.85 for congregational and other purposes connected with the churches where the services were held.

Besides the above he held one meeting in Columbus, Ga., and one in Quincy, Fla. In these two meetings he preached 39 times and conducted 20 prayer meetings, witnessed 150 professions and 38 additions to the Presbyterian Church. While laboring outside of the bounds of the Synod he received no compensation from the Synod's Committee.

Rev. O. G. Jones, D. D., spent four months of the year in the service of the committee, being granted leave of absence for the remainder of the year without salary, first to act as manager for the Synod in the \$3,000,000 campaign, then as Camp Pastor at Norfolk. In the four months of service for the committee, October 1st to February 1st, he held six meetings. In these meetings he reports: 106 sermons and addresses, 159 professions of faith, 28 additions to the Presbyterian Church and \$262.29 contributed to the Synod's work.

Upon granting leave of absence to Rev. O. G. Jones to engage in war work, the executive committee in session in Charlotte, April 30th, authorized the Superintendent to secure the services of efficient men to hold the meetings which were allotted to the several Presbyteries, to be held by Dr. Jones. In accordance with this action the Superintendent secured the services of Rev. D. K. Walthall, D. D., of Waynesboro, Va., for four meetings, the Rev. Leonard Gill for three meetings, and the Rev. T. M. McConnell, D. D., for one meeting. The labours of these brethren were fruitful and greatly appreciated.

In all they report in these eight meetings, 119 sermons, 156 professions of faith, 79 additions to the Presbyterian Church on profession, and contributions to the work of \$493.57.

In addition to the general superintendency of the work, the visiting of the local fields, and the presentation of the work in the stronger churches, which duties have occupied the larger part of the time of the Superintendent throughout the year, he has held five protracted meetings in which there were 52 professions of faith, 46 additions to the Presbyterian Church upon profession and 6 by letter and contributions of \$254.16. In all the Superintendent reports for the year 149 sermons and addresses delivered in 57 places in the Synod and travel by public conveyance of 12,118 miles.

In all, through the general evangelist work of the Synod, 39 meetings were held in which 499 souls were added to the Presbyterian Church on profession of faith, besides the addition of many upon profession to churches of other denominations. In these meetings \$2697.61 was contributed for the Synod's work.

These 39 meetings were distributed among the Presbyteries as

follows—Albemarle, seven meetings; Concord, one meeting; Fayetteville, ten meetings; King's Mountain, four meetings; Mecklenburg, eight meetings; Orange, five meetings; Wilmington, four meetings.

THE WORK IN THE LOCAL FIELDS IN THE PRESBYTERIES.

In this department of the work the Synod's Committee aided in the support of Rev. A. J. Crane, the Superintendent and Evangelist of Albemarle Presbytery and 31 men supplying 27 fields in six Presbyteries, serving 73 weak organized churches and 51 other mission stations. The following is the summary of the report of their labors: 2,859 sermons preached; 257 Professions of Faith; 204 Additions to the Presbyterian Church; 116 additions by letter; 11 Sunday Schools and 2 churches organized; 1 church building erected; \$449.61 contributed for the Synod's work.

Combining the work of the General Evangelists and that of the men in the local fields in the Presbyteries we secure the summary of the Synod's work for the year, as follows: 38 men engaged; 73 weak organized churches and 51 other mission stations supplied; 3,545 sermons preached; 1,439 Professions of Faith; 693 Additions to the Presbyterian Church on Profession; 131 additions by letter; 12 Sunday schools and 3 churches organized, and one church erected; \$3,147.16 contributed in the work, or it is that far self-sustaining.

Special care has been taken in securing and compiling the reports from the mission work done by the Presbyteries. The table appended to this report gives in detail the summary of the whole mission work done by the Synod and the Presbyteries, together with the total amount expended by the Congregations for Congregational Home Missions for a year, showing that the Synod, the Presbyteries and the Congregations together expended the total sum of \$72,288.16 for mission work in the bounds of the Synod for the year.

A careful study of the whole situation brings out the vital fact that there has been a decrease in results of the work as compared with last and former years.

In the Synod's Mission work there were 1,056 additions on profession last year; 693 this year. In the mission work of the Presbyteries 991 last year; 679 this year. In the mission work of the Synod and Presbyteries combined, 1,742 last year; 1,228 this year. This decrease is partially shown in the reports of the churches to the Presbyteries as recorded in the General Assembly's minutes for the year ending April 1st. Added on examination in the N. C. Synod, 1916-1917, 3129; 1917-1918, 2486.

This decrease we believe to be due in part to the vacancies in our churches owing to the entry of pastors into war work. We also believe it to be due in great measure to the diversion of the minds and hearts of the people from spiritual things by the increased opportunity for gain and by intense interest in the great events now transpiring in the world.

The full amount of the legacy of Mrs. Harriet N. Reading (\$2,268.82) has been received by the Superintendent.

He has also received the information from the executor of the estate of Mr. John C. Burroughs that there is a provision in his will bequeathing \$30,000.00 to the Home Mission Work of the Synod. This amount has not yet come into the Superintendent's hands .

At the time of the memorable meeting of the Synod at Goldsboro in 1888, when Synodical Home Missions was inaugurated the Minutes of the General Assembly showed a membership in North Carolina of 22,553. Thirty years after, this year, the Assembly's Minutes show a membership of 59,996, (including Asheville Presbytery, 2,657) a gain of 166 per cent. Then the population of the State was about 1,500,000, now about 2,500,000, a gain of 66 per cent.

The percentage of increase in Church membership in the Presby-

terian Church has been just two and a half times the increase in population. For this we devoutly thank God.

When, however, we look at conditions as they now are, 44 per cent of the mature population of the State with no church membership, the many openings awaiting our entrance, the urgent call of the Presbyteries for assistance to enter their open doors, the Spirit of God comes upon us urging us on to the work committed to our trust.

When we further take into consideration the special immediate conditions set forth in the foregoing part of this report, the decrease in the results of our work, and in every department of the work in the Synod for the past year, and on the other hand the steady increase of our receipts, about \$2,500 each year for three years, the call of God is the more imperative.

We would seek anew the Spirit of the men of God who inaugurated this work, men like Primrose, and Marabel, and Dr. W. D. Morton and the venerable Dr. H. G. Hill, who still abides in strength and vigor among us, and we would covenant anew with one another and with our God to go forward with fresh vigor to the accomplishment of our appointed task.

Those who have gone before long planned a wise and vigorous expansion of the work. Now God is providing us through the enlarged gifts of His people with the means to begin what they and we have long desired.

Your committee has therefore made large increase in its appropriations to the work in the Presbyteries for the ensuing year, amounting to \$11,262.00 and has made arrangements for expansion and vigorous prosecution of the work under its General Evangelists, involving a total appropriation of over \$20,000.00, and we have adopted and do submit to the Synod for its adoption, the following resolutions:

RESOLUTIONS.

1. In recognition of these enlarged appropriations to the Presbyteries, the full amount of their applications, they are hereby urged to do their utmost to secure an increasing measure of self support by the churches now being aided, especially those which have been long aided by this committee, that the Presbyteries may the more freely enter new fields as yet unoccupied, in which we pledge them our support to the full extent of our ability.

2. That under present conditions as hereinbefore set forth, we do recognize the call of God to enlarged and most vigorous evangelistic

work, and that we do elect to the office of General Evangelist in the Synod for the year upon which we are now entering, the Rev. William Black, the Rev. O. D. Jones, D. D., and the Rev. C. Conner Brown, granting leave of absence to Dr. Jones for six months, without salary from the Synod, to engage in war work.

3. We recommend to and urge upon the committee of Home Missions or the Committee on Evangelism in each Presbytery that appointments for evangelistic service be made in every vacant church at least once during the year. Also that, in cooperation with the pastors, arrangements be made for evangelistic service in their churches.

We recommend and urge that the said committee take the initiative in arranging for these services where the pastor does not, and that when the meeting has been appointed they keep the matter under their oversight until they are sure of its accomplishment.

We would call to their minds the responsibility which rests upon them in this matter and urge upon them to cooperate with to the full in arranging for a vigorous prosecution of a special work of evangelism in all our churches this year.

4. Realizing that the campaign of work in the local fields in the Presbyteries and through the General Evangelists can not be carried out on the basis of the old apportionment of \$20,000 to the Presbyteries, and in view of the fact that the Presbyteries themselves are in some cases already exceeding these amounts, and in view of the \$3,500,000 campaign for an adequate support of all our benevolent causes, we do apportion the amount of \$25,000 to the Presbyteries upon the same basis as heretofore, the three fold basis of pastor's salaries (2.5), church membership (2.5), and the total benevolences for the past year (1.5), as follows:

We would state emphatically to the Presbyteries that we make this apportionment upon the basis of present actual need, not as a

goal for the future and we urge them to apportion the full amount to their churches as the minimum of the gifts for this work

5. That the amount of the legacy of Mrs. Harriet N. Reading, \$2,268.82, and that of the legacy of Mr. John C. Burroughs, when it shall have been received, be held as an investment fund, and that it be invested by the Home Missions Committee through its Finance Committee, and that only the interest therefrom be used in the work.

6. That in churches where the General Assembly's Every Member Canvass Plan is not in use, the months of January and July be set apart as heretofore for contributions for Synodical Home Missions.

7. We note with much appreciation the increase in the gifts this year from our Sunday Schools, although many yet take no part in it. Recognizing the fact that the majority of the children in the Sunday schools do not make pledges in the every member canvass for the benevolences; appreciating their interest and their gifts; and knowing the Master appreciates them more; and further, believing that in this way they will be best educated for active participation in the work in after years, we urge upon all our Sunday school superintendents and the sessions to instruct the Sunday schools concerning this work and to give them the opportunity to aid in the support of it. We do direct that at least one Sunday in January and one Sunday in July be set apart in every Sunday school in the Synod for a special collection for Synodical Home Missions.

8. We note also with much appreciation the growth of the Special Albemarle Fund of the Women's Auxiliaries. We would express to them our appreciation of the part taken by them in the support of the Superintendent for Albemarle Presbytery and we commend to them this object for their special gifts again this year.

9. That we do re-affirm and emphasize the action taken at the called meeting of the Committee in Greensboro, June 11th, to-wit:

"We recommend to the Home Mission Committees of the Presbyteries in the general oversight of the vacant fields, that they request the assistance of some neighboring pastor to each vacant field, to act with the session in the supply of the field, preaching therein as much as possible himself, consistent with his duties to his own field, and securing other ministers and elders for such services.

That in this emergency the elders of our church be called upon for special aid, responding to every opportunity for pulpit supply. We recommend to the churches the largely increased use of the fine ability of many of these consecrated elders and other laymen whom God has specially fitted for this work."

On motion the Rev. A. W. Crawford was re-elected Superintendent of Synodical Home Missions and General Evangelist.

The committee on Synodical Home Missions was directed to take out articles of incorporation.

The report of the Permanent Committee on Systematic Beneficence was received and adopted, and is as follows:

REPORT OF THE PERMANENT COMMITTEE ON SYSTEMATIC
BENEFICENCE.

The Presbyterian Reports on Systematic Beneficence have come into our hands and have been tabulated as appears in the accompanying table. They show a very gratifying increase in our gifts in every Presbytery but one, and in the case of nearly every cause.

In view of the fact that there will not be a full meeting of Synod, we are curtailing our report, and present simply the following brief recommendations agreed upon at a meeting of the committee held in Charlotte, as embodying our idea of the program that should be carried out this year. **We recommend:**

1. That the Synod heartily co-operate with the Assembly in its Systematic Beneficence plans, viz: Its Twelve Million Dollar Program for the next three years, and a goal of three and a half million for 1919-20.

2. That the conduct of this campaign be placed entirely in the hands of the Standing Committee of Systematic Beneficence.

Your Treasurer would further report that there is nothing in the Treasury at the present time except a debt of \$94.35, and the only asset available until next October is the assessment of \$42.00 due from Wilmington Presbytery. The whole sum of assessments laid upon the Presbyteries, is only \$400.00. This is not sufficient to meet the absolute expenses and needs of the Synod.

Therefore, your Treasurer would recommend that the assessments upon the Presbyteries be increased about 50 per cent, which is about 1 cent per member, and which should produce a sum total of \$600.00. Furthermore, it is recommended that one half of the assessment be paid in April and the other half in October.

According to this rearrangement, the assessment for each Presbytery would be as follows: Orange \$100, Concord \$100, Fayetteville \$130.00, Wilmington \$60, Mecklenburg \$125.00, Albemarle \$45.00, King's Mountain \$40.00. Total \$600.00.

III. COURSES OF STUDY.

1. The regular course, leading to the degree of Bachelor of Divinity.

2. A special course in English, leading to diploma without degree.

3. A Post-Graduate course.

4. A special mid-winter course for pastors and missionaries wishing to freshen up on theological questions of living interest and on modern methods of practical work.

5. A course of advanced studies leading to the degree of Doctor of Divinity. The Seminary confers this degree, not as an honorary title, but in recognition of proved attainments and eminent scholarship, as evinced by the successful completion of prescribed courses of advanced Post-Graduate study.

IV. SPECIAL LECTURES AND ADDRESSES.

The Society of Missionary Inquiry celebrated the one hundredth anniversary of its organization with a four days' program in January, and appropriate addresses were made by Rev. Messrs. W. W. Moore of Richmond, William E. Hill of Fayetteville, Charles R. Erdman of Princeton, Egbert W. Smith of Nashville, S. L. Morris of Atlanta, J. M. Wells of Wilmington, Robert King of Kingsport, Tenn., D. P. McGeachy of Lewisburg, W. Va., J. W. Orr of Charlotte, N. C., and Dr. Robert E. Speer of New York.

The James Sprunt Lectures were delivered in January by Rev. A. H. McKinney, Ph.D., D. D., of New York City, a series of studies in boyhood entitled "Guiding the Boy Over Fool Hill." Other special addresses were made to the students by various speakers such as Rev. Messrs. J. H. Mills, D. D., of Clemson, S. C., Andrew R. Bird, of Washington, D. C., Lowry Davis, of Kashing, China, Juan Ortz Gonzales, of Nashville, Tenn., and Dr. James B. Woods, of Tsing-kiang-pu, China, and President William J. Martin, of Davidson College, N. C.

A MEMORIAL OF DAVID HOPKINS ROLSTON, D. D.

David Hopkins Rolston was born in Fauquier County, Virginia, October 28, 1878, on his grandfather's farm, near Harrisonburg, Va., he spent his boyhood, and at a country school near his home, he received the rudiments of his education, and at a preparatory school, near Mount Clinton, Va., he was made ready for college.

At the age of 23 years he entered Washington and Lee University, where he completed four years' course in three years, graduating with first honors.

Before entering the seminary he was married to Miss Sallie Rodifer of Harrisonburg, Va., who accompanied him to Union Theological Seminary, Richmond, Va., and remained with him the three years of his stay there.

Before he entered the seminary he was filled with thirst for souls, and wherever opportunity offered, he preached the gospel.

Then during his seminary course he assisted the pastor of the Second Presbyterian church, Petersburg, and he also preached in the adjoining county. On May 18th, 1907, Lexington Presbytery licensed him, and then six days after this same Presbytery ordained him to preach the gospel.

Going into the mountains of West Virginia, he at once gave evidence of those gifts that in after years made him such a valuable aid in evangelistic meetings. In 1908 he became pastor of the Second Church, Petersburg, Va., where he made a profound impression upon the people of that city.

In 1911 he became pastor of the First Church, Charlotte, where for nearly six years, upon the altar of service, he laid every gift that he possessed, following most lovingly the example of his Master who came not to be ministered unto but to minister.

Davidson College conferred upon him the degree of Doctor of Divinity, an honor most worthily bestowed and most worthily worn.

On November 21st, 1917, at the manse in Charlotte, at the early age of 39 years, he laid aside his armour and passed from the Church militant to the Church triumphant.

During the six years of his ministry in Charlotte, he steadily grew in the love and confidence, not only of his own people, but of the entire community. His remains were taken to his old home in Virginia, where surrounded by those beautiful mountains he loved so well, he sleeps in peace.

Physically Dr. Rolston was below medium height, but intellectually and spiritually he was the peer of any of his contemporaries.

Said one of our most consecrated preachers who was for months confined in the hospital, "Dr. Rolston visited me every day. He had more religion than any man I know, and what is very remarkable he knew how and when to use it."

There was something so spontaneous, so genuine in his goodness that he always made you want to be better.

His goodness beamed upon you in his smile and it rang out in his laugh. Men everywhere loved him and trusted him, and when he died there was mourning among all classes.

He was a Prince of pastors, filling that difficult role as men are seldom able to do.

His labors were only limited by human distress, and his death was no doubt hastened by overwork.

Almost daily he was found in the hospitals of the city, where his very presence carried curative powers.

In the camp also among the soldiers he was almost daily found, and nothing he enjoyed more than to preach to them.

He believed fully in the lost condition of man and in the gospel's power to save. The salvation of souls was the mainspring of his ministry.

The following just tribute from the facile pen of Mr. George E. Wilson, an elder of the First Church, gives a true estimate of him as a preacher:

"As a preacher Dr. Rolston was thoroughly sound and orthodox. He never allowed himself to be drawn away from the gospel truths by the topics of the times, but preached Christ and Him crucified. His message was always the same old story, made attractive by sound presentation of the subject. He held out the promises in the Bible, but did not forget the warnings. He preached the whole truth as he understood it.

"He was much interested in the work of the Sunday school, regularly attending its meetings. It was largely through his instrumentality that the large addition of a Sunday school building was added to our church. He was a man of deep piety, with an abiding faith in the providence of God. He impresses his piety upon all with whom he was associated, and this piety shone resplendent in the sermons he preached to his people."

There are many of us here today who miss his presence, who long for "the touch of a vanished hand, and the sound of a voice that is still."

MEMORIAL OF REV. M. N. McIVER.

The Rev. Malcom N. McIver was born of Scotch parents in Moore County, N. C., near Jonesboro in 1844. His grandfather, Alex. McIver, moved from the Highlands of Scotland and settled in Moore County, N. C., after the battle of Colloden. He raised five sons who had distinguished descendents. Malcom McIver, the father of Rev. M. N. McIver, married Miss Mary Ann McNair of St. Pauls, Robeson County, N. C. His wife had two brothers, Dr. A. D. McNair and the Rev. John C. McNair, who died in Scotland while taking a post-graduate course. The Rev. M. N. McIver's father died when his son was an infant and his mother returned to her childhood's home. The subject of this memorial received an academic education, but the demands of the civil war did not permit him to finish his collegiate course, nor to attend a theological seminary. He married Miss Flora Jane Crawford of St. Pauls, N. C., and raised a large family of sons and daughters. He taught classical schools and for some years was superintendent of public instruction in Richmond county. He had a long cherished desire to be a Presbyterian minister and for sometime studied theology privately. In his mature manhood with a large growing family, he was licensed and ordained by Fayetteville Presbytery. For two years he served Union church in Moore county, a large country church, with good results. He also rendered acceptable service in Rockingham, Culdee, Mt. Carmel, Ellerbe Springs, Pittsboro, Haywood, Salem and Mark's Creek churches. At a later period he took charge of a Mission church in Durham, N. C., and remained there several years. Failing health caused him to resign this charge and then he returned to the Presbytery of Fayetteville and ultimately made his residence in Maxton, N. C., where some of his children resided.

In his later years, physical infirmity did not allow him to have regular ministerial work or to attend habitually meetings of Presbytery. But as he was able he preached at times for his brethren, attended the Bible class in the Sabbath school, was habitually present at the weekly prayer meeting and sometimes conducted it. He found great pleasure in religious exercises and services and shared them when physical strength permitted. His wife, three married daughters and two sons survive him. His wife and two daughters live in Maxton, N. C. After some days of growing feebleness, Rev. M. N. McIver passed away from earth April 4, 1918. His funeral was conducted by Rev. H. G. Hill, and was largely attended by neighbors, friends and relatives. Like Barnabas, he was a "good man," sympathetic

with human wants and woes, well qualified for making friends and useful in multiplied stations. He was a man of vigorous mind, genial disposition, winning manners, tender feelings, abundant labors and devout affections. We are assured that like the Psalmist "He beholds God's face in righteousness and is satisfied, having awakened in His likeness."

REV! WILLIAM DENNIS MORTON, D. D.

A mighty man of God has fallen. Our Leader in Home Mission work has passed over the river. A faithful servant of the Lord has entered into his rest.

Dr. Morton, the tireless worker, ever the optimist, the holy-hearted is with his Master whom he served so long and so well. How we miss him in our councils, his voice in prayer, his benignant face, his very form.

Of the three brothers in the family who became ministers of the Gospel, he was the last to join the goodly company of those who see the face of their Lord, and enjoy him forever.

Dr. Morton was born in Bottecourt county, Virginia, of that stock that has left the impress of its piety on every community where one of them settled. At the close of the Civil War, in which he fought as a cavalryman under Jackson, he completed his education at Hampden Sidney College and Washington-Lee. Then he entered Union Theological Seminary, graduating in 1869. His active ministry commenced in Kentucky. He was ordained in 1870 by Muhlenburg Presbytery. His influence was deeply felt not only in other States where later his services to the church were rendered but where the record of his work was known. In the great forward movement in Synodical Home Missions in Kentucky in 1881, it was his zeal and his voice that gave the impetus that carried the cause "over the top," when the very magnitude of the work contemplated made the Synod hesitate. How well he planned, and how splendidly results were secured, has entered into the history of our church, as he and Dr. Guerrant labored as the first Synodical Evangelists in that State.

When in 1885 he entered the Synod of Missouri as pastor at Boonville, he was not permitted to labor there long, for his gifts as Evangelist were sought by the Synod of North Carolina, when in 1888 our church in this State arose from her lethargy, determined to do a larger share in reaching out where her responsibilities had for

years been paramount, but where those responsibilities had been overlooked or neglected.

Dr. Morton commenced his work in this State as Synodical Evangelist in the Fall of 1889, and tho many hearts and hands have since guided the work and led onward the cause, his hand gave the master touch, the mothering care in the days of its infancy.

After a fruitful pastorate at Henderson in the middle 90's, our brother went to Mississippi to plan and start the work of Home Missions in that Synod. He returned to North Carolina in 1900 to become the pastor at Rocky Mount. Here for 18 years he labored as an evangelistic pastor, with impressive results to testify to his wisdom and zeal and power. Instead of one organization, housed in a small wooden building, there is a large membership, influential and liberal, worshipping in a modern, well appointed church, which is mother to four other churches in the neighborhood all monuments to the unwearied zeal and patience of this servant of God, leading a congregation that has caught the inspiration of their pastor.

Dr. Morton was one of the charter members of Albemarle Presbytery, and during both his pastorates, at Henderson and at Rocky Mount, he was Chairman of the Home Mission Committee of this body, besides always giving the fifth Sundays to evangelistic work, in which his soul delighted. Consequently he knew the whole of our territory as no other Presbyterian did. And such was his deep interest in this branch of the work, that the right of way was frequently given to him and his committee during our sessions.

The report of the last year of his service, shows that it was the very best of all his years, in the developmmt of plans and in fruitage of work.

While Dr. Morton was deeply loved by all who knew him, in Presbytery or in Synod, he enjoyed in a special degree the respect, confidence and affection of the people of Rocky Mount, as pastor pre-eminent. His big heart, his tender sympathy, his wide experience, his genial manner, his spirit of humor, his gentleness, his piety, his humility, his deep spirituality, all combined to make him revered and beloved, and honored.

So when on April 9th, 1918, it became known that he had passed away, quietly and suddenly and without pain, the whole community paused, not simply to voice its sorrow, or speak its sense of grief, but, brushing their tears aside as unworthy of his coronation day, they arose to do him signal honor that for years had unselfishly served among them. It was a very ovation of love and respect from those of

all creeds and every class. And he was laid away in a manner well-befitting such a man, with such a richness of the offerings of love, and such thoughtful consideration for those whom he left behind, that it was more a day of holy triumph than the day of lowly burial. His body sleeps in the silent city, his spirit lives in the lives of those to whom he ministered in holy things.

Dr. Morton leaves a widow, a daughter, and a son, to inherit the fortune of his prayers, the benediction of his life, to share the honor of an honored name, and the blessed hope of reunion in the Bright Beyond. He had the rich and joyous pleasure of the answer to his most earnest prayer, when his only son became a minister of the Gospel of the Lord Jesus Christ, and he saw many souls given to his ministry.

Dr. Morton's voice in prayer has been heard in every church in Albemarle Presbytery and in many throughout the Synod. His earnestness, his yearning desire to lead souls to Christ, his patience in hope, needs but the mention. Yet he was strong in the doctrines of our Church, and his statement of them clear and effective. He was a rich and a rare combination-man. We shall miss him as a Presbyter, in our whole Presbytery and Synod, as counsellor and friend and holy man of God.

To his family we extend not merely sympathy at their loss, but we would share with them the sweet assurance of a full life work well done, and now a fadeless crown won through faith in his Lord and Savior Jesus Christ.

MEMORIAL OF REV. E. E. PRESSLY.

Rev. Ebenezer Erskine Pressly was born in Anderson County, S. C., May the 25th, 1837, and died at his home in Statesville, N. C., July the 4th, 1918, at the age of eighty-one. He was the eldest of five children of David A. and Elizabeth Todd Pressly. His early life was spent on his father's farm where he learned many practical lessons that were of great value to him in later life.

From his boyhood he coveted earnestly a college education, but the fulfillment of his longing seemed destined to be denied him; for until his eighteenth year his educational advantages were limited to the short-term school of the day. He did not, however, lose sight of the goal he had set himself. All his spare hours were occupied in read-

ing and studying; he having built for himself a rude study to which he could retire for work when opportunity offered. On the 31st day of December, 1855, he entered Erskine College, Due West, S. C. Being inadequately prepared for college he was not able to enter the Freshman class. Studying faithfully at college and at home during vacation he later became a member of the class of 1861. A few weeks prior to his graduation in May, 1861, the work of the college was suspended on account of impending war between the North and the South. Later—in the year 1868 or '9—the college conferred upon him and other members of his class the A. B. degree.

Mr. Pressly did not decide to enter the ministry until after the close of the Civil War. In August, 1861, he volunteered and entered the Confederate army becoming a member of Company I, 14th Regiment, South Carolina Volunteers. He was in the service of the Confederacy until the 27th of June, 1862, when in the Cold Harbor battle he was wounded in the outside ankle of the right foot. After his wounding there was delay in sending him to a hospital. When he did reach a Richmond hospital the surgeon making the examination failed to locate the bullet, which Mr. Pressly carried in his ankle till a few years ago. He discovered it himself in 1890 and Dr. Gibson of Loray removed it for him. From this wound he was a constant sufferer and at times the pain from it was acute.

When sufficiently recovered from his wound to travel Mr. Pressly, being incapacitated for further military service, left Richmond and returned to South Carolina, locating at Due West where he bought a half interest in a drug business. While attending to his duties in the store he began the study of medicine, and expected to pursue this study further in Richmond, Va., but the fall of that city into the hands of the Northern army prevented his going there. He then gave up all thought of becoming a physician.

His business venture was a failure. For a few years he taught school and farmed. In 1868 he decided to enter the gospel ministry and on the 12th day of October of that year he became a student in Erskine Theological Seminary, Due West, S. C. His studies continued here without interruption until graduation in the spring of 1870. The Second Presbytery of the Associate Reformed Church licensed him to preach the gospel of Christ April the 9th, 1870, at Providence church, Laurens, S. C. He preached at Shiloh church in Lancaster county, S. C., for a year after licensure with a view to a call; and at the expiration of the year the church did call him to become their pastor. He was ordained by the First Presbytery of the A. R. P.

Church at Shiloh, June 14th, 1871. In connection with the Shiloh church he served as pastor also of Unity and Gills Creek churches.

For fifteen years Mr. Pressly continued in this his first pastorate. These were among the best and most successful years of his life. Upon the expiration of this pastorate he spent a year in Arkansas; thinking he might locate there. However he did not like the work. From Arkansas he went to Virginia and preached a few months. While in Virginia he received and accepted a call to Amity A. R. P. church in Iredell county this State. For some four years he labored faithfully and successfully in this field.

The 13th of October, 1890, Mr. Pressly was received into the membership of Concord Presbytery this Synod, which relationship continued until his death in July—a period of twenty-eight years. Soon after his reception into this Presbytery he accepted calls to the pastorate of the Concord (Ire.), Clio and New Salem churches. He labored in this field from December, 1890, until October, 1895. In these five years seventy-two persons united with Concord (I) church. After the close of his pastorate in the Concord (I) field Brother Pressly retired from the active work of the ministry. Although in declining health he engaged in several different activities for a number of years. Finally, however, his health was so impaired that he was unable to do any active work for several years before his death.

Brother Pressly was a good preacher. He presented the truths of the gospel in a clear, forceful way that impressed them on the minds and hearts of his hearers. There are many who can point to him as the one who first directed their attention to the acceptance of Christ as their personal Savior. And many others remember his words of comfort in their time of sorrow. In his preaching he sought to win the unregenerate to Christ and to feed those who were already the sheep of the "Good Shepherd's" pasture.

He was even more successful as a pastor to the people. His own life was so full of suffering and he had endured so many hardships and difficulties; and had spent so much of his life in hard labor on the farm, in the school room, in business and in the army that he had a ready sympathy for all who must meet the sterner realities of life. In the last days of his life, when he could no longer get out among the people—when he was kept indoors for the most part by reason of his infirmities—he was yet ready always to send the cheering message to all who needed it.

Doubtless if Mr. Pressly's career had been directed into business

channels, he would have made good success. For, although his only business venture prior to his entering the ministry was a failure, yet he had the reputation of having good business judgment.

On the 19th day of October, 1865, Mr. Pressly married Miss Elizabeth McDill at her home in South Carolina. To this union nine children were born. Of these, seven together with his wife survive him. To them we extend our sincere sympathy. Brother Pressly's life on earth reached to a little more than four score years. He came to his grave in peace. He sleeps quietly in the cemetery at Statesville.

“It is not death to die—
To leave this weary road
And 'midst the brotherhood on high
To be at home with God.

It is not death to close
The eye long dimmed by tears
And wake, in glorious repose
To spend eternal years.

It is not death to bear
The wrench that sets us free
From dungeon chain, to breathe the air
Of boundless liberty.

It is not death to fling
Aside this sinful dust,
And rise on strong exulting wing,
To live among the just.

Jesus, Thou Prince of life!
Thy chosen cannot die;
Like Thee, they conquer in the strife,
To reign with Thee on high.”

REV. H. J. MILLS.

Rev. H. J. Mills, son of Leighton Cooper Mills and Laura Virginia (Muldrow) Mills, was born in Sumter county, South Carolina, near the town of Mayesville, August 23, 1876, and died at Rowland, North

Carolina, October 24, 1918. He was graduated from Davidson College in 1897. His theological training was at Columbia Theological Seminary, graduating in 1902.

June 11, 1902, he married Miss Amanda McCutchen, one worthy in every way to be his companion and devoted co-worker. She with their three daughters (Irene McCutchen Mills, Hannah Fraser Mills, and Mary Estelle Mills) survive his death.

The Master allowed Brother Mills to work in the active ministry from the spring of 1902 to the fall of 1918. For him these were years of unselfish, consecrated, arduous, faithful and loving service.

The first six years were given to the Ridgway and Longtown churches in South Carolina. The next six years were given to the Clover and Bowling Green churches in the same State. The last five years he served with increasing power and favor the Ashpole and Rowland churches in the bounds of Fayetteville Presbytery in the State of North Carolina.

He was an earnest student and a strong preacher. He had no "isms." Man was a poor, lost sinner, and could be saved **only** by the blood of Christ. Few preachers equaled him as an expounder of the atoning work of our Lord. He was diligent as preacher, pastor and Presbyter. His natural force of character and his fearlessness caused him to be loved and respected by all. It might truly be said of him that he was the very soul of honor. He would often give his much needed vacation to arduous service for his Master. He was still a young man, and was just reaching the prime of his usefulness.

Brother Mills had a clear, logical mind, but still better, a clean and tender heart. In his death the cause of our Lord has lost a faithful servant.

STANDING RULES OF SYNOD.

Revised and Adopted October, 1903 and 1905.

I—GENERAL RULES.

(Pertaining to the Synod as a body.)

1. The stated meetings of the Synod shall be held annually, and unless otherwise ordered, in the month of October, beginning on the Fourth Tuesday of said month at 7:30 p. m. (1917.)

2. The Parliamentary Rules of Order, adopted by the General Assembly, and published in the Book of Church Order, shall be the Rules of Order for the guidance of Synod.

3. The officers of the Synod shall be a Mederator, a Stated Clerk, a Permanent Clerk, a Temporary Clerk, a Treasurer, and a Board of Trustees consisting of five members. The Moderator and the Temporary Clerk shall be elected at each Stated Meeting and the Stated Clerk, the Permanent Clerk, the Treasurer, and the Board of Trustees shall be elected every three years, counting from 1886.

4. The Synod shall elect annually:

(a) A superintendent of Synodical Home Missions, and one Elder from each Presbytery.

(b) A General Evangelist, one or more.

(c) Two members of the Board of Directors of Union Theological Seminary, whose term of office shall be five years. 1914.

(d) *Four members of the Board of Regents of the Orphans' Home, term of office shall be four years. (1910-1912.)

5. The Synod shall elect triennially, counting from 1886, the following committees, which shall be known as the "Permanent Committees" of the Synod:

*The number of Regents changed from 10 to 16, (1910) and term changed to 4 years (1912).

(a) On Synodical Home Missions, consisting of the chairman of each of the several Presbyterial Committees on Home Missions, and one Ruling Elder from each Presbytery. The Superintendent of Synodical Home Missions shall be "ex-officio" chairman, and the General Evangelists shall be "ex-officio" members of this Committee and it shall be charged with the conduct of the work of "Synodical Home Missions" under the direction of the Synod and in harmonious co-operation with the several Presbyteries.

(b) On Foreign Missions.

(c) On Assembly's Home Missions including Colored Evangelization and Evangelistic work. (1910.)

(d) On Christian Education and Ministerial Relief, including the Causes of Assembly's Schools and Colleges and the Assembly's Home and School. (1910.)

(e) On Publication and Sabbath Schools.

(f) On the Sabbath and Family Religion. (1909.)

(g) On the Bible Cause.

(h) On Woman's Work.

(i) On Synodical Schools and Colleges. (1911-1916.)

(j) On Young People's Societies, Brotherhoods, Covenanters, etc. (1911.)

(k) On Systematic Beneficence. (1911). (1916).

These committees, except the first named, shall consist each of a chairman appointed by the Synod, together with the Presbyterial Chairman of the Several Causes, respectively. And it shall be the duty of the committees to take into consideration everything bearing upon the Causes which they represent calculated to inspire interest to increased knowledge and to promote the growth and glory of Christ's Kingdom, and to report in writing through their chairman at each meeting.

(1) A Historical Committee, consisting of three members including the Stated Clerk, who shall be "ex-officio" chairman. It shall be the duty of this Committee to be a medium of communication and information with other like Committees or Societies, and to have a watchful care for the preservation of all records, documents and papers belonging to the Synod and to collect and preserve all possible material of historical value pertaining to the Synod, and report from time to time on all matters of historic value and interest.

6. The Stated Clerk, the Pastor of the Church in which Synod shall meet, and the Ruling Elders appointed to represent said Church, shall constitute a Committee on Enrollment. This Committee shall meet in the church at a time appointed before the opening of Synod and prepare the roll of Synod, and to this Committee each member shall be required to report for enrollment. The roll thus prepared shall be called at the organization of Synod. Additional enrollment shall be made by blank slips distributed through the Synod and collected by tellers appointed by the Moderator.

7. The first half hour of each Morning Session shall be spent in devotional exercises conducted by the Moderator or by some one appointed by him, and the last half hour of each Morning Session shall be given to the hearing of a sermon, or of a public address on some cause of the Church.—See Rule 25.

8. The Synod shall recess from business during the afternoon of the second day in order that the various Committees may meet and prepare their work.

II—SPECIAL RULES.

(Pertaining to the Duties of Officers and Committees.)

9. **The Moderator.** It shall be the duty of the Moderator, at an early hour in the proceedings of the regular meeting, to appoint the following Standing Committees, which shall usually consist of not less than three members each:

- (a) On Orders and Arrangements. (See Rule 15, amended (1915), so that the retiring Moderator shall be Chairman.)
- (b) On Devotional Exercises. See Rule 25.
- (c) On Bills and Overtures.
- (d) A Judicial Committee.
- (e) On Address to the Churches.
- (f) On the Minutes of the General Assembly.
- (g) On the Report of the Directors of Union Theological Seminary.
- (h) On the Report of the Regents of the Orphans' Home.
- (i) On the Report of the Treasurer and his books—Auditing Committee.
- (j) On the Records of Synod. Rule 16.

(k) On the Records of the Presbyteries—Seven Committees.
Rule 17.

(l) On Resolutions of Thanks.

(m) On Leave of Absence.

To these Committees shall be referred without a vote, unless there is objection, all reports, documents, communications, and other matters pertaining to the several subjects upon which they are appointed, and it shall be their duty to formulate reports upon the matters referred to them and to present the same to the Synod for action.

It shall be the duty of the Moderator, in the interim of the meetings of Synod when a vacancy occurs, in any offices of the Synod, by death, resignation, or removal from our bounds, to fill such vacancies by the appointment, until the next meeting of Synod. And also, upon the occasion of the death of a minister. It shall be his duty to appoint a committee of one, to prepare a Memorial sketch of the deceased, to be read in the Synod ensuing, and to be spread upon the Records.

10. **The Stated Clerk.** It shall be duty of the Stated Clerk when he is elected and enters upon the duties of his office, at the opening of the Synod immediately succeeding that at which he is elected, to report to the Synod in writing and in full whatever he has received from his predecessor, in the way of Records, Books, Papers, Documents, Furniture, etc., and the condition of the same when received.

The Stated Clerk shall conduct the correspondence of the Synod and he shall be the permanent (ex-officio) chairman of the Standing Committees on Special Orders and Statistics. He shall publish a notice of the time and place of the meeting of the Synod at least once, a month before the appointed day. He shall secure such reduced rates of railroad travel as may be possible, and he shall sign all necessary certificates for the same, or for other official purposes of the Synod or its members. He shall prepare a detailed docket of business for the next meeting, and cause the same to be published in the Appendix of the Minutes of the last meeting. He shall have at each meeting of the Synod accessible to the Moderator, a sufficient number of dockets, a copy of the last printed Minutes of the General Assembly, and a copy of Alexander's Digest. He shall duly engross the Minutes of the Synod after their approval, and transcribe the same into a book to be known as the "Synod's Official Records," and he shall transmit said Records annually to the General Assembly for review. He shall

cause to be published annually, in pamphlet form, at least one thousand copies of the Minutes of each meeting, as soon as practicable after adjournment, and distribute the same among the members and Church Sessions. He shall cause to be published in the Appendix of the Printed Minutes, the report of the Presbyteries on Statistics and Systematic Benevolence, the report of the Permanent Committees without their recommendations, the annual report of the Directors of Union Theological Seminary, a roll of the Ministers of Synod by Presbyteries, and a list of the Officers, Appointees and Permanent Committees, together with the Standing Rules. He shall cause to be published every five years, according to Rule adopted in 1874, but counting from 1896, the name of the Ruling Elders and Deacons with their respective postoffices, belonging to the churches composing the Synod, and the Stated Clerk of the Presbyteries shall be required to furnish the Stated Clerk of the Synod with the necessary information for the execution of this rule. He shall forward a copy of the printed Minutes, annually to the Librarians of Union Theological Seminary, Davidson College, and the Presbyterian Historical Society, in Philadelphia, and he shall file at least three copies in the Archives of the Synod. He shall also from time to time have the printed Minutes bound in suitable volumes and deposited in the Archives of the Synod. The Stated Clerk shall be charged with the further duty of reporting to the Moderator any vacancies to be filled by him, and of any deaths in the Ministry that may occur, and of reporting to the Synod the expiration of the terms of appointment of its officers and committees according to the Standing Rules.

1. The Permanent Clerk. It shall be the duty of the Permanent Clerk to take, with the aid of the Temporary Clerk, the daily minutes of the Synod. To read said minutes as required by the Synod, for Synod's information, correction and approval. To turn over such minutes to the Stated Clerk of Synod for engrossing or publication, to serve as the official reporter of the Synod. As such reporter: (a) To prepare a daily account of the proceedings for the daily papers; (b) To make account as full, complete and vigorous as possible, stressing those matters of interest to the general public; (c) To have typewritten copies made of such account, and send daily to all the larger dailies of the State, and to such other papers as may seem wise. —1914.

12. The Treasurer. It shall be the duty of the Treasurer to keep a strict and accurate account of all the funds received and disbursed, showing what Presbyteries have paid or have not paid their

assessments, and for what purpose the funds have been disbursed. He shall submit to the Synod annually, his books, together with a report of the receipts and expenditures, presenting vouchers for the same.

13. **The Trustees.** It shall be the duty of the Board of Trustees, as the Synod's medium or agency, in all matters requiring the use or aid of the civil law, to receive, take charge of, and manage to the best advantage, and account to Synod for, according to law, all property and estate belonging, or which may accrue and enure to this Synod; and they shall hold in trust, subject to the order of Synod, the said property, and all legacies and bequests which may be willed to the Synod in behalf of charitable and other objects under its control, and they shall make a full report, in the premises, whenever occasion or circumstances shall require.

14. **The Permanent Committees.** It shall be the duty of any or all of the chairmen of the Permanent Committees, including the President of the Board of Regents of the Orphans' Home, if deemed advisable, to arrange for, and to hold popular meetings in the interest of the respective causes they represent. These popular meetings, if held shall be in connection with, and at the time of presentation of the Report of the Committee, and they shall in no wise interfere with the Standing Orders of the Synod. And it shall be the rule, as far as practicable, to hear in this connection and at this time the Secretaries of the General Assembly, and other representative brethren, in the interest of the corresponding cause which they may represent. And it shall be the duty of the chairman of the several committees, in arranging for the aforesaid meetings, to correspond with the representative brethren, who are expected to be present prior to the meeting of Synod, as to the time when they are expected to be heard agreeably to the Standing Rules.

15. It shall be the duty of the Moderator immediately following the selection of the next place of meeting to appoint a Committee of Arrangements whose period or responsibility shall extend from the close of the Synod to the close of the next and whose business shall be to arrange the entire program of business for the next meeting of Synod conformably to the Standing Orders of Synod. The committee will consist of five members, one of which shall always be the pastor of the church where the Synod is to meet and another the retiring Moderator.—1911.

16. It shall be the duty of the Standing Committee on the Records of Synod to examine the Official Records, and report with special

reference to the condition of the same and as to the neatness and faithfulness in the execution of the work, and whether or not the records have been sent up and approved by the General Assembly.

17. It shall be the duty of the Standing Committee on the Records of the Presbyteries to confer with the Stated Clerks of the Presbyteries whose records they are appointed to examine before submitting their reports to the Synod in order that the Clerks may have opportunity to make explanation in regard to the records before the matter is brought before the Synod. And after the records are examined, the chairman of the several committees shall meet in committee of the whole and compare, classify and adjust to a common Standard of Judgment their criticisms and exceptions. They shall then elect one of their number who shall act as chairman of the committee of the whole, and who shall submit the judgment or criticism of all the committees on all the records in his one report to Synod.

18. It shall be the duty of the Standing Committee on Leave of Absence to receive and pass upon, before presenting their reports to Synod for approval, all excuses for absence from the last and present meeting of Synod, for tardiness, for absence without leave from the last meeting, and for leave of absence from the present meeting. All excuses shall be rendered to this committee and this rule shall apply to all the members of the Synod, except Foreign Missionaries, and infirm ministers who are not required to attend the meeting of their Presbyteries. It shall be the duty of this committee to refuse leave of absence to any member, except upon urgent reasons.

19. It shall be the duty of the Ad-Interim Committee on Memorials, to write simply and briefly a sketch, and not an extended history of the deceased. It is designed for obvious reasons, that shall in no wise interfere with the Standing Orders of the Synod, the sketch shall embrace only the chief dates and main facts in reference to the life, work and death of the deceased.

III—MISCELLANEOUS RULES.

20. It shall be the duty of each member, unless released by a vote of the Synod, when providentially prevented from attending the Synod, to address a letter to the Moderator stating reasons for his detention.

21. It shall be the duty of the Stated Clerk of the several Presbyteries to furnish the Stated Clerk of the Synod, when applied to, with all necessary information required, and with a corrected roll of

ministers and their postoffices annually, and also a roll of the Elders, Deacons, and churches, with their postoffices once every five years. The Stated Clerks are enjoined to be careful, accurate and punctual in filling out all blanks sent them, and returning them to the Stated Clerk before the meeting of Synod.

22. It shall be the duty of all members of Synod and especially the chairman of committees, in preparing written reports to be presented to this body, to write the same in a plain and legible hand-writing, and it is desirable that the chairman of the Permanent Committees furnish the Stated Clerk with an extra copy, if possible, of their annual reports, respectively.

23. The roll shall be called at each meeting before final adjournment and those who are absent without permission shall be noted by the Clerk as "absent without leave," and they shall be required to report to the Committee on Leave of Absence at the next meeting and answer for the irregularity.

24. It shall be a Standing Rule, until otherwise ordered, that the Treasurer of Synod pay the expense of the representative of Union Theological Seminary in attending the annual meeting of Synod.—1906.

25. It shall be a Standing Rule that the Devotional Exercises at the opening of each day's session of the Synod be put into the hands of the Standing Committee on Devotional Exercises—1906.

IV.—STANDING ORDERS.

The following Standing Orders shall be observed by the Synod:

- (1) The Synodical Communion shall be held at 11 o'clock a. m. of the second day without a sermon.
- (2) The Memorials of the deceased Ministers shall be read immediately after the Synodical Communion Service.
- (3) The Popular Meeting in the interest of Foreign Missions shall be held on the evening of the first day.—1915.
- (4) The Popular Meeting in the interest of the Synodical Orphans' Home shall be held at 11 o'clock on the morning of the third day.
- (5) The Popular Meeting in the interest of Assembly's Home Missions shall be held in the afternoon of the third day at 3 o'clock

(6) The Popular Meeting in the interest of the Sabbath and Family Religion shall be held in the afternoon of the third day at 4 o'clock.—1908.

(7) Synodical Home Missions evening of second day.—1915.

(8) Preaching each day at the last morning hour.

(9) Synod recesses from business afternoon of the second day.—1900.

(10) Sunday School work second day at 10:00 o'clock.

(11) Work Among Students in State Institutions second day at 10:30 o'clock.
