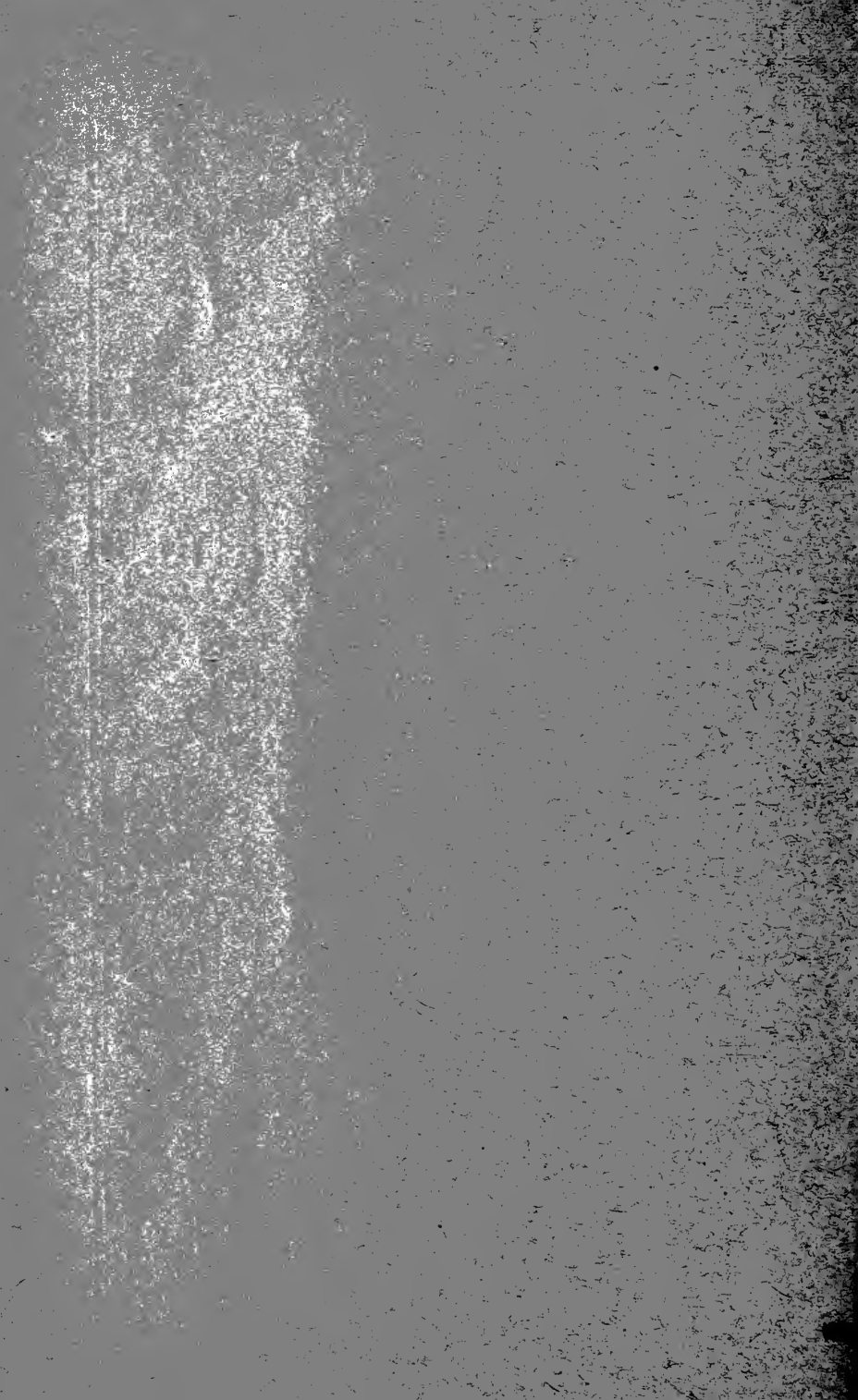

After singing "Rock of Ages," I. A. White read Phil. 1st chapter and preached the introductory sermon from the 29th and 30th verses.

"On Jordan's Stormy Banks" was sung at the close of the sermon.

Report on Sunday Schools was read by J. W. Bailey, as follows:

REPORT ON SUNDAY SCHOOLS.

To the Selma Association of Baptist Churches, convened at Pleasant Hill, Ala., August 10th, 1897:

The International Sunday School Association, whose Lesson Committee of forty (representatives of all evangelical churches) prepares, in advance, the lesson subjects and general notes thereon as used by the Sunday Schools of all Christian countries, is now so well known that the work of extending its organization has been taken up in every one of our States, and in Alabama forty-nine of the sixty-six counties are now thoroughly organized into county and district associations.

This Association is inter-denominational, and its object is co-operation in the introduction of new and better methods of teaching, and organization of Christian forces, adding strength and the stimulus of greater numbers to advance the work. It is succeeding. Every world's, State, county and district convention testifies to the fact.

The recent Dallas County Convention at Plantersville, on July 14th, brought together between 600 and 800 people interested in Sunday School improvement. The best literature and lesson helps, as published by the various denominations, is made easy to obtain. The best methods of teaching primary classes are exemplified. Addresses upon important topics are made, and the discussions which follow discover the needs of the work and supply the remedies. Statistics are furnished, and comparisons drawn, encouraging the active sections and stimulating the passive to greater effort. The result is the reaching of destitute places, the opening of new schools, the open school every Sunday in the year, the attendance of parents as well as children, and a notable increase of general attendance and interest.

The Sunday School is the work-shop of the church; it does manufacturing and repairing, and the raw material used is precious metal, and the finished product is a golden crown that the artisan in this

labor of love shall wear as a reward forever.

That denomination which takes the most active and helpful part in this organized work will receive the greatest benefit. On the second Saturday in October a house-to-house Sunday School canvass is going to be made in every organized county in the State. This is a special opportunity for Baptists. Let them make the most of it. The Baptists are numerically stronger than any other denomination within the bounds of the Selma Association, the State, and in most every section of the State. Let this advantage be increased in every right way. Let there be an awakening of the pastors, renewing their zeal in support of the work; and Baptist people everywhere will rally, and Sunday Schools will become what they are designed to be, namely, the work-shop of the church, and a great revival will sweep the country.

FIRST DAY—AFTERNOON SESSION.

Association re assembled at 2:30 p. m.

After song service and prayer by J. M. Fortune, the report on Education in General was read, and then the report on Ministerial Education was read, and the two were discussed jointly by the following brethren: Fortune, White, Dickinson, Parker, Sr., and Fonville. Reports then adopted, as follows:

REPORT ON EDUCATION.

Education, in its broadest application, is the developing, training and disciplining of all the faculties—physical, intellectual and moral, and the imparting of such information as will prepare one for the duties and privileges of this life, and for entrance into that life which is to come.

This development, training and discipline should be begun early in the child's life. The sooner the better. The home is the child's first school. In the home it receives its first lessons, and its first and most lasting impressions. Its parents are its first teachers. It is not necessary to urge the fact of parental responsibility. The foundation for everyone's character is laid in this home school.

When the time comes to send a child from home to school, too much care in the selection of teachers and of the school cannot be exercised. None but competent Christian teachers, of real merit, should be employed, and none but schools of a high moral character should be patronized. The character and not the cost of education is of greatest importance. The cost is the thing of least importance, and should be the last thing considered in choosing a school for our children.

We cannot too strongly urge our people to patronize our own excellent schools—the Howard College, at East Lake, for boys, and the Judson Female Institute, at Marion, for girls. The work done by these institutions is equaled by few schools of similar grade and surpassed by none.

We rejoice to report the Judson out of debt, and many additions and improvements are being made in that already splendid institution. Also that the bonded debt of Howard College has been reduced and refunded at a reduced interest, for five and ten years, and the notes due the college returned to the trustees.

REPORT ON MINISTERIAL EDUCATION.

By Ministerial Education we mean the mental, moral and physical discipline and training of those whom God has called to preach the gospel. That this is the most important enterprise fostered by us as a denomination is a truism, for every other interest of the gospel and of us as a people sustains to it a most vital relationship. God gave his ministry "for the perfecting of the saints unto the work of ministering unto the building up of the body of Christ, till we all attain the unity of the faith and of the knowledge of the Son of God unto a full grown man." This is a work of boundless magnitude. This knowledge can be imparted, and growth and unity and building up and perfecting achieved, only by educated, cultured, Spirit-filled men. Therefore, to neglect this interest or to support it half-heartedly is ingratitude to Christ, and it imperils the progress of the gospel and denominational perpetuity.

We have had during the past scholastic year twenty-seven ministerial students in Howard College and seven in our Theological Seminary at Louisville, Ky. All these are reported as young men of fine talents, who are making gratifying progress in their work of preparation.

We would call attention to the rule adopted by the Board of Ministerial Education to the effect that monies contributed for this purpose will be used as loans to students, unless designated as gifts by contributors. We would most heartily commend as worthy of your sympathy and patronage our two schools for the training of young preachers—Howard College and the Southern Baptist Theological Seminary.

Report on Temperance was read, and discussed by the following brethren: Catts, Sturgis, of Florida, Parker and Fortune. Adopted, as follows:

REPORT ON TEMPERANCE.

There is practically prohibition prevailing in all the communities in the territory of this Association, except the city of Selma. The decreased drunkenness with its attendant evils abundantly vindicate this method of dealing with the liquor problem as presented in modern society. Yet it will be impossible to reap the full benefits of these local laws so long as the city of Selma, the heart of industrial, social and religious life of this section, is also a seat of social drinking. We could wish for prohibition for Selma.

It becomes us to persevere in this good work until complete suppression of all agencies for the fostering of intemperance are suppressed. A healthy, vigorous public sentiment needs to be cultivated which will be positive both in condemning the evil and encouraging the good. Your committee therefore recommend a temperance campaign in this section during the next year, under the auspices of the Committee on Temperance to be appointed at this session, and that they be instructed and empowered to act to that end.

Our churches need also to exercise a positive discipline to the correction of the habit of drink on the part of their members, remembering that no drunkard shall inherit the kingdom of God.

The cause is growing and we have every reason to be encouraged, and we can now see the end to this terrible evil which has wrought such ruin to the manhood of our people, the piety of saints, the homes of our families, and every cause of God.

SECOND DAY—MORNING SESSION.

The Association met at 9:20 a. m.

Devotional exercises were led by J. B. Powell.

After singing and prayer, the 8th chapter of Hebrews was read, followed by another prayer by M. M. Wood.

The Moderator called the body to order at 9:40 a. m.

Minutes of the previous day were read and approved.

Rev. M. M. Wood, of Birmingham Association, and Col. J. T. Murfee, of Marion, were then recognized as visiting brethren.

The report on Literature was then read, and discussed by Brethren Lamar, Parker and White, and adopted, as follows:

REPORT ON LITERATURE.

Men and women are judged by the company they keep. May we not also judge them by the books they read? There is but little doubt that many of our young men and women have been influenced to commit crimes by reading immoral books and newspapers. Why do we find our newspapers so eager to publish all manner of crime and so seldom note the good deeds and acts? Simply because there is a demand for the former and not for the latter. Where is the remedy for this desire for bad literature? It is in the home and in the pulpit that must come this training and influence. When a mother shows as much anxiety about what her boys and girls read as she does about their clothes and personal appearance, and our preacher as anxious to have his members read their Bibles and denominational papers as he is to see his name in print, then we may expect a growing demand for good literature. Your committee urges this Association to display

more zeal in the reading of God's Word, good books and denominational papers, and then will we see men and women of noble characters and a high grade of morals.

Your committee would especially recommend and urge each family to subscribe for and read the Alabama Baptist, the Foreign Mission Journal, the Home Mission Journal and the State Mission Journal, and that our Sunday Schools patronize the Sunday School Board of the Southern Baptist Convention, located at Nashville.

Reports on Missions were then read, and discussed by Brethren Lamar, Sturgis, Dickinson, White, Parker and Mallory, and adopted, as follows:

REPORT ON FOREIGN MISSIONS.

The marching orders of the Lord and Master are still as imperative as when first uttered, and are yet to be carried out.

That great command of our Lord, "Go ye into all the world and preach the gospel to every creature" has not lost any of its force or divine authority.

The gospel is still the power of God, and is the only means by which we can ever hope to lift those who now live in the dark recesses of cruelty and woe into the Kingdom of Christ.

The heathen are just as much lost as ever. Yet we are better acquainted with their lost condition, this knowledge making our duty and responsibility vastly more imperative. Yet what are we doing as "Missionary Baptists?"

We find in the statistical table for 1896 a report of 1107 members in the Selma Association.

In the financial table for the same year the total contributions for Foreign Missions sums up some \$195.90, which is a fraction less than eighteen cents per capita. Yet the Lord's capital as committed to our people reached mammoth proportions. Does not this show sloth, indifference or parsimony? Brethren, what is it? The answer is left to truth and conscience. But there is a bright side. The great Baptist host went up to Wilmington in May last, and, by an earnest and united effort, freed our Foreign Board from the shackles of debt, and now comes the tidings that the work is prospering, and the general outlook is full of hope.

We earnestly recommend, that, in the future, we be more liberal in giving of our means for the great cause of Foreign Missions.

REPORT ON HOME MISSIONS.

It has been said, that if churches were alive to their opportunities, and as alive to best methods as individuals in private business, the world could be brought to Christ before another decade passes away.

There are various methods in the minds of thinking Christians to bring about this end, and we are happy to report that method, united with persistent effort, has lifted the entire debt hanging over the "Home Mission Board." Now, it is not so much method that we need, but more men and money to support these men, while they evangelize the home field and bring men and women into active co-operation with the church of Christ.

The blessings of God have rested on the labors of the Board during the year. Every effort has been attended by the influence of the Divine Spirit. Yet even this does not alter the tremendous fact that, within the limits of the "Home Field," in some of our cities, men are as destitute of the gospel as the veriest heathen in the "free Congo State."

But a few years ago there came from Louisiana a cry that 250,000 of the men and women of that state were without the gospel, and about the same time investigation proved that the single city of St. Louis had a larger destitution than the whole State of Georgia, and there has not been much advance made in either. To procure the money needed our churches must be imbued with the spirit of missions and lifted out of that low and selfish view of religion so prevalent among them. In short, we must reach about one million Baptists in our churches who never give one cent, thus ignoring alike the commands of the Savior and the needs of men perishing in sin.

"During the century from 1790 to 1890 the United States increased in population from about 4,000,000 to 64,000,000. During the same time the Baptists increased from 65,000 to 3,700,000. The nation increased sixteen fold, the Baptists increased fifty-six fold—nearly four times as fast as the population. In the light of these facts the coming century is luminous with glory. A little over 100 years ago we were only 1 in 61 of population. Now, one in seventeen."

Certainly, if we are to hold our position and make progress we must arise to the magnificence of the hour. We must pray, and work and give, and I know of no fitter place for the imperial clarion to sound the forward movement than in this body of Baptists gathered here to-day. Baptists ought to control this fair land of ours. Divine blessing can bring about this end, and fidelity to truth and duty on our part will insure it. Let us then go forth in the "spirit of the Master," in "His power," laboring for the redemption of our own country from the power of sin.

REPORT ON STATE MISSIONS.

The State Board of Missions in Montgomery has direct charge of the raising of missionary funds in Alabama. In this capacity it represents Home and Foreign Missions as well as State Missions. The work of the Board is manifold.

1. It still maintains missionary pastors at a few weak points where help is absolutely necessary to the life of our cause in such communities. Such points as the Second church, Selma, the South Montgomery and Greensboro churches are still aided, but there is every prospect that the cause will very soon be self-sustaining at all of these points.

2. It prosecutes the general work of evangelism all over the State of Alabama. It has in its employ six evangelists distributed over the State, viz: Bro. Preston, in Southeast Alabama; Bro. G. S. Anderson, in East Alabama; Bro. A. Burns, in North Alabama; Bro. Sanderlin, in Northwest Alabama; Bro. J. V. Dickinson in and around Birmingham, and Bro. W. A. Parker in Southwest Alabama. These brethren go wherever occasion most requires in their several sections, holding meetings, preaching the gospel, advocating missions, fostering the spirit of fellowship and co-operation between the churches in the worship and work of our Lord, strengthening the weak points and enlisting the indifferent. We have great reason to rejoice over the success of our evangelists whom God has so richly blessed in this work. The prospect of a united, active, healthy fellowship of our people and a hearty co-operation in Christian service was never so bright before.

3. Whenever the field has given promise of success the Board has also done some colportage work. However, the urgency of other lines has absorbed the means of the Board to such an extent as to greatly preclude much expenditure along this line. Yet the little attempted has proven remunerative and in every way satisfactory.

4. The Board also publishes monthly The State Mission Journal as its organ to keep the work of the Board before the people and their interest therein alive and vigorous. Every Baptist in Alabama ought to subscribe for this paper and keep himself up and in sympathy and co-operation with his brethren in this common work. It costs only 50 cents per year to secure its monthly visits.

5. This Board has ever been the center of denominational life, the rallying point of the brotherhood, the agency of affiliation for the churches; and, as such, is of incalculable benefit to the developing and enriching of the communion and fellowship of the saints, in building them up in such relations into the body of Christ. Your own soul will be the poorer if you do not avail yourself of this opportunity to enjoy your brethren. To put each Baptist into proper per-

sonal relation to every other as fellow workers in the Master's cause, and fellow helpers of the truth is a blessed work. To bring the churches to love and help and enjoy each other in all the lines of inter-church fellowship is an end inspiring and divinely enjoined. Let us, therefore, give the State Board of Missions our hearty support and fervent prayers.

At 11 a. m. the Association sang "I love to tell the story."

W. A. Parker, Sr., read John 4:1-42, and preached the missionary sermon from Matt. 9:38.

After the sermon a collection was taken for Missions, amounting to \$22.50.

M. M. Wood, Financial Agent of Howard College, was then introduced, and addressed the Association in behalf of the school.

At 1:50 p. m. the Association adjourned for dinner, with prayer.

SECOND DAY—AFTERNOON SESSION.

At 2:30 p. m. the Association joined in song and prayer service, Dr. Ramsey leading.

The Moderator called the assembly to order, and Bro. White offered the following resolution, which was adopted:

Resolved, That Bro. Frank Avery's application for financial aid be referred to the Executive Committee of the Association, who shall hear his statement and take such action as the virtue of the case demands.

The report on Orphans' Home was then read, and discussed by Brethren Edwards, Murfee, Ramsey; White, Powell and Dickinson. A collection of \$11.78 was taken for the Home, and the report adopted, as follows:

REPORT ON ORPHANS' HOME.

Seven years ago Mrs. M. L. B. Woodson, a member of the First Baptist church in Selma, proposed to give all her real estate to the Baptists of Alabama for the maintenance of a Baptist Orphanage in Alabama, to be available after her death. Soon after this she deeded her real estate to the denomination for this purpose. On the 10th day of

March, 1893, in a small rented house, the Home opened to three little orphan children. When the Convention met in Greenville the following fall the number of children had grown to twenty-two. The time had come to give the Orphanage a permanent home, so the trustees purchased some valuable property and located the home at Evergreen. Into this Home have been gathered seventy children; thirty-three were boys and thirty-seven girls. The management has sent out thirty-two—sixteen boys and sixteen girls. There are now thirty-eight children in the Home—seventeen boys and twenty-one girls. The health of the children is good—there has never been a death in the Home. The children are under firm, loving control, and are given a practical education and taught to do various kinds of work.

The purchase price of the Home has all been paid, and important improvements are now being made as means are secured to make such improvements. Money is needed to complete this work, and meet current expenses. The current expenses are a little more than \$200 per month. A few churches and Sunday Schools take collections regularly for this work. We recommend that the churches and Sunday Schools of this Association adopt this plan for raising money for the support of the helpless little children gathered in this Home.
