

REPORT ON DEVOTION.

The Association adjourned to meet Monday morning at 8:30 o'clock.

SUNDAY MORNING.

The seats were carried to the grove and properly arranged, the people began to gather from every direction at 9:30. Rev. Joseph Shackelford opened service by reading the sixth chapter of Deuteronomy and prayer by Elder C. E. Yates, after which Rev. J. Shackelford made an interesting and very impressive talk upon the responsibility of parents in regard to training up their children. Also O. E. Comstock, A. E. Burns and A. J. Preston made an impressive Sabbath-school talk, after which we had five minutes intermission At 11 o'clock we came together by singing. Rev. J. S. Gipson eached an able and interesting discourse, from the 11th Chapter of 1st Corinthians and 2nd Verse. "Now I praise you brethren that ye remember me in all things, and keep the ordinances, as I delivered them to you. After which, we had an intermission until 2 o'clock and pertook of a hearty repast spread before a large concourse of people, by Newsom Springs Church and vicinity,

AFTER NOON.

At 2 o'clock the people was ably entertained by Elder A. J. Preston's, lecture on Missions from a map of the world placed before them, and a canvass followed by A. E. Burns, after which a collection was taken up, the result was \$6.58 cents collected.

SECOND DAY SESSION.

Monday morning at 8:30 o'clock, met persuant to adjournment, after singing, and prayer by Elder J. W. Jones, the body went into the dispatch of business. Detained letters called for, one from Bethelham Church received, and delegates name, J. T. Chenault enrolled. Brother M. J. Pace was received as a delegate without letter from

Salem Church. J. A. O. Pace received as a corresponding delegate from Muscle Shoals Association.

REPORT OF DESTITUTION.

We your Committee on Destitution beg leave to make the following report. By looking over our Association we see there still remains several points that are destitute, that could be occupied to some propfit to the Association, these points have been pointed out so often that the board is familiar with them, we think the best plan that we could suggest to the board, to have these places occupied, would be for the Board of this Association to work in concert with our State Board and employ one Missionary, to labor in the bounds of our Association.

REPORT OF MISSIONS.

Dear brethren we desire to call your attention, first, to what has been done, second, to what remains to be done and third, the means of its accomplishment. 1. What has been done by our foreign mission board? We learn from the latest report that we have 92 missionaries, 78 native assistants, 185 stations, 75 churches, 2.923 members. Last year there were 383 baptisms and our board received \$155 937.23. the object of this board is to evangelize the world. 2. By the home board 368 missionaries have been employed, who have baptized 5,111, and received into the church 9.604. Receipts of the board for last year \$106.989.58 cents. The object of this board is to assist in having the gospel preached in the Southern States, the Indian Territory and Cuba. 3. By the State Beard many men have been employed for a whole or part of their time, about \$12.000 were expended in assisting weak churches and sustaining the gospel in destitute places.

- II. What remains to be done? There are yet many millions of heathens to be converted, or to be lost. They are dying at the rate of 100,000 per day. They are crying for the bread of Life. Come over and help us? Will we heed the call? There is also much destitution in our own Sunny South Land. Indians are calling for the bread of Life, and many others are lost without the Gospel. Even here in our own State there is much destitution. May the Lord help us to take this State, and the World for Christ and the Baptists.
 - III. The means of accomplishing it we must begin at home

(Jerusalem,) and then extend our work throughout the State (Judea,) then throughout the Southern States (Samaria,) and then to the utter-

most parts of the Earth (All Heathen Lands.)

We could perhaps do our home work best by putting an Evangelist into the field, whose duty it shall be to distribute literature and preach the Gospel among the churches as well as in destitute places. We would further suggest that we co-opperate with the existing agencies for the furtherance of the Gospel in our midst and throughout the world. *Adopted. ELDER J. S STOCKTON.

REPORT ON EDUCATION.

Brethren this is a subject of great importance and we do not think there can be too much said upon this great subject, yet, we believe our people in North Alabama, are aroused as never before, they see the great importance of education of the rising generation. Webster said: "Knowledge was Power," Solomon said: "Wisdom was Power," so we think to qualify our sons and daughters for this fast age of ours with knowledge and wisdom, we can look for a prosperous nation, and when we leave these mundane shores of time, we can feel that we have left the Church and State in safe hands with the mind stored with wisdom and knowledge; the Lord God be honored in all things. We are proud to hear of the progress of the High School at Danville, also, our school at Pleasant Site, and we hope our brethren will aid and support our High School at Danville, all of which we respectfully submit.

Also the report of the Board of Trustees of the High School at Danville was read, and the importance of education discussed by Joseph Shackelford, Mike Finney and A. L. Moody. A collection was taken up to supply the necessary school equipments for the benefit of the pupils, which resulted in receiving \$75.00 in subscription to be paid in legal installments to-wit: One fourth, January 1, 1894, one-fourth, in July 1894, one-fourth in January 1895, and July 1895, the balance.

REPORT OF THE BOARD OF TRUSTEES OF THE NORTH ALABAMA BAPTIST COLLEGIATE INSTITUTE AND NORMAL SCHOOL, TO THE BIG BEAR CREEK ASSOCIATION.

Dear brethren:

The Board of Trustees of the North Alabama Baptist Collegiate Institute and Normal School beg leave to submit this their first annual report to your body. The Board held its first session at

^{*}The report of Missions and Destitution discussed at the same time by the brethren.

Decatur, Alabama, in November last, and organized temporarily, electing Judge A. L. Moody, of Colbert county, President, and Rev. Joseph Shackelford, of Morgan county, Secretary. A Charter for the school was prepared and agreed upon, and a committee appointed to secure its passage by the Legislature of Alabama. It was also agreed that the school should open in the Fall of 1893. The Board then adjourned to meet in May 1893. The second meeting of the Board took place at Danville, in June 1893, the May meeting having been postponed. At this meeting the property donated by the citizens of Danville and vicinity, was received by the Board, with a deed to the property, which consists of a two acre lot of land, upon which is erected two large two story buildings containing fourteen rooms all of which is adapted for school purposes. There were some of the considerations which were not fully complied with by the citizens of Danville, such as furnishing desks and etc., but the Board accepted the property and subscriptions and notes which were unpaid, with the hope that something be realized from them. Their subscriptions and notes amounted to something over \$150. As they are collected the means will be appropriated to the purchase of desks and other things needed about the buildings. At this meeting the Committee having charge of this matter, reported that a Charter for the school had been obtained from the Legislature at its last session, under the name of the North Alabama Baptist Collegiate Institute and Normal School, giving full power to the Trustees and Teachers of the same to grant Diplomas to its graduates. The Board elected a Faculty for the school consisting of the following:

President-Rev. Joseph Shackelford.

Protessor of English and Natural Sciences-John C. Tidwell.

Professor of Mathematics, Latin and French-Henry T. Lile.

Principal of Primary and Preparatory Department-Miss Madgie Henderson.

Teacher of Art-Miss Gleen Orr.

Teacher of Music-Miss Anna C. Shackelford.

The Board has contracted no debt in the employment of the Teachers, they are to depend upon the patronage of the school for their salaries. The Board also appointed a Local Board to take special charge of the school.

The school commenced its first session the 28th of August last. The attendance was not so large as we expected and desired, yet, under all the circumstances considering the financial depression, we are hopeful that our numbers will be greatly increased until we shall reach an enrollment of one hundred during the present session, we have now enrolled about fifty-one.

The Board organized permanently by electing R. T. Whitman, of Huntsville, Alabama, President and Judge W. H. Simpson, of Decatur, Alabama, Secretary and Dr. J. M. Richens, of Danville, Alabama, Treasurer.

We suggest to the Association the appointment of Trustees to fill the vacancies occasioned by the expiration of the time of service of those appointed for one year,

Your Board would earnestly beg the Association to rally around this Institution, which it has assisted in creating. The property which the good citizens of Danville and vicinity have given for school purposes is your property, it is your school, you can help make it a great blessing to the Baptist Denomination of Alabama and to the people generally. There are two things needed to make this school a success. The first is students. Give us the students and we will educate them. From the six thousand Baptists of the three Associations which have created this school, we ought to get at least three hundred pupils. Shall we have them? We have the buildings, and we have the teachers, now give us the pupils, and we will make you a school of which you will be proud. The second thing we need is money to purchase such equipments for the school as will make us equal with other Institutions of like grade. We need at least \$1.000 now or within a short time. The Board makes the following suggestions to your body: Of the \$1.000 we think the Baptists of Big Bear Creek Association ought to contribute \$250. We propose to raise the \$1,000 on the following plan: Those who subscribe to this fund will be asked to pay one-fourth of their subscription on the 1st of January 1894, one-fourth on 1st of July 1894, one-fourth on 1st of January 1895, one-fourth on 1st of July 1895. Surely with these easy payments we can raise the amount for which we ask. We trust your body will take this matter into consideration, and allow our President to make an effort to raise a part of the amount apportioned to your Association at this session, and that you will also appoint an agent in each church to assist in raising the amount, and to work for students for the school. Let us know no such word as fail in this enterprise, but let us make an earnest effort to build up an Institution of learning that will be an honor to the Baptists of North Alabama, and a blessing to the The Board desires to say, that young men preparing for the ministry, or ministers who wish to better prepare themselves for their work, are received free of tuition, when they come recommended by their churches, and the State Board of Ministerial Education, or the Ministerial Board of any Association. The sons and daughters of ministers regularly engaged in ministerial work are charged half price.

Trusting that you will take such steps as in your wisdom seem best to promote the prosperity of your school. We remain your servants. Done by order of Board. W. H. SIMPSON, Sec'y.
