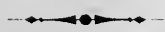

REPORTS OF STANDING COMMITTEES.

PRAYER MEETINGS.

Prayer meetings, to be edifying and profitable, should be informal meetings. When any services in religion are conducted with a view to meet the approbation of the world we will fail to enjoy the comforts of true religion. What pleases the world will not feed the soul or have the dictation of the spirit of our Heavenly Master. We should use various methods in conducting prayer meetings as circumstances may present themselves, or as the Holy Spirit may dictate, and be conducted or led by those most gifted, and who seems to be in the spirituality of the work. For unless the leader of the meeting has spirit and life, the meeting will be a cold and uninteresting one. There must be spirit if there is life in a prayer meeting. If cold and lifeless, it will not edify or profit those in attendance, but will discourage them from regular attendance, and make it a task rather than a pleasure to attend the meeting. All true Christians love to be in a meeting that has a revival spirit in it. It is a joy and a delight for Christians to meet when the Holy Spirit dwells with them.

We can call back so many happy seasons enjoyed in prayer meetings, and suppose most of Christians can witness to many happy seasons they have enjoyed in them where the Joys of God's salvation was restored unto them. It should be the leading object in prayer meetings to have the revival influence of religion in them, which we can have if we desire, expect and earnestly seek for it. God will not bless his people unless they have faith, desire and seek for his blessing, and when we approach Him in this way He will always bless us. We have His blessed word for it, and we have experienced so often the truth of His word. Then why not always at our prayer meetings have times of rejoicing? The cause lays at our own doors and in our own hearts. God will not disappoint us if we approach him in the way laid down in his holy word, for he is the same yesterday, to-day and forever,—he changes not. All Christians should have moral courage and boldness enough to speak in prayer meeting when impressed to do so. We should adopt various methods in conducting our prayer meetings. Sometimes it's profitable to have experience meetings, request meetings and other methods, that all may have an opportunity to express their feelings. That they may speak one to another. That the Lord may harken and hear them, who will keep a book of remembrance for them that fear the Lord and think upon his name.

While pastors of churches should use their influence and encourage all his churches to hold regular prayer meetings, yet it is not necessarily his work or his duty to attend and conduct those meetings. Every member of a church should feel it his work to give prompt attendance, aid and encourage by his presence their words of love and their prayers, always striving to be in the spirit of the Master. When you find a church or neighborhood

where no prayer meetings are kept up, you will find a people without much religion. For religion is a principal that must be cultivated to enjoy it or to grow in grace and in the knowledge of our Lord and Savior Jesus Christ. Our lights will not shine to the world unless we have a revival of religion in our own hearts; we cannot teach transgressors the way, nor will sinners be converted to God through our influence.

We are creatures of imitation; we imitate others, and others imitate us. We are inclined to follow the footsteps of one another, and if we are guided right by the spirit in religious matters, we will guide others in the way of life everlasting. But if the light that is in us be darkness, how great is that darkness. We should so strive to have the love of God dwelling in our hearts that we can say, "I was glad when it was said let us go up to the house of prayer," and when we get there only pray for the things we earnestly desire and expect. And we should make our talks, our prayers and services short, and strive to make them interesting to all. Use subjects appropriate to the occasion, applying them with spirit and power. Doing this, our prayer meetings will grow in interest and numbers, and will benefit us and the world. Advance the cause of our Heavenly Master and glorify His name.

We have but little destitute ground in all of our Association, and as quite a number of our churches are dissatisfied with the present plan of our Evangelist, we most respectfully recommend the body to pass the following resolution:

That all the money sent up or pledged for state missions be used by the Executive Committee to employ pastors who reside in the bounds of the Association at \$1.50 per day to labor in each district, and let these four pastors do the missionary work instead of employing one Evangelist. The money to be equally divided among the districts.

HOW TO GET UP A REVIVAL OF RELIGION.

I feel my inability to do justice to this subject, believing that upon this subject the life of the Christian, of the churches and the advancement of the cause of Christ are dependent. For without the revival influence of religion the Christian and the churches have a name to live but are dead. Now if the life of the Christian is hinged upon this subject, is it not of great importance that we should know how we may get under the influence of a genuine revival of religion? And the question may be asked, what is a revival of religion? It is not a principal of love and joy implanted in the heart by the Holy Spirit? If so, we are told that we must ask in faith for the influence of that Holy Spirit. David called it the joy of God's salvation, and prayed that it might be restored to him.

Revival of religion consists, first, with his people being filled with the love of God, having love for God, for one another and love for the sinner, and a strong desire for their salvation. A revival of religion also consists (as commonly accepted) in conviction of sinners and conversion of mourners. But a revival of religion, or a revival of any principle, is where the principle has once existed, and it cannot be a revival of any principle that has never existed, and before we may hope for the salvation of sinners, the church or the people of God must therefore be revived, return to their first love, be filled with God's spirit and with glory.

We readily see the importance of a revival of religion in our churches and in all our hearts; for if the salvation of the world depends on the efforts of God's people, and that their efforts are vain unless guided by the Holy Spirit, and have the joy of God's salvation restored to them, how important it is that we have a genuine revival of religion in all our churches. Therefore the question arises, what means can be used, if any, to get up this revival spirit in all our hearts? Well, we must desire, expect and ask for a revival of religion in our own hearts, each for themselves first, and then in the hearts of all God's people. We must ask for it and ask in faith. We are told that whatsoever we ask, believing it will be granted unto us, we must ask for the blessing now. * I fear we too often expect to be blessed some time in the future at our next protracted meeting or some future day of that meeting. We should ask for a blessing to-day, not to-morrow,—let to-morrow provide for itself. "Sufficient unto the day is the evil thereof." Oh, how dangerous it is to wait for a more convenient season. My brother, my sister, if your child or friend was dangerously sick you would not be willing for the physician to put off his visit until to-morrow or next week, but would say come now, come at once. Yet when our children and friends are in danger of eternal death at any time, we, by our actions, tell the physician of souls that some time in the future will do. Let this be the cry from every one, "Come now, this very day, this very hour and heal my friends." But the question is still asked, what must we do, what can we do that we may have the blessed spirit to dwell with us, and have a revival of religion in our churches, in our homes and in our hearts?

One important step is, first, earnestly desire, expect and seek for a revival to spring up in each of our own souls, and if we get ourselves revived we will have a revival of religion that will glorify God, and be the means of saving sinners and of building up the cause of our blessed Savior. We will all have the joy of God's salvation restored to us, and if all this is accomplished, we have the word of God for it that transgressors will be taught the way and sinners come flocking home to their Father's house. Christians made to rejoice on earth and saints in Heaven, over the return of lost sinners. Let us all begin now to call from the depths of our hearts, Jesus, thou son of David, have mercy on *me*, help me *now*. Then you can all return to your homes and churches praising God in your feelings for

redeeming grace and dying love, which will kindle a flame of love in our hearts which will burn and spread until this land and country will be made happy because the love of God has been shed abroad in our hearts.

REPORT ON SABBATH SCHOOLS.

Believing that in the Sabbath School the minds of the young are easiest directed in the right channel and their hearts touched and impressed with the truths of the gospel, we therefore most earnestly urge each church in this association to organize one at once. We further favor their organization for the reason that it opens up a work for every member of the church and is a nursery for the children. Knowing that among Baptists the Sabbath School is an almost universal acknowledged factor in the work of the church and an indispensable auxiliary towards its advancement and success, we therefore deem it unnecessary to dwell upon the advantages to be gained by it. But there are a few points which we desire to impress the minds of all.

1st. We believe the school should be under the control of the church, the officers, or at least the superintendent, appointed by the church.

2d. We believe it is the duty of all church members, and especially parents, to co-operate in the work and give all the aid and assistance in their power to advance its interests. We most earnestly insist on every church member making this a personal question.

We recommend the use of lesson helps in our schools strictly Baptist. We recommend *Kind Words* lesson helps publications of our own South land. Believing that more advanced and systematic methods for carrying on the Sabbath School work in our Association are needed, we therefore recommend the appointment of a Sabbath School Convention by the body now in session to be known as the Sabbath School Convention of the Talasahatchie and Ten Island Association, the business of which, as the creature of this Association, shall be to meet annually and discuss the questions pertaining to the Sabbath School work.

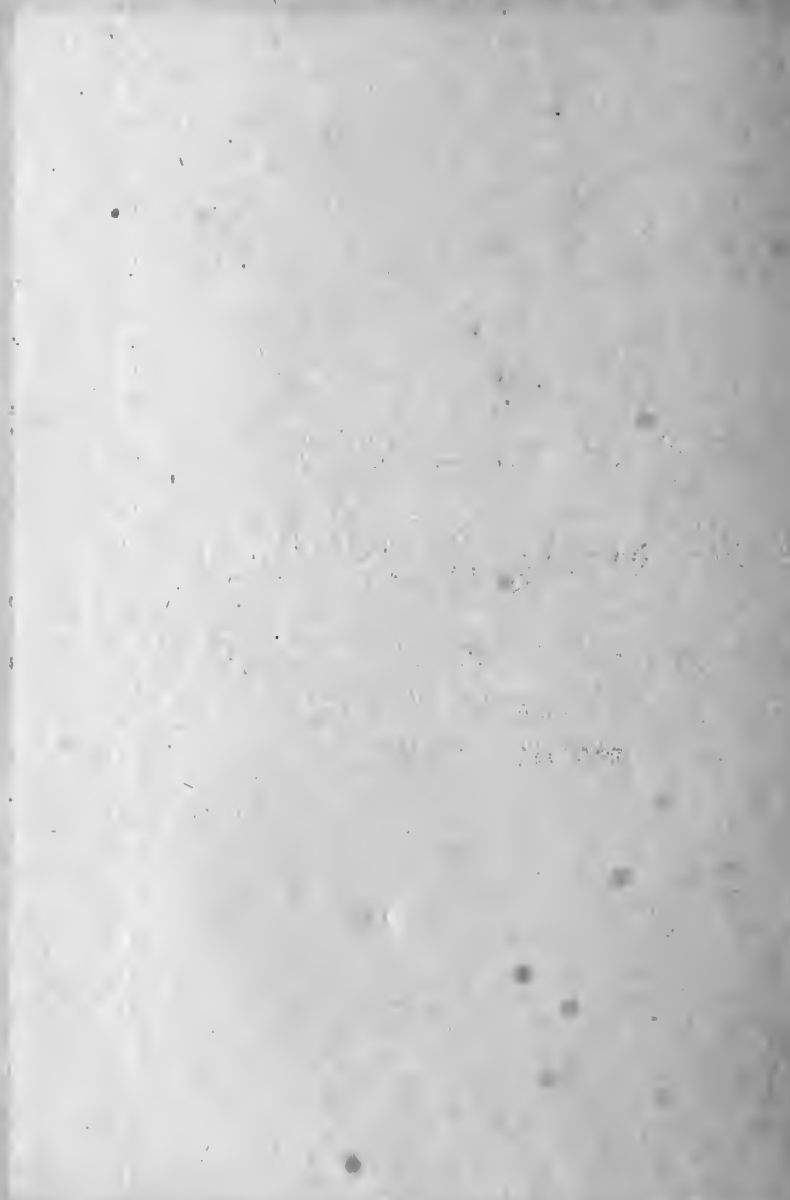
