# MINUTES.

LIVINGSTON, ALA., OCT. 2, 1895.

1. The Bigbee Baptist Association met this day for its forty-third session with Livingston Baptist church, and was called to order by the Moderator, Eld. J. R. Larkin, at 11 o'clock a. m.

7. Rev. J. E. Vaughan not being present to preach the Introductory sermon, on request of the Association Rev. J. W. Stewart occupied the time in preaching from the text as contained in Rom.14:7.

8. Adjourned to 2:30 o'clock with prayer by C. C. Vaughan.

#### AFTERNOON SESSION.

9. Re-assembled and began with singing. Prayer by W. F. Pond.

10. The report of the committee on Program was adopted.

11. The reports on Missions were called for and read, as follows:

#### REPORT ON HOME MISSIONS.

Your committee on Home Missions beg leave to report: That they are glad to be able to report that during the past year reports from the Home field are encouraging. They have expended on the field, as per report for mission work, over sixty-seven thousand dollars. This, the home field, includes the Island of Cuba, where its faithful missionaries, Diaz and his co-laborers, are upholding the standard of the cross, and although the Island is torn with dissensions, the work of the Lord is prospering in their hands.

This work of Home Missions is increasing every day. The influx of foreigners to our shores; the opening up of new settlements; the establishing of new towns, demand greater expenditures and consequently call for larger contributions. Remember, oh Christian! that this work is for Christ. He calls. Obey the call. Let your prayers and your aims be laid upon the altar, then shall salvation cover the earth as the waters cover the sea.

## THURSDAY—MORNING SESSION.

17. Began with singing. The Moderator read the 90th Psalm.

18. It was ruled by the Moderator and sustained by the Association, that delegates without letters were not entitled to seats.

19. The committee on finance was appointed as follows: C. F. Rainer, A. B. Cook and R. H. Lide.

20. The following were appointed a committee on Nominations: J. W. Cook, James Stallings and J. W. Blakely.

21. The subject of Missions was again taken up, and without further discussion all the reports were adopted.

22. The report on Sabbath Schools was submitted, and after discussion by Jno. G. Apsey, L. Pool and A. R. Hardy was tabled until after the preaching of the Missionary Sermon, which was preached by Jno. G. Apsey from the text as contained in a part of Acts 10:14. After the sermon a missionary collection was taken, which amounted to \$26.85.

23. Adjourned to 2:30 o'clock p. m. with prayer by J. D. Cook.

#### AFTERNOON SESSION.

24. Re-assembled at 2:30 o'clock. Sang "Rock of Ages."

25. The report on Sabbath Schools was taken up, and without further discussion adopted.

#### REPORT ON SABBATH SCHOOLS.

The Sabbath or Lord's day school is to the christian dispensation what the synagogue service was to the Jews. God has left us his recorded will, and in order to know that will we must pursue it, and as there seems to be perfect system in all other works of the Divine hand, we conclude that it might be profitable to observe it in so important a matter as a study of our relationship to God.

Some have defined the Sabbath School as "The church at work," others as the "Nursery of the church," but as these terms seem to be defective we will define it as "church work." There is no branch of church work that expands so readily to meet the talent of all as the Sabbath School. There is not a single member in any church within the bounds of this Association but can find profitable employment in this work. All are not qualified to teach, but there are none who are too old or too young to be taught. We believe that if every church maintained a real live Sabbath School, composed of all its members and their families, that there would hardly be any necessity for maintaining many of the societies that now exist in our churches. It is missionary in spirit, and would answer for that organization. It is charitable, and could easily dispense the charities of the church. It is conducive to sound doctrine, hence heresies could be easily detected. Aside from the spiritual benefits derived in a growth in grace from a study of his word, it is highly entertaining and instructive to peruse a book so replete in wisdom that has stood the test of centuries and the fires of innumerable enemies. The Sabbath School sustains a relation to the church that a training school does to a mighty army of conquest. Each member prepares himself or herself to be instruments in God's hands of doing good. He is armed with the sword of the Spirit, which is the word of God, and is able to meet the enemy on any battle field and put him to flight. There are, according to our last minutes, 1180 church members composing this Association, with only 489 Sabbath School pupils and sixty officers, making in all 547. Of these it is safe to say that about one out of every three is a church member, making 183 church members engaged in Sabbath School work. What of the 997? They are either engaged in working for God or Satan. Surely they are not all preachers or invalids? How are we ever to utilize this latent force for the Master's cause? This is a question that most concerns us at this time. We believe that every

pastor ought to see that each of his churches has a well organized Sabbath School, and that each member be repeatedly requested to participate.

We would also suggest the organization of a Sabbath School Convention in every county of the State; and that church statistics show actual number of members who engage in Sabbath School work.

#### REPORT ON BIBLE AND COLPORTAGE WORK.

Your committee beg leave to report that the work of disseminating the Bible and denominational literature does not receive the attention that it should from our Baptist people. The printed page is frequently read and reread long after the living voice has ceased to be heard. There has not been as much done during the last year by our Colportage Board as in some former years. In some instances colporters have been forced to quit their fields on account of the meagre sales. The board has thirteen men employed. There have been 1,621 books, Bibles and Testaments sold, valued at \$1,675.65. There have been 23,566 pages of tracts distributed. Donations have been received in books and cash to the amount of \$500.49. We would call attention to the fact that the Bigbee Association has about \$100 in the original colportage fund, and would advise that a colporter be put into the field whenever the way is open to do so.

#### REPORT ON TEMPERANCE.

We, the committee appointed to make a report on Temperance, beg leave to report: That we find it takes two million of our best young men and boys in these United States to manufacture 150,000 drunkards, produce annually 300,000 paupers, all of whom have to be supported at the expense of the State or good citizens; to say nothing of the woe, misery and unhappiness which these drunkards bring to their mothers and sisters, who have to suffer from the liquor habit. Tears, such as angels weep, are daily shed by God-loving mothers and loving sisters over their fallen ones.

The cost of the liquor traffic is between nine and ten millions yearly; the cost to each individual family is not less than one hundred dollars. Are not these figures startling?

Now, let us see for a moment what is being done for the advancement of Christianity. We find from all Christian denominations there is only five and a half million of dollars raised for mission work, or evangelizing the world. We find by statistics there are between



twenty-five and thirty million bushels of grain used in manufacturing ardent spirits. Now, is not this a deplorable state of the country, when we look around us and see so many mothers and children starving and crying for bread?

Our young ladies could help the cause of practical temperance by refusing to indulge with young men in wines and champagnes which are served at social gatherings. In the two hundred thousand saloons of America doubtless more than a million receive pernicious education every day in the year, or as they are paid to vote. We are all of one accord that the palladium of our government rests upon our citizens, and if we tolerate such unjust balloting, can the safety of our Union be perpetual? The saloons must have boys, or shut up their shops. One family out of every five must contribute a boy to keep up the supply. Will you help? Which of your boys are you willing to give?

The brewers and manufacturers of liquors claim to give employment to half a million of men. Now, let us suppose for a moment what a greater number of men could be employed in more honorable and laudable pursuits with the money expended for liquor. If every person in this country whose signature is fixed to a church record would abstain from this dishonoring habit, more than half our saloons would have to shut up shop and seek other employment. Besides, the Bible teaches temperance in all things, so let us heed its admonitions.

## CONSTITUTION.

1. This body shall be known by the name of the Bigbee Baptist Association.

2. The officers of this Association shall consist of a Moderator, Clerk and Treasurer, who shall be elected at each annual meeting, from its own body, and shall hold their office until their successors are elected.

3. The Moderator shall preside over the Association, and shall discharge the duties usually imposed upon officers presiding over deliberative bodies.

4. The Clerk shall keep a fair record of the proceedings of this Association, and shall attend to the printing and distributing of the Minutes.

5. The Treasurer shall perform the duties usually assigned to such officer, and shall report annually to the Association.

6. The Association shall hold its meetings at such time and place as it shall from time to time appoint.

7. Every church shall be entitled to two delegates, and also one for every twenty-five members exceeding twenty-five.

8. This Association disclaims all right of exercising authority over the internal regulation of churches, believing that within their own sphere they are accountable to God only.

9. The Constitution may be altered or amended by the concurrence of three-fourths of the members comprising the Association.

## ARTICLES OF FAITH.

1. We believe in one living and true God, that in the Godhead are Father, Son and Holy Spirit.

2. We believe that the Old and New Testaments are the Word of God, and the New Testament is the only rule of faith and practice.

3. We believe that the Church of God is composed of such persons as believe in Jesus Christ and have been baptized; that baptism consists in the immersion of the whole body in water; and that the Lord's Supper should be administered to church members only.

4. We believe in the doctrines of grace taught by the United Baptists, viz: In the depravity of man; in the converting grace of God; in the resurrection of the dead; in the general judgment; in the eternal life of the righteous; in the everlasting punishment of the wicked.

## RULES OF DECORUM.

1. At each meeting of this Association the Moderator shall take the chair, shall call the members to order, shall decide questions of order subject to an appeal, shall open and close the Association with prayer, shall appoint committees, when not otherwise ordered, and shall pronounce the decisions to the Association.

2. The names of members shall be called each day, and invitations to seats extended to ministering brethren.

3. The members shall observe respect to officers and to each other, shall arise when addressing the Moderator, shall confine themselves to the questions, shall avoid personalities, shall not speak without leave more than once, until every member shall have opportunity to speak, and shall sustain that bearing to each other which becomes gentlemen and Christians.

4. When a motion is made and seconded, it shall be stated by the Moderator, and then shall be in the possession of the Association, but may be withdrawn by the mover before amendment or decision.

5. When a question is under debate, no motion shall be received



except to adjourn, to lay on the table, to amend or postpone; which motion shall have precedence in the order enumerated.

6. All questions, except those relating to the Constitution, shall be decided by a majority. Any member voting with the majority may move for a reconsideration on the day of decision. Members may not leave the Association without permission.

7. When questions of order are not provided for in these rules, they shall be decided according to the rules and regulations governing legislative bodies generally.

8. The Association shall have power to receive into its body and fellowship such churches as apply for admission; and shall also be empowered to withdraw its fellowship from any church or body of men walking disorderly, and supposed to be unworthy the fellowship of this Association.
