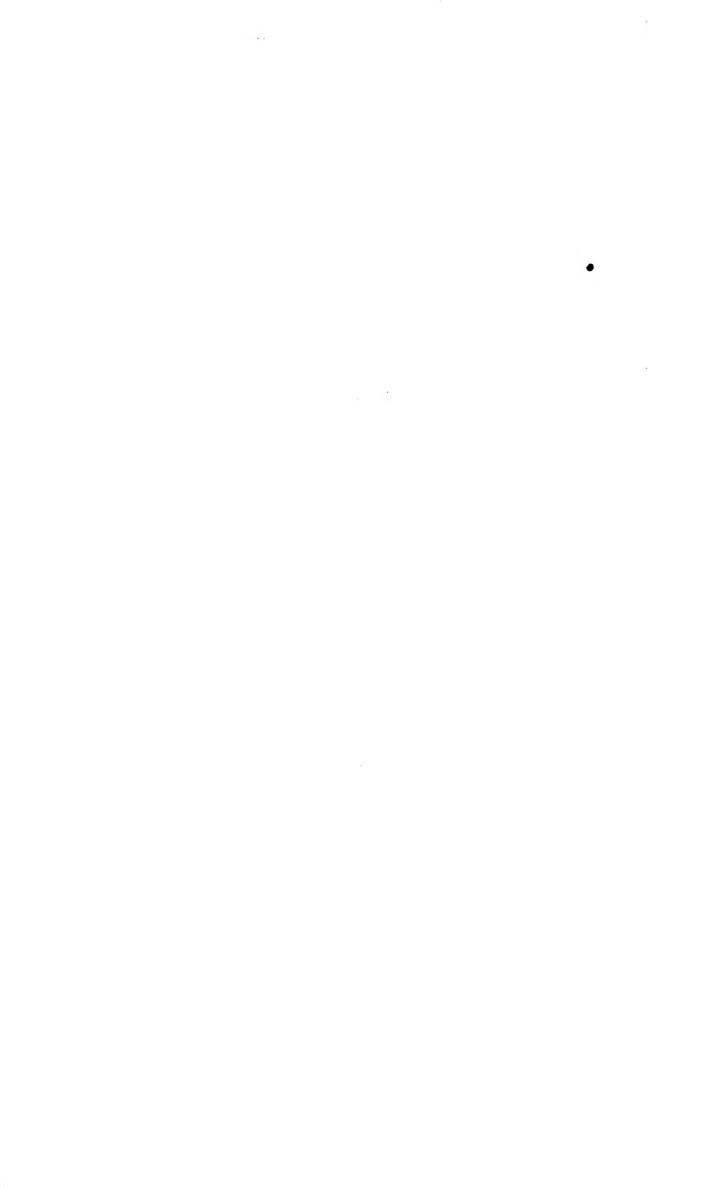

MINUTES.

SALISBURY, N. C., December 5th, 1860.

THE NORTH CAROLINA CONFERENCE, convened this day according to appointment in this town, Bishop ROBERT PAINE, President.

Conference was called to order at 9 o'clock, A. M., and opened with reading the scriptures, singing and prayer by the Bishop.

The roll was called, and sixty-five of the brethren being present, answered to their names.

On motion, William E. Pell was appointed Secretary, and James P. Simpson, assistant Secretary.

On motion, it was ordered that the daily sessions of this body be opened at 9 o'clock, A. M., and adjourned at 1 o'clock, P. M.

The following Committees were then appointed :

On Public Worship,—William H. Bobbitt, T. W. Guthrie.

Books and Periodicals,—C. P. Jones, B. F. Long.

Memoirs,—William Closs, N. F. Reid, C. F. Deems.

Here the Bishop briefly addressed the Conference.

The Chair presented a communication from Dr. Taylor, on Sunday Schools, which was referred to the committee on Sunday Schools; also a communication from the Agent of Depository at Charleston; referred to the committee on Books and Periodicals.

Rev. Mr. Ruple of the Presbyterian Church, and Rev. Mr. Groseclose of the Lutheran Church, at this place, and Rev. Mr. Smiley of the Virginia Conference, were introduced to the Conference, and invited to take seats.

Question 2nd being taken up,—Theodore B. Kingsbury, Richard

S. Webb, Franklin H. Wood, and Bernice B. Culbreth probationers of one year, passed and were continued on trial.

Question 3rd being taken up.—John C. Brent, John R. Brooks, Robert A. Willis, Benjamin F. Guthrie, Perley H. Seovell, John W. Jenkins and William H. Wheeler, probationers of two years, passed, were admitted into full connection and elected to deacon's orders.

On motion,

Resolved, That this Conference sit with open doors until otherwise ordered.

Resolved, That when this Conference adjourns, it adjourn to meet at the Methodist Church.

Pepper, David R. Bruton, Charles H. Phillips, William Barringer, Alfred Norman, Braxton Craven, Joseph C. Thomas, N. H. D. Wilson, William H. Bobbitt, Thomas W. Guthrie, and J. J. Mises, passed examination of character.

Conference took a recess to allow the Missionary Society time to meet.

Conference then resumed its business and after the usual notices adjourned.

THURSDAY MORNING, December 6th, 1860.

Conference met according to adjournment, and was opened with religious exercises, by Rev. Alfred Norman. The roll being called, twenty-four brethren who were not present at the opening of the Conference on Wednesday, answered to their names and took their seats.

The Minutes of yesterday were read and approved.

The bar of the Conference was fixed, and the calling of the roll was ordered to be dispensed with after to-day.

Rev. R. Abbey, Financial Secretary, was introduced and addressed the Conference on the business of his office.

The Bishop presented a communication from the Mission Commit-

tee at Nashville, Tenn., which being read was referred to a special Committee, composed of William Closs, D. B. Nicholson, and John Tillet. The Bishop also presented the annual exhibit of the publishing house, which being read was referred to the committee on Books and Periodicals.

A communication from the Financial Secretary was read and referred to the same committee.

Rev. Mr. Norris from Georgia, was introduced, and made some remarks, in relation to the Educational Repository for which he is Agent.

The Bishop presented a communication from Rev. Dr. Means, Chairman of Educational Committee, which was read and referred to the Committee on Books and Periodicals.

Rev. Mr. McTeer of the Holston Conference, was introduced and invited to take a seat in the Conference.

Question 9th being taken up,—A. W. Mangum, George E. Wyche, Wm. C. Gannon, James F. Smoot, Alexander D. Betts, John S. Long, John L. Newby, deacons of two years, passed, and were elected to Elder's orders.

James B. Bailey, a deacon, passed, and was continued.

Question 6th being resumed,—Medicus H. Hight, a deacon of one year, passed.

Question 2nd being resumed,—Robert T. N. Stevenson and J. H. Robbins, probationers of one year, passed, and were continued on trial.

The examination of Elders being resumed,—Marcus C. Thomas, Thomas B. Reeks, W. W. Albea, John W. Floyd, Isaac P. Keerans, C. M. Anderson, Isaac W. Avent, Marble N. Taylor, S. H. Helsabeck, elders, passed.

Question 1st being taken up; W. A. Smith, a local preacher of Raleigh circuit; Thomas J. Gattis a local preacher of High Point and Trinity College Station; Edwin A. Yates, a local preacher of Charlotte Station, and Edward A. Wilson, a local preacher of Jones Circuit, were admitted on trial in the traveling connection.

The hour of adjournment having arrived, the session was extended, and after several notices, Conference adjourned.

FRIDAY MORNING, December 7th, 1860.

Conference met at 9 o'clock, and was opened with religious exercises by Rev. Dr. Means, of the Georgia Conference.

The Minutes of yesterday having been read were approved.

Rev. Dr. Means of the Georgia Conference was introduced and invited to a seat.

Ira T. Wyche, William M. D. Moore, and T. P. Ricaud, members of the Conference, appeared and took their seats.

Question 1st being resumed,—Alexander B. Raven, a local preacher of Newbern Station, John B. Williams, a local preacher of Wilson Station, William H. Moore, a local preacher of Wilson Station, Thomas J. Eatmon, a local preacher of Contentnea Circuit, Carson Parker, a local preacher of Whitesville Circuit, and Thaddeus L. Troy, a local preacher of the Greensboro' Station, were received on trial in the traveling connection.

Rev. Mr. Watts of the South Carolina Conference was introduced and invited to a seat.

Reports from the President of Trinity College, the President of Greensboro' Female College, and from Glenn Anna Female Seminary, were read and referred to the Committee on Education.

A communication was read from Wm. T. Smithson, Esqr., of Washington City.

N. H. D. Wilson, Agent of Trinity College, presented his report, which was read and referred to the Committee on Education.

On motion, N. H. D. Wilson, John W. Lewis and H. T. Hudson were added to the Committee on Books and Periodicals.

The Chairman of the Committee on the publication of the Minutes, presented his report, which being read, on motion, the following resolution was adopted as a substitute :

Resolved, That William E. Pell, R. T. Heflin and Joel W. Tucker, be a Committee to publish the Minutes of the Conference, provided said Committee can secure the means to pay the expense, and publish them by the 15th of January.

The examination of Elders being resumed : Ira T. Wyche, W. E. Pell, John N. Andrews, Abram Weaver, N. A. H. Goddin, Wm. F. Clegg, H. H. Gibbons, Washington D. Meacham, C. P. Jones, Robert S. Moran, N. A. Hooker, Moses J. Hunt, and William Closs, Elders, passed.

The name of James H. Brent being called, William Closs, his P. E., arose and gave a brief account of the labors and death of our de-

parted brother. C. F. Deems added appropriate remarks; the Bishop also spoke very feelingly on the subject.

After several notices the Conference adjourned.

SATURDAY MORNING, Dec. 8th, 1860.

Conference met according to adjournment, and was opened with religious exercises by Rev. J. H. Wheeler.

The minutes of yesterday were read and approved.

Question 1st being resumed: Wesley M. Roby, a local preacher of Wilkes Circuit, and Francis B. Andrews, a local preacher of Goldsboro' Station, were admitted on trial in the traveling connection.

Question 8th being taken up: John W. York, a local preacher of Granville circuit, Jacob Sheek, a local preacher of Mocksville circuit, William B. Woodruff, a local preacher of Surry circuit, James Minish, a local preacher of Jonesville circuit, Benj. S. Hardy, a local preacher of Snowhill circuit, Blackman Culbreth, a local preacher of Sampson circuit, Owen H. Johnson, a local preacher of Bladen circuit, and J. J. Prather, a local preacher of Fayetteville Station, were severally elected to Deacon's orders.

Rev. Dr. Schon, Missionary Secretary, here addressed the Conference upon the Missionary operations and wants of the church.

Rev. Messrs. Puett, Nelson and Edwards, of the South Carolina Conference, were introduced and invited to seats.

Rev. Dr. Means of the Georgia Conference, addressed the Conference upon the character and claims of the "Educational Repository."

Hon. Judge Caldwell of Salisbury, was introduced to the Conference.

Question 10th being taken up: Turner M. Jones, a local deacon of Greensboro' Station, and W. S. Van Eaton, a local deacon of Jonesville circuit, were severally elected to Elder's orders.

Application being made for the restoration of the credentials of George C. Compton, an expelled deacon, but now a local preacher of Tar River circuit, upon the recommendation of the Quarterly Conference of said circuit;

On motion, the application was rejected.

On motion, the Secretary was authorized to furnish Rev. Micha-

el Robbins, with a copy of the minutes and papers in his case, at the session of the Conference held at Warrenton in 1851.

The examination of Elders being resumed: W. H. Barnes, H. T. Hudson, Robt. G. Barrett, L. Shell, J. H. Wheeler, John M. Gunn, Thos. L. Triplett, Jas. L. Fisher, Isham H. Hill, Wm. M. Walsh, John Jones, Pierce W. Yarrell, Samuel M. Frost, C. F. Deems, Joseph Wheeler, G. W. Deems, Simeon D. Peeler, P. J. Carraway, W. B. Richardson, Daniel Culbreth, Caswell W. King, and Wm. M. D. Moore, Elders, passed.

L. W. Martin, elder, passed, and was continued in a supernumerary relation.

After several notices, Conference adjourned.

MONDAY MORNING, Dec. 10th, 1860.

Conference met and was opened with reading the Scriptures, singing and prayer, by Rev. Wm. M. Walsh.

Minutes of Saturday were read and approved.

Bishop Paine reported, that on Sabbath at 11 o'clock, A. M., he ordained the following persons, deacons, to wit: John C. Brent, John R. Brooks, Robt. A. Willis, Benj. F. Guthrie, Perley H. Scovell, John W. Jenkins, Wm. H. Wheeler, John W. York, Evan A. Stoker, Jacob Sheek, Wm. B. Woodruff, James Minish, Wesley M. Roby, Benj. S. Hardy, Blackman Culbreth, Owen H. Johnson, and John J. Prather.

Also that he ordained Adolphus W. Mangum, elder, on Saturday night, at his room, and that he ordained at 3 o'clock on Sabbath, the following, Elders, to wit: George E. Wyche, Wm. C. Gannon, James F. Smoot, Alex. D. Betts, John S. Long, John L. Newby, Turner M. Jones, and Wm. L. Van Eaton.

Reports from Wayne Female College and Olin High School were read and referred to the Committee on Education.

Wm. A. Smith, T. J. Gattis, Edwin A. Yates, Edward A. Wilson, Alex. B. Raven, John B. Williams, W. H. Moore, Carson Parker, Thaddeus L. Troy and Wesley M. Roby, having been previously examined and admitted on trial, were called and examined by the Bishop before the Conference, according to Discipline.

T. J. Eatmon and J. B. Andrews of the same class, not being present, having been compelled to return home before this examination, it was

Ordered, That the rule be suspended in their cases, and that they be required to pass said examination at next Conference.

The examination of Elders being resumed: Peter Doub, L. S. Burkhead, R. P. Bibb, Gaston Farrar, John Tillett, James W. Wheeler, Wash. S. Chaffin, Thos. C. Moses, Shockly D. Adams, Zebedee Rush, Wm. M. Jordan, Marquis L. Wood, and James P. Simpson, passed.

On motion.

Resolved, That this Conference hereby affectionately requests Rev. Peter Doub, D. D., to prepare as soon as possible, the necessary materials for a biography of his life and times.

The name of Bro. Marquis L. Wood, our Missionary to China, having been called, and after the usual representation of his health, labors, &c.

On motion, the Conference engaged in solemn prayer, led by Rev. Dr. Schon, in behalf of Bro. and Sister Wood, and for their preservation and success.

On motion.

Resolved, That the Secretary of this Conference and Dr. Schon, Missionary Secretary, be requested to communicate to Bro. and Sister Wood, the deep interest felt for and the entire confidence reposed in them by this Conference.

Question 13th being taken up: Wm. Holmes, Bennett T. Blake, John R. McIntosh, Samuel B. Dozier, Thompson Garrard, Joshua Bethel and Henry Gray, elders passed, and were continued in a superannuated relation.

Wm. Closs, Chairman of the Committee, to whom was referred the Circular of of the Mission Committee of the Parent Missionary Society of the Methodist Episcopal Church, South, beg leave to report.

That they have had the paper under careful consideration, and respectfully recommend the adoption of the following resolutions:

Resolved, That we concur in the recommendation that no Mission be established within our bounds, which can be avoided; and that provided we have not raised the amount apportioned to our Conference, the Bishop be requested to draw only in proportion to the amount collected.

Resolved, That we do not concur in the recommendation, as to the transmission of our funds, but that the amount necessary to meet the first and second instalments be retained, and that the surplus be transmitted to the Treasurer of the Parent Society.

All of which is respectfully submitted,

C. P. Jones, Chairman of Committee on Books and Periodicals presented their report which after being read, was adopted as follows :

REPORT OF COMMITTEE ON BOOKS AND PERIODICALS.

The Committee on Books and Periodicals beg leave to present the following report :

THE PUBLISHING HOUSE.—The Annual Exhibit of the Agent, shows the House to be in a healthy and prosperous condition. Its assets are gradually increasing, and its liabilities diminishing. It has been managed with tact and ability, and to the entire satisfaction of the Book Committee and of the Church generally.

The active capital is entirely too small for the business of a great Publishing House. The Agent is cramped in his operations, and the increasing demand for books cannot be met. The Financial Secretary has labored earnestly and faithfully to augment the capital, but compared with the resources of a great Church, has not, we are sorry to say, met with success commensurate with the interests involved. Shall we not aid him to give a pure Southern literature to the millions who demand it? We sincerely hope so, and that ere long our Publishing House will have abundant means to give to the entire South a literature uncontaminated with Northern fanaticism.

We submit the following resolution :

Resolved, That we will aid the Financial Secretary in any plans which he and this Conference may adopt to increase the capital and extend the operations of the Publishing House.

THE QUARTERLY REVIEW.—This Periodical maintains its ground as a literary journal, though published under unfavorable circumstances. It is worthy of the patronage of the church and friends of literature. We regret that its circulation is limited. The wants of the church, and the advance of science and general intelligence demand its circulation. We submit the following resolution :

Resolved, That we recommend the Quarterly Review to our people, and that we will endeavor to increase its circulation.

THE HOME CIRCLE.—This monthly is unexcelled in artistic skill and literary merit in the Southern country. It should be in every family, as it will equally adorn the centre-table, and instruct the head and heart. We earnestly recommend the adoption of the following resolution :

Resolved, That we will cheerfully recommend the Home Circle to our people, and aid in its circulation.

THE SUNDAY SCHOOL VISITOR.—This paper for the youth of the Church is a most excellent sheet. For children somewhat advanced, and Sunday School Teachers it is invaluable. But while we recommend it as

a Sabbath School Journal, we very much desire to see issued a Child's Paper.

Resolved, That we will increase its circulation.

THE EDUCATIONAL JOURNAL AND FAMILY MONTHLY.—This is a new publication, and is the organ of the Educational Institute. The object of its publication is thus set forth in the Prospectus; "It is designed to sustain and advance all the great educational enterprises of our Church, promote a spirit of love, fraternity and harmony among the large and increasing class of its educators;" "also to supply a safe and pleasant companion for the fireside."

We submit the following resolution:

Resolved, That we recommend the Educational Repository and Family Monthly to the attention and patronage of our people.

THE NORTH CAROLINA CHRISTIAN ADVOCATE.—This paper is in the fifth year of its existence. With but little means and under circumstances very embarrassing, it has pursued the tenor of its way until it is among the very best papers published by the Church. We would not, however, be understood as endorsing everything which has appeared in its columns; yet we are highly pleased with its general improvement, both in matter and typographical appearance.

We earnestly recommend the adoption of the following resolution:

Resolved, That we recommend the N. C. Christian Advocate to our people, and that we will, if possible, increase the subscription list the following year to 5000.

MONDAY 3 o'clock, P. M., Dec. 1

Conference met according to adjournment, and was opened with religious exercises by Rev. N. A. Hooker; Rev. James Reid being in the Chair.

The Minutes of the morning session were read and approved.

Leave of absence was granted to Rev. S. M. Frost.

Question 16th was taken up, and the statistics were reported. See Document A.

On motion, Conference adjourned.

TUESDAY MORNING, Dec. 11th 1860.

Conference met and religious exercises were conducted by Rev. D. Culbreth.

The minutes of yesterday afternoon were read and approved.

Wm. Closs made a statement in regard to a proposition of a Mr. Edwards of Edgecombe, to buy an old church &c.; on motion.

Resolved, That Bro. Closs be appointed Agent to dispose of the matter according to his best judgement.

On motion,

Resolved, That the Bishop be respectfully requested by this Conference, to appoint the time of our next session on some day between the 1st and 20th of Nov. 1861.

The Committee on Books and Periodicals made report No. 2, which was read, adopted and filed.

The Publishing Committee of the North Carolina Christian Advocate, made their report, which on motion was adopted, as follows:

REPORT OF PUBLISHING COMMITTEE.

The Publishing Committee of the N. C. Christian Advocate submit to the Conference the following report:

The pecuniary condition of the Advocate is much sounder than at our last session. There are some liabilities still unmet, though not embarrassing to a very great extent. Twelve hundred dollars only of the thirteen hundred pledged at last Conference have been received, and part of that amount, \$150 is in notes unpaid. Nearly a sufficient amount from the Districts has been pledged to buy a press, and we have made arrangements to do so as soon as the money can be collected.

The Committee by the request of Dr. Heflin has associated with him in the Editorial Department, Rev. William E. Pell. The committee bespeak from the Conference a united and hearty support of the North Carolina Christian Advocate. It is a necessity to us, and must be sustained by us.

The Committee on Education made their report, which was read and adopted as follows:

REPORT OF THE COMMITTEE ON EDUCATION.

The Committee on Education would respectfully submit the following report:

There is evidently a marked and most intimate connection between

the education and religious culture of our race. These two great enterprises constantly act and re-act upon each other, at so many points of interest—mutually influencing each other, either for the good or evil, the weal or woe of humanity, that it would most sadly reflect upon the piety as well as the intelligence of any branch of the Christian Church, to intimate that it can feel even the slightest indifference to the former, while it has any true regard for the latter.

With great pleasure we contemplate the interesting fact, that while the primitive characteristic of Methodism—its ancient and venerable zeal for the spread of scriptural holiness over the world—is still unabated, we see that the connection with it, of an earnest, active, intelligent zeal in behalf of a sound education, is becoming more and more the enviable distinction of our church, especially within the bounds of our own Conference. This will appear the more obvious from the following encouraging report, which we are able to present to you, of the prosperous condition of the Literary Institutions now under our patronage.

TRINITY COLLEGE.—This institution sends a good report. The College is doing a good work, the scholarship is sound, and thorough, the discipline ennobling and good—and the whole tone of life, such as will exert a good moral influence on the sons of our people committed to their Institution for intellectual and moral training. We learn with pleasure from the report of the President, that new buildings are under contract, that the work is to commence at an early day, and go forward to completion as rapidly as possible; and when completed will afford ample accommodations, suited to the wants of our people. The boarding arrangements are now good, and we take pleasure in stating that at least two hundred young men, can be well accommodated.

The Agent has succeeded in raising, during the past Conference year, in cash and in bonds, payable in one, two, three, and four years after date, the sum of eight thousand nine hundred and twenty-six dollars. This amount, being as it is, the largest ever reported by any agent, appointed by our Conference to any agency in our Church, shows not only the efficiency of our agent, but also proves that his appointment is not a doubtful experiment, nor is the successful issue of this enterprise of the church any longer to be questioned. Your committee in view of these facts would respectfully present for the adoption of the Conference the following resolutions, viz:

Resolved, That Trinity College deserves the confidence and support of all our people, and that the literary, moral, and disciplinary character of the Institution entitles it to the position that it occupies, and only needs to be understood by the people to insure it a large and influential patronage from all classes.

Resolved, 2. That the preachers be requested to distribute catalogues, and otherwise represent the interests of Trinity in all parts of our Conference.

Resolved, 3. That we will continue the agency, and that we request the re-appointment of Rev. N. H. D. Wilson to that work.

We recommend the following members of the Conference as a visiting committee to attend the next Annual Commencement, viz: John Tillet, H. T. Hudson, R. G. Barrett, L. S. Burkhead, and Thos. W. Guthrie.

GREENSBORO' FEMALE COLLEGE.—Greensboro' Female College has already accomplished a glorious work for the cause of Christian Education in North Carolina. We rejoice to learn that the success of the College, during the present year, has surpassed that of any previous year in its useful and brilliant career. The number of pupils in regular attendance has been 175, of whom 160 have been boarders. The present capacity of the buildings, is not sufficient to accommodate this large number, without crowding them, in a manner inconsistent with comfort and convenience. Consequently 27 young Ladies were placed in such private families, near the College, as would require them to observe all the general regulations of the Faculty. The time, however, is near at hand when the new wing, at the east end of the building, 95 by 50 feet, 3 stories above ground, with a basement, will be completed. The Institution will then possess unusual advantages for Educational purposes.

During the present session the College has been blessed with a gracious revival of religion. About 60 of the young Ladies were subjects of the revival influence; most of whom have connected themselves with the church, and give gratifying evidences of consistent piety. It gladdens our hearts to know that the Pastor of the Church and the Faculty have been so blessed in their labors, under God, as to enable them not only to train the minds and hearts of those committed to their care, but also to lead them to the saving knowledge of Jesus Christ!

In regard to the \$20,000 proposition your committee would state, that an account has been opened between the Conference and the Trustees. The Conference was charged on the 15th of June, 1860, with \$20,000 and \$6,227 36, were entered to its credit. Since that time, the President has collected and placed to the credit of the Conference \$1,935 40. To meet the balance of the debt, the Conference has bonds, supposed to be good, to the amount of \$9,261 94, and bonds supposed to be doubtful, \$1,000. During the present year the Conference has enjoyed the benefit of the provision above referred to, and your Committee think that prompt and active steps should be taken for the collection of the bonds due the College. We, therefore, recommend that the bonds now due and those that will mature during the coming year, be placed in the hands of the Presiding Elders and preachers of the Conference for collection, and that they be directed to remit the funds received to Rev. T. M. Jones, President of the College.

At the request of the board of Trustees we recommend. 1. That the number of Trustees of Greensboro' Female College be increased to forty.

2. We recommend the following gentlemen, not members of the Conference, as suitable persons to be elected, viz:

In conclusion we most heartily recommend Greensboro' Female College to the increased confidence and patronage of our people.

WAYNE FEMALE COLLEGE.—The President, Rev. S. M. Frost, A. M., reports this Institution in a very flourishing condition. The patronage is increasing, the finances are in a very healthful state, and the Trustees contemplate the erection, at an early day, of a spacious building for a Chapel. Such a building is rendered absolutely necessary, both on account of the increasing patronage, and the large number of visitors at the annual Commencements. The friends of the Institution confidently hope, that the nett profits of the College will soon be amply sufficient to meet this necessity.

The Board of Instruction is complete and efficient, the grade of scholarship is high, and the religious-interest of the pupils is specially cared for.

The daughters of all ministers of whatever denomination who devote themselves to the work of the ministry, will be educated in this Institution free of charge for tuition; and the daughters of all local preachers will be charged only *half price* for tuition.

Your Committee take great pleasure in recommending Wayne Female College to the confidence and patronage of the public.

WARRENTON FEMALE COLLEGE.—This Institution located in a highly intelligent, refined, and wealthy section of our Conference, is doing good work in the cause of Female education. Your committee have received no formal report from the President, but understand from reliable sources, that the last session has been prosperous—indeed rather more so than any former one. A high grade of scholarship is maintained, the religious interests of the pupils are carefully looked after, and noble efforts are made to meet the educational wants of that portion of our work. Your committee earnestly recommend Warrenton Female College to the confidence and patronage of our people and the public.

OLIN HIGH SCHOOL, MALE AND FEMALE.—This Institution, located in Fredell county, meets a pressing necessity of our church and of the community through a large section of the surrounding country. It is represented to be in a very prosperous condition. During the past year nearly one hundred students were in attendance. The Principal, A. H. Merritt, A. M., and his Assistant, Miss S. E. Purvis, have managed the school to the entire satisfaction of its patrons and friends. Parents and

guardians may be assured that the moral and mental training of the pupils of this Institution will be correct and safe. We earnestly desire that "Olin High School" may continue to prosper, and that the anticipations of its most sanguine friends may be fully realized. We most heartily recommend this Institution to the confidence and patronage of our people.

Your committee have received reliable information that "Olin" is still greatly embarrassed financially; and we recommend that this Conference put in operation some plan looking to its relief.

JONESVILLE MALE AND FEMALE ACADEMY.—This Institution is doing a good work in the western part of our Conference. We are pleased to hear of its continued prosperity, and that its prospects are brightening for the future.

Rev. W. L. Van Eaton, the Principal of the Institution, assisted by several competent teachers, is laboring with commendable zeal in the cause of education. At this Institution the children of ministers may receive instruction for *one-half* of the usual charges for tuition, and students sent by the "Young Men's Aid Society" will be taught free of charge.

We recommend "Jonesville Male and Female Academy" to the patronage of our people.

GLENN ANNA FEMALE SEMINARY.—This Institution, located at Thomasville, is owned and managed by J. W. Thomas, Esq., an enterprising member of our church. The school is flourishing and doing good in the cause of education and religion.

We recommend it to the patronage of the public.

The pecuniary condition of Olin High School being under consideration, the following plan for its relief, was submitted by Wm. Closs and seconded by C. F. Deems:

Whereas, Olin High School in Iredell county, has been in financial embarrassment, and our brethren, the Messrs. Foard have assumed the responsibility, which they have borne for several years; and whereas, at the last session of this Conference we resolved to make an effort to obtain sufficient funds to relieve them, and the agency we appointed was unsuccessful;

Therefore Resolved, That a joint Stock Company be formed, with a capital of \$12,000 divided into shares of \$100 each, and that the amount subscribed be divided into four equal installments, and that the Messrs. Foard retain the property until the whole amount of \$12,000 be paid, and that they guarantee to the North Carolina Conference ten scholarships, during the time they hold the property; and that such members of this Conference as shall subscribe, be allowed to obtain the amount

upon their respective charges, and be stockholders to the amount of stock obtained by them; and that the Messrs. Foard be stockholders to the amount of twenty shares, to cover the amount they have already paid; and that the Presiding Elders be Agents of the Conference to open books of subscription, and that no portion of the stock subscribed shall be collected, until the whole capital shall have been subscribed.

Resolved, That pending the efforts to accomplish the above plan, Olin High School be preparatory to Trinity College.

On motion, the plan was adopted.

On motion,

Resolved, That Wm. Closs, O. G. Foard and D. B. Nicholson be a Committee to prepare the necessary articles of agreement and rules for the regulation of the said Joint Stock Company.

The Joint Board of Finance composed of L. L. Hendren, Chairman, H. T. Hudson, T. W. Moore, L. S. Burkhead, C. H. Phillips, R. P. Bibb, and John Tillett, ministers, and J. C. Blocker of the Wilmington District, Dr. J. B. Beckwith of the Newbern District, P. G. Foster of Washington District, D. S. Hill of Raleigh District, S. S. Harrison of Greensboro' District, E. P. Fearington of Fayetteville District, and O. G. Foard of Salisbury District, laymen, made their report, which on motion was adopted and filed. See Document B.

The Treasurer of the Conference Missionary Society reported \$9,837 66 as having been raised the past year for Missions. See Document C.

The Chairman of Committee on Sabbath Schools reported \$1,290 92 as having been collected the past year for Sabbath Schools.

H. T. Hudson, T. W. Moore, Alex. D. Betts, C. H. Phillips, Marcus C. Thomas, B. F. Guthrie and P. J. Carraway, were appointed the Joint Board of Finance on the part of the Conference, for the ensuing year.

The Committee on Parsonages presented the following report, which being read, on motion was adopted :

REPORT OF COMMITTEE ON PARSONAGES.

There are within the bounds of our Conference thirty-two Parsonages, valued, with their furniture and fixtures, at \$47,930; of this number, seven are connected with our Stations, twenty-four are on Circuits, and one is a Presiding Elder's Parsonage, located at Olin, in the bounds of the Salisbury District. On some of the Parsonages there are debts of small, and on a few, of large amounts; but a majority of them are clear

of debt, and it is believed that all or nearly all of those now embarrassed, will soon be able to discharge their pecuniary liabilities.

Some of these Parsonages are large and comfortable, and of a high order of workmanship. And it is believed that one at least, is equal, if not superior to any thing of the sort in the Southern Church.

These are certainly gratifying evidences of the affection and liberality of our people, and of their devotion to our Itinerancy, and should be hailed by us as testimonials of the improvement of our Church, and sure indications of still better times coming. We hope the day is not distant when a comfortable Parsonage home, will be found in all our charges capable of supporting ministers with families; and your Committee are pleased to learn that other homes of this sort will soon be provided for our preachers. Indeed, we may affirm that, Parsonages are not only a generous and grateful response on the part of our people to our necessities as men of families, but are now indispensable to the success of the itinerant ministry. Our efficiency requires that they be embosomed firmly in the confidence of our brethren, and every thing tending to shake this confidence should be regarded as inimical to the church. Your Committee would therefore, make some suggestions for the benefit of both preachers and people in this respect.

1. When Ministers are appointed to charges having Parsonages, they should occupy them whenever practicable.

2. They should not stay at their Parsonage homes to the neglect of pastoral visiting. Such a course would not only awaken in the people who give us our homes, a complaint of neglect, but a regret that they had furnished the means which keeps the preacher from visiting their flocks. If the preachers would keep up the confidence and interest of the people in Parsonages, let them spend a goodly portion of their time with their charges. This suggestion is not intended to implicate those Preachers who stay with their families in seasons of affliction. Neglect of our families at such times would damage our Christian character.

3. Ministers should be careful of the property thus kindly and generously placed in their hands. Our people who give this property for the comfort of our families must see that we appreciate their kindness. Each Preacher, should, therefore, show a proper solicitude for the preservation of the Parsonage property. He should, moreover, take it in trust to be handed over to his successor in as good condition as its proper use will allow. As it is not given to the present incumbent alone, but to his successor in charge, he who neglects or abuses the property commits a trespass upon the generosity of the church and the rights of his successor; and while his successors are damaged, the people are discouraged, and are unwilling to repair the damage. They cannot endure these constantly recurring applications to put property where ungoverned children, and undisciplined servants are allowed to smash it up, and hack it in pieces and destroy it.

4. Ministers should not transfer to their successors, debts upon the Parsonage for articles purchased for their own accommodation. Let them raise money and pay these debts, or retain, or sell these articles and indemnify themselves. It is manifest injustice to impose upon those who succeed them the task of paying for articles which are destroyed, or so injured as to be of little use.

Your Committee would, therefore, recommend the passage of the following resolutions.

Resolved, 1. That we recommend the Quarterly Conference to appoint a committee to examine the Parsonage furniture and fixtures at the time the Preacher takes charge, and also when he delivers them up for the purpose of examining the amount of damage, if any, done to the property by abuse or neglect and carelessness.

Resolved, 2. That it is the opinion of this Conference that the occupant of the Parsonage pay for the repairs of all damages occurring through neglect, or carelessness, and in case he fail to do so, the stewards should retain an amount sufficient for that purpose out of the Disciplinary allowance of said occupant.

Resolved, 3. That we recommend the erection and furnishing of Parsonages on all our charges capable of supporting Preachers with families.

Resolved, That this Conference receive with sincere cordiality the fraternal letter of the Methodist Protestant Church, addressed through Rev. Mr. Wills; that we reciprocate the expressions therein made of Christian respect and affection, and that we appoint a messenger from our body to convey to the next session of the Methodist Protestant Conference, a response to the address they have so kindly transmitted to us.

On motion, C. F. Deems was appointed Messenger of this body to that Conference, and N. H. D. Wilson was appointed alternate.

Resolved, That when we adjourn, we adjourn to meet at 3 o'clock, P. M.

After the usual notices, the Conference adjourned.

3 O'CLOCK, P. M., Tuesday, Dec. 11th, 1861.

Conference was opened with prayer by Rev. John Tillett. Rev. James Reid in the Chair.

The Minutes of morning session were read and approved.

The Committee on Sabbath Schools presented the following report, which was read, and on motion was adopted and filed.

REPORT ON SUNDAY SCHOOLS.

The Committee on Sunday Schools submit the following report:

We have had the subject under consideration, and while we are gratified at the partial success of this blessed cause, we are convinced that its success is not such as its merits deserve, nor such as the wants of our people demand.

Our statistics show that we have about 308 schools, and about 11,312 scholars. We think this number ought to be twice as large as it is.

We are not aware of any positive opposition to Sunday Schools among our people, and must believe that the meagre patronage with which they are favored is the result of indifference.

This indifference can be overcome only by determined perseverance on the part of those to whose care the souls of our people, parents and children, are committed.

Our ministers must not neglect this part of their work, but preach on the subject and keep up constant effort until our people are brought fully up to their duty in this glorious cause.

Our statistics show that about 1167 colored children are receiving catechetical instruction within our bounds. We are sorry, however, to state that this part of our work is not yet attended to even on all of our colored missions.

We find that our Sunday School Visitor has but a very limited circulation within our bounds. Only 309 copies of this beautiful and instructive paper are scattered amongst the 11,500 scholars in our Sunday Schools. Why should this be so?

Other denominations are preparing food for infant minds by circulating Sunday School periodicals, and we should not, we *must* not neglect our children.

We do sincerely hope that every member of the Conference will exert himself to increase the patronage of the Sunday School Visitor.

Believing that the time has come when the Church can accomplish more by strict attention to the religious instruction of children than in any other way, the cause of Sunday Schools should not be considered a matter of minor importance.

Our people should spare no reasonable pains and labor in building up a good Sunday School in every community.

Many a Sunday School teacher will find in eternity that the hours

spent in patiently instructing the young were spent for God and for good, and will meet a good reward.

May the great Head of the Church grant us grace to do our whole duty in this glorious cause, and let His blessing rest upon all our Sunday Schools.

Your committee on the Bible Cause having received a communication from the Agent of the American Bible Society within the bounds of North Carolina, setting forth the condition of the enterprise, as well as a condensed statement of his own operations for the past year: Do report as follows: That the American Bible Society claims to be a conservative, religious organization; that its objects and aims certainly are evangelical and noble; that it is accomplishing an immense amount of good for the benighted peoples and nations of the earth, and that it is entitled to the sympathy and earnest co-operation of all christian hearts and intellects. It received during the year ending March 1860, four hundred and thirty-five thousand dollars, and published and put in circulation between seven and eight hundred thousand copies of the Bible in thirty-four different languages.

There are eighty auxiliary societies in North Carolina—most of which are in good condition.

There is however great destitution in many parts of our State, and much need of energetic prayer and effort to place the lamp of life in every family. Therefore.

Resolved, That we will co-operate with the agent in the great work of soul saving through the circulation of the word of God.

DOCUMENT. D.

MEMOIR.

The Committee on Memoirs submit the following report :

Rev. James Henry Brent, was born in Rockingham county, N. C., in the year 1825. His early associations, apart from a pious mother, were unfriendly to religion. He was endowed with a fine intellect and a noble nature: instinctively high minded, honorable and generous. His father failed in business just at a time when he needed educational assistance, and on that account he was in youth thrown upon his own energies and efforts. Heroically struggling with the difficulties of his situation, he was preparing himself for the profession of Medicine, when in the year 1843 under the ministry of Rev. John Rich, he was converted to God. Soon after his conversion he felt that he was called by the Holy Spirit to the ministry of Jesus. Without hesitation he at once changed his plans and course of study, and bent all his energies to a preparation for the great work. Whilst endeavoring to educate himself, he also assumed the additional burden of educating his sisters and brothers. After having taught school and gone to school, for several sessions he was a student in Randolph Macon College, (from which Institution he afterwards received the honorary degree of A. B.) after which he was admitted on trial in the N. C. Conference, at Warrenton in 1850. He first received an appointment in connection with Topsail Academy. From the Louisburg Conference in 1852, he was appointed to the charge of Smithville circuit. God peculiarly owned him as his servant in crowning his ministerial efforts, with success. From Smithville he removed to Goldsboro', and founded the Goldsboro' Female College, now Wayne Female College. He presided successfully over this College two years, until the winter of 1855, when he resigned and was stationed in Fayetteville. At the session of Conference held in Greensboro' in 1856 he located. He was re-admitted in 1858 and stationed in Newbern. In 1859 he was re-appointed to the Newbern Station, where he died at his post in the midst of his labors, at one o'clock, a. m. on Friday the 17th of August, in the year of our Lord 1860. Just before his death, being informed that his departure was at hand and asked if the religion he had professed sustained him in the solemn hour, he replied, "I have no doubts nor difficulties on my mind, I look back upon all my labors for the good of souls as a very small matter, and my whole trust is in Christ; I feel that I can and do fully trust in the atonement."

The Newbern *Progress* just after his death closed a very highly eulogistic notice of him, with these words—"His warning voice will no more be heard in Centenary Church or elsewhere, but his precepts and example will live in the minds of many a wayward son and daughter of the race for many long years to come. His place will be hard to fill,

for he had but very few equals in the North Carolina Conference as a preacher and pastor."

Thus has passed away, in the prime of life, and flushed with the successes of ministerial effort, one of our best beloved. Whilst in mind and heart we gather around the spot where he labored and fell, and pour forth our tears to his memory, we gather fresh strength to our faith and hope from his lofty example in labor and self-denial, his calm, trustful, patient submission in affliction, and his brilliant exit in the hour of his departure. His last thought was centered on the cross—his last act was obedience to God—his last word was the note of christian triumph.


