

REPORT ON EDUCATION.

It is unnecessary to speak of the importance of education. All know that there is nothing more essential in our civilization. It is the thing that has elevated nations ever since the world has had a history. Our education is superior to any that has preceded it, in that it is on a broad moral and religious basis. We have cause to be proud of our education in general, as a people. As a Baptist denomination, we should be proud of some of our institutions of learning, and it gives your Committee great pleasure to recommend the Judson Institute. It is very gratifying to know that the Judson is now in better condition than it ever has been. No better school can be found for the education of the girls of our State and country. We would also present to you the Howard. It seems now to be on a firm footing, and, brethren, it is our duty to give it our support and patronage.

We should be careful, too, that we give attention to Ministerial Education, in a measure at least, worthy of its great importance. Do we do what we can and should for the furtherance of this noble enterprise? J. M. McIver, Ch'n.

Several speeches were made on Howard College. Brother, Curry informed the body that the College had now \$100,000.

Brother G. S. Anderson and others presented the claims of Ministerial Education. Brother W. B. Crumpton called attention to the splendid work and condition of the Judson.

Adjourned to meet at 9:30 A. M. to-morrow.

THURSDAY.

9:30 O'CLOCK A. M.

Religious exercises conducted by Brother W. G. Curry for thirty minutes.

Minutes read and adopted.

Brother Curry announced his readiness with Report on Missions, which he read.

REPORT ON MISSIONS.

Your Committee beg leave to report, as follows:

STATE MISSIONS.

The State Mission Board has diligently prosecuted the work of supplying the destitution in the State, employing during the year seventy-six men for all, or part, of their time. The churches have contributed something over \$\$,000 for this work. The building of new towns and the opening up of sections of the State by railroads call loudly upon us for more men and money. The appointment by the State Mission Board of a number of strong men in different sections of the State to do evangelistic work, we think, would greatly increase the efficiency of the State Mission work. Large contributions to State Missions would enable the Board to undertake this much needed work.

HOME MISSIONS.

This Board is laboring to supply the destitution in Florida, Louisiana, Texas, Arkansas, and the Western Territories, and is also supporting a mission in the Island of Cuba. The work of Diaz and others in Cuba is perhaps the most wonderful work of modern times. Only a little more than two years have elapsed since the organization of the first church on that Island. Up to last May, 1,100 had been baptized. In a single year these converts have contributed \$4 610. So marked has been ordered to enlarge its work in that quarter. As we turn our eyes towards Cuba we exclaim with wonder and astonishment, "What hath God wrought!"

FOREIGN MISSIONS.

This Board is prosecuting its work in Mexico, South America, Italy, Africa and China. Some of its most valued missionaries have passed away during the past year; but God is raising up others to take their places. The outlook in all the foreign fields is hopeful, especially so in Mexico, where the matchless missionary Powell has the work under his immediate supervision. A number of devoted men and women are now under appointment, and are ready to sail to their places among the taborers in the foreign field.

We would urge upon the pastors to get their churches to adopt some plan of regular collections for Missions, at least quarterly. As a plan which will suit the condition of most of our churches, we commend the envelope system. Your Committee believe that our churches will give liberally to Missions if the pastors will properly instruct them.

REPORT ON SUNDAY SCHOOLS.

Your Committee are gratified to report that all the churches of our Association have well sustained Sunday Schools, with a single exception. We would only urge on all a deeper interest in this important department of Christian service; that more than ever it be sought to make the Sunday Schools a spiritual force, and as far as possible, check all doubtful tendencies in connection with them.

Meeting called to order and Report on Literature read by Brother A Edwards, as follows:

REPORT ON LITERATURE.

The morals of a people and a community are formed and governed almost absolutely by the literature they read. The power of the press in our beloved country has done, and is doing, more to elevate the sentiment of the people than any other power in existence, save the Christian religion. Tis' true, as Solomon said, "Of making books there is no end; and much study is a weariness of the flesh," yet it is true the taste of the people is to read, and this is rapidly on the increase; hence the imperative necessity and duty of Baptists as a denomination, and as citizens of a great and growing country, to see to it that no books, papers, or magazines of low and grovelling drift, should come into their libraries, or that of their neighbors, if they can prevent it. We know of no agency that is more vicious in its tendency to demoralize and corrupt the young, than much of the dime novels and yellow back literature that is spread broad cast over our land to day. It is a fact that the United States has become a depository for all the outcasts and vicious of European countries. As we hear the tramp of the great influx of emigrants pressing their way to this land of freedom, it behooves us to place in their hands such periodicals and books as will ennoble and elevate the instincts of the strangers when they press their feet on our soil. It is a fact that men's piety may be measured by the literature they read, and the company they keep, hence the necessity of pure, religious literature. We would recommend to all, The Alabama Baptist, our own paper, and we urge every Baptist in the State to take and read it. The colportage system of our State Board affords good literature to every family. We also recommend the Sunday School literature of the American Baptist Publication Society, and of our Home Board, and of Kind Words, as the best for our Baptist Sunday Schools, also our Foreign Mission Journal, and our Home Field, published by our Home Mission Board.

Kill the gorgon intemperance with the sting of truth and manhood. It is pleasing to note that good society no longer counts a man worthy, who indulges too freely in drink. This will soon tell for good. There is no cause for temperance workers to give up the fight; a few defeats may only make the road to success safer for future travel.

We urge the necessity of these when it is possible, believing that much good will result therefrom.

The information that we have had was limited, but it shows that we have both a growth of membership and spiritual growth.
