### REPORT OF EXECUTIVE COMMITTEE.

Your Executive Committee beg to report :

That this Association having failed to appoint delegates to represent it in the State Convention, which convened with the Ruhama Baptist Church, December 15, 1897, the Committee appointed to serve in that capacity the following brethren, viz: J. P. Stiles, T. P. Waller, J. W. Minor, R. J. Waldrop, D. N. Talley, J. L. Hagler, D. D. Jones, S. R. Caffee, F. S. White and A. N. Hawkins.

The Committee employed Bro. F. H Watkins, Missionary Evangelist, for a period of three months, beginning November 1, 1897, and ending January 31, 1898. Compensation for his services was fixed at \$50.00 per month. Payments have been made to him as follows, viz:

The Committee, on January 10, 1898, agreed to give Brother J. E. Creel  $\$8.33\frac{1}{3}$  per month for his services as Missionary Pastor at Mary Lee, on condition that the church at that place would give him \$5.00 per month. The proposition was accepted, Brother Creel agreeing to preach there every Sunday.

The State Mission Board not being in condition to give substantial cooperation, and the Committee having no funds with which to pay expenses, nothing has been accomplished in the matter of utilizing the ministerial students of Howard College in the Mission work. For a like reason, the Committee did not engage a missionary to take charge of the work in this Association as contemplated in the recommendation adopted at your last sussession, and it is reported with regret that the work in this, the most important field in the State, has been practically abandoned.

The Committee calls attention to the pressing need for Mission and Church Extension Work at North Avondale, among a people brought in by the different manufacturing establishments at East Birmingham and the new cotton mills at Avondale.

The Committee calls attention to a similar need in the neighborhood of Ensly City, where the new steel plant is being erected, and the bi-product plant will soon be in operation. The Committee makes the following recommendations:

First, That a committee of members on Church Extension be added to the list of Standing Committees, and that Brother A. B. Johnston, President of the Church Extension Society, organized under the auspices of this Committee, be requested to report the work done by said society.

Second, That all State Mission funds be subject to the order of your Executive Committee until some satisfactory plan has been agreed upon by and between your Committee and the State Mission Board, whereby the work within the bounds of this Association can be resumed.

Third that all monies for State, Home and Foreign Missions, the Orphans' Home and Ministerial Education, be sent by the local church treasurers to the treasurer of the Association, M. M. Wood, Birmingham, Ala., together with a specification of the object for which it is intended.

Fourth, That the treasurer be required to keep a correct account of all monies so sent, and to forward the same without delay to the proper destination.

Fifth, That there be added to the list of standing committees, an auditing committee of two members, whose duty it shall be to examine the books of the treasurer, and perform such other duties as may be referred to it, and report to this body in regular session.

The churches are asked to raise the amounts in Table of Apportionment if possible.

# REPORT ON APPORTIONMENT.

The report was discussed by Brethren J. B. Gibson, J. V. Dickinson and A. B. Johnston, and pending the discussion, on motion of Brother Dickinson the report was tabled until the final report of the committee. (See item 35).

12. The report of the Committee on Young Peoples' Work, was called for and submitted by Brother B. D. Gray, as follows, viz :

#### REPORT ON YOUNG PEOPLES' WORK.

The hope of our denomination in the future depends largely upon the proper development of our young people. They must of necessity, soon be called upon to take the place of their seniors—must soon assume the leadership in pew and pulpit. The special purpose of the young peoples' movement is to help prepare them for this great work. A more thorough knowledge of God's word, a deeper spirituality, a more intense consecration, and a more intelligent method of Christian service, these are some of the ends to be achieved.

The work is steadily growing, and the educational features of the work are full of promise. A forward movement has been undertaken in the State of Alabama by the B. Y. P. U. State Convention. Some of the suggestions adopted by that Convention we would recommend to our churches: First, that all our local unions, as far as possible, adopt and study faithfully the Christian Culture Courses. Second, that officers and members of the local unions be urged to co-operate with the State Executive Committee in establishing unions in neighboring churches where no unions now exist. Fourth, that the members of unions be requested to contribute, through their churches, to the various benevolent enterprises of the denomination.

This work among our young people, seems to your committee, most admirably suited to our village and country churches where the services of the church are less frequent than in the cities where our great Baptist population is found.

14. Brother A. B. Johnston moved that the request of the church at Adger for a letter of dismission from our Association in order to join the Mud Creek Association, be granted, which was carried.

15. Brother A. B. Johnston offered the following resolution which was adopted, viz;

"*Resolved*, That in connection with and immediately succeeding the report of the committee on the letters of the churches, there shall be opportunity given for verbal reports on the condition of their respective churches, by the messengers, and that they be encouraged to make such verbal report."

The hour for adjournment having arrived, the body adjourned to 7:30 Р. м.

### FIRST DAY-EVENING SESSION.

After a prayer and praise service the Association was called to order by the Moderator at 7:30 P. м.

16. The reports on Missions was called for and read as follows, viz:

#### REPORT ON STATE MISSIONS.

The position of the State Board of Missions in our system of mission work is by few of the Baptists of Alabama correctly estimated. The object of this report will be to place before this body a plain statement of the objects for which this Board was created and to strive thereby to awaken a deeper interest in its work.

1. To the State Board is committed all the interests of missions in Alabama, including the interests of the Home Mission Board, at Atlanta, and the Foreign Mission Board, at Richmond. The employees of the State Board are careful to look after these several phases of missions, realizing that distinctions between them are only in name, each having in view the same grand purpose, viz: the extension of Master's kingdom among men in obedience to His command. Your committee deem it important that the fact that the State Board has in hand all these interests of missions, be clearly set forth, for a contribution to the support of the State Board is indirectly a contribution to the Home and Foreign Boards. Attention is called to the evident fact that the prosperity of every phase of the mission work depends upon the prosperity of the State Board. If its policies are vigorously sustained, good results will be seen in every department of our work. Each consecrated man put on the field in Alabama, whether as evangelist, missionary pastor or colporteur, adds one to the number who have at heart every interest of the Master's Kingdom.

2. The State Board is engaged in the following special lines of work :--

First—Evangelical. This means the employment of consecrated men to travel and preach among the churches striving to awaken a deeper interest in the cause of missions at home and abroad, as well as visiting destitute regions and preaching to the lost the peerless Gospel of the blessed God. Of these men there are at present under the employment of the Board Brethren A. J. Preston, Southeast Alabama, W. A. Parker, Sr., in the Southwest, J. W. Sandlin, in the Northeast, and Jos. Shackelford, in the Northern part of the State. The importance of this work can be better appreciated when we remember that out of the 120,000 white Baptists in the State not more than 12,000 are making contributions to missions. To add to the number of regular contributors to the cause is greatly to be desired and must be done if we hope to enlarge the work and to do anything like what ought to be done in Alabama for the advancement of the Master's kingdom.

Second.—Missionary Pastoral Work. The work consists in helping to support pastors at important points that give promise of soon growing into self-sustaining churches. Beyond question the brightest page in the history of the State Board is that page that gives record of the work that has been done in this department of labor. There are more than a score of churches that are now strong and self-supporting that in their early history were sustained by the State Board—indeed, many of them were planted by the Board. But while it is true that a grand work has been done, "there remaineth yet much land to be possessed." Many destitute fields are sounding the Macedonian cry, "Come over and help us," but lack of means prevents the Board from responding favorably.

It is proper to say in this connection that the Secretary of the Board gives much of his time to missionary and evangelistic work.

From these very brief statements we can gather some conception of the important work that is being done by our State Board of Missions. That this work commends itself to our hearty sympathy and support is a most evident proposition. Just at this time your committee is in position to know that the Board is sadly in need of funds. The secretary is struggling to pay the indebtedness of the Board to its employees. Some of these have not been paid in the last year. Your committee speaks with authority when it assures this Association that the State Board of Missions was never in so pressing need of help as now; and we would urge the churches that in the very near future they make a special contribution to this work.

#### REPORT ON HOME MISSIONS.

The recent war with Spain and the consequent acquisition of new territory in the West India Islands has greatly enlarged the demands upon our Home Mission Board. A great opportunity is presented to the Baptists in this new territory, and we shall need to greatly increase our contributions to this Board.

The following is taken from the last report of the Board of the Southern Baptist Convention :

#### FINANCIAL.

"The amount raised and expended on the field for Home Missions this year, is \$54,251.04 against \$45,671.82 last year. There have been collected and expended in building houses of worship this year, \$56,385.46 against \$51,540 last year, making a total of money raised on the field, \$110,636.50 against total raised on the field last year of \$97,211.82, an increase of \$13,424.68. Total cash received by the Board from all sources has been \$86,887.27 against \$83,184.31, an increase of \$3,702.96."

"In addition to the fifty thousand dollars raised by our Missionaries and expended in building houses of worship on their fields, the Board has invested more than \$10,000 in cash in places of worship.

#### SUMMARY OF WORK.

The summary of work for the past conventional year is as follows:

Missionaries, 467; weeks of labor, 11,407; churches and stations, 1,960; sermons and addresses, 49,306; prayer meetings, 10,359; religions visits,

59,841; baptisms, 4,739; received by letter, 9,509; churches constituted, 103; houses of worship built, 45; houses of worship improved, 68; Sunday schools organized, 297; teachers and pupils, 7,710; bibles and testaments, 4,668; tracts distributed, (pages) 1,580,741."

Your committee would recommend in view of the pressing needs of the Board, that special effort be made to largely increase our contributions for the coming Associational year.

#### REPORT ON FOREIGN MISSIONS.

The last words of our risen and ascending Lord, were: "Go ye therefore and teach all nations."

In direct obedience to this command, Southern Baptists, have through their Foreign Mission Board, opened Missions in six heathen and papal countries, viz: China, Africa, Italy, Brazil, Mexico and Japan.

The promise of Christ, "Lo, I am with you," has been verified in our work. Success has attended the efforts made, and we are encouraged to go forward. The great work which engaged the thought and heart of the World's Redeemer, is taking hold of His people as never before.

The hosts of Israel are just waking up to the great responsibilities upon them, and the doors open to them; and yet we are not doing a tithe of what we ought to do. God requires no impossibilities of His people; and when the door is opened to us, and He says, "Go in and possess the land," it is because we are able." To refuse to enter is to be disloyal to our King. The opportunity to do good, implies the obligation. God is opening the world to the gospel, and He is honoring our nation with the privilege of giving to the nations of earth, not only the best form of government ever enjoyed by any people, but also the great privilege and opportunity of giving to these nations, the pure gospel of the Son of God.

The late war with Spain has opened to us new doors, which should be entered at once. Graver and weightier responsibilities are thus laid open to us.

A once down-troden, priest-ridden, oppressed people, freed from the yoke of bondage and tyranny, by the omnipotent hand of God, through American arms, now appeals to us in stronger and louder tones for the glorious gospel of the blessed God, which makes men free indeed. We cannot close our eyes to these opportunities, or stop our ears to their cry. Having been permitted under the blessing of God to accord to them religious liberty, it now devolves upon us to teach them the right way, and help our fallen brother rise. Let us lift up our eyes and view the fields already white unto the harvest, and as we look let us thrust in the sickle, and reap the golden sheaves for the Master's use.

We have a total of 102 churches on the foreign field, with 4,760 members, and 92 out stations, where doubtless churches will soon be organized. In conclusion, I quote the closing words of the last report of our Foreign Mission Board. "With grateful hearts we look back over the past. Years ago our fathers laid strong foundations, and we have entered into their labors, when we review seven years—that is, from 1891 to 1898. We find that in 1891 we had 38 main stations. 2,377 members, 361 baptisms, and the contributions from the home churches were S111,600.03. Since 1891 our Missionaries have baptised 4,122 professed believers. This number is much larger than the entire membership in 1891. Surely we have here great cause for gratitude, and great incitement for more vigorous effort. Let us remember that nearly two hundred workers (including Missionaries and native helpers) represent us on foreign fields. God, through the v, is leading us on. Let us follow."

It is with profound gratitude to God, that we note that our Foreign Mission Board this year was able to report all debts paid, and \$2,975.96 in the treasury, at the late meeting of the Southern Baptist Convention. In 1896, our Foreign Board went to the Convention with a debt of \$31,900,71. In 1891, with a debt of \$13,532,79. This is indeed encouraging, and yet of this sum, Alabama, with a membership of 119,454, gave \$5,950.74, and average of 04.9c per member. "How much owest thou my Lord?" The total amount contributed for Foreign Missions last year was \$124,249.69. Our Association last year, with a membership of 4,353, reported \$446.95 for Foreign Missions. Let earnest prayer rise from all hearts to God for His blessing upon the work.

18. The Association was called to order by the Moderator at 9:30 A. M., and after prayer, the discussion of the reports on Missions was continued by Brethren Jas. Hagan, A. B. Johnston, W. R. Ivey, J. A. Glenn, R. H. Hendon, J. G. Lowrey and M. P. Lewis.

19. At this juncture, Rev. Dr. Butt, pastor of the Methodist Episcopal Church, South, was introduced to the Association and invited to a seat in this body.

20. The hour having arrived, the Missionary Sermon was preached according to appointment by Elder J. V. Dickinson. Text: Matt. 28; 18–20. After the sermon a collection for Missions was taken, amounting to \$22.74, and the reports on Missions were adopted.

21. The following resolutions were presented by Brother N. B. Williams, and adopted, viz:

" Resolved, That we re-affirm our loyalty to the State Mission Board."

"*Resolved*, That it is the conviction of this body, that it is of first importance that the debt of that Board be at once, if possible, attended to by the churches."

"Resolved, to this end, That it be recommended that collections be taken before the meeting of the State Convention in November."

Adjourned in order.

## SECOND DAY-AFTERNOON SESSION.

After a prayer and praise service, conducted by Brother J. M. Huey, the Association was called to order by the Moderator at 2:30 P. M.

22. The report of the Committee on Moral and Spiritual Conditions was called for and read by Brother A. B. Johnston, and after being discussed by Brethren A. B. Johnston, B. D. Gray, J. V. Dickinson, J. A. Howard and J. B. Gibson, the report was recommitted, and Brother B. D. Gray added to the committee. (See item 30).

23. The report on Religious Literature and Education was called for and read by Brother B. D. Gray, as follows, viz:

REPORT ON RELIGIOUS LITERATURE AND EDUCATION.

An antidote for the worthless and harmful literature so prevalent in our day, is a sound religious literature. Never before in the history of the world

has the printing press been so powerful as now. Cities, villages, hamlets, and the rural regions, are being flooded with all kinds of pernicious literature. In the place of all this mischievous stuff we should put sound, wholesome religious literature. Of course, at the head of the list we must put the Bible, that great purifier of the mind and heart. In every home, and for each member of the home, let there be a copy of God's word. The Bible, and the Bible alone is the religion of Baptists. It is our stronghold. When we put the chief honor upon the oracles of God, we may justly expect that He will send His blessings upon our people.

The literature of the Sunday School Board of the Southern Baptist Convention, Nashville, Tenn., is constantly growing better, and has become a great factor in the development of our people. We most heartily commend it to the support of our churches.

The Alabama Baptist, our denominational organ for the State, is open to brethren for the advocacy of all our work and can be made an ever-increasing factor in the upbuilding of our work. We need it, and it needs us. We recommend it most cordially to our people.

The Birmingham Baptist, the organ of the Birmingham Association, is especially set for the development of Baptist affairs in the bounds of this Association. It in no way conflicts with the State paper, and its low price, only fifty cents, should give it a wide circulation.

We most cordially recommend the circulation of good Baptist books among our people. Our people must become more intelligent, if they enlarge in usefulness.

In educational lines, we have reason for great encouragement. The Judson, at Marion, under the scholarly and vigorous leadership of Dr. Patrick, has removed its burdensome debt and is in a most prosperous condition. To name the Judson is to suggest thoughts of culture, refinement, thoroughness and true womanhood. The prospects for a great attendance for the coming session are first-class. The Central Female College of Tuscaloosa, while not under the control of our State Convention, is in every way worthy of our patronage, furnishing as it does, honest, thorough work, and situated most favorably for the development of a great section of our State.

The Howard College, the pride of all our people, is in better condition than for years past. The teachers are capable and consecrated to their work. They need our hearty support. The Birmingham Association should have a hundred boys in Howard College. We have in the College a great agency for the development of this growing and needy field. Shall we not use it for our good and for God's glory ?

29. Brother J. W. Stewart, Superintendent of the Orphans' Home, upon invitation, addressed the Association in the interest of the Institution, and received privately, four dollars and fifty cents.

30. Brother A. B. Johnston re-submitted the report on Moral and Spiritual Conditions, (see item 22) which was adopted without discussion, as follows, viz :

Your Committee on Moral and Spiritual Conditions beg to report that as there is a difference of opinion as to the scope of the duty of the Committee, this report is confined to the moral and spiritual condition of the churches. Your Committee regrets that it cannot report a satisfactory condition, while the churches exert an ameliorating and restraining influence on the more outbreaking sins and corruptions of the worldly minded, it is also true that the vanities, follies, and modes of thought of the world have invaded the churches to such an extent that in many cases it is hard to distinguish a professed Christian from the man who makes no such profession.

As far as outward appearances are concerned, if the fruits of the Spirit are love, joy, peace, long-suffering, gentleness, goodness, faith, meekness, temperance, and if they that are Christ's, have crucified the flesh with the affections and lusts, then it will only take a little introspection to show each one of us how far short of perfection we come, and the reason for our lack of that beneficent influence, we should exert upon the world, is not far to seek. We need a deeper work of grace in our own hearts, and a more complete consecration of our own lives, together with a willingness to do anything in order that we may prove our love to God and man before we can let our light so shine that men will take note of us that we have been with Christ and have learned of Him.

33. On motion of Brother J. B. Gibson, the Association ordered the collection taken for Missions on yesterday to be all paid to State Missions, and another collection for State Missions was taken amounting to two dollars and fifty-nine cents.

34. By general consent the regular order was suspended, and Brother H. H. Brown submitted the report on Ways and Means, as follows, viz:

## REPORT OF COMMITTEE ON WAYS AND MEANS.

By recommendation of the Executive Committee, this Association, at its last session established a new standing committee, to be known as the Committee on Ways and Means, and its duty was laid down as follows: "It shall be the duty of the Ways and Means Committee to search out the best methods of financiering that may be employed in our religious work."

The duty thus enjoined raises the most important question that now, under existing circumstances, concerns "our religious work," and it is well that the Association has made this one of the subjects to receive special attention at its sittings.

The government established by the "King of Kings," through which "our religious work" is to be accomplished, requires work and money, ("ways and means") and each and every subject of the Kingdom is under a moral and binding obligation to contribute to the support of it. The obligation is personal, purely so, and there are principles which must control the citizens in making their contributions for the support of the government, and these principles are fixed, and they are, together with the plan or mode (we will not say modes) of giving money, plainly and specifically set forth in the Bible, which is the Constitution and laws of the Kingdom. There is not, however, in said Constitution and Laws, any power given to levy a specific tax upon the citizens of the kingdom, nor is there any authority for adopting compulsory methods of collecting what might be considered due from them, each citizen being personally responsible to the King, and to Him only, for the manner in which he may discharge his duties in the premises.

According to the teachings of the Bible upon the subject of giving money to carry on "our religious work," such gifts should be made solely and purely as offerings to the Lord, and there must be a proper motive. And there must be connected with these offerings: First, Faith.—" By faith Abel offered unto God a more excellent sacrifice than Cain." Heb., 11:4. Second, Heart consecration and entire freedom of will. "Every man, according as he purposeth in his heart so let him give, not grudgingly, or of necessity, for God loveth a cheerful giver." 2d Cor., 9:7. Third, Regularity as to time and reference to ability. "Upon the first day of the week let every one of you lay by him in store as God has prospered him." 1 Cor., 16: 1. Fourth, Offering in connection with worship. "And Jesus sat over against the treasury and beheld how people cast money into the treasury." Mark, 11: 41.

Many more proofs of the mode of giving and cf the principles which must control the gifts can be found in the Word of God, but time and space forbids me here.

Once the necessary amount of money is regularly secured, the work of expending it should be done in a business-like way, economically, with as little machinery as possible, and looking solely to the best and highest interests of the great cause of saving souls.

### THIRD DAY-MORNING SESSION.

The Association was called to order at 8:30 A. M., and Brother N. B. Williams led in prayer.

35. The final report of the Executive Committee was read by the Chairman, Brother J. B. Gibson, and inserted in the first report, (see item 7) which was taken from the table and the discussion continued by Brethren J. B. Gibson, W. C. Bledsoe, H. H. Brown, J. V. Dickinson and R. H. Hendon, and adopted.

36. Brother D. N. Talley submitted the report on Sunday Schools, as follows, viz:

#### REPORT ON SUNDAY SCHOOLS.

#### TO BIRMINGHAM BAPTIST ASSOCIATION;

We find upon investigation, that the status of the Sunday School interest is about what it was at last session.

The reported enrollment is about half that of our church membership, which indicates that not more than one-third of our church members attend the Sunday School.

The wide difference between the enrollment and the average attendance indicates also a sad state of affairs, the average attendance being only 58 per cent. of the enrollment. These two facts, revealed by the letters from the churches, call for your most serious consideration.

One of the hinderances to higher and better Sunday School work is the neglect of parents and church members to attend the schools, become members and zealous workers, thereby setting living examples for the young.

If parents were to so enlist, and become interested, there would be less disposition to turn the spiritual welfare of the children over to others; there would be no impassable gulf between parent and child. Often you hear parents say they cannot talk to their children about their salvation. This difference alone rests upon the parent and not the child. Parents have made this great distance; this is contrary to the child's nature, and therefore rests upon the parent. This state of affairs should never exist. When the entire family are members of the Sunday School, the lesson becomes a home topic, or can and is a subject which the entire family can discuss, child with parent and parent with child, and in this way the child soon becomes interested in Sunday School work. The shrewd parent can now begin to impress upon the child the importance of his personal salvation. And if parents will only become members along with the children, forming as you see a kind of partnership with them, lessoning the difference in age and character, giving all the time into the hands of the parents, more and more power for good over the child, and growing themselves in knowledge and grace, living more consecrated lives themselves, (a natural consequence of such lives) all the time making and moulding finer characters in the young, living higher and higher each day, carrying the young higher, leading them into pastures of usefulness, developing into such men and women as the Master would have them, men and women who can and will take the front in Church and State, making as you see, great pillars of strength in the Master's kingdom. I ask, would it not make the humble hearts of christian parents well up in everlasting praise to God, to the founder of Suuday Schools, to the faithful teacher, and to those who influenced them to become Sunday School scholars? The question now arises how are we to enlist the parents and church members? This has been tried time and again in the Sunday School of which I have the honor to belong, and has partly failed. I am persuaded, my brethren, that the pastors of our churches, on their rounds, making pastoral calls, could wield a mighty influence in this direction, speaking to the children in reference to Sunday School work, turning to the mother, impressing upon her the

necessity of her becoming a member along with the children, thereby gaining more and more influence over the child, and impressing upon the mother, that she has and should have much to do with the conversion of her child. I am persuaded that much of the stay-at-home parents would come to naught. Of course, there are families where old age, sickness, and in some instances, distance and bad weather may keep away. Then we would recommend the home department, and with the workings of this department the Sunday School will begin to grow in interest and number, and when the Sunday School takes on this new life, our treasury will also begin to be filled, our entire Sunday School and church grow into a real Missionary Sunday School and Church. By this plan, or some other, you bring our people together oftener, exchange ideas, by great plans, plans that expand our own views, open up avenues of usefulness for good, all school and church working together as one mighty host. Then, and not until then, will we as Christians, begin to live on that higher plan of usefulness that it is our privilege, and duty as well, to live on.

We would suggest, finally for your consideration, that it would be a good thing in the building up of our Sunday School, to make this work more prominent in annual meetings, and as one means to this end, in some way secure the attendance of all Sunday School Superintendents at these meetings, and that these Superintendents be requested to make short talks on their schools.

39. Brother J. V. Dickinson offered the following resolution, which was adopted without opposition, viz: " Resolved, That this Association desires to record its opposition to the liquor traffic and intemperance."

40. Brother J. G. Lowrey moved that "the thanks of this body be tendered the Moderator and Clerks for their very kind and efficient services," which was adopted.

41. The business of the session having been completed, after singing and general handshaking among the messengers, Dr. B. D. Gray led in prayer, and the Moderator declared the body adjourned.
