WILMINGTON, DEL., October 17th, 1899.

On account of the unfinished improvements of the Central Church, the Synod of Baltimore met in the First Presbyterian Church of this city, at 8 p. m., and was opened with a sermon by the retiring Moderator, the Rev. McCullough of Eastern Church, Washington City Presbytery, to the Synod of Baltimore in 1897, would respectfully report that we have examined the case and find an order of the General Assembly of May 22, 1899, page 45 of the minutes, directing the Synod of Baltimore to try and issue the case according to the provisions of the Book of Discipline. Therefore, we recommend, that the appeal being in order as declared by the Synod in 1897, that Synod proceed to try and issue the case according to the provisions of the Book of Discipline, and that a Judicial Commission be appointed to try the case.

JUDICIAL COMMISSION.

The Moderator appointed the following a Judicial Commission:

Revs. Thos. A. McCurdy, James E. Moffatt, Samuel A. Gayley, William Fitz Simon, Henry Branch, John L. Allison; Elders John A. Nicholson, Ashton R. Tatnall, Isaac Baird, William Reynolds, O. F. Day, Wm. C. Vogts.

FOREIGN MISSIONS.

The Chairman of the Standing Committee on Foreign Missions rendered its report, which was accepted, and its recommendation adopted, as follows:

Resolved, That the Pastors and Elders of this Synod make the cause of their King in foreign lands a matter of more personal concern this year than ever before.

DEVOTIONAL EXERCISES.

Synod spent half an hour in Devotional Exercises.

At 12 o'clock Synod took recess until 2 p. m.

At 2 p. m. Synod resumed business.

Education.

The Standing Committee on Board of Education made a report, which was accepted, pending its adoption Rev. E. B.

Hodge, D. D., Secretary of the Board of Education addressed the Synod, after which the recommendations of the report were adopted:

- 1. That while we press upon Church Sessions the duty of seeking out suitable young men for the ministry, they be advised to use great care and proper discrimination in their selections, and that Presbyteries require fuller and broader preliminary examinations as to the qualifications of candidates and their fitness for the ministry.
- 2. That Presbyteries exercise a stricter oversight of their candidates and probationers, for which purpose the use of printed forms might be inaugurated.
- 3. That the Presbyteries be instructed to give careful attention to the matter of placing their probationers, inducting them preferably into the weaker and mission churches; to have especial oversight of all their vacant churches, and to use earnest effort to employ all their ministers.
- 4. That the last Thursday of January, 1900, be observed as the Day of Prayer for Colleges, and that on the following Sabbath (28), Pastors are requested to preach on the work of the Church, its needs and hindrances, or subjects kindred thereto.
- 5. That the subject of a Synodical Conference for considering plans and methods for carrying on the work of this Board be canvassed by the Synodical Committee, in conjunction with the Presbyterial Committees, and if approved, that proper arrangements be made for holding the same, whereof due notification shall be given to the churches.
- 6. We recommend the work of the Board of Education, congratulating it on its freedom from debt, heartily sympathizing with it in its contention with adverse forces, which seem to be at the present time in the ascendent, and making special reference to the excellent report of the Corresponding Secretary to the last Assembly, as comprehensive, timely and suggestive.

SUSTENTATION.

The Standing Committee on Synodical Sustentation made a report, which was accepted, and the recommendations adopted. (See appendix to these Minutes.)

HOME MISSIONS.

The same Standing Committee made a report on Home Missions, which was accepted, and its recommendations adopted:

1. That we exhort the churches under our care to make liberal

contribution to the work of the Board of Home Missions, remembering its importance for the future of our land and of the world; and encouraged by the removal of the debt, which assures them that their gifts will be devoted to present labors in the Gospel.

- 2. That the report of the Women's Synodical Home Missionary Society be approved, and that they are most heartily commended for their zeal and success in the work.
- 3. That the election of officers by the Woman's Synodical Society for the coming year be approved.

FREEDMEN.

The Standing Committee on Freedmen made a report, which was accepted, and pending the adoption of the recommendations the Rev. W. H. Weaver, D. D., agent of the Board of Freedmen, addressed the Synod. The recommendations were adopted, as follows:

- 1. Synod heartily endorses the plan that was adopted by the last General Assembly to rid the Board of debt, and urges all its churches to promptly meet their portion of the obligation independently of their annual contributions to this cause.
- 2. Synod earnestly commends this worthy cause to the liberality of all its churches, and urges them not only to contribute to this cause, but to make persistent effort to increase their offerings to at least the average of the whole church, which last year was 14 cents per member.

SACRAMENT OF THE LORD'S SUPPER.

The Committee of Arrangements made a further report, which was accepted and adopted, as follows:

The Committee of Arrangements would report, That in the administration of the Sacrament of the Lord's Supper, the Moderator preside and introduce the ordinance; Rev. Henry Branch, D. D., to offer the prayer of consecration and administer The Bread; Rev. Asa S. Fiske, D. D., to administer The Wine and to offer the prayer of thanksgiving.

That the following Ruling Elders serve in the distribution of the Elements, viz: L. P. Bush, I. S. Baird, M. D. Crossan, Thos. K. Porter, William M. Canby, J. Frank McCoy, Charles S. Howland, C. B. Bailey, T. C. Steward, J. A. Nicholson, R. L. Ewing, E. G. Polk.

Synod took Recess until 8 p. m.

At 8 p. m., Synod reassembling the Synodical Sermon, on the text, John 17: 19, "And for their sakes I sanctify myself that they also might be sanctified through the truth," was delivered by Rev. Geo. L. Curtis of the Baltimore Presbytery.

The Sacrament of the Lord's Supper was then administered, according to previous arrangement.

Adjourned with the benediction.

THURSDAY, October 19th, 1899.

Synod assembled at 9 a.m., and was opened with prayer. The Minutes of yesterday's session were read and approved.

JUDICIAL COMMISSION.

The Judicial Commission appointed by the Synod to try the appeal of N. N. McCullough, referred back to Synod by the last General Assembly, presented a report which was ordered to be made a part of the record of the Synod, and is as follows:

In matter of McCullough vs. Hopkins referred by the General Assembly to Synod of Baltimore, and on report of Judicial Committee to a Judicial Commission.

The Commission met on the call of the Chairman, Rev. Thos. A. McCurdy, in the annex of West Presbyterian Church, Wilmington, Del., Wednesday, October 18, 1899, at 2 p. m. Present—Revs. Thos. A. McCurdy, James E. Moffatt, Samuel A. Gayley, William Fitz Simon, Henry Branch, John L. Allison; Elders John A. Nicholson, Ashton R. Tatnall, Isaac Baird, William Reynolds, O. F. Day and Wm. C. Vogts.

The Commission was duly constituted with prayer and solemnly charged by the chairman. The action of the Assembly referring the matter to the Synod of Baltimore was read, and the action of the Synod referring it to this Commission was read. Whereupon it was decided to hear the appellant and representatives of the inferior judicatory on the question of entertaining the appeal. After discussion the appeal was entertained and the case issued in accordance with the provisions of the Book of Discipline, Chap. IX, Art. IV, Sec. 99. The specifications of error were voted upon separately and each one not

sustained by a unanimous vote, and the judgment of the inferior Court affirmed. The minutes were read and approved, and ordered to be signed by the chairman and secretary.

NARRATIVE.

The Committee presented the following, which was approved:

A review of the Narratives of several years preceding the present one, reveals the fact that there has heretofore been much difficulty in securing the necessary information from the several Presbyteries in time to make out a satisfactory report to Synod, one brother expressing his perplexity at the meagreness of his information by confessing to a painful sympathy with the Israelites of old, who were required to make bricks without straw. The present Committee is glad to report, however, that the straw together with the other necessary material, has been forwarded long enough in advance to permit the making of the bricks that compose the Synodical Narrative of 1899.

The following report covers, as far as is known, all of the churches in two of our Presbyteries, and fifty-nine out of sixty-four and one Mission in the third.

Congregational Worship.-Divine services have been held with regularity throughout the year in nearly all of the churches, most of them having two services every Sunday, a few of the smaller ones holding one service, and in the more remote districts, service being held at less intervals. The attendance has in some cases been encouraging, in others discouraging. Too often many professing Christians allow the most trival matters to keep them away from attendance upon the stated means of grace. That they should heed the command not to forsake the assembling of themselves together, should be strongly impressed upon them. It is gratifying to note that in some of our churches, the children and young people are very faithful in their attendance. In two churches of Baltimore Presbytery all of the young people attend divine worship, and in several other churches of that Presbytery, an excellent showing is made by the children in this particular. Cannot these young lives, full of energy and enthusiasm be enlisted to interest some of the older people of their homes and community, so that the latter may be brought nuder the influence of the preaching of the gospel?

The mid-week service is held regularly in many of the churches throughout the year; some suspend it during the summer. Others, and we are glad to say that the number is small, held no week night service at all, either in the church or in the homes of the people. There may be, and doubtless are, special reasons in these cases.

Sunday Schools.—Every church in the Synod, so far as reported, has one or more Sunday Schools in connection with its work. The Westminster Helps are used in most of them, and the Shorter Catechism taught with more or less fidelity—we fear with less rather than with more in a number of our schools. Some of them neglected it altogether. We would urge upon these the importance of taking up this branch of Presbyterian training, that the children of the present generation may not be less wise in their knowledge of this compendium of theology than were their parents and grandparents, who were drilled and instructed in the Catechism in the days of their youth.

Teacher's meetings are held regularly only in a small proportion of the schools; thirty-two (32) schools in Baltimore Presbytery, and forty-two (42) in New Castle Presbytery holding no such meetings at all. The Presbytery of Washington is silent upon this point. As quite a number of the Schools report discouragements, the question might well be raised whether these in some measure might not be removed, and the efficiency of the school promoted by the holding of teacher's meetings regularly, when the needs could be discussed and plans formulated for the betterment of the work.

Hindrances of various sorts in the Sunday School work are reported by a number of the Schools; but on the whole, this branch of the church's work is encouraging. The outlook is bright. The hope is with the children, who if rightly instructed now, will in coming years be the faithful and zealous laborers in the church. Among the encouraging features mentioned are, "success in the home department," "additions to the Church," "deep spiritual interest," "earnest and faithful workers."

Societies.—Of societies among the men there are very few, only sixteen (16) churches in the Synod, so far as reported, having such organizations. Surely there is a field for development among the men of our Church as well as among the women; and the interest and energy of the former as well as of the latter should be aroused and engaged.

The women have organizations for local and missionary work in nearly all of the churches, and they aid greatly in these causes.

Christian Endeavor Societies are found in nearly every church, some having in addition to the Senior, Intermediate and Junior branches of this work. Most of these are reported as doing earnest, faithful service.

Spiritual Conditions.—While there has been no unusual awakening spiritually throughout the entire bounds of the Synod, yet many churches have been richly blessed and 22 report great cause for en-

couragement and thanksgiving. In one Presbytery, 9 churches state that they observed special days of fasting and prayer, and it is significant to note that the Presbytery reporting this has 12 of the 22 churches that mention unusual religious interest. Is there not a connection here? It was when the apostolic church continued in fasting and in prayer that the blessings from heaven came. May not the churches of our Synod have similar blessings, if the necessary conditions are met?

The difficulties that are mentioned as hindering the work are of various kinds, intemperance, worldliness and indifference being chief among them. Despite these obstructions, the gospel has been faithfully preached, and over one thousand members have been added to the churches during the year.

Benevolence.—It is gratifying to note that a large number of the churches report a growth in giving in accordance with ability. The Bohemian and Moravian Church, of Baltimore, has the splendid record of having given three times as much this year as last. It is not at all without the sphere of possibility, for many others to follow this worthy example during the coming year.

One command which has been too long neglected and too often disobeyed is to "Honor the Lord with thy substance and with the first fruits of all thine increase." Giving as a joy and a privilege seems a paradox to those not instructed in this grace. One of the great needs therefore of the church today is that its wealth should be consecrated, and that its members should bring the first fruits of all their increase to God.

The financial obligations in the local fields are being met in most cases with fidelity. Many of the churches are contributing to all of the Boards. It is a cause for regret, however, that some do not. Every church should feel its privilege as well as obligation in this respect, and give something to every Board, even if necessarily small, so that there shall not be a single church in the Synod delinquent in this regard.

Many of the church societies, such as C. E. and women's organizations, are doing a most commendable benevolent work. Nor does this help, which is given in most cases for causes outside of the local field, interfere with the proper provision for the poor in the field.

Family Religion.—From the reports submitted, there is reason to believe that in many cases, family religion is not what it should be. The family altar is too often neglected, and in too many instances has no longer a place in the family life. The training of the children is left in a great measure to the Church and to the Sunday School, and while these agencies under God can do much, they cannot, however, take the place of the home. Christian parents should therefore be

shown their duty to train their children in the fear and admonition of the Lord, and to present to them not only precept but example.

Miscellaneous.—The recommendation of the General Assembly for the observance of special days is complied with to some extent, Children's Day being the most generally kept. Some moral reforms are reported as being vigorously pushed in the Presbytery of Washington. Church Sessions in the main, observe a reasonable oversight of the various organizations of the work.

Such in brief is the narrative of the state of religion within the bounds of our Synod, and while there are many causes for encouragement, there is also reason for serious reflection on the part of all of the churches, to resist the tide of worldliness which is steadily and surely advancing. May God deliver us from the form of Godliness, without its power.

TEMPERANCE.

The Standing Committee on Temperance presented a report, which was accepted, and the recommendations were adopted:

- I. That this Synod urges greater fidelity among our Pastors and Elders, in making returns in future to their Presbyteries as to the progress of Temperance within their bounds, in compliance with the request of the General Assemblys Permanent Committee.
- 2. That our Sessions will endeavor to enlist the entire church membership, Young People's Societies and Sabbath Schools in this reform movement, and secure a wider distribution of literature showing the perils to which the home, the State, and Church of Christ is subjected by this iniquitous system known as the liquor traffic.
- 3. That to advance this important reform, and aid the Permanent Committee on Temperance to prosecute their mission, increased contributions be made by all our churches the coming year.
- 4. That we regard the rental of property for the sale of intoxicants, as well as sanctioning the evil by signing applications for license, to be a violation of our church covenant as aiding and abetting the sworn antagonist of Christ's kingdom.
- 5. That in accordance with the recommendations of the General Assembly our churches be requested to observe Temperance Day during the month of October.
 - 6. That as a Synod we utter our emphatic protest against the

retaining of the beer canteen in the army of the United States, in plain violation of the will of the people and interpretation of Congressional enactments, and that an immediate appeal be made to President Mc-Kinley for its instant suppression, and that the Stated Clerk send a copy of this resolution to the President of the United States and the representatives in Congress representing the districts covered by this Synod.

MINISTERIAL RELIEF.

The Standing Committee on Ministerial Relief made a report which was accepted, pending its adoption the Synod listened to an address delivered by Rev. B. L. Agnew, D. D., Secretary of the Board. The recommendations were then adopted, as follows:

- I. That the peculiar claims of this Board be urged upon the Eldership of the Synod, that they may use their best efforts to enlighten and interest the Churches in this cause.
- 2. That as far as possible each Session shall appoint one or more of its members to co-operate with the Pastor in securing offerings for this cause.

The order of the day having arrived the Synod spent one-half hour in Devotional Exercises, and at 120'clock took Recess.

At 2 p. m. Synod resumed business.

AID FOR COLLEGES.

The Standing Committee on Aid for Colleges reported, and the recommendation was adopted, as follows:

That the Board is to be congratulated on its year of prosperity, and commended for its wise and economic administration, and is hereby assured of our cordial co-operation and support in its high aim to place Presbyterian educational work at the front in the new Northwest.

Systematic Beneficence.

The Standing Committee on Systematic Beneficence made its report, which was accepted, and its recommendations were adopted, as follows:

 That this Synod urge all its churches to adopt some plan of systematic giving to every Board, according to Chapter VI, Directory of Worship, and to this end that it may be made an item of regular business at the October meeting of each Presbytery annually to call the roll of the churches and hear their responses on this matter, and their reasons for not contributing shall not be sustained unless they are special and satisfactory; this being in accordance with the recent recommendation of General Assembly.

- 2. That the attention of Pastors, Stated Supplies and Sessions be especially called to Chapter VI. of the Directory, "On the Worship of God by Offerings," and that they be urged to conform the worship of the sanctuary thereto; as is also recommended by the General Assembly.
- 3. That the Assembly Herald be again commended to all our churches as a valuable means of information as to the opportunities and needs of our Church in its work of extending the Kingdom.

Publication and Sabbath School Work.

The Standing Committee on Publication and Sabbath School Work presented their report, which was accepted. After an address by Rev. E. R. Craven, D. D., Secretary of the Board, the recommendations of the report were adopted, as follows:

- 1. That the Home Department be more generally utilized by the Sabbath Schools of the Synod as a means of arousing interest in Bible study among parents, the aged, and the sick.
- 2. That Pastors and Sabbath School Superintendents be urged to encourage the memorizing of Scripture and the Shorter Catechism by the scholars of their schools.
- 3. Recognizing the importance of the missionary work of the Board, that the Pastors and Sessions be requested to use all diligence to secure an annual contribution from the churches for this object, and that those now giving endeavor to increase their amounts.
- 4. That the Superintendents of our Synod be urged to introduce the "Twentieth Century Movement" at once, and arouse their schools to put forth an earnest and prayerful effort to do their part in winning the half million of new scholars as an offering of our Church to Christ at the entrance into the new century. That our churches be called to united prayer for this movement.

CHURCH ERECTION.

The Standing Committee on Church Erection presented their report which was accepted, and the following recommendation was adopted: That in view of the fact that forty of our churches contributed nothing to the cause during the past year, the Synod lays it upon the hearts and consciences of the Ministers and Elders to see that an offering is made to this Board this year by every church in connection with the Synod.

STANDING COMMITTEES AND RULES.

The Committee on Standing Committees and Rules made . a report which was accepted and adopted. (For Standing Committees see page 2).

SABBATH OBSERVANCE.

The Committee on Sabbath Observance presented their report which was accepted, and the recommendations adopted, as follows:

- 1. That the Synod reaffirm that the law of the Sabbath is a law of perpetual binding obligation upon all men.
- 2. That we deplore the spirit of the times, which is so far removed from puritanical doctrine and practice, and which would give up the day to business or pleasure excursions.
- 3. That we recommend that each Pastor and Stated Supply on the first Sabbath of December next, preach a sermon on some phase of this question, and either at that time, or as soon thereafter as possible, secure an offering for the work of the American Sabbath Union, and forward such offering to the Treasurer, Col. A. S. Bacon, 34 Wall street, New York City.
- 4. That the Synod urges all our office bearers and members who are employers of labor, either as individuals or corporations, to use every legitimate means to reduce the Sabbath labor demanded of employees, and deprecates and condemns any system that leaves to the laborer the alternative between avoidable Sabbath labor or dismissal.

FINANCE.

The Committee on Finance presented a report, recommending the approval of the accounts of the Treasurer, which they found sustained by the proper vouchers. They are as follows:

The following Committee was appointed to audit the accounts of the Treasurer of the Sustentation Fund and report to the Stated Clerk:

TIME AND PLACE OF MEETING.

The consideration of a request for a change of the time of holding the Annual Meetings of Synod, to a later date, and also of the place, to the intent of securing the wider visitation of our whole territory by said meetings, was referred to the Moderator and Clerks to report next year.

NEW WINDSOR COLLEGE.

The Committee on New Windsor College made a report setting forth the progress and needs of that institution. The following facts were noted, viz:

The need of money to fit up rooms for boarding students. About \$35 or \$40 will fit up a room. There will be needed, September 2, 1900, the \$5444.44 to pay the mortgage. The Faculty is well organized and is doing faithful work. The stock is now in control of the Presbytery of Baltimore, hence the security of the property, and the perpetuity of the school are assured.

The report was accepted.

ARMY AND NAVY.

The Committee on the Religious Work in the Army and Navy presented their report, which was accepted with an appreciation of the interest taken by Col. Charles Bird, U. S. Army, chairman of the committee in this work. The report closes with the following:

"Comparing this report with the last, makes it very evident, that far greater interest has been taken by our churches in the religious welfare of the soldier than before, and it is hoped that the churches situated in localities where soldiers are stationed will take an interest in the men and an active spiritual work be done among them."

PRESBYTERIAL MINUTES.

The Committees on the Minutes of the Presbyteries of Baltimore and New Castle reported, recommending their approval, as far as written.

The Committee on the Minutes of the Presbytery of Washington City reported, recommending their approval up to page 237. With respect to a paper on pp. 201 and 202, we

recommend that so much of said paper as applies to what (in October, 1898), has been accomplished by God's aid is approved. All that which is prospective and refers to future policies of the Government is disapproved.

The reports were adopted.

SYNODICAL SERMON.

Rev. J. B. Turner, of the Presbytery of New Castle, was appointed to preach the Synodical Sermon at next Stated Meeting.

Theme-"Living in Christ."

Moore's Digest.

The Stated Clerk was authorized to purchase a copy of Moore's Digest for the use of the Synod.

CASE REFERRED TO PRESBYTERY OF NEW CASTLE.

The Presbytery reported that it had decided that it is best to take no further action in the matter. Report accepted.

THE WOMAN'S SYNODICAL SOCIETIES.

The following is a summary of the reports of the Woman's Synodical Committees for Home and Foreign Missions.

Home Mission Society.—Number of societies, 105; bands, 58; members, 4,049.

New Castle Presbytery reports 39 societies, 18 bands. Contributions, societies and bands, \$1,354.27; Christian Endeavor Societies, \$90.74; Junior Christian Endeavor Societies, \$20.50; Sabbath Schools, \$122.77. Total, \$1,588.28. Boxes, valued at \$1,075.01.

Baltimore Presbytery reports 40 societies, 24 bands. Contributions, societies and bands, \$2,595.24; Christian Endeavor Societies, \$232.21; Junior Christian Endeavor Societies, \$20.50; Sabbath Schools, \$230.60. Total, \$3,758.10. Boxes, valued at \$2,588.58.

Washington City Presbytery reports 26 societies, 16 bands. Contributions, societies and bands, \$4,316.62; Christian Endeavor Societies, \$482.94; Junior Endeavor Societies, \$59.18; Sabbath Schools, \$558.43. Total, \$5,417.17. Boxes, valued at \$1,799.

Totals.—In money, \$10,763.55; in boxes, \$5,462.59; grand total, \$16,226.14. Decrease from last year \$71.47, in money, and \$65.10, in value of boxes.

Report of the Secretary of the Synodical Society of Home Missions of the Synod of Baltimore:

In making my report as Synodical Secretary, I feel that you should have something more than a bare financial statement, for though, as pastors, you all know that all money here reported has gone through the Woman's Board of Home Missions, it would not be strange if you should ask how this has been expended, and what are the objects that are demanding the gifts of the women of the Synod. In our three Presbyteries we support five missionary teachers; two in the Indian Territory, one in Virginia, one in New Mexico and one in Utah, and we carry thirty-nine scholarships in our various schools.

Synodically, we support an Evangelist among the Ute Indians in Colorado. He seems to be the right man in the right place, and his work has been signally blessed. His teaching has created in these Indians a desire for Christian education; last year they paid the salary of a teacher for several months, and this year have built a neat little chapel. The bell for the chapel is to be furnished by the Washington Presbyterial Society.

We also contribute as a Synod, one thousand dollars to the work in Alaska, all of which is now entrusted to the Woman's Board, and one thousand to work among the Mountain Whites in North Carolina, where this year a new Presbytery has been formed as a result of the school work.

Many of the Societies continue to send valuable boxes of clothing to missionaries and their families, and to schools; a road cart and an organ have also gone to our teachers.

The Board has given several objects to the young people in the Christian Endeavor Societies, viz: The Asheville Farm School, the salary of Rev. Mr. Lamb in Indian Territory and the Indian Churches on Sisseton Reservation, thus dividing their contributions between the Board of Home Missions and the Woman's Board. Many societies have given to these objects, many more have not, but their gifts have been diverted to outside things—not Presbyterian.

All other money collected is used in the General Fund, for the salaries of teachers, the support of schools and necessary repairs to buildings.

We notice with regret that for two years there has been a falling off in the amounts contributed by societies and bands. Will you help us to turn the tide the other way, by rallying the women in your several churches to do greater things for missions, and by encouraging the organization of societies in churches where there are none. Of this class there are twenty-nine in Baltimore Presbytery; fourteen in New Castle Presbytery, and four in Washington City Presbytery. Many of these churches receive help from the Board of Sustentation, but believing as we do that an active society, intelligent in Missions, is a source of spiritual life in the church, and that those who are trained to give to Missions will respond more heartily to all other calls made upon them by their pastors. We arge these organizations upon you.

In loyalty to Christ and our Church, this report is respectfully submitted.

Foreign Missionary Society—The Woman's Committee of Foreign Missions report a small loss in their sum total, \$10,524.67, for their work, not an actual loss, but an error in retaining too large a balance in one Presbytery, and would report that with the present system and fine organization they hope to surpass the substantial gain of 1898.

Standing Rules of the Synod of Baltimore.

1899.

- I.—The Synod shall meet annually, at the time and place appointed at the preceding meeting.
- II.—The officers of the Synod shall be a Moderator, a Stated Clerk, (who shall also act as Treasurer,) a Permanent Clerk and one Temporary Clerk.
- III.—The Stated Clerk and Treasurer, and Permanent Clerk, shall be elected for a term of three years. The salary of the Stated Clerk shall be \$75 per year, and that of the Permanent Clerk \$10 per year. All other offices shall be filled by election, at the opening of each stated meeting of the Synod.
- IV.—The Stated Clerk shall give due notice of the time and place of each meeting of Synod; and he shall, for each meeting, prepare and keep a docket of the business that is to come before Synod, and he shall send out a copy of the same, with the notice of the meeting.
- V.—The roll of each meeting of the Synod shall be made out by the Stated Clerk from authentic reports, to be furnished him by the Stated Clerks of the Presbyteries, after the rising of the meeting of those bodies, next preceding the meeting of Synod. It shall be the duty of the Stated Clerk, at the opening of the second day's session, to have prepared and ready for use in the Synod's business, a roll of the members in attendance, and to add thereto the names of any additional members, who may report their attendance.
- VI.—The Moderator of Synod shall at each stated meeting, appoint the following-named Committees: On Bills and Overtures; Judicial Cases; Finance; Minutes of the General Assembly; Presbyterial Records; Leave of Absence; The Narrative for the ensuing year; Standing Committees and Rules; and a Committee of Arrangements and Devotional Exercises, of which the Pastor of the church entertaining the Synod shall always be chairman.
- VII.—Standing Committees, to consist of one Minister and one Elder from each of the Presbyteries composing the Synod, shall be appointed to serve at the pleasure of the Synod, as follows: I. Systematic Beneficence; 2. Home Missions and Sustentiation; 3. Foreign

Missions; 4. Education; 5. Church Erection; 6. Publication and Sabbath School Work; 7. Freedmen; 8. Ministerial Relief; 9. Aid for Colleges; 10. Temperance; 11. Religious Work in Army and Navy; 12-Sabbath Observance; with the understanding, that the Chairman of the Presbyterial Committees be as far as possible, placed upon the corresponding Committees of the Synod.

VIII.—At the close of each stated meeting of Synod, the roll shall be called, and the absentees who have not been excused from attendance, shall be noted, and their names shall be recorded in the Minutes.

IX.—The General Rules for Judicatories, recommended by the General Assembly, shall be the rules for the transaction of business in this Synod, unless otherwise ordered by the Synod.

X.—The first half-hour of each morning's session shall be spent in devotional exercises.

XI.—It shall be the duty of the Committee on Devotional Exercises and Supplies, to report to Synod such special public religious services as may be deemed proper, or desirable, and also to appoint supplies to such churches in the vicinity, as may desire to be supplied during the session of the Synod.

XII.—The Committee on the Narrative shall prepare from the several Presbyterial Narratives, a succinet report on the state of religion within the Lounds of Synod, and it shall be the duty of each Presbytery, to send to the Chairman of the Synod's Committee on the Narrative, a copy of the (Presbyterial) Narrative as soon as it has been adopted.

XIII.—The Committee on Presbyterial Records, and Judicial Cases, and on Bills and Overtures, shall be charged with the duties usually assigned to such committees in Presbyterian Judicatories.

XIV.—The Committee on Leave of Absence shall consider, and pass upon, all requests and all reasons assigned for absence from any session, or meeting of the Synod, and make report of the same to the house for record, before final adjournment.

XV.—The Committee on Finance shall audit the annual report of the Treasurer, and make the proper assessment upon the Presbyteries to meet the expenses of the Synod.

XVI.—It shall be the duty of the Committee on Systematic Beneficence, to report to Synod on the whole subject of Systematic Beneficence, or the agencies, efforts and comparative success on behalf of the Boards of the Church, or other schemes for doing good within the bounds of Synod. And it shall be the duty of each corresponding

Presbyterial Committee, to transmit to the Chairman of the Synod's Committee, before the meeting of Synod, a copy of the report which it may have to the Presbytery.

XVII.—It shall be the duty of the Committee on Foreign Missions, to correspond with the Assembly's Board of Foreign Missions, and thus to obtain information of the progress of the Missionary work abroad; and to correspond with the Presbyteries and individual churches at home in order to obtain knowledge of what has been done at home for the Foreign Missionary work. And it shall be their duty also, to recommend to the Synod such plans and methods as may, in their judgment, most effectually promote in our churches the interest of this great cause.

XVIII.—It shall be the duty of the Committee on Home Missions and Sustentation, to be the organ of communication between the Synod and the Assembly's Board of Home Missions. It shall be charged with the duty of circulating information concerning the Sustentation work of Synod; and, in all possible ways, promoting contributions to this cause. The Home Missionary Committee of each Presbytery shall submit to this committee, by October 1st, of each year, a detailed estimate of the amount of money which will probably be required by that Presbytery, for the ensuing year, and also the amount that can probably be raised by that Presbytery for Sustentation. The Synod's Committee shall consider these reports, and shall recommend to the Synod, at its annual meeting, the total amount to be provided, the part which each Presbytery, in view of its financial ability, should be asked to raise; and the sum which should be allotted to each Presbytery for its use.

XIX.—It shall be the duty of the remaining Committees on the Benevolent Work of the Church, to present to Synod the progress, propect and needs of the respective Boards, and to recommend such action as may seem best.

XX.—It shall be the duty of the Committee on Temperance, Religious Work in the Army and Navy, and Sabbath Observance, to report to Synod the progress of these causes; and to recommend any action they may deem advisable.

XXI.—The above-named Standing Committees shall each present to Synod a carefully written annual report of its labors; the consideration of which, unless otherwise ordered, shall take precedence of other reports. The Stated Clerk, two weeks before the meeting of Synod, shall notify the Chairman, or in case of the removal from the Synod of any Chairman, the next man on the Committee, of his appointment and duty to report; and that it is his duty to secure such information from the Presbyteries as may be necessary for his report.

XXII.—A Committee consisting of two ministers and one elder, shall be appointed, at each alternate session of Synod, to visit Wilson College, at the expense of the College, and report upon its condition.

XXIII.—The Stated Clerk shall make an official statement and record of the fact, that the Minutes of Synod have been submitted to the General Assembly, with its action thereon.

XXIV.—The Stated Clerk shall send one copy of the Minutes of Synod to each Minister, and one copy to each Church Session, in the Synod. The Printed Minutes shall be furnished to all persons, who are not entitled to receive free copies, for 25 cents.

XXV.—These Standing Rules may be suspended at any meeting of the Synod, by a vote of the members present, but may be altered or amended only at a stated meeting.

SYNOD OF BALTIMORE.

OCTOBER, 1899.

The Committee would respectfully present its Eighth Annual Report to the Synod of Baltimore in session in Wilmington, Delaware, October 18th, 1899.

Oniet times do not furnish much material for history, and therefore we have nothing novel or striking to report. The past has been a year of quiet and gradual growth in all our churches. The blessings of Sustentation become more and more apparent from year to year. About the same kind of work has been done this year as last. Forty-one men have labored in fifty-five churches. There were eighteen men in twenty-two churches in the Presbytery of Baltimore. Sixteen in twenty-four churches in New Castle, and seven in nine churches in Washington City Presbytery. Thus, practically, every church in the bounds of the Synod has been supplied. The progress appears in the regularity of the supply. Thirty-eight were supplied the entire year; seven more for eight months, and the balance—being small churches or where a change of minister was taking place-were regularly supplied four or five months.

STATISTICS.

We have quite full statistics for this year. These churches report an average attendance of 3,510 each Sabbath. 218 have been added on profession of faith, and 104 by certificate. The total membership reported is 3,089. 47 adults and 201 infants have been baptized. There are 53 Sunday schools, with a membership of 4,786. Almost everyone reports having a Home and Foreign Missionary Society, Aid, Christian Endeavor or Temperance Society, and a few have all these. The value of church edifices is \$205,600, and parsonage property is \$28,675.

Amount raised for repairs or betterments, \$5,730. There are church debts to the amount of \$25,086, but the larger part of this is on a few comparatively new buildings; most of the churches report no debt. \$4,678 has been paid to cancel debt. These churches raised \$16,912 for pastors' salary, and \$6,372 for current expenses.

BENEVOLENCE.

These churches gave to Sustentation, \$416; to Home Missions, \$718; Education, \$90; Foreign Missions, \$838; Publication, \$270; Church Erection, \$102; Ministerial Relief, \$110; Freedmen, \$94; Aid for Colleges, \$60, and other benevolence, \$241, a total of \$2,940, about \$200 more than last year. There has been an advance in almost every item of the statistics this year over last, with the exception of additions on profession of faith, which fell from 346 in '98 to 218 in '99, a loss of 128. This falling off of additions to the church upon profession of faith seems to have prevailed all over the church to such an extent as to arrest general attention. As this is the vital part of our work it calls for earnest prayer and renewed consecration.

One-fourth of the ministers and one-third of the churches of the Synod are aided by the Sustentation fund. Wherever it is possible churches are grouped together so as to raise as much as possible on the field, but even thus many would be vacant were it not for the aid of this fund. The ministers in

these churches are on very small salaries, the average being but a little over seven hundred dollars, and out of this some have to pay house rent or keep a horse. These man are worthy of double honor, and should receive much larger support.

The original purpose of Sustentation was for this Synod to do all the work of Home Missions within our bounds, and that all that was given to the Board should be used for the great work beyond our bounds in the West and South, and in the ever increasing demand for new work. This should be kept steadily in view. Sustentation should receive far more attention and much more liberal gifts than it has ever yet received. As a means of administration it is a vast improvement on the old method by the Board of Home Missions, and prompt payments have made it much more comfortable and satisfactory to the men aided by it. The work of supervision is close, kindly, sympathetic and helpful, and the support goes right to the spot. A great, far-reaching and permanent work is being done all over the Synod by these little churches everywhere strengthening the cause of Christ, and, therefore, your Committee appeals with all earnestness and confidence to the ministers, churches, societies and individuals of our congregations for continued and. larger gifts to the cause of Sustentation in the Synod of Baltimore.

The receipts from the churches of the Synod are \$356.75 less than last year. Baltimore Presbytery fell off \$89.81; Washington City, \$161.49, and New Castle, \$105.45.

We regret this falling off of receipts, for the disbursements to the Presbyteries this year were \$528.06 more than last year. However, all, except a few of the very small churches, have contributed to the fund, showing that the cause has a good hold on the churches of the Synod. Mr. Ammidon, the treasurer, was absent in Europe three months, during which time Mr. Elisha H. Perkins kindly acted as treasurer, and ten dollars were expended in clerk hire.

In order to fully provide for the mission work of the Synod we applied to the Home Board for \$4,500, and have received it. This was \$300 less than the previous year.

We respectfully submit the following resolutions for the consideration and action of the Synod:

- 1. That the experience of another year confirms the Synod in the judgment that Synodical Sustentation is the best method of carrying on mission work within its bounds.
- 2. That all the Sunday Schools in the Synod, which do not otherwise contribute to the fund, be asked to make special offering on the Sabbath before the 22nd of February, dividing it equally between the Board of Home Missions and the Sustentation Fund.
- 3. That the Synod asks that all Women's Home Missionary Societies and Young People's Societies devote the first meeting in

March to the consideration of this cause, and to prayer for it, and that they make at that time a special offering to it, or an appropriation for it from their benevolent fund.

- 4. That Synod recognizes with approval the general interest shown in this cause by pastors, sessions and people, and directs all church officers, who have not been accustomed so to do, to present this cause fully and earnestly this year, and expects all churches to meet, at least, the full amount apportioned to them, as an act of loyalty, not only to the Synod, but to the cause of Christ within its bounds.
- 5. That churches taking a special collection for this object, are advised to do so in March, and all churches are enjoined to forward their offerings not later than July 1st.
- 6. That the pastors and officers of all churches receiving aid are enjoined to use their utmost efforts to reduce annually the amount of aid asked, agreeably to their promise made in the application; and the Presbyteries and their committees be directed, if necessary, to enforce such reduction.
- 7. That the churches of the Synod should raise during the next year, not less than \$6,000; of which those in the Presbytery of Baltimore should give, at least, \$2,800; those in the Presbytery of Washington City \$2,100; and those in the Presbytery of New Castle \$1,100.
- 8. That the committee be directed to apply to the Home Mission Board, for sufficient additional funds in bulk, to fully provide for the mission work of the Synod, until such time as the direct contributions to Sustentation can be so increased as to suffice for the purpose.
- 9. That the Presbytery of Baltimore be allowed to draw \$2,200, which may be increased to \$2,500 in case the full apportionment of \$2,800 is raised; that the Presbytery of New Castle be allowed to draw \$1,500 which may be increased to \$1,600, in case the full apportionment of \$1,100 is raised; and that the Presbytery of Washington City be allowed to draw \$1,600, which may be increased to \$1,900, in case the full apportionment of \$2,100 is raised; and that any money which may be received from the Home Mission Board shall be distributed to the Presbyteries according to the judgment of the committee.
- 10. That the chairman of the committee be hereafter allowed \$50 to cover clerk hire and incidental expenses.
 - 11. That the Treasurer be allowed \$50 for clerk hire.
- 12. That this report and the Treasurer's statements accompanying it, be published as an appendix to the printed minutes of Synod.
