MINUTES

Of the Third Session of the OLIVE PRIMITIVE BAPTIST ASSOCIATION Held with the Church at Mt. Gilcad, Lee County, Ala., on the 16th, 17th and 18th days of October, 1885.

First—The introductory sermon was preached by Elder J. J. DICKSON, of the Olive Association from Isa. 30th ch. 21st verse: “Thine ears shall hear a word behind thee, saying, This is the way, walk ye in it, when ye turn to the right hand, and when ye turn to the left.”

Second—Opened the Association by prayer, by Elder R. T. WEB, from Sulphur Fork Association, Texas.

Third—Called for, received, and read letters from the churches composing the body, enrolled the names of messengers present, and minuted their condition. (See tabular statement.)

Fourth—Invited visiting ministers and brethren to seats with us.

Fifth—On motion, reelected by acclamation, Elder W. M. MITCHELL, Moderator, and John N. Hurst, Clerk, then took up the business in the following order:

1st Appointed the following committees:

To arrange the order of preaching, Elder J. S. BAXLEY, J. G. Ware and W. A. Lamb, together with the messengers of this Church, Elder L. B. PORTER, L. Pickard and J. G. Leslie.

To write corresponding letter, J. M. Parker.

To examine corresponding minutes, J. B. Folks, C. P. D. Taylor, A. R. Powell.

2nd. Called for correspondence from sister associations, and received from the—

Bulah—Elder J. T. SATTERWHITE, correspondent, and H. Leslie, visitor, with minutes.

Upatoic—G. W. Cargle, L. Wheeless, A. J. Digby, J. R. Thompson, N. E. Miller and Samuel Rodgers with minutes.

Conceh River—Elder J. E. W. HENDERSON bearing petitionary letter for correspondence

Ocmulgee—No correspondence.

Wetumpka—L. M. Parker with corresponding letter.

Late Primitive Western—G. W. Head, visitor.

Hillabee—Elder J. J. CLEVELAND with corresponding letter.

Sulphur Fork, Texas—Elder R. T. WEB, visitor.

3d. Appointed union meetings.

1st. Dist. To be held with the church at Mt. Gilead, Lee county, Ala., commencing on Friday before the third Sunday in April, 1886.

2nd Dist. To be held with the church at Concord, Tallapoosa county, Ala., commencing on Friday before the first Sunday in August, 1886.

4th. Adjourned until half after eight o'clock to-morrow morning. Prayer by Elder J. E. W. HENDERSON, then a recess of 30 minutes.

SATURDAY, OCTOBER 17TH.

Met pursuant to adjournment. Prayer by Elder J. T. SATTERWHITE.

5th. The committee on examining corresponding Minutes report that there is nothing claiming the attention of the body, but they have been *verbally* informed that the Primitive Western Association with whom we have been corresponding, at her last session adjourned indefinitely, to which we call the attention of this body.

6th. Returned correspondence to sister associations.

Beulah--To convene with the church at Mt. Pisga, Ala., nine miles north of Buffalo Wallow, and eighteen miles northwest of West Point, Ga., commencing on Saturday before the third Sunday, in September, 1886. J. S. Baxley, E. F. Ware, W. H. Newell, and C. P. D. Taylor.

Upatoie—To be held with the church at Bluff Springs, Macon county, Ga., four miles northwest of Andersonville, commencing on Tuesday, after the first Sunday in September, 1886. L. B. Porter, and J. W. Foster.

Ocmulgee—By minutes.

Wetumpka—To convene with Swamp Creek Church, Coosa county, Ala., commencing on Friday before the fourth Sunday in September 1886, nine miles west of Rockford, C. H. J. S.

Baxley, G. C. Freeman, T. J. Stevens, J. G. Ware and J. W. Patterson.

Hillabee—To convene with the church at Liberty Hill, Coosa county, Ala., two miles from Rockford, commencing on Saturday before the second Sunday in October, 1886. Elder J. J. Dickson, and B. J. Hornsby.

Conecuh River—To convene with the church at Pilgrim's Rest, Covington county, Ala., commencing on Saturday before the second Sunday in October, 1886. Elder J. J. Dickson, Elder J. S. Baxley, J. M. Parker, and Elder L. B. Porter.

Primitive Western, having at her last session adjourned indefinitely, we therefore of necessity, suspend correspondence.

7th. Called for and received contributions from the churches to the amount of \$17.75, and ordered that 500 copies of this minute be printed and distributed among the churches, reserving a sufficient number for corresponding purposes, and that the clerk superintend the same, and retain the remainder of contributions for his services.

8th. Called for, received and adopted the corresponding letter.

9th. The next session of this body is appointed to convene with the church at Canaan, Tallapoosa county, Ala., commencing on Friday before the third Sunday in October, 1886. Located two miles southwest of Waverly depot on railroad leading from Opelika to Dadeville, Ala.

10th. *Resolved*, That the thanks of this association be and are hereby tendered to the friends and citizens of this community for the kindness and hospitality so generously extended during the present session.

11th. Minute read and adopted and repaired to the stand for final adjournment.

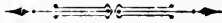
