# MINUTES

OF THE

## Columbia Baptist Association.

---

BLUFF SPRINGS, NOVEMBER 3rd, 1897.

The Columbia Baptist Association according to previous appointment met in its 13th annual session with Bluff Springs Church, this Wednesday Nov. 3rd, 1897, at 10:30 o'clock, former Moderator, W. C. Cleveland presiding.

After devotional exercises, led by Bro. G. W. Oliff, for 30 minutes, Bro. J. J. White preached the introductory sermon from the text: "Take heed unto thyself, and unto the doctrines; continue in them: for in doing this thou shalt both save thyself and them that hear thee." 1st Timothy, iv chapter, 16th verse. The subject of the sermon was directed to the ministers of the Association, showing what an acceptable servant of Christ should be, in order to have blessings of God in the leading of souls to the ways of righteousness. These plain forceful words will long be remembered and no doubt bear fruit in the future.

**REPORT ON ORPHANAGE.**

The Association had the following paper read, which was received.

**FACTS ABOUT THE ORPHANAGE.**

Its name is Louise Short Baptist Widows and Orphans Home of Alabama.

The first step taken toward establishing it was in November, 1890, when the State Convention was in session in Mobile Mrs. M. B. L. Woodson made known to the Convention through Rev. F. C. Plaster, that she would give her real estate to the maintenance of a Baptist Widows and Orphans Home in Alabama. The

home, however, was not actually started till March 10th, 1893, when in a small rented house we received three poor children. It had now been only temporarily located in Evergreen. By November, our family numbered twenty-two and the trustees after advertising for bids for location, selected property in Evergreen, and located the home permanently.

The property has been paid for and there is no incumbrance on it.

There have been received into it in all 70 children, 37 girls and 33 boys, 32 of whom have gone out, so that at present we have 38. Of those that have gone out two have been apprenticed, seven have returned to their people, and twenty three have been adopted.

There have been received from the following counties: Barbour, 3; Lee, 3; Covington, 8; Talladega, 6; Limestone, 1; Walker, 6; Escambia, 7; Conecuh, 2; Monroe, 4; Tuscaloosa, 3; Jeffers on, 8; Montgomery, 2; Marengo, 4; Russell 1; Pike, 4; Bibb, 2; Chambers, 1; Butler, 3; Tallapoosa, 2. The children have enjoyed good health this year. There has never been a death in the home. They are under firm loving control. They seem to be contented and happy. They are taught to do various kinds of work. All who are old enough attend the Agricultural School. The home is receiving some important and much needed improvements. At present hands are greatly needed to do this work. Only a few churches and Sunday schools contribute to us regularly, and there is more than 1,200 churches in the state that have never given a cent to it. The work commends itself to the Lord's people. Brethren help.

#### REPORT ON STATE MISSIONS.

We, your committee beg leave to make the following report:

State Missions are clearly now in view of the approaching convention meeting, the department of "God's" cause that specially appeals to Baptists for their consideration, their prayers and offerings. The individual Christian is the fundamental factor in Christianity and responsibility falls directly upon him. But Christ clearly means that the individual shall not stand isolated, but shall unite his prayers, his voice, his councils and his resources with others, in forwarding God's work. Evangelization is the great work of Christ, and it is the great work of the Church. All missionary work at the beginning and in all territorial progress is evangelizing work. There are, in the several sections of the state, six evangelists, Brother Purser in the North, Brother Sandlin in the North-West, Brother Dickinson, in and around Birmingham, Bro. Parker, in the South-West, Bro. Anderson, in the East, and last, but not least, our own Bro. Preston, here, in the South-East, whom you all know, has labored faithfully and earnestly for the furtherance of God's cause. Respectfully submitted.

#### REPORT ON HOME MISSIONS.

The Home Mission Board is located at Atlanta, Ga., and I. T. Tichnor, D. D., is the Corresponding Secretary. The hardest year ever experienced by the Home Mission Board has past into history. The board began it with a debt of \$8,000, and an obligation to pay \$5,700 on the house of worship, purchased for the first, in New Orleans, making a total of \$13,700 over and above the support of our Missionaries, required to meet our financial needs for the year. The great financial pressure which embarrassed all our mission boards seemed to increase the needs of our Home Mission field and made numerous and earnest cries for help that come from nearly every quarter.

The report of the past Conventional Year is as follows: Missionaries, 372; Weeks of labor, 11,075; Churches and Stations, 1,963; Sermons and Addresses, 48,508; Prayer meetings, 11,237; Religious visits, 62,175; Baptism, 4,709; Received by letter 4,746; Total additions, 9,455; Churches constituted, 139; Houses of worship built, 57; Houses of worship improved, 129; Amount expended on houses of worship, \$52,010;

Sunday Schools organized, 313; Teachers and pupils, 10,725; Bibles and Testaments, 2,837; Tracts distributed, (pages) 645,346.

The State Boards of Alabama, Arkansas, District of Columbia, Florida, Georgia, Indian Territory, Kentucky, Louisiana, Maryland, Mississippi, North Carolina, Oklahoma Territory, South Carolina, Tennessee, Texas, Virginia, Western Arkansas and Indian Territory and Western North Carolina are in cooperation with us in part or the whole of their work, and we recommend that this Association, and all of our people contribute liberally to the support of our Home field, and we pray the blessings of God and the guidance of the Holy Spirit to be with our Missionaries, for the salvation of souls, and the extension of the kingdom of our dear Redeemer.

We are glad it is good so far, and every good man who values home and his children should rejoice on account of the benefits of the institution and the influence it exerts over the people of our country. But while the Baptists of the Columbia Association are thus congratulating themselves, many of you ought to hang your heads in shame, because you do nothing to advance

this cause in any particular. Good men, good women so far forget or disregard their duty to themselves, to their families and to their God, that they never lend their presence, aid or concern to the cause of Sunday Schools.

#### REPORT ON EDUCATION.

"Education," it is said, "is the instinction, the foundation of manners." There has been but few races or families of Earth's inhabitants, but what has had some fashion by which they more or less educate their children; some of the most rude, even the Indian, has had some things real attracting, i. e., in their manners. It is an actual proof of a God given principle that moves his creatures to feel it a duty they owe to their off-springs: How can parents in a civilized country, with the educational facilities we have here, prove to us that they love their children, when they let grow up to man and womanhood, without the fundamental principles of an education, those whom the wise creator has entrusted them with. There is time enough spent, in most communities, in disputes over teachers and where the school house shall be built, how much public money appropriated for the school, or I will send as long as the public funds last, (to say nothing of the money spent for the various ruinous poisons,) to amply educate every sane minded child, both white and black in America. Boys and girls are educated because the laws of the land so provide, and so necessitate it in some countries: Oh! how we boast of our American liberties. We are made to think, sometimes they are an injury to us in this one particular. There should be a law to make us school our children as well

as give them other home provisions and protections. The wise and loving God has arranged, in the order of his providence, that both poor and rich may educate their children. Many who neglect it do it to their shame and that of their children. Often men and women grow up without the advantages of an education, feeling the responsibilities of life coming upon them, and to meet them, decidedly unprepared. Oh! what an embarrassment. The father of a many a boy has been made to blush yea, even to weep, when he saw that his boy believed himself called to preach the gospel without even a primary English education. We who have had to suffer under such a weight, should engage our pens, and raise our voices both in public and in private, against the sin of neglecting our dear children in this important matter, until we move our people to more activity along this line. Let a strong, healthy man neglect his offspring, in the way of furnishing provisions to eat and clothes to wear, and every man or woman who has a human soul, says he ought to be denounced, yea he ought to be made to support his family by law. Which of the two is the most deserving the contempt of the public? Neglect to feed the body, you have a physical dwarf, neglect the proper training of the mind you have a mental dwarf.

## CONSTITUTION OF COLUMBIA ASSOCIATION.

ARTICLE 1. This union of churches shall be known and distinguished by the style and name of "The Columbia Baptist Association."

ART. 2. The object of the Association shall be to combine our Christian efforts for the purpose of carrying the appointed means of grace to dying men and women, and to regard all churches united under this constitution with a vigilant eye for good. Her principal object shall be to promote the declarative glory of God by extending His kingdom of grace on earth through the medium of preaching the gospel, and all other means within reach of a working christian organization.

ART. 3. This Association shall be composed of representatives from the churches as follows: Each church having one hundred members or less shall be entitled to two messengers, and to one additional messenger for every fifty members or fractional part thereof in excess of one hundred. But in the business of the Association whenever the messengers from any church desire it the vote shall be taken by churches in which case each church shall be entitled to two votes.

ART. 4. The messengers when convened shall organize themselves into a deliberative body, by the appointment of a Moderator and Clerk, and these officers shall be chosen by ballot, or otherwise as the body may decide at each annual meeting, and continue in office until their successors are chosen. Should any event transpire, so as to prevent any annual meeting of this Association, the Moderator shall have the power to call a meeting at any time and place, which meeting when convened, shall have all the rights of a regular meeting.

ART. 5. This Association shall not interfere with the rights of the churches of which she is composed. She shall regard them as independent bodies in all measures of internal government, and shall act in an advisory council assuming no authority but what is expressly delegated to her by the churches, or evidently implied by the very nature of the compact. But she nevertheless claims authority over her own members, the messengers of the churches, and in justice and propriety must have power to withdraw from and disown all churches that depart from the principles of the compact by holding opinions repugnant to the doctrines of the Scriptures, or are disorderly in practice.

ART. 6. Newly constituted churches or churches dismissed from Associations of the same faith and order may be admitted into this union on their sending up messengers to an annual meeting with a petition, and those messengers agreeing to the abstract principles adopted by the Association.

ART. 7. The churches in this union shall transmit to every annual session of the Association written communications specifying the names of messengers, members in fellowship, baptised, received by letter, dismissed, excluded, restored since last session and such other information, as the churches may deem important, which shall be read and minuted accordingly.

ART. 8. This Association shall have a fund, supplied by voluntary contribution of the churches; and all moneys thus contributed or otherwise received shall be transmitted through the finance committee to the treasurer who shall be elected by ballot or otherwise, as the body may decide, and hold his office during the pleasure of the Association.

ART. 9. It shall be the duty of the Clerk to keep a regular file of printed minutes of every session of this body and deliver over the same to his successor in office.

ART. 10. This Association when convened shall be governed by proper rules setting forth the duties of officers and such other matters necessary for a deliberative body, and may alter or amend such rules from time to time by a majority vote of the body in annual session.

ART. 11. The executive committee shall attend to such duties as may be imposed upon it by the Association, and when the Association is not in session this committee shall have power to fill vacancies that may occur.

ART. 12. This Constitution may be altered or amended at a regular meeting of the Association by a vote of two-thirds of the members present, provided such alteration or amendment is not disapproved of by a majority of the churches in their written communications to the next annual session of the body.

## DECORUM.

1st. It shall be the duty of the Moderator to preside over the deliberations of the Association in session, preserve order, submit motions or other matter and announce results when passed on by the body. He may have the same right of speech as any other member provided the chair is occupied, but is not allowed to vote, except the body be equally divided, in which case he shall give the casting vote.

2nd. It shall be the duty of the Clerk to keep a correct record of the minutes of the proceedings in a clear and concise manner, and immediately after the adjournment of each annual session, to prepare a copy of the same for distribution to the churches, for the payment of which he shall draw his draft upon the Treasurer of the Association.

3rd. The Treasurer shall keep a correct account of all monies coming into his hands, as well as the manner in which it is distributed. He shall only pay out money upon the order of the Association in session, or the Executive Committee in vacation. He shall render an annual statement to the Association of all funds received and distributed by him showing the balance, if any, remaining on hand.

4th. This Association shall not consider any query or other matter affecting the churches, unless they have first endeavored to solve the same and failed; nor any difficulty between churches, unless they have pursued the directions contained in the 18th chapter of Matthew and have not been able to bring about a settlement and reconciliation, in which case the Association shall take such matters under consideration, and act upon them or not at her discretion.

5th. Every motion made and seconded shall come under the observation and be acted upon by the body, except it be withdrawn by the member who made it.

6th. Every person who speaks in debate, shall rise from his seat and address the Moderator and shall not be interrupted while speaking, unless he departs from the subject of debate.

7th. No member shall speak more than twice upon the same subject without leave of the body. And it shall be a violation of these rules for any member to abruptly break off or absent himself without leave of the body; and if he does so he shall be liable to reproof by the Moderator.

8th. The Clerk, Treasurer and all members of the standing committees shall be entitled to the same privilege of speaking and voting as other members, except in cases where the interests of any individual church is to be affected by the matter at issue. In this latter case they may express their views, but shall not be allowed to vote.

9th. These rules may be altered or amended by a majority of the members in session.

Art. 3. We believe in the doctrine of election, and that God chose his people in Christ before the foundation of the world; that they should be holy and without blame before him in love, having predestined them to the adoption of children by Jesus Christ, according to the good pleasure of his will. Tim. 1: 8, 9. Eph. 1: 3, 12. 1 Pet. 1: 1, 2. Rom. 11: 5-6. Rom. 8: 28-38. 2 Thess. 2: 13, 14. Ex. 33: 18-19. Matt. 20: 15. 2 Pet. 1: 10, 11.

Art. 4. We believe in the doctrine of original sin. Gen. 1. 27. Gen. 3: 6-24. Rom. 5: 19. Eph. 2: 1-3. Ezek. 18: 19, 20.

Art. 5. We believe in man's incompetency to recover himself from the fallen state he is in by nature by his own will and ability. Eph. 2: 8. Matt. 18: 11. Acts



15: 11. Isa. 53: 4, 5. Heb. 7: 25.

Art. 6. We believe sinners are justified in the sight of God only by the imputed righteousness of Christ. Acts 13: 39. Rom. 5: 9. Rom. 5: 17. Rom. 4: 4, 5. Rom. 5: 19. Rom. 5: 1, 2.

Art. 7. We believe that God's elect shall be called, regenerated and sanctified by the Holy Ghost. John 3: 3. John 3: 6, 7, 8. 2 Cor. 5: 17. John 1: 13. James 1: 14-18. 1 John 5: 1.

Art. 8. We believe that nothing can separate the true believers from the love of God, but that they will be kept by the power of God through faith unto salvation. John 8: 31. 1 John 2: 19. Rom. 8: 8. Phil. 1: 6. Phil. 2: 12, 13.

Art. 12. We believe that no minister has a right to administer the ordinance unless he is called of God, and comes under the imposition of the hands of a Presbytery, and is in fellowship in the church of which he is a member. 1 Cor. 1: 1-13. 2 Cor. 8: 5. 1 Cor. 11: 2. Rom. 16: 17-20. 1 Cor. 4: 17.

Art. 13. We believe that a proper administrator of the ordinance of baptism should be called of God, set apart by a Presbytery and in full fellowship with the church of which he is a member. Phil. 1: 1. Acts 14: 23. 1 Tim. 3. Titus 1.
