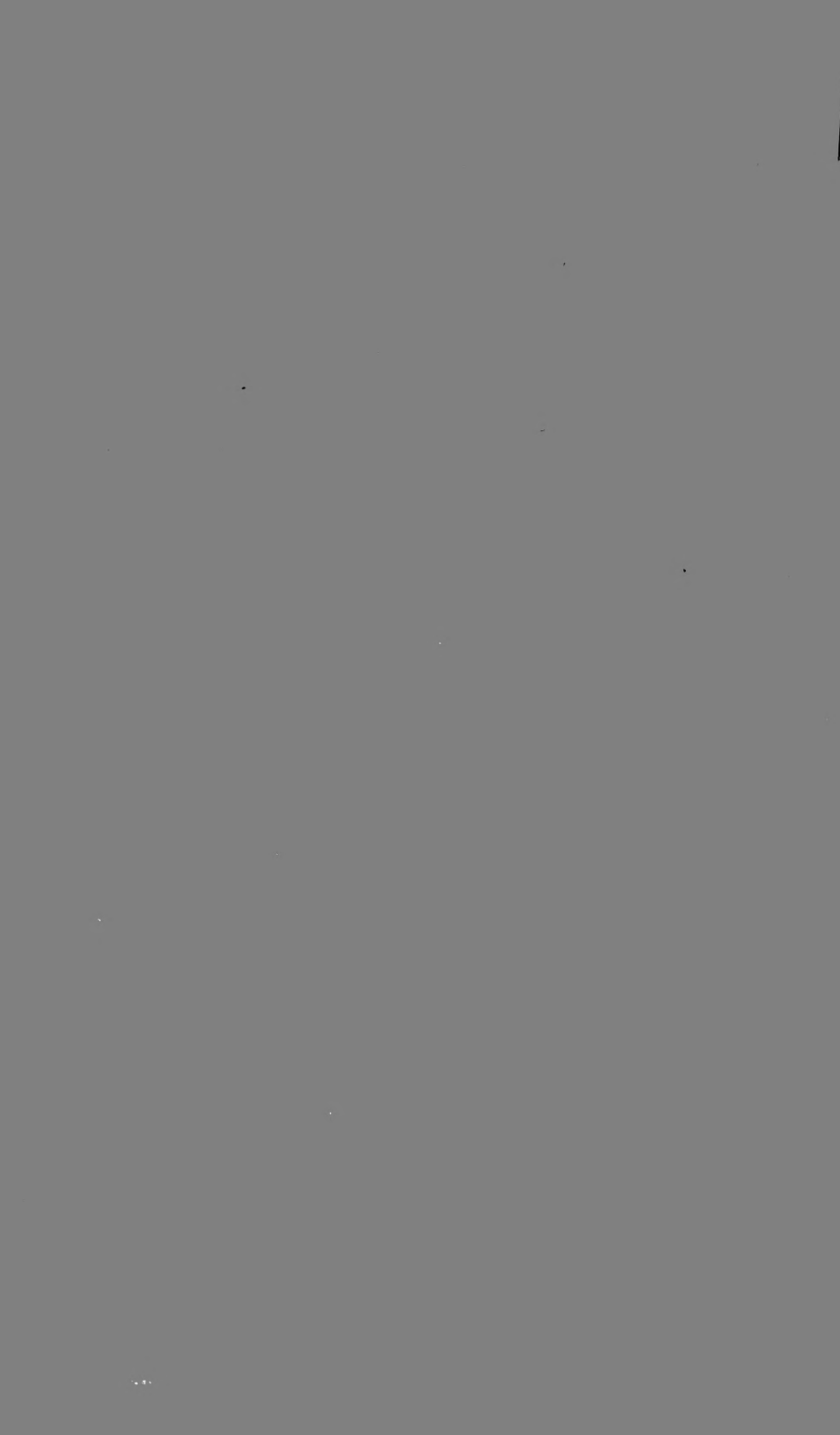

Constitution

—OF THE—

ALABAMA COLORED BAPTIST ASSOCIATION.

ARTICLE I—NAME.

This body shall be known as the Alabama Colored Bap't State Convention.

ARTICLE II—OBJECT.

The object of this Convention shall be the promotion of the gospel of Christ and general and ministerial education.

ARTICLE III—MEMBERSHIP.

This Convention shall consist of delegates sent by the Baptist churches and Associations composing this body, and individuals complying with the terms of admission.

ARTICLE IV—REPRESENTATION.

Associations and Churches holding and practicing the doctrine of Missionary Baptist churches may be represented as follows:

First Associations. An Association shall be entitled to one delegate by the payment of five dollars, and three dollars for each additional delegate.

Second, Churches. A church shall be entitled to one delegate by the payment of three dollars, and two dollars for each additional delegate. Individuals connected with any acceptable Baptist Church may be admitted to membership by the payment of one dollar, and to life membership by the payment of five dollars.

ARTICLE V—OFFICERS.

The president is to preside at all meetings, sign all orders for Convention, and perform such other duties as are usually assigned to such officer. 2. The Vice-President is to preside in the absence of the President, and perform such other duties as would be performed by the President. 3. The Recording Secretary is to keep a correct record of all proceedings of the Convention, and to read all communications. 4. The Corresponding Secretary is to do all communications for the Convention, write and sign orders for the payment of money, and to provide reduced rates for persons attending the Convention.

ARTICLE VI—STATE MISSION BOARD.

This Convention shall have a Board, known as the State Mission Board, consisting of seven persons named by the Convention, the Moderators of the Associations belonging to this body, and the officers of the Convention, whose duty it shall be to prosecute the mission work, and any other necessary business of the Convention. Eleven members shall constitute a quorum.

ARTICLE VII—TREASURER'S SECURITY.

The Treasurer shall give such security as shall be approved by the Convention. He shall keep a faithful account of all moneys received and paid out by him, and report the same at each annual session of the Convention. He shall pay out no money except by order of the Convention or State Mission Board, signed by the President and Corresponding Secretary.

ARTICLE VIII—BOARD OF TRUSTEES.

There shall be a Board known as the Board of Trustees, whose duty shall be to take charge of all properties belonging to the State Convention, and to have control of the educational work of the Convention. The Board shall consist of twelve members, four of whom shall be elected every year, as provided by the charter and shall serve three years.

ARTICLE IX—REPORTS OF BOARDS.

The State Mission Board and the Board of Trustees shall make annual reports of their respective works, make recommendations, and keep the Convention informed of the educational and religious condition of the field.

ARTICLE X—AMENDMENTS.

This Constitution may be amended by a vote of three-fourths of the members at any annual meeting.

PROCEEDINGS.

UNIONTOWN, ALA. Dec. 8th 1897. The Thirtieth Annual Session of the Colored Baptist of Alabama, assembled according to appointment, in the first Baptist church, at 10 a. m. Wednesday. Rev. J. P. Barton, president of previous year's presiding, called the meeting to order and announced the following the program as submitted by committee. Rev. L. J. Green and N. Winston could conduct the devotional exercises. The audience led by Rev. Winston, sang "I heard the voice of Jesus say etc." Prayers followed, being offered by Revs. R. T. Schell, S. Barnett, S. M. Fisher, and E. B. Young. Rev. Winston read a part of Luke 15th. chapter. "Direct my footsteps," "Alas and did my Savior bleed," "Blessed be the Name" and other songs were sung. Dr. D. L. Moorhouse Field Secretary of the American Baptist Home Mission Society, New York was introduced to the Convention and delivered an address which did much toward unifying the brethren. Among other things he said: "May we all feel that we are the Lord's trustees and trustees must serve the conditions of the trust imposed. We are one body, though many members; and as the sickness of the little finger, makes sickness of the whole body, so sin in the least one of you affects the health of all. Let us have no selfish motives. If any brother has come for any other purpose than for the glory of God he should go home.

Eleven o'clock having arrived, and the Introductory sermon being in order, Rev. S. L. Ross was appointed to lead the devotions, which he did by reading Romans 12. The Convention sang "Come Holy Spirit, Heavenly Dove." Dr. M. Tyler then announced his text, Exodus 14:13-14 "And Moses said unto the people, fear ye not, stand still and see the salvation of the Lord, which he will shew to you to-day," etc. Theme: Moses as an example.

1. His character as a servant. He believed that God's presence was with him and would be his sufficient and constant encouragement and support.

He appears dependent upon God, was meek and trustful.

2. He opposed and hindered. The foe, the wilderness, the moun-

tain and the sea surrounded while the people murmured. Only God was his hope and his encouragement.

3. He is constrained to service by his love for God. The man that loves God, can serve him under all circumstances. I am going you are coming. We fathers have begun a grent work, lead on by the God who lead Moses. There was a time when we had only three men in the convention who could do our writing, viz: Revs. W. H. McAlpine, Holland Thompson and C. O. Boothe. See how many of you can now serve as clerk. What will you young people do with the gospel enterprises which have been given to you by your christian fathers? My cradle is 72 years behind me, but my tomb is just before and I feel that I am saying to you, farewell, farewell, farewell. Glorious discourse. "Rest for the weary" was sung. Dr. McAlpine lead in a fervent prayer. "Saviour more than life to me" was next sung.

The roll of associations, churches, Sunday schools etc., being completed, the president announced the election of officers in order. After some discussion as to manner of election, it was decided to allow nomination speeches and vote by standing. Rev. Barton being nominated for the presidency, by motion Rev. Dr. Pettiford was asked to act as president during the election. The following were elected officers of the convention.

First Day—Afternoon Session.

The convention re-assembled at 5:15 o'clock. "Blessed assurance Jesus is mine" was sung. A number of prayers were offered for the success of the convention. Dr. Pettiford was requested to install the officers of the convention which he did in a few well chosen words, urging upon each officer to consider well the responsibility of the office to which elected. Each officer responded with appropriate remarks. Rev. A. A. Battle read the program as prepared by the committee. By motion the program was adopted after making the following changes: 1st Instead of Thanksgiving sermon by Dr. C. O. Boothe on Thursday at 11 a. m., the American Baptist Home Mission Society be discussed by Dr. H. L. Moorehouse. 2nd, That a committee on digest of letters be appointed to receive letters instead of having them read.

By motion Rev. Barton was appointed to respond in behalf of convention to remarks to be made at evening session by some white person. Revs. J. P. Barton, D. M. Coleman and W. T. Mackey, were appointed to look after reduced rates for those not securing certificates. The convention adjourned to re-assemble at 7:30 o'clock.

Benediction, Rev. B. G. Glover.

First Day—Evening Session.

Pursuant to adjournment Rev. J. Q. A. Wilhite, called the convention to order. An anthem—"Wait on the Lord" by the choir. Prayer, Dr. C. O. Boothe. Singing, "Happy in the love of Jesus" by the choir. Rev. W. M. Madison, pastor of the church, was introduced and delivered on behalf of the church the address of welcome. Music, "Hallelujah Praise His Name" by the choir. Response, Rev. P. J. Johnson, Union Springs. Singing, "Trusting in the Lord," the choir. Col. T. G. Fowler was introduced and addressed the convention. According to action of afternoon session Rev. J. P. Barton responded. Music "Blessed Book" by the choir. Singing—"I love Thy Kingdom Lord." Rev. R. T. Schell read Matt. 23rd chap. and Rev. A. N. McEwen offered prayer. The president introduced Rev. J. D. Maddox as the preacher of the evening who took as his text Psalms 8:4, "What is man that thou should be mindful of him? and the son of man that thou visitest him"? His subject being "Man." The sermon was forcible and was doubtless enjoyed by all. Singing, "Are you ready." Collection \$6 09.

Adjourned with benediction, Rev. D. M. Coleman.

Second Day—Morning Session.

UNIONTOWN, ALA., DEC. 9, 1897.

The Convention assembled at 9:10 o'clock with vice-president Dawson in the chair. Rev. D. M. Coleman conducted the devotional exercises. Singing—"There is a fountain filled with blood;" prayer by Rev. J. H. Garner. Dr. C. O. Boothe read 2nd. Cor. 11th, chapter. Prayer by Rev. J. L. Frazier.

The secretary read minutes of previous day which were approved. By motion the order of the day was suspended two minutes to allow the president to appoint a special committee on grievances.

The report of the Board of Trustees of the Alabama Baptist University was read in the following order: Board's report—Dr.

L. L. Barwell, President's report—Dr. C. S. Dinkins, Boards explanation of the controversy that has been going on, by Dr. L. L. Barwell. The president announced the following as a special committee on grievance: Rev. Wm. M. Madison, J. Dawson, M. M. Archer, J. P. O'Riley, S. L. Ross, P. T. Bowden, C. Carter.

The time having arrived for the address from Dr. H. L. Moorehouse, he came forward and addressed the Convention on the "Work of the American Baptist Home Mission Society." His was an excellent and forcible address. He said: "the Home Mission Society and the Baptists of Alabama were not strangers. The relation between you for the past 18 years has been the most pleasant and profitable. Its attitude is a helper only to those who help themselves. Its object being to develop self-help and self-reliance. The work among the colored people has been its largest work for the past twenty five years. Concentration of efforts on one Institution in each state, to make it permanent is the policy of the North and should be with you in the South. It has taken seventy five years and more for the white people with all their intelligence, experience and wealth to establish institutions on a permanent basis. It is well to have academies provided they do not divide the efforts from the central Institution. It is impossible for each association to have an academy. While there intentions are good, their efforts are wrong.

We have felt all along that the plan of co-operation was beneficial. We have accomplished more than ever before along the line of missionary work, and the third year will bring still greater results. The brethren in charge of the work are more competent and the people are understanding better its working. And now we come to the third year. If it can be made a pronounced success, we shall demand from the white brethren such respect as to continue for an indefinite period of this great mission work. I therefore charge you brethren, to stand shoulder to shoulder and to put more of your money, time and interest in the work, for we are now passing the most critical point."

By motion of Rev. McEwen a vote of thanks was extended to the Home Mission Society through Dr. Moorehouse and a collection was taken for the same. By motion the collection taken was made \$25.00. Singing, "Bless be the tie that binds."

Benediction, Rev. T. B. Goldsby.

Second Day—Afternoon Session.

The devotional services were conducted by Rev. A. A. Battle—special prayer for Bro. J. L. Fraizer, was offered by Dr. Dinkins, he, Bro. Frazier, having received a telegram which told of the critical illness of his child. Different passages of scripture were read and brethren were called upon to speak on them. The devotions being concluded, the president announced the discussion of the Board's report in order. Dr. C. O. Boothe addressed the Convention on the report. Upon Bro. Foster, requesting a few minutes to lay his claim before the Convention, by motion the or-

der of the day was suspended to hear from him. A proposition being made by Rev. Foster to donate \$20.00 of the \$72.89 due him by the Convention, if paid at once was accepted by the Convention. The rule was further suspended to hear from Mrs. R. T. Pollard, president Women's Convention, who was compelled on account of the sickness of her husband to return home the next day.

She made a forcible address and doubtless put the brethren to thinking more deeply upon the women's work.

By motion the Board's report be adopted by sections. The secretary read part one of the report which upon motion of Dr. C. O. Boothe was adopted. Pending the adoption the report was very warmly discussed. After a lengthy and heated discussion Rev. McEwen called for previous question and the report was adopted.

Part II. was next read by secretary. On motion of Rev. Barton the report was so amended as to say this Convention gives it hearty endorsement to the Board's plans for employment of teachers during the summer months. This report was discussed by the following: Revs. McEwen, Boothe, Bragg, Dr. Moorehouse, Revs. Winston and Mays, Brethren Wimbs, and Leftwich. By motion the previous question was put which resulted in the adoption of the report as amended. Singing, "Come ye that love the Lord."

Adjourned with benediction by Rev. A. N. McEwen.

Second Day—Evening Session.

The Convention re-assembled at 7:30 o'clock with Rev. I. Dawson, in the chair.

Singing, "A charge to keep I have;" prayer, Rev. S. T. Carter. Singing, "Come Holy Spirit Heavenly Dove." The explanation of the Board's position came up for adoption. By motion it was agreed not to re-read said explanation; but to permit Rev. J. H. Eason, to reply to the explanation. After Rev. Eason's reply, the explanation was adopted and ordered printed in minutes as part of Board's report. By motion the Board's report was adopted as a whole. At this point a collection amounting to \$52.35 was taken for the Alabama Baptist University.

Anthem—"Be ready to enter the Golden Gate," by the choir. Rev. A. N. McEwen read the 90th Psalm. Prayer—Rev. Chapman. Singing, "God moves in a mysterious way." Rev. P. S. L. Hutchins was introduced to preach the Educational Sermon. He took as his text Hosea 4:6. "My people are destroyed for the lack of knowledge etc." Theme—"Education, its needs, power and results." He said: "Our highest aim in life should be to make the world better by our having lived in it. This is a century of mind. Knowledge is life but ignorance is death. Better have a man who reads in a stammering manner but filled with the Holy Spirit, than to have a highly educated man whose life is not seasoned with the Holy Ghost. So many preachers are seeking popular applause, preaching to please men rather than God; following each other for selfish motives and because of friendship. The time has come when we want men to stand to men only when in the right. Men who are not afraid to preach the unadulterated

word of God—men to stand in the gateway and lift high the light that a sinful world may see the reflection of our Lord and his Christ." Brother Hutchins' sermon was practical and well seasoned with the word of God.

Singing, "Go preach my Gospel." Prayer—Dr. H. L. Moorehouse. By motion of Bro. J. C. Leftwich, class No. 1. of the Board of Trustees whose time expired Nov. 1897, be re-elected as class No. 5, time to expire Nov. 1902. Bro. J. C. Leftwich offered a resolution relative to Rev. P. S. L. Hutchins leaving the State. It was amended so as to include Rev. S. A. Rivers; adopted—see resolutions. "Come ye that love the Lord," was sung. The Convention adjourned with benediction by Rev. P. S. L. Hutchins.

Third Day—Morning Session.

Devotional exercises were conducted by Rev. J. A. Peals who sang, "O for a closer walk with God" and lead in prayer. Rev. W. C. Owens read 7th Psalms and made appropriate remarks. Several brethren took part by way of prayer and remarks. The vice-president called the house to order and after singing "Come thou fount of every blessing" the journal of the previous day was read and approved. Upon a statement by Dr. C. S. Dinkins of the valuable assistance rendered him in his work by the Eutaw Blade, Rev. I. Dawson Editor, Eufaula Herald, Prof. C. M. Wells Editor, The Southern Watchman, Rev. A. N. McEwen Editor, The Alabama Citizen, Rev. W. T. Bibb Editor, a motion was made by Rev. C. L. Fisher to extend a vote of thanks to said journals. The order of the day was suspended ten minutes to hear a resolution by Dr. W. H. McAlpine pertaining to assassination of Prof. P. H. Patterson of Montgomery Ala., which resolution was adopted—see resolution.

Brothers J. T. Prince and Ad Wimbs spoke on the resolution.

Prof. H. B. Jordan was introduced to the Convention. After making a few remarks, he read a poem on the Convention which he had prepared. By motion it was decided to have the poem appear in the minutes. A collection at this point to the amount of \$25 25 was taken for the Alabama Baptist University. Rev. P. S. L. Hutchins became a life member by the payment of \$5 00. The time having arrived for report of the State Mission Board, Rev. P. S. L. Hutchins read the Boards report. Rev. J. H. Eason read the report pertaining to the Baptist Leader. Then Dr. C. O. Boothe, presented an illustration of the manner of procedure in giving instruction in the New Era Institute work. While he was writing his outline on the black board the Convention sang, "I am so glad that Jesus loves me."

The outline given below and the development were pointed ra-
 cy, and clear.

THE HOLY SPIRIT

1st His Personality— (a) As appeareth in the Old Testament

(b) As appears in the New Testament. 2nd. His Work— (a) As a light giver. (b) As a comforter. (c) As a teacher.

The good to the brethren from the lecture was inestimable. From the demonstration it was apparent that every thought was clinched by the Holy Spirit. Following the blackboard exercises, came the report of the Treasurer of the State Mission Board presented by Rev. C. J. Davis. Upon a motion to adopt the report of the State Mission Board, it was discussed by the following brethren, Revs. D. T. Gully, F. A. Chapman, A. A. Battle, and Ad Wimbs. An amendment was moved to the adoption of the report to the effect that the part which refers to the contract of the Trustee Board and Baptist Leader upon the "Voice" material and the removal of the Leaders office be eliminated. After a very heated discussion an amendment was offered that the matter be left in the hands of an arbitration committee. Pending the adoption of these motions the house adjourned for dinner. "I love thy Kingdom Lord" was sung. Benediction by Rev. A. W. Ragland.

Third Day—Afternoon Session.

The Convention assembled pursuant to adjournment with Pres. Wilhite in the chair. The devotional exercises were conducted by Rev. S. L. Ross, S. S. Missionary. The debate on the Board's report was resumed. Dr. Dinkins gained the floor during the discussion and said there was something better than a contract—The Spirit of Christ. If the "Leader" come into line with the work there will be no need of the "Voice." I would rather not have the "Voice," for it simply means more work for me, if the "Leader" can be utilized for the good of the Institution. Let us be united. At this point Rev. J. H. Eason arose and extended his hand to Dr. Dinkins with the words "I am done with it," referring to the past controversy, and they shook hands amid the great applause of the audience. Rev. Fisher uniting them in bonds of peace to be held forever sacred. Then it was that a lieu motion to all previous amendments prevailed that the report be adopted.

Rev. C. L. Fisher read the report of the committee on resolutions. The report was adopted by numbers. The resolution on the Bapt. Publication Society was so amended as to include the National Baptist Publishing Board in Nashville Tenn. Pending the adoption of the 7th. Rev. S. M. Fisher made appropriate remarks. Revs. A. F. Owens, A. N. McEwen, J. P. Barton, C. L. Fisher, and others made remarks approving of Rev. Fisher's work as an evangelist. The report was adopted.

The report of the committee on Time and Place was made, presenting invitations from the African Baptist Church, Tuscaloosa, and the Berean Baptist, Marion. The Convention voted to hold its next session in Tuscaloosa.

Upon a proposition made by Rev. J. T. Prince to give the Convention \$36.00 of the \$136.00 due him, if paid now, the Convention by motion authorized the Board to pay the claims of Rev. J. T. Prince, D. T. Gully, and P. S. L. Hutchins, as much of the

money due them as can be done under the present financial conditions. The committees report on Sunday Schools was adopted (See report)

The report of the committee on Alabama Baptist University was adopted. (see report) Rev. I. T. Thompson offered a resolution pertaining to State rallies which was adopted. (see resolutions.)

On motion of Rev. W. H. McAlpine, D. D., the State Mission and Trustee Boards were authorized to take in hand the resolutions pertaining to State rallies, systematize the matter of State finance and publish the results. The following brethren were elected members of the State Mission Board. Revs. D. T. Gully, C. J. Davis, A. N. McEwen, J. R. Scott, M. M. Archer, L. P. Foster.

The report of committee on Divine services was read and adopted. The following communication, which on motion of Rev. A. F. Owens, was ordered to appear in minutes, was read by Rev. P. S. L. Hutchins:

Louisville, Ky. Dec. 7th. 1897., To the Baptists of Alabama in Convention assembled. Dear Brethren: At this writing Brethren Jackson and Tule and Sister Branton are well on their way to Africa. Sad to say, they went without money to build the chapel. We have a little for the purpose which will follow on. Will you make a special effort at your session and direct to Rev. R. A. Jackson, Capetown, South Africa? With what you send we hope to have at least \$500 on the way by Christmas day. Our effort to raise \$2500 only resulted in about \$700. The yellow fever and general hard times contributed much to this, but the ungodly complaining and insinuation of some of our papers have done us greater harm. Your Board begs your prayers and help. We herewith send you copies of our districting plans. Hoping you will see your way clear to adopt or endorse them, We are Yours in His name,

L. G. Jordan.

By motion, the request from Rev. Jordan, be refered to the State Mission Board. By motion it was decided to take a collection for Foreign Missions after the sermon to-night. The committee on New Bodies through its chairman, reported (see report)

The committee on obituary reported. By motion a committee consisting of Drs. W. H. McAlpine, W. R. Pettiford, and Rev. Wm. C. Bradford, be appointed to examine the rules of order published by Rev. J. P. Barton. By special permission Rev. J. T. Prince was allowed to speak of the amount due him by the State Mission Board. By motion the settlement of claims of missionaries be reconsidered, to bring Rev. Prince's matter properly before the Convention. By motion of Rev. M. M. Archer it was decided to supplement the appropriation from State Mission Board so as to make Rev. Prince's amount \$35.00.

By motion of Dr. Pettiford, sister J. R. England was given sister Pollard's place on program, she having spoken, to speak of the

Colored Orphan's Home recently started in Birmingham. Sister England was introduced to the Convention. Prof. B. H. Peterson was introduced. Singing "Come ye that love the Lord." Rev. Peterson read the 9th Psalm.

Prayer—Rev. E. B. Young.

Singing—"In all my Lord's appointed ways."

Rev. J. H. Eason was introduced to preach the Missionary sermon. He took as his text, Mark 16:15 "Go ye into all the world and preach the gospel to every creature." Requisites of Readiness, 1st. Knowledge of the Word, 2nd. Endowment of the Holy Ghost. The first thing to do is to get ready. I recommend you first to go get the gospel, then give it to the people. Peter, the Hermit preached the Crusade, Columbus preached the discovery of America, John Brown preached abolitionism, but we are to preach the gospel. The gospel brings to the depraved soul a friend. Christ's name makes to leap the heart of both Greek and Barbarian." Rev. Eason's sermon was scholarly, profound and logical.

Prayer—Rev. W. T. Mackey. Singing—"Go preach my gospel" Collection for Foreign Missions \$8.55. Rev. T. W. Walker agreed to make the collection \$10.00 when he returned home. A special collection was taken for Rev. A. Z. Wilson.

By motion \$250.00 of the money on hand be paid to Dr. C. S. Dinkins for settlement of some pressing claims of the University. Adjourned with benediction by Rev. J. P. Barton.

Fourth Day—Morning Session.

The Alabama Baptist State Convention re-assembled at 9:30 o'clock Saturday, with Pres. J. Q. A. Wilhite presiding. Rev. W. T. Mackey conducted the devotional services, Singing—"O for a closer walk with God." Prayer—Rev. D. M. Coleman, Singing—"Blest be the tie that binds." "Paul's attitude to the gospel, to all men and to himself." 1 Cor. 9:15-27 was the subject of the scripture lesson by Dr. C. O. Boothe. Prayer—Father John Green. Singing—"Lord in the morning we shall hear."

The president ordered the reading of the minutes of previous day which was done and the minutes stood approved. By motion of Dr. Boothe the order of the day was so suspended as to allow Dr. R. H. Boyd, representative of the National Baptist Publishing Board to speak from 11 to 11:30 o'clock. The committee on missions through its chairman made its report. The report was discussed by Drs. Boothe and Pettiford. The following was announced as committee on claims and accounts: Revs. Wm. Madison, Wm. Stephens, S. M. Fisher, L. W. Calloway, L. S. Steinback.

Dr. W. H. McAlpine, Revs. M. M. Archer, J. H. Eason, J. Q. A. Wilhite and Hon. John C. Leftwich were named as a special committee to visit the legislature with reference to changing the name of the University. Communications from Rev. Northcross and Dr. L. L. Burwell were read. By motion the letters and donations were received, and the secretary was ordered to write to them the thanks of the Convention.

Dr. R. H. Boyd, Sec. Nat. Pub. Board was introduced and addressed the Convention. He said: "Perhaps I should not seem to waste your precious time in turning your attention to my one idea. I am a crank possibly, but I am of the opinion that this world must be run by cranks. In other words the man of one idea is the man of power. I believe this, and therefore I act on one idea. I bear to you the greetings of the National Baptists Convention. We had in Boston a good meeting, but it was not best to go to Boston, for the white people of the North do not understand Negro life. We have first a Foreign Board, which brother Jordan is leading as he works himself to death under misunderstandings and abuses, because of which he will soon join Simmons, Luke and Vann in the other world. 2nd. The Educational Board is led by Dr. Bishop Johnson. 3rd. The Home Mission Board of which I am secretary.

I am not against the publication society. We can never know what good has been accomplished in our behalf by this society. They deserve our gratitude forever. But we must make literature for ourselves, for the reason that only Negro persons can express Negro history and experience. We must make our own books or else we shall never be expressed.

We don't fight the American Baptist Publication Society. If there was a disposition on our part to fight or stop patronizing this great society it would be fifty years from now before we could do so". After answering some questions concerning the writers for the teacher, he concluded his address. The address was simple, and practical and enjoyed by all.

Having received the needed information, Rev. W. T. Coleman offered a resolution pertaining to Rev. J. T. Brown, one of the writers for the National Baptist Publishing Board, which was adopted. (see resolution)

Sister J. R. England was introduced and addressed the Convention on the "Orphan's Home" recently started in Birmingham. She made a very touching address on behalf of the little orphans who wander the streets, and made an excellent impression for the "Home." A collection of \$1.02 was taken for the "Home."

Rev. S. L. Ross, S. S. Missionary addressed the Convention on the work of the Publication Society. By motion of Rev. Ross \$5.00 was donated to the Society.

Prof. C. M. Wells made a statement concerning the burning of the Eufaula Bapt. High School. By motion of Rev. P. S. L. Hutchins, a special collection of \$2.50 was taken for the school. On motion of Rev. Hutchins \$5.00 was donated to the National Bapt. Pub. Board and \$5.00 to the Baptist Leader.

The secretary read a communication from Rev. R. T. Pollard in which he asked the Convention to pay Bro. R. B. Hudson \$5.00 for compiling the statistics of the Convention, as he was sick and unable to do the work.

By motion the request was granted and Bro. Hudson received the \$5.00.

The secretary read the statistical report. The committee on

Barton's rules of order reported. The Finance committee through its chairman Rev. Bradford submitted a partial report. The committee on Temperance made its report in the form of a resolution, (see resolutions on temperance.) Rev. A. F. Owens offered a resolution on the Eufaula Academy, which was adopted. On motion of Rev. Hutchins \$100.00 was set aside for printing and distributing minutes. On motion of Rev. Bradford the secretary was paid \$20.00. On motion the sexton was paid \$5.00 By motion 2000 minutes were ordered printed. By motion the remainder of money on hand and all to be collected be given to Selma University. Bro. Archibald of Pickens County Association was introduced, and addressed the Convention.

Rev. Owens offered resolutions of thanks which were adopted. By motion of Rev. Owens, a vote of thanks was tendered Rev. J. Q. A. Wilhite, the president, for his satisfactory ruling.

On motion the Convention adjourned to meet Wednesday before the 4th. Sunday in November 1898 with the African Baptist Church, Tuscaloosa, Ala.

Thus ended the Convention, which session has been looked forward to with much interest, as one of the most critical in the history of the Alabama Baptist, yet it was harmonious and peaceable. Differences being buried and the Baptists brought more in touch and sympathy one with the other.

REPORT OF BOARD OF TRUSTEES.

Brethren of the Convention, we the Board of Trustees of the Ala. Col. Baptist University, feel proud in making this our annual report. We fully believe that the hand of the Lord has been over us guarding and directing our every step. Though we have had many interruptions and hinderances during the last Conventional year, yet we can bring to you the glad news to-day, that the school is in a better condition, financially than it has ever been.

Instead of increasing debts, we have been steadily reducing them until only \$497 of old debts remain unpaid.

The closing of the last session of our school made a deep impression upon the Baptists of Alabama. Some very promising young men and women received their diplomas and are now engaged in active educational work.

On the very eve of opening the present session, we were interrupted by the small-pox scare and the yellow fever which compelled the President to close school for a long time. After which school again opened and is doing a splendid work.

The President has shown his ability as an educator and financier. By his financial manipulations he prevents the accumulation of debts.

By his careful directions young men are being prepared of which we have high hopes for the future.

We have undivided and unswerving confidence in his ability and gentlemanly standing.

We have a faithful and able corps of teachers, who seem to be greatly interested in their work, who are working with untiring efforts to promote the educational welfare of the school and class-room.

We heartily recommend the support of the college.

We also have in school to-day some as promising young men and women as ever left the school. With continued interest and co-operation on part of the Baptists of Ala. they too will soon go for the helping to conquer the world for Christ and humanity.

BUILDINGS.

We have been unable as yet to make any additions to the buildings, owing to the pressure of back debts, yet with a few minor repairs the present buildings present a very handsome appearance.

RECOMMENDATIONS.

It is a source of regret that we again have to report to you the unfinished wing of the girl's building. But we have in hand \$275.00 with which to begin the completion of the building, and recommend to this Convention the immediate raising of \$2,000 dollars, of this amount, we can assuredly say that the women will raise \$500.00 leaving the men to raise \$1500.

We further recommend to this Convention the necessity of put-

ting up another building known as the boy's building, and the removal of the posterior portion of the Woodsmall building, and the repairing and painting the same.

We are cognizant of the fact but little can be done in this direction, we simply place this before you for present and continued consideration until such a building is complete.

Feeling the need of disseminating the workings and needs of our school, and the general work, and to arouse interest in our work as a board throughout the State, we do recommend to this Convention, a reviving of the Student's Voice, and the placing of all the type, press, and any and all things belonging to said paper under the control of the Board of Trustees.

We humbly submit this report to you for careful and immediate consideration.

To conduct the work of the literary department of the Institution, including the industrial work and work of lady principal required \$3,751.22. This money came from the following sources:

This does not include any part of Dr. W. H. McAlpine's salary which if added, would make the amount more than \$4000.00. I have called your attention to this particularly, that you might consider the heavy burden we are carrying; and yet this amount is far too small to do thorough and efficient work.

THE TEACHER'S WORK.

Experience has taught that a man cannot do the regular work of teaching and pastoring as thoroughly as the one who gives his whole time to teaching. This is the conclusion of the most eminent educators. If the work in the school room was all that was required of the teacher, this might be done after a fashion. But the true and faithful teacher knows that is not all. Every spare moment is needed to prepare for his classes. When this is done, where is the time to make regular and thorough preparation for the pulpit? Or if he prepares as he ought for the pulpit, where is the time to prepare for the class room? In cases where this is done, both the school and church suffer. There are scholars out in the world who to-day are deficient in their studies, and their deficiency is due largely to the fact that their teacher had too much work. No parent wants his child neglected in the school especially if he pays the charges, and yet that is what is done when teachers have regular work on the outside.

Teachers like pastors ought to be paid for their services, so that they can give their time, thought and strength to their work. That the denomination can do this needs no argument. 9 cents a piece from 500,000 members would more than pay our teachers without any aid from the Home Mission Society.

THE CLAIMS THE INSTITUTION HAS ON THE CHURCHES.

Has the Institution any claim upon the churches? This, it seems to me is an important question, for upon the answer to it depends the duty of the churches to support it or not as the case may be. Article II of the Constitution says: "The object of this Convention shall be the promotion of the gospel of Christ and

general and ministerial education." A fair interpretation of the great commission makes it our duty to support the cause of christian education. Moreover our duty to ourselves, to our children, to our denomination and to the world makes it our duty to support a christian school. If these things be true, which no intelligent and true hearted christian will deny, then it follows that we cannot choose to do or not do as we please. Our duty is plain and we cannot with impunity disregard it. And yet our report shows how few there are who are regarding their obligation. It is difficult to see how we can ask the favor of God upon ourselves when we are so negligent.

OUR HINDERENCES.

Our financial condition has during the last few years prevented our bringing our work before our people as it should be. As a consequence we have suffered very much. The churches are becoming ignorant of the work, as a result their interest is not as great in many cases as formerly. To remedy this the Board was requested at their regular meeting in April 1896 to secure the services of Revs. C. L. Fisher and J. H. Eason through the summer of '97. No objection was raised to the plan at that time nor for a year afterwards. Had it been carried out, the work would have been brought before the denomination in a very effectual manner, students would have been secured, money would have been raised and the work would have been helped generally. But opposition was raised to the plan and it failed. In this connection it will be out of place to quote a statement concerning the Home Mission Society, found in the N. Y. Examiner. It is as follows: "After the death of Dr. Halsey W. Moore, the efficient secretary of the American Baptist Home Mission Society, it was decided to leave the office vacant for a time in the interest of economy, hoping that the pastors of the state would bring to the attention of their churches the work of home missions, and secure for its treasury an annual collection. Some pastors have loyally and efficiently done this, but a very considerable number have failed to do it. The result has been that the work of the Home Mission has lost its hold on many churches, and other causes pressed by special agents have come in to take its place. It is felt therefore that the experiment of dispensing with a secretary for home missions in this part of the field is not a success. The Board will probably at an early date, proceed to elect a new secretary."

Such is the statement. How well does it express our case? The plan presented to the Board was more economical than the employment of a regular financial agent and would accomplish as much or more. The cost to the denomination would be less than 3 mills apiece. Many of our people are too eager to find an excuse for not giving. A little encouragement in that direction enables them to find it easily.

THE HOME MISSION SOCIETY.

The Home Mission Society during the year 1896-'97, gave to our work, \$1300.00. The Women of Chicago gave \$320.00. I would recommend that a vote of thanks be extended by this Board

to each of these organizations for their liberality and ask the continuance of the same. At their annual meeting in June the Home Mission Society voted to donate \$1000.00 to us this year '97-'98. The decreased appropriation is no indication of any lack of interest, but rather a lack of money. Their interest in us real and sincere as witness the fact that though so heavily burdened they listened to our earnest appeal for an increased appropriation and gave us \$272.00 more, and that in face of the fact that they had denied others whose appeals seemed almost as urgent. Certainly we have every reason to thank the Society without whose aid our work would be almost hopelessly crippled.

THE UNFINISHED WING

Many have asked why has not the girls' hall been completed? Our answer is that we have been paying the debts of the Institution, which three years ago amounted to \$370,000. The amount we have paid on debts would more than complete the wing. We are glad however to say, that the debts will soon be settled, and then we can begin the work of improvement. Ours is a building like the cost of making and burning a kiln of brick on our ground, we find that we have sufficient money on hand donated by the women with which to do this. The Board is authorized to lay this out now, also to make some necessary repairs on the building. We shall be building.

REMARKS:—The amount received last year (95-'96) was \$2181.26, making the amount this year \$824.60 less. Had it not been for the fever, in all probability the amount this year would have considerably surpassed that of last year. There were 105 persons who contributed directly to the work; 76 churches, Sunday schools and societies; 41 Associations and Conventions. The average amount given by those persons who contributed directly to the work was \$1.86. If one-third of our entire membership would each give only one-fourth the amount, we would realize over \$27,000.00. If this were an impossibility we would not say anything about it. Suppose we should distribute this amount equally among 12000 members to raise for our work, how much would it be? Exactly 18 cents a piece. Can we raise this amount if we try? If we all were truly interested in the work as some are, we could do so. If we refuse to give because things are not just what they should be we will never give. It is an easy matter to find fault; it does not require any great amount of brain to do that—it is not so easy perhaps to suggest a remedy. DESTRUCTION is much easier than CONSTRUCTION. A sympathetic rather than a fault finding spirit is the thing we need in our work at this time; with such a spirit on the part of all success is ours.

TEACHER FOR THE SEWING DEPARTMENT.

At the last meeting of the Women's Convention at Anniston, Mrs. A. A. Bowie resigned her position as teacher in sewing. She rendered four years of earnest service, and accomplished much good. Since her resignation no one has been found to fill her place. The position is not so easily filled as most persons might think. The Executive Board of the Women's Convention is on the lookout for a suitable person for that work.

And now as we review the work of the past year we have every reason to believe that God has been with us and blessed us, and that he has great things yet in store for us, if we will only prove ourselves worthy of them. I would suggest to the Board and through the Board to the Convention that when the debts have all been paid that a day set be set a part as a day of thanksgiving for deliverance from debts that have been resting on us fully 12 years or more and that we have a grand rally in which to raise money to complete the south wing.

AN EXPLANATION TO COLORED BAPTISTS OF ALABAMA.

By order of the Board of Trustees of Ala. Colored Baptist University given in its meeting held July 29th. '97, the undersigned committee hereby explain to the denomination certain matters about which there has been much controversy in newspapers, circulars and otherwise.

The Board not having a meeting since April, could not, even if it was thought prudent to so do, order this explanation sent out to the denomination. And in making this explanation the Board desires to thank the denomination for its cordial support in the denominational work of education, and at the same time to assure the denomination that the Board is fully aware of the great responsibility resting upon it, and therefore is leaving nothing undone that would indicate that there is carelessness on the part of the Board.

At the time of the meeting of the State Convention, held in Opelika, November, 1895, the trustee Board was re-organized in keeping with the new charter granted the Board.

It was reported to the Board, that one of the teachers, who besides the work in the school, served as pastor of two churches, and was editor of the Baptist Leader, was complainant of as not being able, because of these extra burdens, to do his full duty in the school room, that as he had to go away on the train twice per month in order to reach one of his churches, he necessarily every other week was unable to meet and do his full duty to one or two of his classes in the school room, his train reaching Selma about 9:30, a. m. while the school opened about 8:45. a. m. as the report did reach the Board through the President of the school, the board sent for the president afterward for the teacher in question, to ascertain from the president first whether or not these reports were true, and from the teacher to account for the conditions.

The Board finding that much time was lost by the teacher, not only when he went to one of his churches, but also when during school hours the teacher was compelled to be in the Leader office, requested the teacher to give up his church to which he had to go on railroad and also the Baptist Leader.

One or two months later the Board finding that the teacher was not inclined to comply with the request, although the Board had raised his salary to five dollars per month more, held a second meeting and re-affirmed its actions touching upon the teacher.

Finding that the teacher was still unwilling to give up the work which he was requested to leave off, the Board was advised that it was prudent to let the teacher hold this extra work till the close of the session of the school. This was agreed to.

In April, 1896 the Board held its annual meeting for the purpose of electing teachers for the next session. Before going into the election the Board passed several rules governing teachers, among them was that the teachers should not be pastors of churches while teaching, nor should they do any other work that might interfere with their duties in the school room.

Before electing this teacher in question, the Board sent for him to know whether or not this teacher would comply with the rules made and give up his outside work.

Also the Board asked this teacher and one other to serve as financial agents during the present summer months. This teacher promised to give up his outside work, and serve as financial agent during the present summer, 1897.

But about 10 days before the opening of the session of school of October, 1896, the teacher wrote letters to members of the Board asking to be allowed to keep his churches and the Leader, also to be relieved from his promise to do work as financial agent during the summer.

The members of the Board did not agree to his request to hold the extra work, but expressed, some of them, their willingness to excuse him from the summer work if his salary be fixed according-

ly. When school opened the teacher was allowed to begin work in the school on his assurance to the president of the school, that he (the teacher) had complied with the request of the Board.

After school work began, it was found that as a matter of fact the teacher had not given up his outside work. The president called the teacher's attention to this neglect and informed him that he must comply with the request of the Board to give up the school work.

On the teacher's refusal to do either, the president informed that in case the teacher failed to comply with the rules he would forfeit his salary. After the school had run about two weeks, the teacher gave up his work as teacher, rather than give up his other work. When the State Convention met in 1896 in Birmingham, the Board held a meeting and sent for the teacher and offered him his place in school, provided he would comply with the rules. To this proposition the teacher refused to concur, but was willing to return to his work if he be allowed to keep his other work.

In this Board meeting in Birmingham the Board agreed to raise the salary of Rev. C. L. Fisher, one of the teachers, ten dollars per month more with the understanding that Prof. Fisher raise this amount when doing mission work on the Sabbath, as the Board in giving this order to Bro. Fisher was not as clear and specific as it might have been (though with no intention to license him to take full charge of the school) it was soon found that Bro. Fisher was doing the very thing to which the Board had previously objected. In the first meeting of the Board afterwards, Prof. Fisher was required to give compliance with the rule of the Board.

But because of the dissatisfaction from several because Bro. Fisher was doing this work he had ceased to preach as pastor of the church when the Board met.

The Board has been charged with bringing an unnecessary expense of \$620 a year on the denomination. When a committee of fact it is only \$290. For instance one teacher who received last year, \$65 per month for 8 months, making \$520, receives under the present arrangement only \$75 per month for 12 months, making \$900. The difference in salary on the part of that teacher, it can be readily seen is \$140. The other teacher who received \$55 per month for 8 months last year gets only \$70 per month for 12 months under the present arrangement. This makes a difference of \$160 on the part of that teacher. So you see that the Board increases the financial obligation only \$300 for two teachers, but for this increase the Board gets 8 months work—four months from each teacher. The Board is thoroughly convinced that teachers cannot do their duty in the school room and on the school grounds and hold pastoral charges and other burdensome outside work.

The double work of the President, acting as president and financial agent all at the same time has been found entirely too hard for one man.

The president complained of the extra work put upon him, and

recommended that these teachers be allowed to help him in this way. The Board felt that it saw the wisdom in thus doing, because in the first place, it gives the teachers sufficient support to enable them to do their full duty without resorting to outside work during the school session, and secondly, help the Board to meet the need of more help for the president in his duty as financial agent with the least cost to the Board.

Besides all this, the schools of the grade of ours pay such teachers as these in question from 70 to 75 dollars per month. Previous to three or four years ago the Board paid such men as Profs. Alston, Rishel, Purce, Dinkins and Fisher salaries equal to 70 and 75 dollars per month, that means that the two teachers now in question are asked to serve for 12 months for the same amount these other teachers used to serve only eight months. In order to hold our teachers we have got to give them about what other men of their standing and education are getting in the pastorate or in other schools. Now if the Board can so arrange, that with the same amount of money that it used to pay teachers to work eight months, it can get them to work twelve months, thus meeting two needs, that of securing the teacher, and also giving the Board more aid in raising money, and work up an interest in the school who can reasonably object?

The employees of the State Mission Board are confused with the employees of this Board. The names of several brethren who, it is claimed worked during the summer for the Board and did not raise their salaries, when as a matter of fact not one of these brethren named, except Rev. M. M. Archer was ever in the Board's knowledge employed as financial agent, and if the Board owes them anything it has no knowledge of the debt. Rev. M. M. Archer was employed by the Board but not in the summer months.

Finally, the Board feels that the denomination owes it to its own interest to condemn the action of our brethren in intercepting the plans of the Board by sending out circulars and giving untruthful and misleading statements concerning the Board's actions. The Board has no objection to the proper public criticism of its action, and the proper time is at the State Convention when the Board renders a report of its doings. But if every body who has an opinion gets up in public places, and by circulars criticise the Board, the Board cannot hope to succeed. It is the privilege of the State Convention to call the Board's attention to what may be regarded as an error, and if the Board persist in making them their resignation can be easily called for.

Hoping this explanation will justify the Board in the eyes of the denomination, we subscribe ourselves,

On March, 4th, it became our painful duty to accept the resignation of Dr. W. H. McAlpine, by reason of his having been called to the pastorate of Tabernacle Church, Selma, Ala.

This put your Board to some disadvantage for a while, because it was not an easy task to find a proper successor to this Prince in Israel.

Your general missionary, Rev. R. T. Pollard had to do more than his duty to keep up an interest during this vacancy—hence his indisposition today—billionsness and overwork.

But we are pleased to announce that, a kind and wise heavenly Father, who is always faithful to those who put their trust in Him, had in reserve for this vacancy the invincible and time honored standard bearer, Dr. W. R. Pettiford, whose services your Board was able to secure. He entered heartily into the work and has endeavored to foster all plans of the Board in carrying forward the work.

Success has been his, under peculiar circumstances.

The fifth Sunday in last August was rally day for Mission work, under the auspices of your Board. Two thirds of all monies raised in said rally were to go for the co-operation plan, and the remaining one third is to go to the long standing claims against your Board.

The rally was not a financial success as desired. Only \$79.99 Seventy nine dollars and ninety nine cents were realized. If the amount raised is the measurement of missionary zeal among the nearly two hundred thousand colored Baptists in our State, it is a sad comment thereupon.

We are pleased to say, that, by the assiduous labors of our missionaries, in connection with money raised on rally day, we have obtained \$284.68, Two hundred, eighty four dollars, and sixty eight cents.

The report of the Baptist Leader, will be made as usual, by its management, Editor, J. H. Eison.

We regret very much indeed to announce that by force of circumstances, Rev. R. T. Pollard offered his resignation, but the Board has requested him to recall it.

SECOND ANNUAL REPORT,

R. T. POLLARD, GEN. MISSIONARY FOR ALABAMA, FOR YEAR BEGINNING DEC. 1, 1896, ENDING NOV. 30, 1897.

To the State Mission Board.

DEAR BRETHREN:—By the goodness of God we have passed through the second year of co-operation, and I now present to you a report of the field and of our work during the year. At the beginning of this year the missionaries started out with new inspiration gotten from the report they were able to make to the Board and the Convention last year, and the expressions of joy shown by the actions of the Board and the Convention touching the report of missionaries. The outlook was brighter than ever before, but the resignation of one of our district missionaries, and the failure of the Board and the co-operating bodies to take prompt steps to supply the vacancy, caused a lag in the work. For eight months one of the districts was without a missionary. Added to this the quarantine regulations to prevent the spread of yellow fever greatly interfered with missionary work just as they did every other business. Yet through all this we have great reasons to thank God for the spirit of mission that is being kindled in our State by the plan of co-operation, and for the healthful effects the institute work is having upon the pastors, churches and the masses.

I do not hesitate to predict that if the denomination continues to prosecute this method of mission work, ten years a revolution for good will be worked in our churches, among our ministers and in the attitude to our denominational work. Dr. Boothe the district missionary for the Tennessee Valley reports encouraging progress in his field.

Rev. W. R. Pettiford, D. D., was appointed to fill the vacancy made by Dr. McAlpine's resignation. He began work August 1st, last and is prosecuting his work with telling effect. The following is a summary of work done this year:

REPORT ON BAPTIST LEADER.

One of the institutions planted by our fathers to be fostered by us, is the Baptist Leader. To our honor is it, that it still exists.

Marvelous have been its struggles, and like the Baptist denomination, great has been its unostentatious success.

Inexperience and ambition have tripped it up several times; but like Babylon, it has arisen every time it fell. Like a child it has toddled to learn to walk. When I rendered our report to you 12 months ago in Birmingham, the thought was in mind to return it to you, as a burden too heavy for my youthful shoulders. But the liberal donation given, and the resolutions passed encouraged me, and I rallied my energies to the task once more.

With clouds lowering around, and sky darkened we pulled out

for another year's struggle, hoping the sun would shine before we shall have gone far. But not so. By January distant rumbling thunder was heard, a little later the lightning flashed and the cold rain fell, and the chilly winds blew. We were in the storm.

How well we have wrought ye are judges; how I have suffered, I know best.

Money to operate the paper was secured after the hardest effort.

Brethren warred with one another through its columns. The indifference and opposition chargeable to the contestants, were laid at the door of the paper. Notwithstanding, the paper has gone to the people this year with some increased regularity. It has been issued 43 times this year—failing to come out nine times out of 52 weeks; three of which failures being caused by the yellow fever. Fifty dollars worth of type have been added to the office. For this type the money donated to the paper last year in Birmingham, has been paid. The paper cutter on which we proposed to use a part of the money in fixing, could not be mended for the amount donated, for the reason Mr. W. M. Montgomery, who was foreman at the time, misplaced a costly piece of it.

Out of the appreciation of the honor done me in leaving the money with me to use as I saw best and in keeping with the sentiment that it should be used in getting material for the office; seeing I could not use it profitably on the cutter, we turned it into type: which was our greatest need in the office at that time.

A thirteen dollar mailer has been added to the office also.

The Leader has arranged with the Board of Trustees to remove the building it now occupies to a location on Philpot street; on the north side of the Uni. grounds and pay for its use \$2 00 a month.

For the use of the University printing material in the Leader's possession, we have agreed to allow the University a column in the paper each week, and do \$30 00 worth of printing free yearly.

We are needing money to remove the house and fix it up with better facilities. We need a font of Italic type; a paper cutter, and brass rules. Our needs are many. Our office is growing every day, it takes more money to run it.

OUTLOOK FOR THE FUTURE.

Notwithstanding the great struggle the paper has had this year it looks out with hope for the future.

The press in the buying which it has been interested, is now paid for.

The \$394.07 reported at the last Convention has been reduced to \$225.00; a large amount of money used in running the paper this year has been donations from churches, conventions, associations and individuals; to all of which we turn our most grateful thanks. We would mention your names but space will not allow us. We are sorry to say our subscribers have not paid up very well this year. Out of twelve hundred, there are 700 who owe the whole or part of this year's subscription. They told us, and tell us, they will pay. We borrowed money and sent the paper on their word and have had to pay it back out of our pockets. We

hope the paper has done them some good. We are glad to say that there remains a debt on the paper for the present year of only \$25.00. We have four young men in our office to work regularly. Mr. Ira T. Bryant is working our job department up to be second to none in the State. Mr. J. B. Eason has charge of the mechanical work of the paper. Revs. J. A. Martin and J. R. Scott, are now associated in the operation of the paper.

There help and council have been valuable. We thank God that we have been able to run a paper that has been so generally accepted by the people we serve. If it be ours to run in the future, we hope to make it more acceptable and profitable to all.

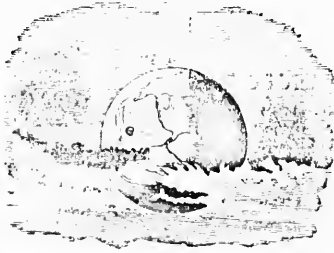

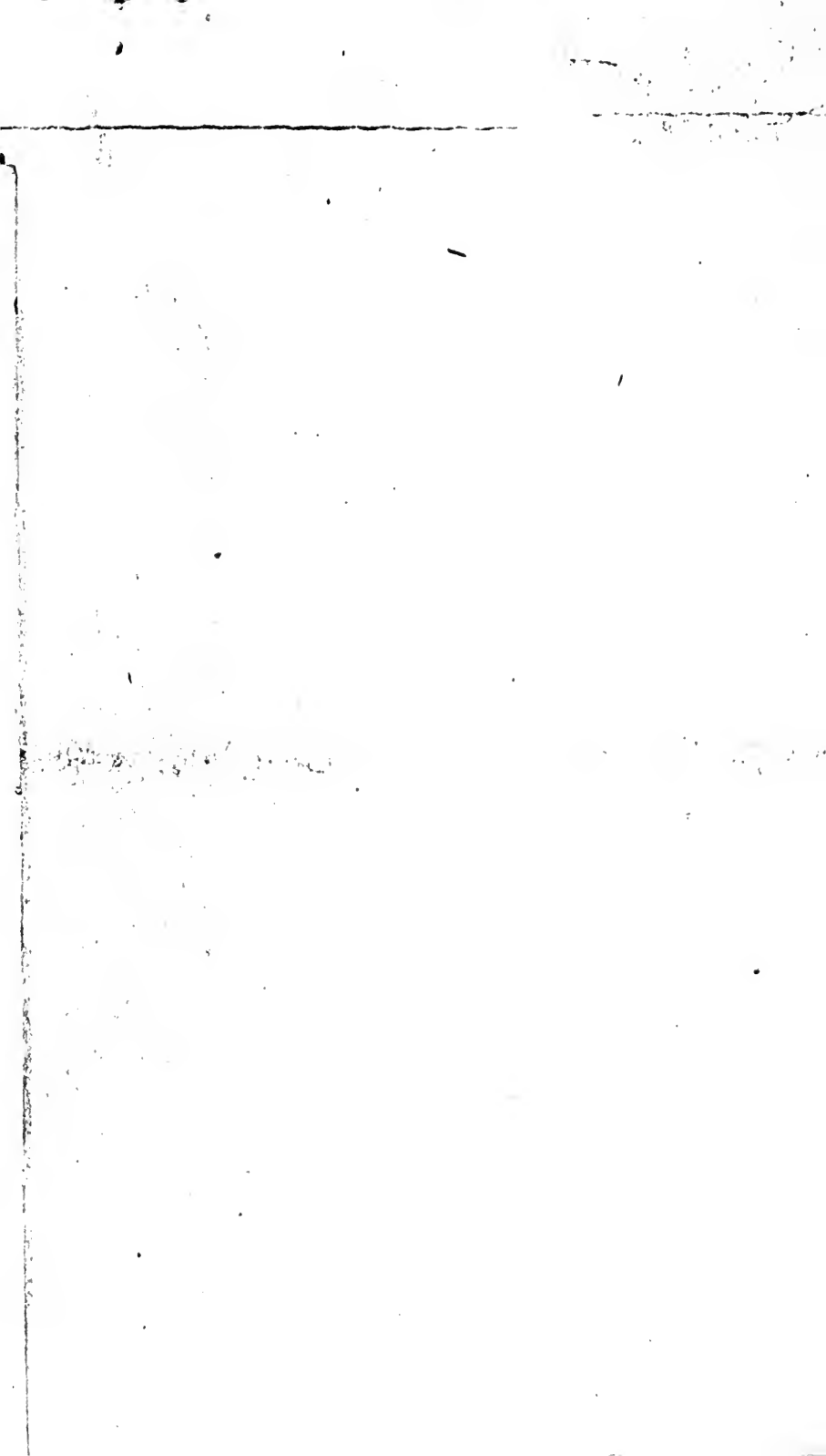
