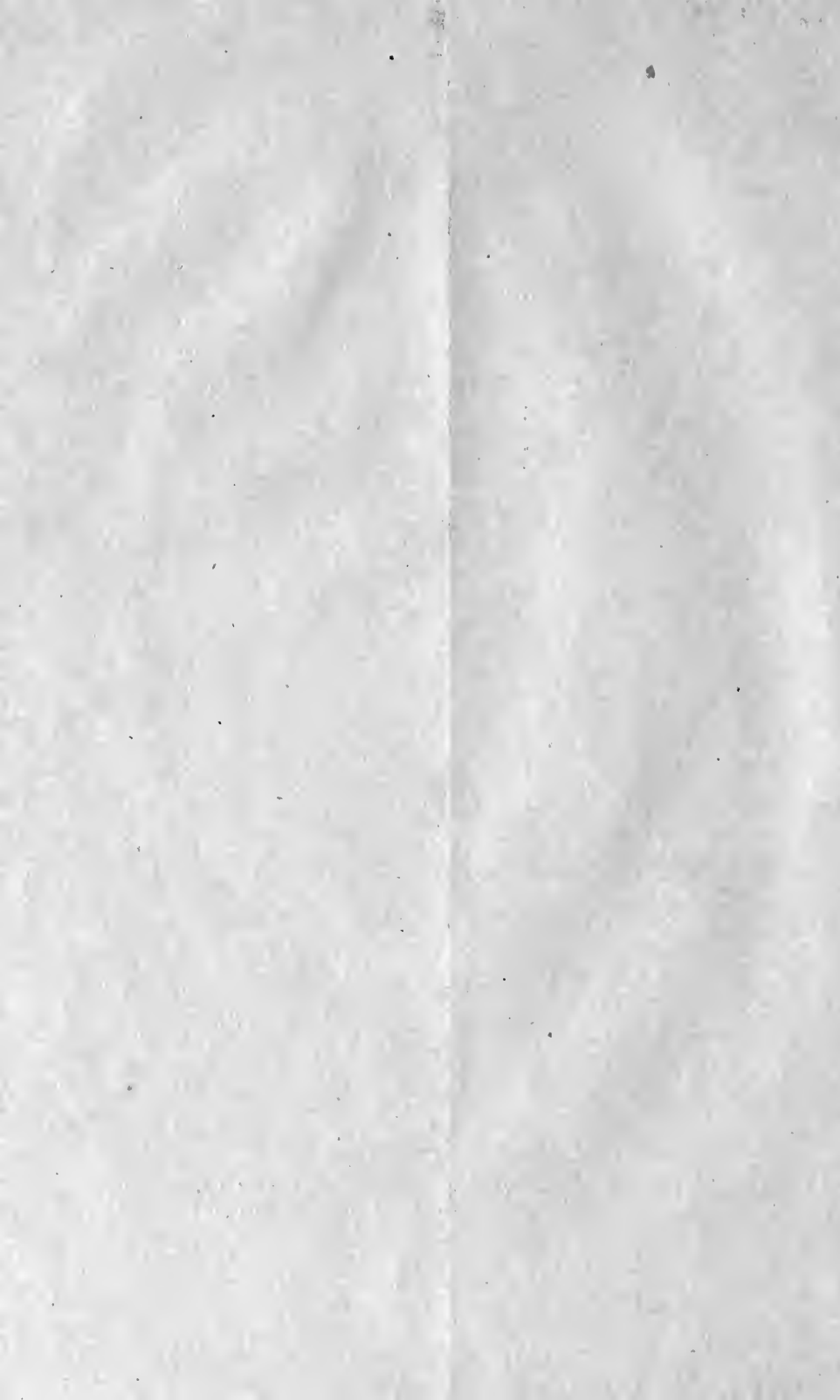

 SATURDAY, September 27th, A. D. 1879. }

11 o'clock, A. M.: The delegates composing the Boiling Spring Association, met pursuant to adjournment. The Introductory sermon was preached by Elder J. D. Jordan, followed by Elder J. A. Shaddix. Text: 2nd Timothy, 2nd chapter and 15th verse. "Study to show thyself approved unto God, a workman that needeth not to be ashamed, rightly dividing the Word of Truth."

After Intermission of one hour, the delegates assembled to complete Organization.

1 o'clock, P. M.: The Moderator being absent, on motion, Elder A. F. Allen was requested to act Moderator *pro tem*.

The Moderator announced the election of Officers in order, and requested Brethren B. W. Mattison, and Dr. C. B. Hughes of the Coosa River Association to act as tellers. Elder A. F. Allen was elected Moderator, and J. W. McClintock, Clerk.

The Moderator announced the organization completed and ready for business.

On motion, adopted the former order of business.

Read the Rules of Decorum.

Enquired for churches desiring membership with this body, when letter and abstract of principles were presented from Corinth church by the delegates, and on motion, was received by the Moderator, giving the right hand of fellowship in behalf of the body.

Invited visiting Ministers to seats and called for correspondents from other Associations. Received from the Coosa River Association Elder S. G. Jenkins, and Dr. C. B. Hughes, B. W. Mattison, A. McCane. From the Cary Association Elder E. M. Moore.

Correspondents welcomed by the Moderator.

Appointed a committee to arrange preaching, viz: M. H. Morrison, E. A. Smith, W. W. Payne with the Deacons of Salt Creek church.

Appointed a committee on Finance, viz: J. H. Davis, J. H. Fullerton, N. C. Kennedy, E. B. Kilgrove.

Joined in Prayer in behalf of the churches, Elder S. G. Jenkins leading.

The committee on preaching reported Elder J. A. Shaddix to preach at candle-light, followed by Elder E. M. Moore, Elder S. G. Jenkins at 9 a. m. on Sabbath to preach a sermon Dedicatory of the New Church house and on Communion.

Adjourned to meet 9 a. m. Monday. Benediction by the Moderator.

*Devotional.*

Sabbath, 9 A. M. Sermon by Elder S. G. Jenkins, followed by Elder J. D. Jordan. Text: Corinthians, 11th chap 23rd to 25th verses inclusive. At 11 o'clock, in church house, Missionary sermon by Elder A. F. Allen. Text: 6th chap of Mark, 12th verse. Same hour in school house, sermon by Elder H. C. Knight. 2 o'clock P. M. sermon by Elders J. D. Jordan and J. A. Shaddix. Same hour in school house, sermon by Rev. W. G. Preston, followed by Elder J. W. Stephens. At candle-light, sermon by Elder J. W. Chandler, followed by Elder J. M. Barrett.

The different subjects were ably elucidated, and listened to by large and attentive congregations, good order prevailed, with the exception of one or two parties, who seemed to spurn the preacher, whose names we forbear, Oh, may God spare them yet a little longer!

## MONDAY, 9 O'CLOCK A. M.

Assembled pursuant to adjournment, the body was called to order by the Moderator, and led in prayer by Elder J. W. Chandler.

Called the roll and marked absentees.

Read and adopted the preceding Minute.

Renewed the invitation to visiting ministers.

Renewed the call for correspondents.

Called for reports of standing committees.

Report on domestic mission read and adopted. See appendix A.

Report on the Bible, read and adopted. See appendix B.

Report on Sabbath schools, read and adopted. See appendix C.

Report on obituaries, read and adopted. See appendix D.

Report on Family Worship, read and adopted. See appendix E.

Report of the committee to answer Queries was called for, only one committeeman being present, on motion, the order of business was suspended to allow the Moderator to appoint two, to act with Brother G. H. Preston, and that they be allowed further time. Committee E. B. Kilgroe and J. A. Kennedy.

Having come up with the former order of business, on motion, agreed to proceed until time to adjourn for refreshments.

On motion, went into the election of Brethren to preach

Elected Elder J. A. Shaddix to preach the Introductory, Elder H. C. Knight Alternate. To preach the Missionary sermon, Elder J. D. Jordan and F. M. Campbell, Alternate.

Called for the report of the committee to answer Queries. Report read and adopted. (See Appendix I.)

On motion, adjourned for refreshments until 1 o'clock.

1 o'clock, P. M.:—Re-assembled, called to order by the Moderator, was led in prayer by Elder J. M. Barrett.

On motion, suspended the order of business to hear a request from Jasper Wilkerson, who claims that he has been unjustly excluded from Salt Creek church, and after hearing his petition and request, on motion, a committee consisting of Brethren J. A. Shaddix and J. W. McClintock was appointed to go and enquire whether proper steps has been taken or not in reference to his case.

Called for report of Finance Committee, report read and adopted. (See appendix J.)

Treasurer's report adopted. (See appendix K.)

On motion, adopted the following resolutions :

*Resolved* 1st, That the District meetings are hereby requested to send up a report to the Association, through the Clerk, the church with which they desire the body to convene.

*Resolved* 2nd, That the brother Clerk is requested to have as many minutes printed as the funds will justify and distribute them according to the funds sent up by each church.

*Resolved* 3rd, That the Brethren, Sisters and Friends of Salt Creek church deserve, and that we hereby tender them, our thanks for their hospitality during the outgoing session.

*Resolved* 4th, That the next session be held with Mt. Moriah church 3 miles east of Delta, in Clay county, to convene on Saturday before the 4th Sabbath in September, A. D. 1880.

On motion to adjourn, the Moderator requested the Association to sing, to give the parting hand, after singing and extending the right hand, and the blessings of Heaven invoked by the closing prayer of Elder J. A. Shaddix, the Association was declared adjourned, to time and place as above.
