MINUTES.

The Pea River Baptist Association met in its Twentieth Annual Session with Bethany church, on the 31st day of October, and the 1st and 2nd days of November, 1896.

Introductory Sermon was preached by Eld. A. B. Metcalf, after which adjourned until 1:30 for refreshments.

The Association re-assembled pursuant adjournment, and was called to order by the former Moderator, J. M. Rowe. Singing and prayer by Eld. J. W. Brooks, after which letters from the several churches composing the body were presented and read by A. J. Wise, Jr., and W. W. Falkner, and delegates' names enrolled as follows:

Read and adopted report on Sabbath Schools as follows :

We, your Committee on Sabbath Schools, report as follows: We find from the reports of the letters sent in from the several churches that six out of seventeen have Sabbath Schools all the time, two during summer season; Whitewater the year round; Woodland Grove, Mt. Pleasant, Zion Chapel, Elba, Bethany, New Home, summer season; Shiloh summer

season. Brethren, less than half of our churches have Sabbath Schools. We are sorry to have to make this report. Now, what shall we do? Shall we continue to bury talents given us, or let them shine? So that our children may see our good works let us train them up in the way they should go. God's word says, that he that knoweth the right and doeth it not commits sin. Let us do all in our power to interest our children in the Sabbath School. Brethren, let us hear the conclusion of the whole matter, fear God and keep his commandments, for this is our duty; lets do it, let us be faithful, so when God calls us we may hear the welcome plaudit, "Well done, good and faithful servant."

The following is the report of the committee on Temperance, which was read and adopted :

We, your Committee on Temperance, offer the following report: Again we offer you a report on the all important subject of Temperance. While we should live temperate in all things, we will speak only of alcoholic drinks. We are happy and proud to say that all the better classes of people are living away from the evils of strong drink; we only note the blighting effects among the low and vicious. The great danger to us is that our boys may fall into the habit of drinking. We know now of some bright, intelligent youths who carry flasks around in their pockets, and even drink to excess around the church house. Let us condemn it on every occasion and beg God to give us strength to live up to a strictly temperate life, so that our every day walk will not condemn the principles we teach. Strong drink is a curse. Let us pledge ourselves not to sign whiskey petitions. In some localities, even now, the vicious and low are making drunkards of citizens and small boys under the name of cider, bitters, tonics. We have had the statistics given from year to year, both as to quantity and destructions, and all well informed people admit their truthfulness and we will not rehearse them. In conclusion, we recommend that any church who tolerates drunkenness, and on proof of such that the Pea River Association withdraw from such church as being in disorder.

ARTICLES OF FAITH.

1. We believe in one only true and living God—the Father, the Son and the Holy Spirit, and that these three are one.
2. We believe that the Scriptures of the Old and New Testaments are the Word of God, and the only rule of faith and practice.
3. We believe in the doctrine of eternal and particular election.
4. We believe in the doctrine of original sin.
5. We believe in man's incapacity to recover himself from the fallen state he is in by nature, by any exertion of his own free will.
6. We believe that sinners are justified in the sight of God only by the imputed righteousness of Jesus Christ.
7. We believe that God's elect shall be called, regenerated and sanctified by the Holy Spirit.
8. We believe that saints shall persevere in grace and never finally fall away.
9. We believe that Baptism and the Lord's Supper are ordinances of Jesus Christ; that true believers are the only subjects of these ordinances; and that immersion only is baptism.
10. We believe in the resurrection of the dead and the general judgment.
11. We believe that the punishment of the wicked will be everlasting, and that the joys of the righteous will be eternal.
11. We believe that no minister has a right to administer the ordinances of the Gospel, except one who has been regularly called and ordained to the work by the imposition of the hands of a presbytery.

RULES OF DECORUM.

- RULE 1. The Moderator shall fill the chair and preserve order in the Association, which shall be opened and closed by prayer.
- RULE 2. The privileges and authority of the Moderator shall be respected by all the members; he shall decide all questions of order and propriety.
- RULE 3. The Moderator shall vote in no case, unless there is a tie in the Association, then he shall give the casting vote. He shall have the same privilege of speaking as other members, provided he shall appoint some member to fill the chair.
- RULE 4. But one member shall speak at a time, who shall rise from his seat and address the Moderator; and keep the subject; and he shall not speak more than twice on the same subject without leave from the chair.
- RULE 5. No member shall leave the body while on business, except by permission from the chair.
- RULE 6. When a question is taken up, after allowing time for deliberation, the Moderator shall take the voice of the body by calling for the yeas and nays.
- RULE 7. All motions in order shall be disposed of by the body, unless withdrawn by him that made it.
- RULE 8. A list of the names of the delegates shall be called and absentees marked.
- RULE 9. The Clerk shall enroll the names of the delegates, and keep a regular record of all the business of the Association.
- RULE 10. The minutes of the Association shall be read and corrected before the body rise.
- RULE 11. This decorum may be altered, or amended, by two-thirds of this body.
