MINUTES.

The New River Baptist Association met with Unity Church, Oct. the 10th, 1893, and in the absence of the appointee and his alternate, the introductory was delivered by Eld. J. Taylor of the Harmony Grove Association. After a bountiful repast the body met, and the Moderator and Clerk being absent, on motion, Eld. W. G. Baker was made Moderator and Zach Savage Clerk until the body should be permanently organized. After devotional exercises letters from the different churches were called for and Bros. J. H. McGuire and J. D. Thomas were appointed to read the letter. Letters were read and names of delegates enrolled. (See statistical stable.)

After which went into election for Moderator and Clerk resulting in the choice of Eld. W. G. Baker, Moderator, and Zach Savage, Clerk.

Called for report of committee on Denominational School when the following was submitted and adopted :

Your Committee beg to report so far as we are aware there is no denominational school or schools within the limits of our territory. Several efforts have been made during the last decade by this body to set on foot a denominational Baptist school at some eligible point within our borders but only to end in failure each and every time. Your committee were once favorably disposed to such a move and would yet be if there were fair prospects of success; but we fear that within ourselves we are financially too weak to support such a school. Things that are right are not at all times expedient; so your committee do not deem it expedient at this time to further moot the question of the proposed Baptist school within our bounds.

Your committee would not be understood however, in what is said above, as opposing denominational schools. On the contrary, we favor them, and point with pride to our Baptist colleges in Alabama as the very best schools in which to educate our sons and daughters when they are prepared for higher education.

The Alabama Central Female at Tuscaloosa, is the property of the Baptists of Alabama, given to the denomination by the State, and this grand old college has this fall entered upon her fifty second session with new vigor and new life, and under the auspices of her new management we predict for her glorious results.

With this and the Judson at Marion for our girls, and the Howard at East Lake, for our boys, and the Southern Theological Seminary at Louisville, for our young preachers, the Baptists of Alabama have reason to congratulate themselves on their superior educational facilities; and we heartily commend them all to the favorable consideration and patronage of our people.

In this connection we take pleasure in calling attention to the most excellent preparatory school at Fayette Court House, under the able management of Prof. Jas. S. Vandiver, and his accomplished wife, Mrs. G. G. Vandiver. Prof. Vandiver is too well known to our people to need commendation at our hands, and Mrs. Vandiver's reputation as a trainer of girls and young ladies warrants us in bespeaking for this school the liberal patronage of our people. This school is not denominational in any sense of the word whatever, but its moral tone is sharp and decisive, and its discipline well nigh perfect.

Called for report of Mission Board, when the following was offered and adopted :

The Mission Board of this and Harmony Grove Associations held a joint meeting at Fayette on the 15th December, 1892, at which Eld. W. J. Akins was present by invitation and the two Boards jointly contracted with Bro. Akins to pay him \$25.00 per month to continue

his services in the destitute field in the northern boundary of our territory, *i. e.*, in the same field occupied by him last year. At that meeting Bro. Akins reported verbally that his salary for the preceding year had been paid in full, including some payments to him by the State Board of Missions, and also what had been paid to him or to your Board for him upon subscriptions made at our last session. Your Board have not been able to collect but very little since said meeting, and we are not able to report how much our Sister Association has done for Bro. Akins, nor are we able to report what amount Bro. Akins has collected in the field, nor amount of services performed, but through reliable information we have learned that Bro. Akins has done efficient service and has received but scanty pay. We are dependent on his report for particulars. For convenience of reference we attach the subjoined account, which shows the amount subscribed, collected and disbursed by your Board, including subscription made at our last session:

Subscriptions, \$93.50; collected and paid Bro. Akins, \$87.75.

The following report of Committee on Ministerial Education was adopted:

Your Committee heartily recommend that our churches, through their pastors, take up regular monthly collections for ministerial education. The Ministerial Board of our State Convention is sadly in need of funds to aid ministerial students at the Howard; and in consequence of the great falling off of the usual contributions from the churches the board have been obliged to withdraw the assistance heretofore to a great number of young preachers at the college. This board is located at Montgomery with Bro. Ellis as sect., who will receive and receipt for all contributions for ministerial education, and funds so collected will be applied and used generally at the Howard for all ministerial students attending there or for any particular student designated by the donor. Brethren we need an educated ministry, and if we are not mistaken there is a growing demand among our people for such. As the people become better educated the greater is the demand for educated preachers, and we believe the time will soon come when our ministers will all compare favorably in point of education with members of the learned professions all over our land and when butchering the "Queen's English" in the pulpit will be no longer a common phrase of reproach in the mouth of every upstart who can parse a sentence in Morris's grammar correctly.
