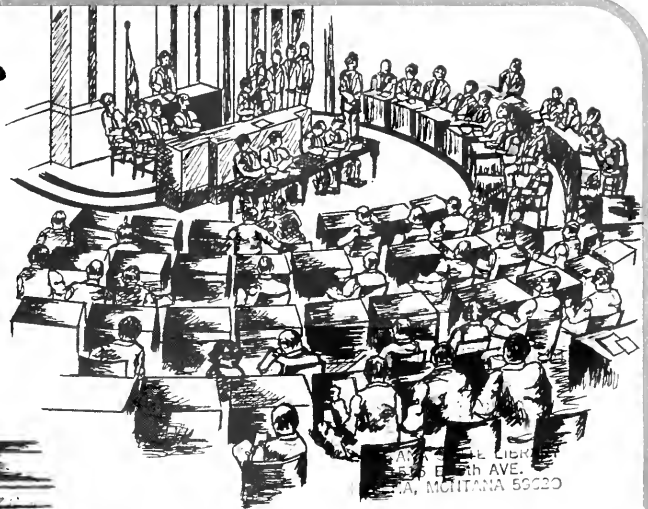

INTRODUCTION

The Montana Legislature is comprised of a 50-member Senate and of a 100-member House of Representatives. The Legislature meets every odd-numbered year for 90 days. The Legislature convenes in Helena at noon on the first Monday in January; if Monday happens to be January 1, the Legislature convenes on the first Wednesday.

Members of the Senate serve four-year terms; half of them are elected every two years. House members are elected every two years. While the Legislature is in session, members receive \$34.98 per day in salary and \$40 per day in expenses.

All meetings of the Legislature and its committees are open to the public. All citizens are encouraged to visit Helena during the legislative session to learn more about the legislative process and to voice their views on the issues facing our state. Welcome to your Legislature!

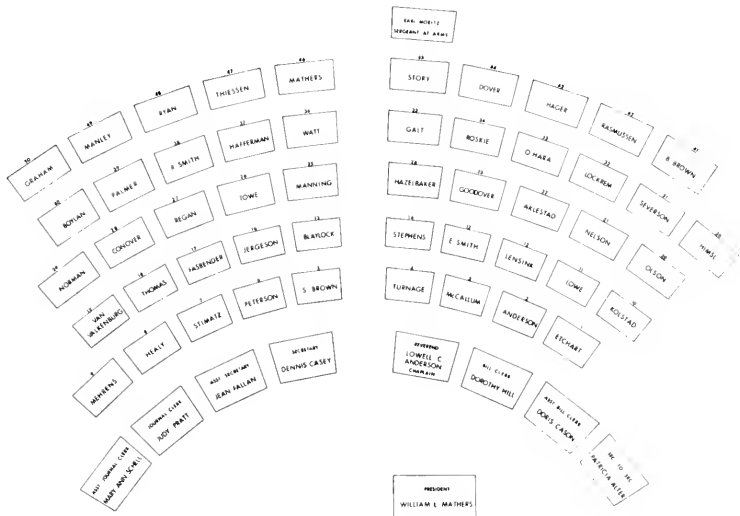

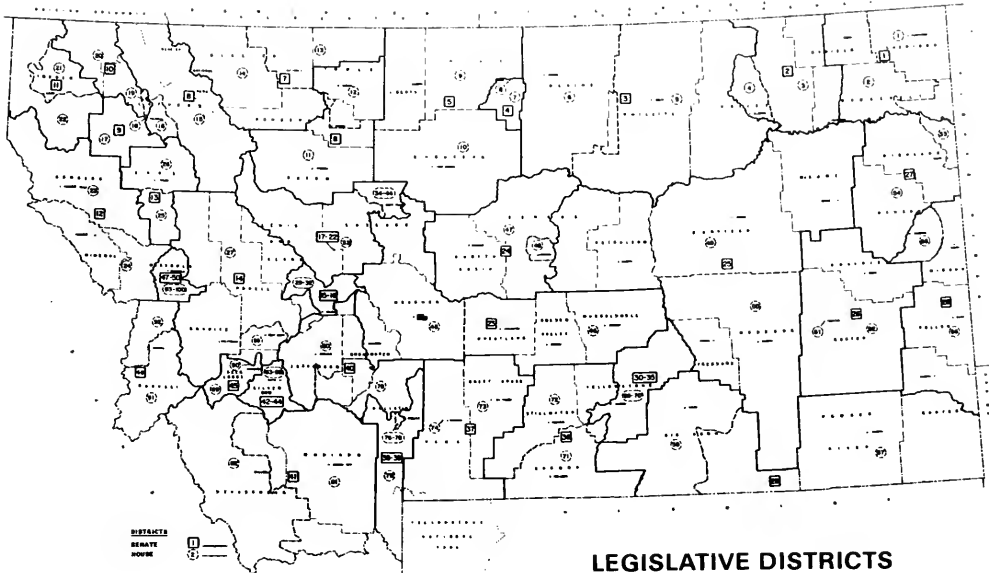
