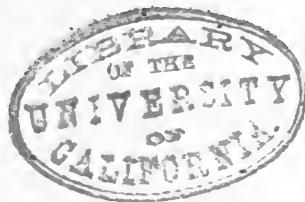

## PREFACE.

*My Dear Sir* :—I am in receipt of your communication informing me of your intention to print certain material relating to the Pepper, Platt, Taylor and Newbold families, and asking me to furnish to you any matter that I may have concerning the Platt family.

It affords me pleasure to co-operate with you in this enterprise, and I therefore enclose herewith my manuscript notes upon the Platt family record, for you to use in full or in part, or in any shape or form that you may deem best. Much of the material therein contained was communicated to me by Miss R. Hooper, Trenton, N. J.

It was intended to print simply the notes upon the ancestry of John Platt and the list of his descendants. But as there was in hand considerable material concerning the descendants of the brothers and sisters of John Platt, and no present likelihood that this material would be printed elsewhere, it was deemed best to alter and amend the original plan and print herewith the incomplete list of descendants of Thomas Platt 3d, and Jacob Platt, the brothers of John Platt, and the descendants of his sister, Hannah (Platt) Hooper.

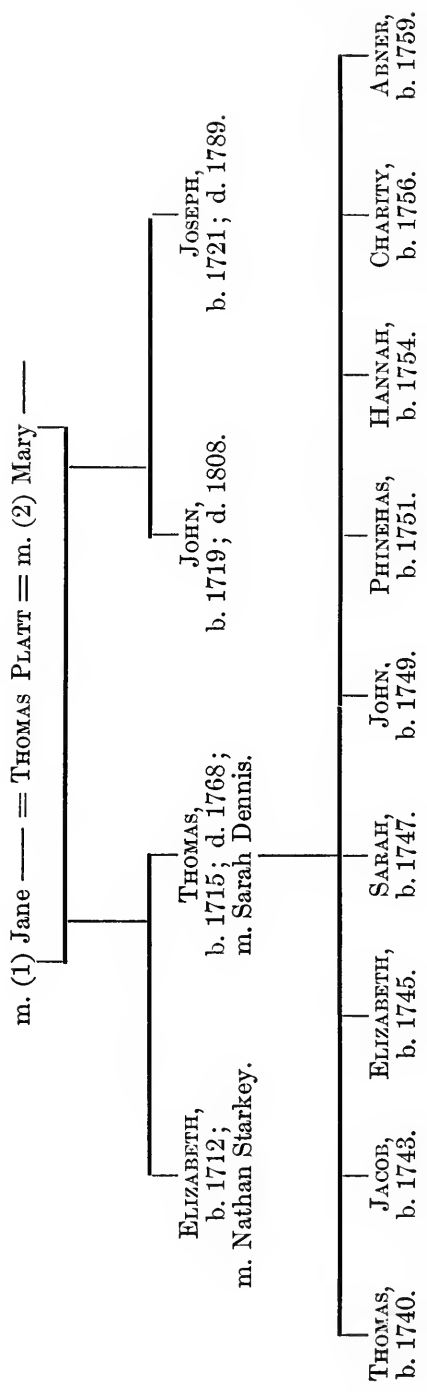

THOMAS PLATT 1st appears to us only as a dim and shadowy figure. He was probably born about 1685 or 1690, the exact date and place of birth being unknown. From 1712 to 1722 he was living in Burlington County, New Jersey, and some (not all) of his children were baptized at Old St. Mary's Protestant Episcopal Church at Burlington. It is not likely that we have the full list of his children, nor do we know the date of his death. He had two wives and left children by both. It is possible that he was descended from the Richard Platt who settled in Connecticut in 1638. The "Platt lineage," by Rev. G. Lewis Platt, gives a fairly full description of the sons and grandsons of Richard Platt, and these lists fail to produce any record which makes out the connection between Richard Platt, of Connecticut, and Thomas Platt, of Burlington County, New Jersey; yet, inasmuch as Richard Platt's descendants passed from Connecticut to Long Island and from there to Monmouth County, New Jersey, it would need only a moderate lack of completeness in the published list of Richard Platt's descendants to account for the failure to successfully close up the record connection. However, the point must remain for future elucidation, and in the meantime this description of the Platt ancestry begins with Thomas Platt 1st.



## THOMAS PLATT 1st.

Married, first, Jane ——. Children by first wife:

It is reported that there are descendants of Elizabeth 1st, who married Nathan Starkey, and that there are some bearing the Starkey name now living in Burlington County.

John 1st and Joseph (sons of Thomas 1st) seem to have moved into Monmouth County, New Jersey, and to have left numerous descendants there. The Monmouth County records show many Platts in the Revolutionary war, in the war of 1812, and as holders of State or County offices, and presumably these are, in part at least, the descendants of John or Joseph Platt. Probably some of these descendants know and have the complete record of the lines coming down from John and Joseph Platt. John Platt 1st died in his ninetieth year, and Joseph died in 1789, aged 68.

There are many Dennis descendants in Monmouth County, N. J. Samuel Dennis, as early as 1670, was a prominent citizen, a Judge, Provincial Councillor and Treasurer of the Province. He lived at Shrewsbury. There were other Dennis families, less distinguished in public life, who lived as early as 1670 at Woodbridge and other places in the county. It should be possible to trace John and Elinor Dennis (the father and mother of Sarah Dennis who married Thomas Platt 2d).

All of this information concerning Thomas Platt 2d and his wife Sarah Dennis, and her family, and the names and birth dates of his children, comes from private family records, which, in two cases, have been carefully kept, which confirm each other, and which are themselves confirmed by an occasional public record of a marriage or death. Thomas Platt 2d is not known to have held any public office, and died in 1768, at the age of fifty-three years. His wife Sarah survived him,

dying in 1804. An old family record gives the following death records, which deal with two generations:

- John Platt, d. March 26, 1808, in his 90th year. [This was the son of Thomas 1st and Mary Platt.]
- Joseph Platt, d. May 20, 1789. [This was the son of Thomas 1st and Mary Platt.]
- Abner Platt, d. May, 1778, in his 18th year. [Son of Thomas 2d and Sarah Platt.]
- Phinehas Platt, d. Aug. 31, 1783, in his 31st year. [Son of Thomas 2d and Sarah Platt.]
- Sarah Platt, d. April 8, 1804, in her 84th year. [This was Sarah Dennis, wife of Thomas Platt 2d.]
- Rebecca Platt, died Sept. 25, 1805, in her 82d year. [This was probably the wife of either Joseph or John Platt 1st, and moreover her age corresponds to age of Rebecca Dennis, younger sister of Sarah Dennis, thus indicating the probability that two brothers married sisters.]
- Mary Platt, d. May 1, 1809. [This was probably the record of death of Mary Budd, wife of Thomas Platt 3d.]
- Alice Platt, d. July 4, 1807. [This was Alice Stevenson, wife of John Platt 2d.]
- William Hooper, d. July 27, 1815.
- Jacob Hooper, d. Sept. 7, 1824. [Hannah Platt, daughter of Thomas 2d and Sarah Platt, m. Jacob Hooper.]
- Jacob Platt, d. July 17, 1816. [Son of Thomas 2d and Sarah Platt.]
- Thomas Platt, d. June 26, 1824. [Son of Thomas 2d and Sarah Platt.]
- John Platt, d. Dec., 1823. [Son of Thomas 2d and Sarah Platt.]
- Sarah Wardell, d. Nov. 14, 1824. [This is probably Sarah Platt, daughter of Thomas 2d and Sarah Platt, though there is no other evidence of her marriage to Wardell.]
- Lawrence Minor, d. Feb., 1818, in his 82d year. [He married Elizabeth Platt.]

Elizabeth Minor, d. Jan. 15, 1822. She was b. Jan. 25, 1745. [She was daughter of Thomas 2d and Sarah Platt.]

Lawrence and Elizabeth Minor had children: Thomas, Charlotte, Rebecca m. Wright, Catherine m. Stevenson, Mary m. Pots, Hannah m. Woodward, Eliza m. Baker. There are descendants.

THOMAS PLATT 3d, son of Thomas 2d and Sarah, b. Dec. 28, 1740; d. May 26, 1824, and is buried at Pemberton, N. J. He m. Mary Budd (she was b. Sept. 25, 1740) and had nine children:

Sarah Ann Eliza Whitaker m. Nathan Middleton, and had one son, twice married, the widow surviving him.

THOMAS PLATT 4th, son of Thomas 3d and Mary, b. Jan. 27, 1773, married and left a daughter, who was married to William F. Crook. The latter left one daughter (now in Yonkers, N. Y.), and three grandsons, one in California; location of the others unknown.

JOHN PLATT 3d, son of Thomas 3d and Mary, b. Nov. 11, 1781; d. in Mansfield, Ohio. A grandson, Benj. F. Platt, lives there, and probably there are other descendants.

GEORGE PLATT, son of Thomas 3d and Mary Platt, b. April 22, 1785; d. Aug. 24, 1859; married, on Jan. 6, 1810, to Lydia Longstreet. She was b. June 15, 1792, and d. Jan. 2, 1865. They had nine children:

JACOB PLATT, son of Thomas 2d and Sarah, b. March 10, 1743; d. July 16, 1816; buried at Wrightstown, N. J. He married Lettice (last name is not known) and had eight children:

2. Nathaniel, went West to Iowa (?).
3. Abner, lived at Millville, N. J. Descendants now there.

Daniel Platt (son of Jacob and Lettice) lived near New Egypt, Burlington County, N. J., and d. at Mt. Holly. He m. Mary Kirdy, of English parentage, who d. aged 90. Their children were: Elisha, Martha and Mary (twins), Jacob and Richard Platt. Elisha, son of Daniel, d. at Wilmington, Del., 1860, aged 70. Jacob Platt, second son of Daniel, d. 1876, in his 56th year. Richard, son of Daniel, d. 1865, aged about 42. Mary m. John Holbert, of Philadelphia, and d. 1880, aged 68. Martha m. George Flenard, of New Jersey. She survives her husband. Jacob 2d, son of Daniel and Mary, m., and had a son, the Rev. William Henry Platt. The Rev. William Henry Platt, son of Jacob 2d, m. Sept. 30, 1874, Frances Hart, daughter of Joseph Hall, of Philadelphia; their children are: Dallas Hall and Elizabeth Hall Platt. The Rev. William Henry Platt is recently deceased.

George Hooper, son of Abner and Mary, b. Aug. 18, 1818; m. May 9, 1841, to Isabella Watson, and had two sons, George and John. There are now no living members of this family.

William Hooper, son of Abner and Mary, b. July 11, 1821; m. June 20, 1848, to Ellen Howell. They had a daughter, Adelia.

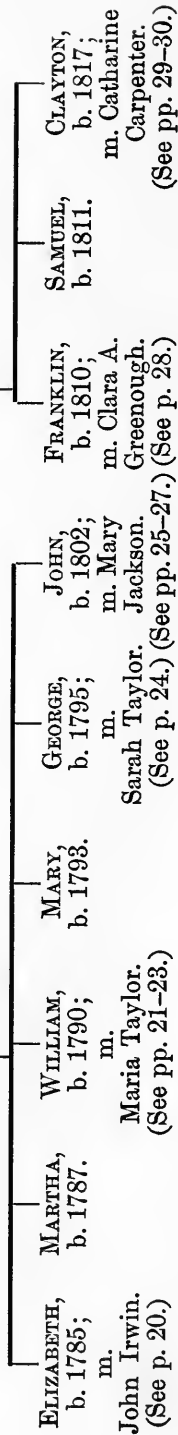
Edward D. Hooper, son of Abner and Mary, b. July 18, 1828; m. Sept. 22, 1849, to Mary Borden. They had children: Anna B., Isabella, Mary, Hannah G., Edward D., Anna B., who m. William De Zouche, and had a son, William. Hannah m. George Johnson, of Monrovia, California, and has two children, Paul and —.

Phoebe Hooper, daughter of Jacob and Hannah, b. Nov. 17, 1784; m. about 1809, to William Howell, and had nine children: Mary, Joseph, Amos, Elizabeth, Lydia, Hannah, Charles, Harvey and Ann.

John Hooper, son of Jacob and Hannah, b. July 3, 1787; m. unknown, and had two children, John and Margaret.

Elizabeth Hooper, daughter of Jacob and Hannah, b. Feb. 4, 1792; m. Charles Cliver, and had children: Sarah, Hannah, Charity P., Thomas E., Susan M. Sarah m. William Hutchinson, Hannah m. Borden Vorhees, Thomas E. m., first, M. A. Horner, and second, Mary Antrim Smith.

JOHN PLATT 2d, son of Thomas 2d and Sarah, b. Aug. 13, 1749; d. Dec., 1823.

John Platt was b. in New Hanover Township, Burlington County, N. J., and his father, Thomas 2d, died there in 1768. In 1777, John Platt received his commission in the Delaware Regiment of Foot, on the Continental Establishment (Colonel Hall), and served until 1783. In that same year he was one of the original members of the Delaware Society of the Cincinnati. He held no public office, and lived and died at his place "Chatham," near Wilmington, Del. John Platt had two wives and nine children, six by his first wife and three by the second. On Sept. 23, 1784, at the Upper Springfield Meeting House, Burlington County, N. J., John Platt was married to Alice Stevenson, daughter of William Stevenson, of Upper Freehold township, Monmouth County, N. J. The old original certificate, in the possession of the family, shows the usual long list of subscribing witnesses, and is a roll of the families residing in the region at that date.

His first wife, Alice Stevenson, died on July 4, 1806.

John Platt died in Dec., 1823, his widow, Mary Platt (Conrow), long surviving him. She d. in July, 1854, aged 77 years, at Wilmington, Del.

Alice, the first wife of John Platt, was a Friend and a member of the Wilmington Meeting, and her death appears upon their records; presumably she was buried in their burial ground at Wilmington. Moreover, John Platt was probably buried in the same burial ground in 1823; but as he was not a Friend, his name does not appear upon their records at all. Though not a Friend himself, yet John Platt married Friends, both of his wives having been birthright members of Friends meeting.

In March, 1805, John Platt purchased his farm called "Chatham," about two miles from Wilmington, Del., and there he lived until his death, in 1823. The old house still remains and but little altered. The property is now owned by a Car Wheel Manufacturing Company.

ELIZABETH PLATT, oldest daughter of John 2d and Alice Platt, married John Irwin. They had eleven children: Mary Ann, Elizabeth, Lydia, Alice, Maria, John W., George W., Samuel, Edwin, William Platt and Charles Irwin. The last died in his youth.
