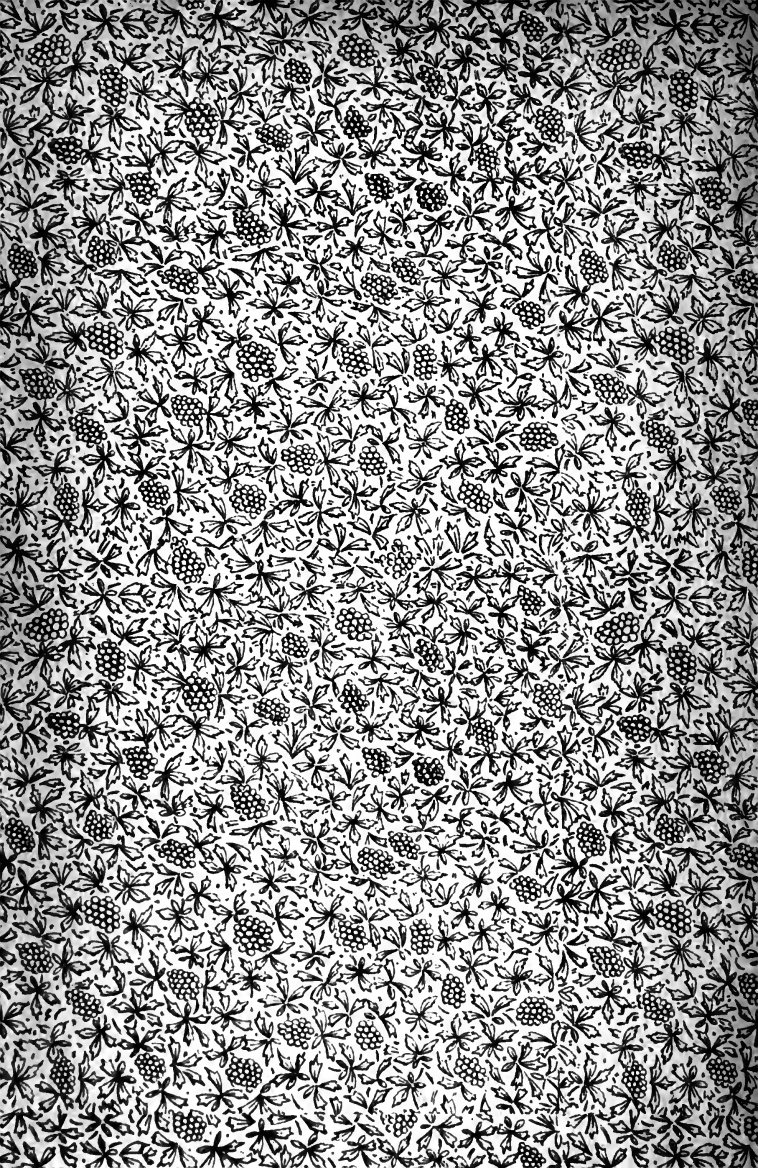
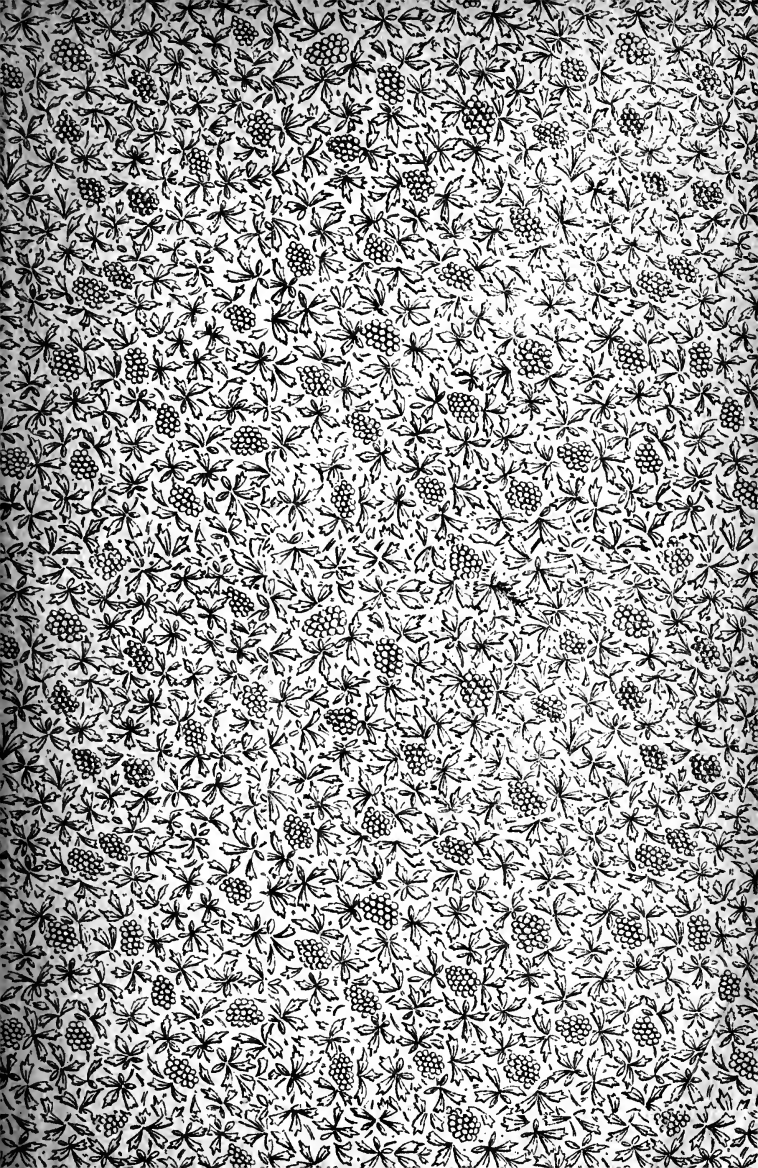


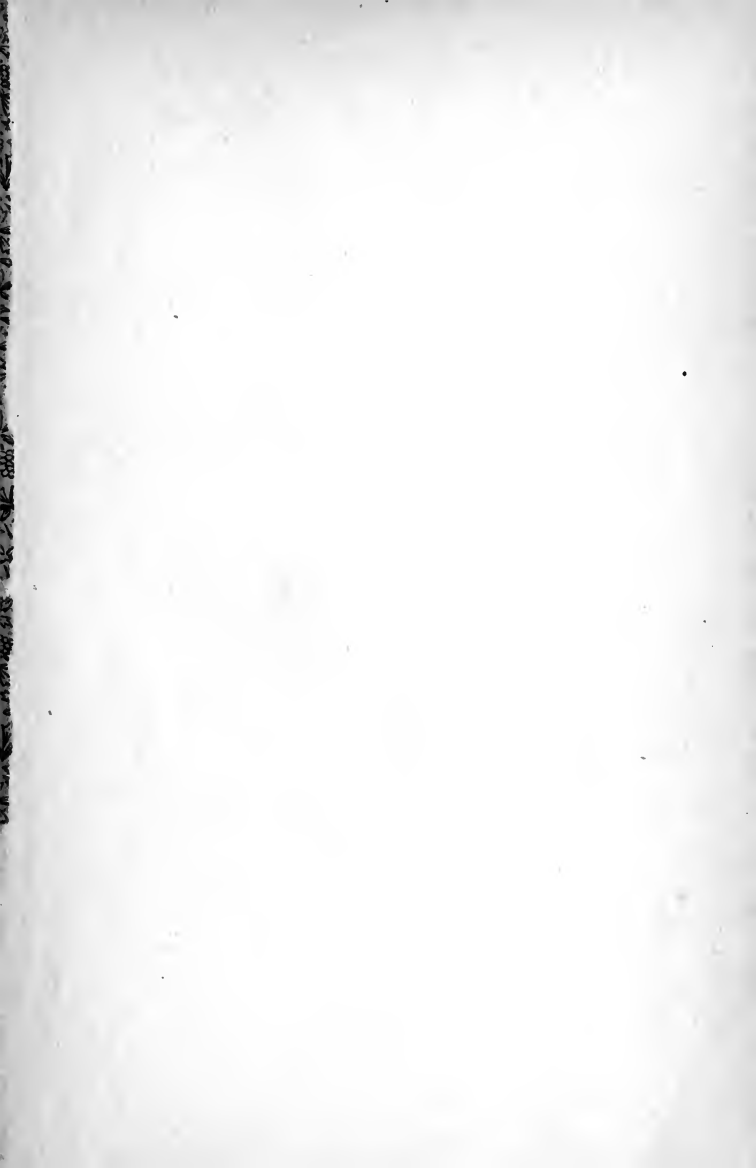

CERTIFICATE OF INCORPORATION

OF THE

UNIVERSITY CLUB OF BUFFALO.

WE, the undersigned citizens of the United States and of the State of New York, and residing in the City of Buffalo in said State, being desirous of forming ourselves into a society or club for social purposes, under and in pursuance of Chapter 368 of the Laws of the State of New York, of the year 1865, entitled "An act for the incorporation of societies or clubs for certain social or recreative purposes," and passed April 11, 1865, and the acts amendatory thereof, do hereby certify as follows :

First. The name or title by which the society or club into which we desire to form ourselves, as aforesaid, shall be known in law shall be "THE UNIVERSITY CLUB OF BUFFALO."

Second. The office and location shall be in the City of Buffalo in the State of New York.

Third. The particular business or object of such society or club shall be to promote social intercourse among its members.

Fourth. The number of trustees, managers or directors to manage said society or club shall be twenty.

CONSTITUTION.

Name.

I. The name of this association shall be
THE UNIVERSITY CLUB OF BUFFALO.

Object.

II. Its object shall be to promote social intercourse among its members, and provide them with the conveniences of a club-house containing a library, a reading-room and other means of promoting science, literature and art.

Officers.

III. The officers of the Club shall be a President, a Vice-President, a Secretary and a Treasurer.

President.

IV. The President, and in his absence the Vice-President, shall preside at the meetings of the Club and of the Council. In the event of their absence, a meeting of the Club or of the

Council may elect its presiding officer. The President shall, with the Secretary, sign all written contracts and obligations of the Club, and shall perform such other duties as the Council or the Club may assign him.

Secretary.

V. The Secretary shall give notice of all meetings of the Club and of the Council, and shall keep minutes of such meetings. He shall conduct the correspondence and keep the records of the Club. He shall furnish to the Treasurer the names of all members elected to membership, and shall be the keeper of the seal of the Club.

Treasurer.

VI. The Treasurer shall collect all entrance fees and all dues, and shall keep the accounts of the Club, and report thereon at each regular meeting of the Council. His accounts shall be audited by the Auditing Committee semi-annually. He shall pay all bills on the certificate of their correctness by the House Com-

mittee. He shall notify persons elected to membership of their election.

Council.

VII. 1. The Board of Trustees or Directors of the Club shall be known as the Council. The Council shall consist of twenty members, five of whom shall be elected by ballot at each annual meeting of the Club, to hold office for four years. The Council shall have general charge of the affairs, funds, and property of the Club; it shall have full power, and it shall be its duty to carry out the purposes of the Club according to its Charter, Constitution and By-Laws. The interpretation of the Constitution and By-Laws shall rest with the Council.

2. The Council shall, on the last Saturday in December of each year, elect from its own body the President, Vice-President, Secretary and Treasurer, who shall hold office for the ensuing calendar year and until their successors are elected.

3. The Council shall submit at each Annual Meeting a general report of the affairs of the

Club, with an estimate for the ensuing year, which shall be printed and distributed to members five days before the Annual Meeting, and shall report at other times if required.

4. The Council shall meet once a month, except during the months of July and August, and Special Meetings may be called by order of the President or of the House Committee. A majority of its members shall constitute a quorum of the Council.

5. The Council shall prescribe rules for the admission of strangers to the privileges of the Club.

6. The Council may fill any vacancy in its body by election of a member to hold office for the unexpired term.

7. The Council shall have power to remit penalties for offences against the Rules and for unintentional violations of the Constitution.

Club Meetings and Elections.

VIII. 1. At the regular meeting of the Council in November of each year, the President shall appoint a committee of five, to

consist of two members of the Council whose terms expire in the December following, and three members of the Club at large, to nominate at least two candidates for each office to be filled at the ensuing election. On or before the last Saturday in November the committee shall make their report to the Secretary, who shall cause a list of the candidates nominated to be posted on the bulletin-board. Any fifteen, or more, members desiring to make nomination or nominations for any office or offices, may at any time before 6 P. M. on the Saturday next preceding the annual meeting, send such nomination or nominations in writing, signed by them, to the Secretary, who shall forthwith post the same on the bulletin-board, with the names of the signers. No member shall be permitted to nominate more than one candidate for each office. No person not nominated as herein above provided shall be a candidate for any office at any annual meeting. All elections of officers shall be by ballot, and a plurality of votes shall constitute an election. It shall be the duty of the Secretary to provide a sufficient number of printed ballots, each ballot contain-

ing the names of all the candidates nominated, and the members voting shall make a cross opposite the names of the candidates for whom they desire to vote. No voting by proxy shall be allowed.

2. There shall be an annual meeting of the Club on the second Saturday of December in each year. At the annual meeting, to be held in the month of December, 1894, twenty members shall be elected by ballot, who shall constitute the Council for the first year and who shall divide themselves into four classes, to hold office respectively for one, two, three and four years, and thereafter at each annual meeting five members shall be elected by ballot as members of the Council, whose term of office shall be four years.

3. At the annual meeting, to be held in the month of December, 1894, twenty-one members shall be elected by ballot, who shall constitute the Committee on Membership for the first year, and who shall divide themselves into three classes, to hold office respectively for one, two and three years, and thereafter at each annual

meeting seven members shall be elected by ballot as members of the Committee on Membership, whose term of office shall be three years.

4. Officers and members of the Council and members of the Committee on Membership shall hold office during the term for which they are elected and until their successors are chosen.

5. Members of the Council and of the Committee on Membership, at the expiration of their term of office, shall be ineligible for election to the same office for the year next ensuing, except members elected to fill vacancies during the year.

6. Upon the written request of ten members, the President shall call a Special Meeting of the Club, which request, as also the notice of any Special Meeting, shall state the object for which the meeting is called, and at a Special Meeting no subject not so stated shall be considered. In case of the absence or refusal of the President, the Vice-President shall call such meeting. In case of the absence or refusal of both such officers to call such meeting, the

Council shall call such meeting. Notices of any meeting, whether Annual or Special, shall be posted in the Club-house for one week. Thirty members shall constitute a quorum at any meeting of the Club.

Qualifications of Members.

IX. 1. Any person shall be eligible to membership in this Club who shall have received from a University or College a degree, to obtain which, in regular course, at least three years' residence and undergraduate study are required (exclusive of Theological, Medical and Legal Schools), or who shall have received an honorary degree from such University or College, or who shall have graduated at the United States Military Academy or at the United States Naval Academy; provided that, in the case of the holder of an honorary degree, the candidate shall be distinguished in Literature, Art, Science or the Public Service.

2. The Council shall determine what degrees, and from what Universities or Colleges,

either American or foreign, shall qualify the holder for membership.

3. Graduates of over fifty years standing, who have attained distinction, may be elected by the Council as Honorary Members.

4. The number of Resident Members of the Club shall not exceed two hundred and fifty (250).

5. The number of Non-resident Members of the Club shall not exceed one hundred (100).

Committee on Membership—Election of Members.

X. 1. The Committee on Membership shall consist of twenty-one members, seven of whom shall be elected by ballot at each Annual Meeting. The term of office of the members of this committee shall be three years. At the first meeting in each calendar year the committee shall elect a Chairman and Secretary of the committee from among their own number to serve for one year. Vacancies occurring in the committee shall be filled by the committee for the unexpired term. No member of the Council

shall be a member of this committee. The names of the committee shall remain posted in a conspicuous place in the Club-house.

2. The committee shall hold regular meetings as provided by their rules, and Special Meetings may be called at any time by the Chairman on a notice of three days.

3. At meetings of the committee eleven members shall constitute a quorum and two negative votes shall be a rejection of a candidate. The name, residence and college or place of instruction of every person proposed for admission, with the names of the members proposing and seconding, shall be posted in a conspicuous place in the Club-house for at least two weeks. The application shall then be referred to the Committee on Membership, the proceedings of which committee shall be secret and confidential. It shall be the duty of the committee, after careful consideration and examination, to vote upon the names of each candidate separately and by ballot.

4. No member of this committee shall propose any candidate for membership to the Club.

On the election of each new member, the committee shall forthwith notify the same to the Secretary of the Club.

Resignations.

XI. 1. Resignations of membership shall be made to the Secretary in writing.

2. Such resignation of any member shall not be accepted until all his indebtedness to the Club shall have been discharged.

Dues.

XII. 1. The entrance fee shall be ten dollars for Resident Members, and ten dollars for Non-resident Members.

2. The annual dues for Resident Members shall be twenty dollars, and of Non-resident Members ten dollars, payable semi-annually, in advance, on the first days of January and July. Every Resident Member elected after the dues are payable, shall have a deduction therefrom of two dollars for each month from the date said dues were payable to the date of his election.

3. Persons not residing or having a place of business within twenty miles of the City Hall, in the City of Buffalo, may be elected as Non-resident Members.

4. Non-resident Members shall not be entitled to vote at any meeting of the Club or to hold office.

5. Any Resident Member who may remove his residence and place of business to a distance of at least twenty miles from the City Hall, in the City of Buffalo, shall, on written notice to the Treasurer of such removal, become a Non-resident Member ; and any Non-resident Member who may remove his residence or place of business to within twenty miles of said City Hall shall become a Resident Member, and shall notify the Treasurer in writing of such removal.

6. Candidates elected, shall become members of the Club on payment of the entrance fee and of the dues for the current half year, and the election of any candidate shall be void if he fail to make such payment within thirty days after notice of his election is mailed, addressed to him at the place given as his residence on his application card.

7. Officers of the Army and Navy who shall be elected, shall be considered as Non-resident Members, except that, when ordered on service outside the limits of the United States, or when stationed at a post distant more than two hundred and fifty miles from Buffalo for a period longer than one year, their dues shall be remitted during the period of such service.

8. The names of all members who shall fail to pay their semi-annual dues on or before the first days of February and August shall be then posted in a conspicuous place in the Club-house ; and if such dues are not paid on the first days of March and September thereafter, such members shall cease to be members of the Club ; subject, however, to the provisions of Article VII., Section 7, of the Constitution.

Expulsion.

XIII. 1. Any member shall be expelled from the Club whose conduct shall be pronounced, by a vote of the Council, to have endangered, or to be likely to endanger, the welfare, interest or character of the Club.

2. At any time within ninety days after such expulsion, a meeting of the Club shall be called, if a request therefor in writing by twelve members be addressed to the Secretary. At such meeting an appeal may be taken from the decision of the Council, and the member may be restored by a vote of a majority of the members then present.

3. No vote shall be taken on the proposed expulsion or suspension of membership, until after a ten days' notice shall have been given to the member in question. Any member may be suspended by a vote of the Council for a violation of the Rules of the Club.

Gambling.

XIV. 1. No games of chance shall be allowed in the Club-house, except such as are approved by the Council, and the Council shall determine under what restrictions all games shall be played and the revenue which the Club shall derive therefrom. No games shall be played in the Club-house on Sunday.

Rules.

XV. 1. The Council shall prepare and enforce Rules regulating the use of the Club-house by the members.

2. No member shall be allowed to treat another member in the Club-house.

Appointment of House and Auditing Committees.

XVI. 1. The Council shall appoint from its own members an Auditing Committee, to consist of three members, and a House Committee, to consist of not more than three members, each committee to be a Standing Committee for the current official year.

House Committee.

XVII. 1. The House Committee shall meet at least once a month. It shall be its duty, subject to the control of the Council, to manage the Club, to regulate prices, to order purchases, to audit bills, to receive complaints, to redress grievances, and to appoint and dismiss all employees.

Auditing Committee.

XVIII. 1. The Auditing Committee shall audit the accounts of the Treasurer semi-annually, and report to the Council thereon. It may also act as a Finance Committee, with such duties and powers as the Council may prescribe.

Rules of Council and Committee on Membership.

XIX. 1. The Council and Committee on Membership shall each have power to make rules for its government, and to prescribe and enforce penalties for the violation of such rules.

Committee on Literature and Art.

XX. 1. The Council shall appoint a Committee on Literature and Art. This committee, under direction of the Council, shall have charge of the Reading-room, and of all books, papers and works of art belonging to the Club, and shall have power to solicit and receive donations, and to select and purchase all books, periodicals and works of art for the Club.

Notice to Members.

XXI. 1. Members may enter in a book, to be kept at the office, a mail address, to which all notices to be sent to them under the Constitution or Rules shall be directed. In default of such entry, such notices shall be served by mailing them directed to the addresses given in the application cards, and members shall be held to have received them ten days after they shall have been so mailed.

Amendments.

XXII. 1. The Constitution may be amended at any meeting of the Club, Annual or Special, by vote of a majority of the members present, until after the Annual Meeting to be held in 1897, and thereafter by a vote of two-thirds of the members present. Notices of all proposed amendments shall be furnished to the Secretary and posted in the Club-house at least twenty days before the meeting at which it is proposed to consider them, and the Secretary shall cause such notices to be printed, and sent to each member at least ten days before such meeting.

HOUSE RULES.

I. The House will be open at 8 o'clock A. M. Members will not be admitted after 1 o'clock A. M. The House will be closed at 2 o'clock A. M.

II. The Restaurant and Café will be closed at 12 o'clock midnight, except on special occasions, when they will be kept open until 1 o'clock A. M.

III. The Billiard and Card-rooms will be closed from 12 o'clock on Saturday night until 8 o'clock on Monday mornings.

IV. The tariff and regulations for the use of the Billiard and Card-rooms and Bed-rooms will be under the control of the House Committee.

V. No betting or play of any kind for stakes is allowed in the Club.

VI. On the first day of each month, or as soon thereafter as may be practicable, a notice

of the amount of his indebtedness shall be sent to each member in arrears on the last day of the preceding month. If such indebtedness exceed five dollars and be not paid on or before the fifteenth day of the month, the name of the member, together with the amount due, shall be posted on the bulletin-board, and such member shall be refused further credit until his indebtedness be discharged.

Should, however, a member become indebted to the Club at any time in the sum of twenty dollars or more, he shall be immediately notified of the same, and, upon failure to pay the indebtedness within one week after notification, his name shall be posted and his credit suspended ; and, in every case where credit is suspended, no further supplies shall be furnished to such member until the indebtedness already incurred shall have been discharged.

VII. At the expiration of four weeks after the mailing of the first notice of indebtedness, if such indebtedness exceed five dollars, a second notice shall be mailed to each member continuing in default, notifying him that, in the event

of his continued failure to pay his indebtedness, he shall be charged with such failure at a subsequent meeting of the Council, and a motion will then be made for his suspension on such charge, in accordance with the provisions of Article XIII. of the Constitution.

VIII. All orders and alterations of orders for articles served from the Restaurant, Café, or elsewhere, must be signed by members. Members introducing guests shall be responsible for all debts incurred by them to the Club.

IX. No newspapers, magazines, books or other articles, the property of the Club, may be removed from the house by any member or employee.

X. Newspapers, magazines and books belonging to the Club shall not be marked, cut or otherwise defaced; neither shall they be removed from the Library to any private rooms in the Club.

XI. No member shall be allowed to give, under any pretence whatsoever, money or any gratuity to any one in the service of the Club.

XII. The Committee on Literature and Art

shall have charge of the general regulations of the Reading-room and Library.

XIII. Dinners may be served until 10 P. M. The private Dining-room may be used to dine resident non-members without extra charge. For all other dinners served therein, one dollar extra for use of room will be charged.

XIV. All requests and complaints should be made in writing, signed, addressed to the House Committee and deposited in the locked box provided for the purpose.

XV. Members shall not be allowed to send the servants out of the Club on any pretext. On application to the Steward, messenger boys will be furnished at usual rates.

XVI. No refreshments will be served in the Library.

XVII. No room shall be rented for a period longer than seven consecutive days if required for occupancy by another member.

The Club is not responsible for personal property left in Bed-rooms.

XVIII. No dog shall be allowed on the Club premises.

RULES OF THE COUNCIL.

RULE I. The regular meetings of the Council shall be held at the Club-house on the second Saturday of each month, except July and August, at 8.30 o'clock P. M. Special meetings may be called at any time by the President, or, in his absence, by the Vice-President, and shall be called by either of them upon the request of five (5) members. Notice of all meetings shall be given by the Secretary, to each member of the Council, through the post-office; but no special meeting shall be held, except upon a previous notice of at last two days to each member.

Order of Business.

1. Calling the Roll of the Council.
2. Reading and approving Minutes of the previous meeting.
3. Collection of Dues and Fines.

4. Reports from Treasurer, Secretary, Standing and Select Committees.
5. Reading the Suggestion Book.
6. Motions and Resolutions.
7. General Business.

RULE 2. A member failing to appear at roll-call at the time appointed for any meeting of the Council, shall pay a fine of one dollar to the Treasurer, unless excused therefrom by the presiding officer, or by a vote of the Council.

RULES

FOR THE

ADMISSION OF VISITORS.

I. No person, other than members and guests, shall be admitted to any part of the Club-house.

II. A resident non-member is anyone residing or having a place of business within twenty miles of the City Hall—not a member of this Club.

III. Members can receive resident non-members of the Club only in the reception-room, and at dinner in the private dining-room. Persons calling to visit members shall be shown into the reception-room, and the member shall be notified of the presence of such visitor. Meetings of committees and other bodies, composed

largely of members, shall be permitted to be held in suitable rooms, as authorized by the House Committee.

IV. A member may personally introduce non-residents to the Club-house for one day. Their names and places of residence and the name of the member introducing them and date of such introduction, must first be entered in a book kept for that purpose. No member of the Club shall have more than two introductions in force at any one time. The House Committee, or the President, may also, at the request of a member, issue a written invitation to any non-resident, which shall entitle him to the privileges of the Club for two weeks, or such longer period as the committee may deem proper.

Any member introducing a non-resident or visitor to the Club shall be held responsible for all debts or liabilities to the Club that may be incurred by such non-resident or visitor.

V. Visitors shall neither give entertainments in the Club-house nor be present at business meetings.

VI. Undergraduate students, residents of Buffalo, who are pursuing a course for a degree in some college or university, which degree would make them eligible for membership in the Club, will be classed as non-residents and entitled to the same privileges in the Club.

VII. The privileges of introducing under these rules may be suspended with regard to any individual member, or non-resident, or visitor, at the discretion of the Council.

R U L E S
OF THE
COMMITTEE ON MEMBERSHIP.

MAY, 1895.

1. A stated meeting of the committee shall be held on the Tuesday evening following the second Saturday of each month at 8.30 o'clock, except the months of July, August and September. Members of the committee absent from the meeting, except for a good and sufficient reason, shall be fined \$1.00, the amounts thus collected to be paid into the treasury of the Club.

2. Names of candidates shall be entered in a book to be kept in the office of the Club. In such book shall also be entered the college at which each candidate graduated, the year of his graduation, the degree received by the candidate, his residence and his profession or occupation. If the candidate have no profession or occupation, that fact shall be stated. If the eligibility of the candidate depends upon an

honorary degree, the fact that the degree is honorary and the year when the degree was received shall be stated. Until such entry is made and signed by the proposer and seconder, or by the secretary of the Committee on Admissions, the name of a candidate shall not be posted.

3. The proposer of a candidate for admission to the Club is required to send to the Committee on Membership a letter of recommendation, giving the name and place of residence of the candidate, and such statement of his qualifications as the proposer may deem proper. A letter of recommendation is also required from the seconder.

If the name of any candidate is called up for consideration at a meeting of the committee, and it shall then appear that no letter of recommendation has been received from the proposer and seconder, the name shall be passed; and the secretary shall immediately notify the proposer and seconder that the nomination cannot be acted upon without a proper letter of recommendation. In case no such letters are received

before the next following stated meeting, the candidate shall be deemed withdrawn, and his name shall be dropped from the list.

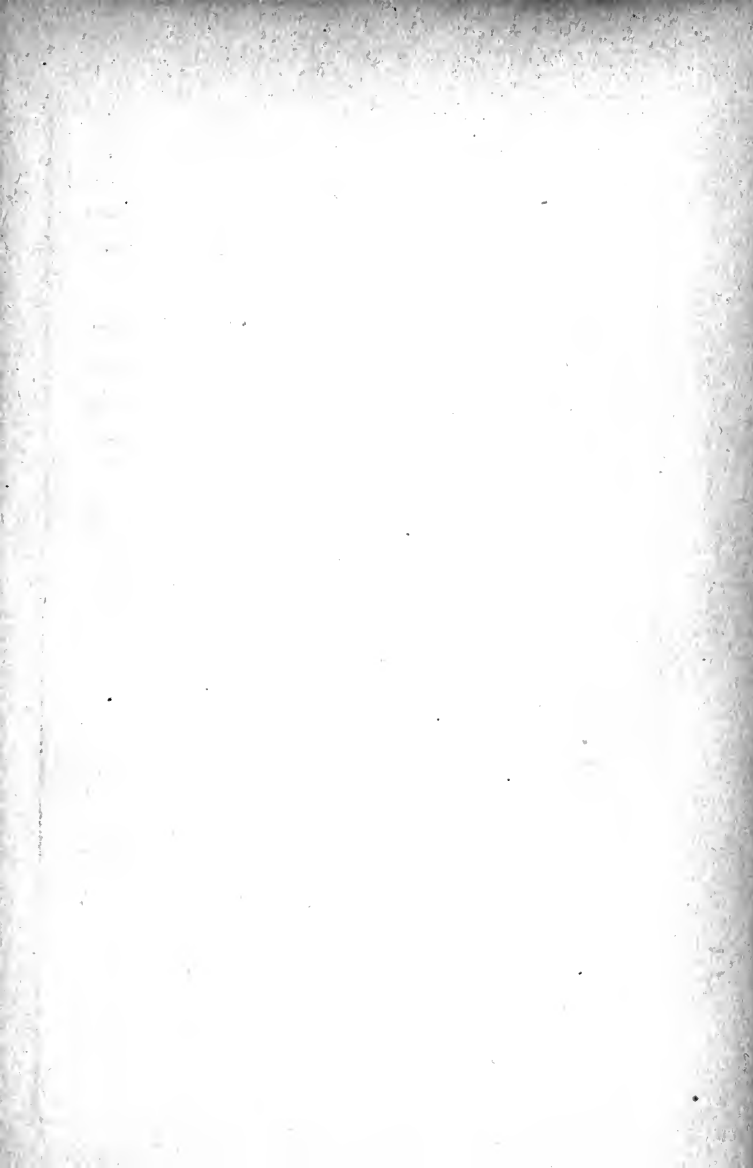
4. Letters, except those of the proposer and seconder, relating to candidates whose names have been finally acted upon, shall forthwith be destroyed, unless by a vote of the committee any particular letter be preserved.

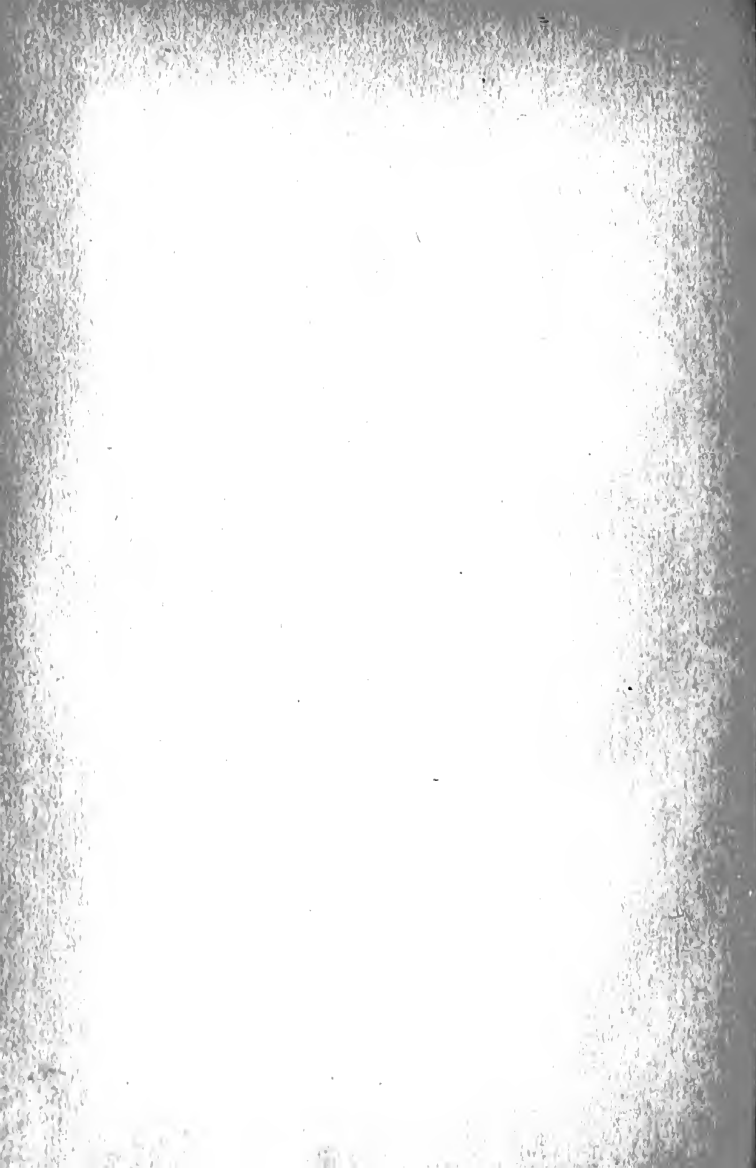
5. The name of a candidate for non-resident membership shall not be considered by the committee unless a letter respecting his candidacy shall have been received from a resident member of the Club, or unless such candidate shall be personally known to some member of the committee present.

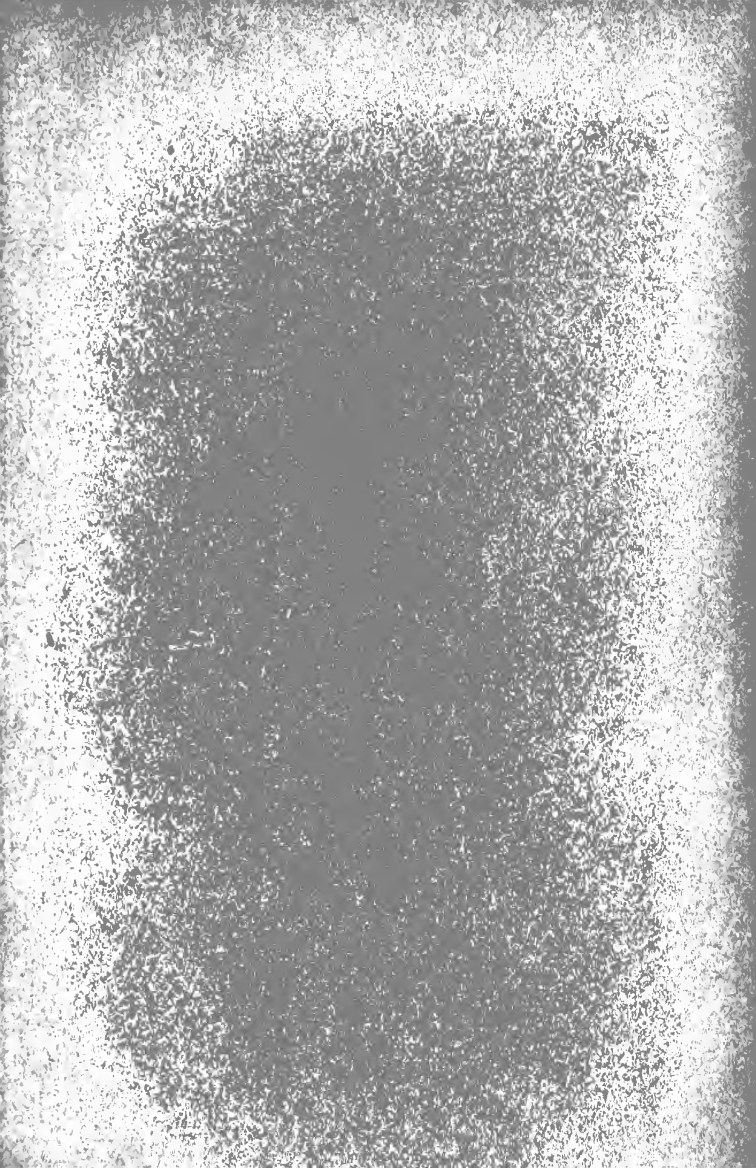
6. The name of a candidate proposed before his graduation shall not be posted.

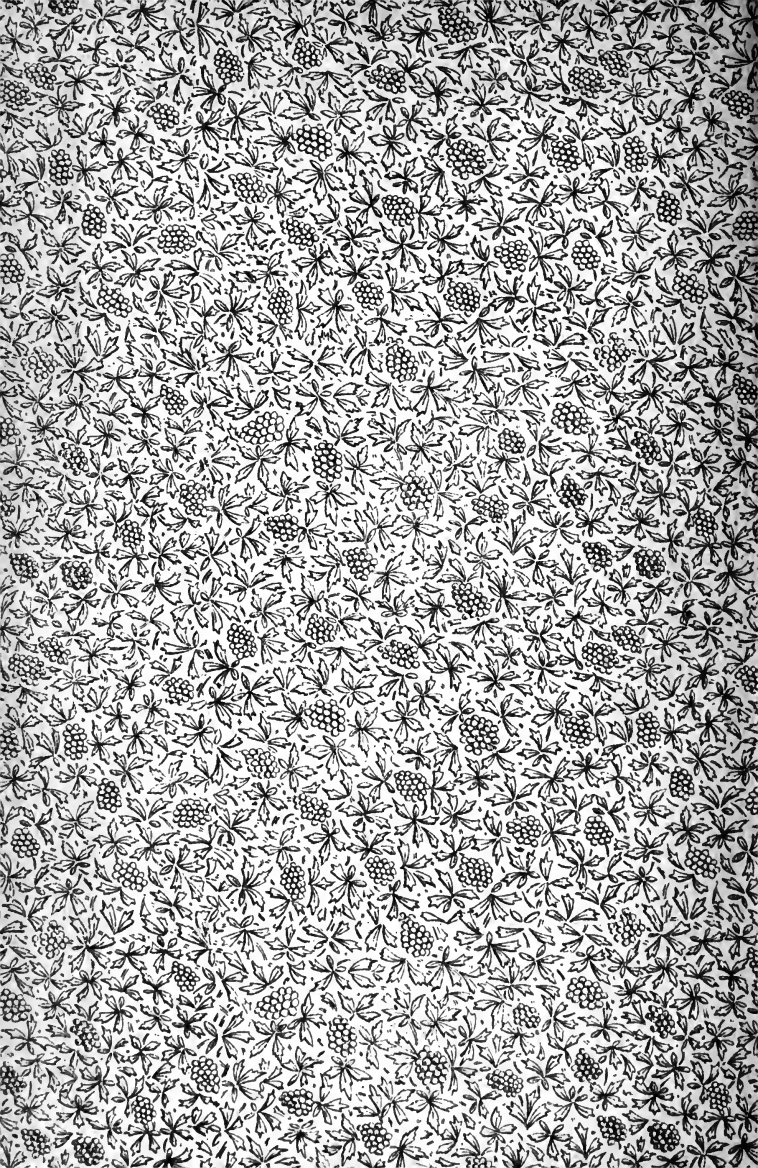
7. Candidates for resident membership must be personally known to at least one member of the committee present.
