Description of FRANCE.

THE French Monarchy has always been enjoyed by an uninterrupted succession of native Kings: it has never borne the yoke of the Barbarians: it has never been altered by a mixture of heterogenous people: it has already subsisted fourteen ages in the same form that it is now.---*France, formerly Gaul.* lies between 45 and 50 degrees of longitude, and 42 and 52 of northern latitude. Its length, from east to west, is about 250 leagues, and its breadth, from north to south, is about 200.---The air is very clear and healthy, and all the blessings of the seasons are enjoyed there, under a very temperate climate, without feeling their inconveniences, as in other places. There is no country in Europe whose situation is so charming, and where it is so pleasant to live. It is watered by the ocean on one side, and the Mediterranean on the other. A great many rivers running thro' the country, communicate with both seas, and bring a very considerable trade. Every thing that can minister to the delight and wants of life, abounds there; and the fruitfulness of Sicily and Egypt, so much celebrated, is not to be compared to that of France; since, besides the innumerable multitude of natives she maintains, she has enough largely to supply other nations with her superfluities. There is nothing to be seen uncultivated or barren. There the fields produce abundance of corn & fruit, without almost any help of art and husbandry. The very mountains are covered with them; and the vallies are full of a prodigious number of cattle. The game is of an exquisite flavour, and the salt is the best in the world. France makes a large trade of it, as well as of its wines and other manufactures. All these advantages make it sufficiently appear, that France in general is the best country in Europe. I can do without other nations; but they cannot, without great difficulties, do without it, either on account of the necessaries or comforts of life.

They reckon in France 800 cities, whereof 40 are of the first rate, 125 of the second, and about 635 of the third, without comprehending a vast many market towns, and an exceeding great number of villages and noblemen's seats. The number of the inhabitants amounts to above thirty millions. Those who know Spain, England and

Germany, have made it appear, that France is three times more populous than the two former, and near twice as populous as the latter. Very exact calculations allow nine millions of souls to the kingdom of Spain, ten millions and an half to the three kingdoms of England, Scotland and Ireland, and eighteen millions to Germany. Therefore France is looked upon as the most considerable power in Europe; and it ought not to be a matter of wonder, that in time of war it raises four hundred and fifty thousand men, and keeps a standing army of two hundred and fifty thousand men in time of peace. The warlike temper of the people, the surprising number of fortified places on her frontiers, the prodigious land and sea armaments she keeps at all times, the trade, great finances, and the improvement of Sciences and Arts, are in a much more flourishing state than they ever were at Athens and Rome, and make France the first State of Europe. Every thing justly gives it that pre-eminence, and raises it to that high pitch of greatness, which makes it so dreadful to its neighbours. The yearly revenue of the King amounts to about three hundred millions, which make about fifteen millions sterling; and he takes place of all the other Christian Princes, except the Emperor.

P A R I S, the capital of France, is the most magnificent city of Europe. It has 17 gates, and contains 25 grand squares, 12 bridges, 830 streets, 50,000 houses, 100 convents, 74 parish churches, many abbees for men and women, and 26 hospitals, the most celebrated of which is that of the Hôtel-Dieu, into which have been received, at times when sickness has prevailed, 3000 patients, none being excluded on account of their nation or religion. It has also a university with 60 colleges, besides 6 academies.—Paris contains about one million of souls.

VERSAILLES, the place of the ordinary residence of the French Monarch, is a small city, situated four leagues from Paris. Its castle, or Royal Palace, which was built by Louis X V. is one of the finest edifices in the world, being the master piece of the most celebrated architects, painters and sculptors: even the stables are more stately than the palaces of many European Princes. It is said that the castle of Versailles has cost more than 200 millions of livres, besides the expence of upwards of 30 millions for the subterraneous works.

ECLIPSES for the Year 1784.

THERE will be four *Eclipses* this Year, two of the *Sun* and two of the *Moon*, in the following Order :

I. The first will be of the *Sun* on Friday the 20th of February, at 4 o'Clock in the Afternoon, invisible. The *Sun's* mean distance from the *Moon's* ascending Node, 11 f. $20^{\circ} 32' 9''$ It will be celebrated in the 2d degree of the celestial *Fishes*.

II. The second will be of the *Moon*, on Friday the 6th of March, visible, calculated as follows, viz.

Beginning at - - 9h. 50m. Evening.

Middle, - - - 10h. 58m.

End, - - - 12h. 6m.

Duration, - - - 2h. 16m.

Quantity eclipsed 4 Digits, on the north Limb.

Moon's distance from her ascending Node 6 f. $8^{\circ} 17' 11''$

Celebrated in the 17th degree of the celestial *Virgin*.

III. The third will be of the *Sun* on Sunday the 15th day of August, at about half after 7 o'clock in the Afternoon, invisible. *Sun's* true distance from the *Moon's* ascending Node, 5 f. $23^{\circ} 1' 41''$ Celebrated in the 20th degree of the celestial *Lion*.

IV. The fourth will be of the *Moon*, on Monday the 30th of August, about 10 o'clock in the morning, invisible. Celebrated in the 9th degree of the celestial *Fishes*.

Every Town having 50 rateable polls has a constitutional right to elect and depute one Representative; and a town containing of 300 male electors, and 1600, they may elect three; and 5000, making 225 rateable polls the mean increasing number for every additional Representative. — They are to be chosen annually in May, ten days at least before the last wednesday of that month, and each of them to have been one year an inhabitant of and seized in his own right of a freehold of the value of £.100 within the town he shall be chosen to represent, or any rateable estate to the value of £.200. — Not less than 20 members are to constitute a quorum; and no member can be arrested on mesne process during his going unto, returning from, or attending the General court. — They have power to impose fines upon such towns as shall neglect to return members. — All money bills are to originate with them, and the Senate may propose or concur with amendments. — They have power to adjourn themselves, but not exceeding two days at a time; and are judges of the returns, elections, and qualifications of their own members. —

The anniversary Convention of the Congregational Ministers is always held at *Boston* the Thursday following the last wednesday in May; on which day a Sermon is preached before them, and a collection made for the relief of such of their Society or families who may stand in need thereof.—The Rev. Mr. *Joseph Willard*, President of the University at Cambridge, is to preach the Sermon at the next Convention.

A Charity Quarterly Lecture is also held at Faneuil Hall, for the benefit of the poor of the town, on the first Lord's Day evening in *March, June, September* and *December*, beginning at six o'clock.

By the Laws of this Commonwealth the inhabitants of each town within the same are to take due care from time to time to be constantly provided with an able, learned, orthodox minister or ministers to disseminate the word of God to them, who are to be suitably encouraged and sufficiently supported and maintained. —

Also, every Town having 50 householders and upwards, are to be constantly provided with a School-master, to teach children and youth to read and write: And where any town has the number of 100 families or householders, there is also a Grammar school to be set up therein, the Master of which is to be suitably encouraged and paid.

By Law, no Person in Boston is to keep in any build-
ing, except the Magazine, more than 25lb. weight of
Gun-Powder, on penalty of forfeiting the same; and
for every half barrel (exclusive of the forfeiture thereof)
they are to pay a fine of 20l. and so in proportion for a
greater quantity, and to pay a double fine on the second
offence.

And by an Act pass'd in March 1783, in consequence of the late fire at the north Mills (near which were deposited a number of loaded Shells) no person in Boston is to take into or keep in any dwelling-house, stable, barn, out-house, warehouse, store, shop, or other building, any Cannon, Swivels, Mortars, Howitzers, Cohorns, Fire-Arms, Bombs, Granades, or Iron Shells of any kind, charged with or having Gun Powder in the same, on penalty of forfeiting and paying the sum of 10*l*.— Such Fire-Arms, Bomb, Granades, or other Shells, are also liable to be seized and sold, one half to the Firewards, and the other half to the poor of the Town.—

By an Act of this Commonwealth, pass'd in July 1783, "there is to be paid an Impost of 5 per cent. ad valorum, on all nails, looking-glasses china, glass, stone and earthen ware; and an impost of two and an half per cent. ad valorum, at the time and place of importation on all other goods, wares, and merchandize, that shall be brought into the Commonwealth by land or water (except hemp and salt, and such articles as are the manufacture and growth of the United States of America) that shall be landed or unloaded within the same."

For every beaver or beaver hat imported, 6*s*.

For every castor hat imported 3*s*.

For every other imported hat, 1*s*.

Likewise, the owner or possessor of the following carriages, are to pay yearly, on or before the 15th of May, for each carriage as follows, viz.

For every coach £. 5.

For every chaise £. 5.

For every sulky, and other riding chair, 9*s*.

It is also enacted, that every person taking out a licence as innholder, shall pay the sum of 24*s*. and for a licence as a retailer of spirituous liquors, the sum of 12*s* to be paid to the Clerk of the Pleas at the time of taking out their licences, exclusive of other charges.

All the moneys arising from the above-mentioned duties and excise are to be applied for the payment of the interest on government consolidated securities, and interest on the note issued to the officers and soldiers of the Massachusetts line of the army for their services in 1780.

The time by law, that all licenced and permitted persons are to account and pay in the Excise to the Collector (who is to attend at some convenient place for that purpose, first giving reasonable and public notice) is the 15th day of May, and the 15th day of November annually. —

 Guns fired at one Minute's distance. The Castle is not
 to Salute any Vessels coming in, except Men of War,
 Frigates, and armed Vessels belonging to our Allies, and
 none of them with more than 13 Guns, and always to
 discharge two less than the Vessel discharges.---

Upon discovering an Enemy in the Night, the Alarm
 is to be given at Nantuxet Fort (near the Light House)
 by firing one Cannon and three Rockets successively,
 every six Minutes, till answered by the Castle; and the
 Castle is to do the same till they are answered at Boston
 by the Battery on Fort-Hill.

If an Alarm should be general in the Night, the Bea-
 con on Beacon-Hill is to be set on Fire, and Expresses
 sent into the Country to Fire the other Beacons there.

Militia Matters, &c.

By the Militia Act of this Commonwealth, the training band is to consist of all able bodied men from 16 to 50 years old, excepting the Lieutenant Governor, members of the Council, Senate and House of Representatives, members of Congress, Secretary, Justices of the Supreme Court and Court of Common Pleas, Judges of Probate, Justices of the Peace and Sheriffs, Officers and Students of the College, Ministers, Elders, and Deacons, Church Wardens, Grammar School-masters, Masters of Arts, Quakers, Selectmen, and all who have held the post of a Subaltern or higher Officer, Masters of Vessels, Constables, Deputy Sheriffs, Negroes and Molattoes:—And the alarm list to consist of all able bodied men from 16 to 65 years of age, with only the following exceptions, viz. the Lieutenant Governor, Council, Senate, & House of Representatives, the American Congress, Secretary, Ministers, Quakers, Selectmen, Negroes, Indians, and Molattoes; each to be equipt and constantly provided with a good Fire Arm, with a steel or iron ram rod, a worm, priming wire and brush, and a bayonet fitted to his gun, a cartridge-box that will hold fifteen rounds at least, six flints, one pound of powder, forty leaden balls fitted to his gun, a haversack and blanket, and a canteen that will hold one quart.——Any officer or soldier, of sufficient ability, not so furnished, is liable to a fine, as are also the soldiers for not appearing on muster days when duly notified thereof by the commanding officer.——The fines to be recovered by the Clerk within sixty days after the offence is committed.——

As the Militia of this, as well as the other United States of America, is looked upon as the palladium of their security, having ever been the first (and sometimes effectual) resort in case of hostility, so the Legislature of Massachusetts have always been very careful, from the first settlement of the country, to have a well regulated and disciplined one ready, at a *minute's* warning, to turn out for their defence against any hostile invader whatever:—The following therefore are the names of the Generals and other Field Officers who at present have the command, according the last returns.——

A R T I C L E S

Of Confederation and Perpetual Union,
between the States of *New-Hampshire, Massachusetts-Bay, Rhode-Island and Providence Plantations, Connecticut, New York, New Jersey, Pennsylvania, Delaware, Maryland, Virginia, North Carolina, South Carolina, and Georgia.* [Ratified by CONGRESS: March 1st, 1781.]

ART. I. **T**HE stile of this Confederacy shall be,—
"THE UNITED STATES OF AMERICA."

ART. II. Each State retains its sovereignty, freedom and independence, and every power, jurisdiction and right, which is not by this Confederation expressly delegated to the United States in Congress assembled.

ART. III. The said States hereby severally enter into a firm league of friendship with each other, for their common defence, the security of their liberties, and their mutual and general welfare, binding themselves to assist each other against all force offered to, or attacks made upon them or any of them, on account of religion, sovereignty, trade, or any other pretence whatever.

ART. IV. The better to secure and perpetuate mutual friendship and intercourse among the people of the different States in this Union, the free inhabitants of each of these States (paupers, vagabonds, and fugitives from justice excepted) shall be entitled to all privileges and immunities of free citizens in the several States; and the people of each State shall have free ingress and regress to and from any other State, and shall enjoy therein all the privileges of trade and commerce, subject to the same duties, impositions and restrictions, as the inhabitants thereof respectively, provided that such restriction shall not extend so far as to prevent the removal of property imported into any State, to any other State of which the owner is an inhabitant; provided also, that no imposition, duties or restriction, shall be laid by any State on the property of the United States, or either of them.

If any person guilty of, or charged with treason, felony, or other high misdemeanor, in any State, shall flee from justice, and be found in any of the United States, he shall, upon demand of the Governor, or executive power of the State from which he fled, be delivered up, and removed to the State having jurisdiction of his offence.

Full faith and credit shall be given, in each of these States, to the records, acts and judicial proceedings of the courts and magistrates of every other State.

ART. V. For the more convenient management of the general interests of the United States, Delegates shall be annually appointed, in such manner as the legislature of each State shall direct, to meet in Congress on the First Monday in November, in every year, with a power reserved to each State to recal its Delegates, or any of them, at any time within the year, and to send others in their stead for the remainder of the year.

No State shall be represented in Congress by less than Two, nor by more than Seven members; and no person shall be capable of being a Delegate for more than Three years, in any term of Six years; nor shall any person, being a Delegate, be capable of holding any office under the United States, for which he, or another for his benefit, receives any salary, fees or emolument, of any kind.

Each State shall maintain its own Delegates in a meeting of the States, and while they act as members of the Committee of the States.

In determining questions in the United States in Congress assembled, each State shall have one vote.

Freedom of speech and debate in Congress shall not be impeached or questioned in any court or place out of Congress; and the members of Congress shall be protected in their persons from arrests and imprisonments, during the time of their going to and from, and attendance on Congress, except for treason, felony, or breach of the peace.

ART. VI. No State, without the consent of the United States in Congress assembled, shall send any embassy to, or receive any embassy from, or enter into any conference, agreement, alliance or treaty with any king, prince or state; nor shall any person holding any office of profit or trust under the United States, or any of them, accept of any present, emolument, office or title, of any kind whatever, from any King, Prince or foreign State; nor shall the United States in Congress assembled, or any of them, grant any title of nobility.

No two or more States shall enter into any treaty, confederation or alliance whatever between them, without the consent of the United States in Congress assembled, specifying accurately the purposes for which the same is to be entered into, and how long it shall continue.

No State shall lay any imposts or duties, which may interfere with any stipulations in treaties, entered into by the United States in Congress assembled, with any King, Prince or State, in pursuance of any treaties already proposed by Congress to the Courts of France and Spain.

No vessels of war shall be kept up in time of peace by any State, except such number only as shall be deemed necessary, by the United States in Congress assembled, for the defence of such State, or its trade; nor shall any body of forces be kept up by any State, in time of peace, except such number only, as in the judgment of the United States in Congress assembled shall be deemed requisite to garrison the forts necessary for the defence of such State; but every State shall always keep up a well regulated and disciplined militia, sufficiently armed and accoutred, and shall provide and constantly have ready for use, in public stores, a due number of field pieces and tents, and a proper quantity of arms, ammunition and camp equipage.

No State shall engage in any war without the consent of the United States in Congress assembled, unless such State be actually invaded by enemies, or shall have received certain advice of a resolution being formed by some nation of Indians to invade such State, and the danger is so imminent as not to admit of a delay, till the United States in Congress assembled can be consulted; nor shall any State grant commissions to any ships or vessels of war, nor letters of marque or reprisal, except it be after a declaration of war by the United States in Congress assembled, and then only against the kingdom or State, and the subjects thereof, against which war has been so declared, and under such regulations as shall be established by the United States in Congress assembled unless such State shall be infested by pirates, in which case vessels of war may be fitted out for that occasion, and kept so long as the danger shall continue, or until the United States in Congress assembled shall determine otherwise.

ART. VII. When land forces are raised by any State for the common defence, all officers of or under the rank of Colonel shall be appointed by the legislature of each State respectively, by whom such forces shall be raised, or in such manner as such State shall direct, and all vacancies shall be filled up by the State which first made the appointment.

ART. VIII. All charges of war, and all other expences that shall be incurred for the common defence or general welfare, and allowed by the United States in Congress assembled, shall be defrayed out of a common treasury, which shall be supplied by the several States, in proportion to the value of all land within each State, granted to or surveyed for any person, as such land, and the buildings and improvements thereon shall be estimated according to such mode as the United States in Congress assembled shall from time to time direct and appoint. The taxes for paying that proportion shall be laid and levied by the authority and direction of the legislatures of the several States, within the time agreed upon by the United States in Congress assembled.

ART. IX. The United States in Congress assembled shall have the sole and exclusive right and power of determining on peace and war, except in the cases mentioned in the sixth article—of sending and receiving ambassadors—entering into treaties and alliances, provided that no treaty of commerce shall be made whereby the legislative power of the respective States shall be restrained from imposing such imposts and duties on foreigners, as their own people are subjected to, or from prohibiting the exportation or importation of any species of goods or commodities, whatsoever—of establishing rules for deciding in all cases what captures on land or water shall be legal, and in what manner prizes taken by land or naval forces in the service of the United States shall be divided or appropriated—of granting letters of marque and reprisal in times of peace—appointing courts for the trial of piracies and felonies committed on the high seas, and establishing courts for receiving and determining finally appeals in all cases of captures, provided that no member of Congress shall be appointed a judge of any of the said courts.

The United States in Congress assembled shall also be the last resort on appeal in all disputes and differences now subsisting, or that hereafter may arise, between two or more States, concerning boundary, jurisdiction, or any other cause whatever; which authority shall always be exercised in the manner following. Whenever the legislative or executive authority, or lawful agent of any State, in controversy with another, shall present a petition to

Congress, stating the matter in question; and praying for a hearing, notice thereof shall be given by order of Congress to the legislative or executive authority of the other State in controversy, and a day assigned for the appearance of the parties by their lawful agents, who shall then be directed to appoint, by joint consent, commissioners or judges to constitute a court for hearing and determining the matter in question; but if they cannot agree, Congress shall name three persons out of each of the United States, and from the list of such persons each party shall alternately strike out one, the petitioners beginning, until the number shall be reduced to thirteen; and from that number not less than seven, nor more than nine names, as Congress shall direct, shall in the presence of Congress be drawn out by lot, and the persons whose names shall be so drawn, or any five of them, shall be commissioners or judges, to hear and finally determine the controversy, so always as a major part of the judges who shall hear the cause shall agree in the determination: And if either party shall neglect to attend at the day appointed, without shewing reasons, which Congress shall judge sufficient, or being present shall refuse to strike, the Congress shall proceed to nominate three persons out of each State, and the Secretary of Congress shall strike in behalf of such party absent or refusing; and the judgment and sentence of the court to be appointed, in the manner before prescribed, shall be final and conclusive; and if any of the parties shall refuse to submit to the authority of such court, or to appear or defend their claim or cause, the court shall nevertheless proceed to pronounce sentence or judgment, which shall in like manner be final and decisive, the judgment or sentence and other proceedings being in either case transmitted to Congress, and lodged among the acts of Congress, for the security of the parties concerned; provided that every commissioner, before he sits in judgment, shall take an oath, to be administered by one of the judges of the supreme or superior court of the State where the cause shall be tried, "well and truly to hear and determine the matter in question, according to the best of his judgment, without favour, affection, or hope of reward:" Provided also, that no State shall be deprived of territory, for the benefit of the United States.

All controversies concerning the private right of soil, claimed under different grants of two or more States, whose jurisdictions, as they may respect such lands and the States which passed such grants, are adjusted, the said grants or either of them being at the same time claimed to have originated antecedent to such settlement of jurisdiction, shall, on the petition of either party to the Congress of the United States, be finally determined, as near as may be in the same manner as is before prescribed for deciding disputes respecting territorial jurisdiction between different States.

The United States in Congress assembled shall also have the sole and exclusive right and power of regulating the alloy and value of coin struck by their own authority, or by that of the respective States; fixing the standard of weights and measures throughout the United States; regulating the trade and managing all affairs with the Indians, not members of any of the States, provided that the legislative right of any State within its own limits be not infringed or violated; establishing and regulating post offices from one State to another, throughout all the United States, and exacting such postage on the papers passing through the same, as may be requisite to defray the expences of the said office; appointing all officers of the land forces in the service of the United States, excepting regimental officers; appointing all the officers of the naval forces, and commissioning all officers whatever in the service of the United States; making rules for the government and regulation of the said land and naval forces, and directing their operations.

The United States in Congress assembled shall have authority to appoint a Committee, to sit in the recess of Congress, to be denominated, "*A Committee of the States,*" and to consist of one Delegate from each State; and to appoint such other Committees and civil officers as may be necessary for managing the general affairs of the United States under their direction; to appoint one of their number to preside, provided that no person be allowed to serve in the office of President more than one year, in any term of three years; to ascertain the necessary sums of money to be raised for the service of the United States, and to appropriate and apply the same for defraying the

public expences; to borrow money, or emit bills on the credit of the United States, transmitting every half year to the respective States an account of the sums of borrowed or emitted; to build and equip a navy; to agree upon the number of land forces, and to make requisitions from each State for its quota, in proportion to the number of white inhabitants in such State; which requisition shall be binding, and thereupon the legislature of each State shall appoint the regimental officers, raise the men, and cloath, arm and equip them in a soldier-like manner, at the expence of the United States, and the officers and men so cloathed, armed and equipped, shall march to the place appointed, and within the time agreed on by the United States in Congress assembled: But if the United States in Congress assembled shall, on consideration of circumstances, judge proper that any State should not raise men, or should raise a smaller number than its quota, and that any other State should raise a greater number of men than the quota thereof, such extra number shall be raised, officered, cloathed, armed and equipped in the same manner as the quota of such State, unless the Legislature of such State shall judge that such extra number cannot be safely spared out of the same, in which case they shall raise, officer, cloath, arm and equip as many of such extra number as they judge can be safely spared. And the officers and men so cloathed, armed and equipped, shall march to the place appointed, and within the time agreed on by the United States in Congress assembled. The United States in Congress assembled shall never engage in a war, nor grant letters of marque and reprisal in time of peace, nor enter into treaties or alliances, nor coin money, nor regulate the value thereof, nor ascertain the sums and expences necessary for the defence and welfare of the United States, or any of them, nor emit bills, nor borrow money on the credit of the United States, nor appropriate money, nor agree upon the number of vessels of war to be built or purchased, or the number of land or sea forces to be raised, nor appoint a Commander in Chief of the army or navy, unless Nine States assent to the same; nor shall a question on any other point, except for adjourning from day to day, be determined, unless by the votes of a majority of the United States in Congress assembled.

The Congress of the United States shall have power to adjourn to any time within the year, and to any place within the United States, so that no period of adjournment be for a longer duration than the space of Six months, and shall publish the Journal of their proceedings monthly, except such parts thereof relating to treaties, alliances or military operations, as in their judgment require secrecy; and the yeas and nays of the Delegates of each State on any question shall be entered on the Journal, when it is desired by any Delegate; and the Delegates of a State, or any of them, at his or their request, shall be furnished with a transcript of the said Journal, except such parts as are above excepted, to lay before the legislatures of the several States.

ART. X. The Committee of the States, or any Nine of them, shall be authorized to execute, in the recess of Congress, such of the powers of Congress as the United States in Congress assembled, by the consent of Nine States, shall from time to time think expedient to vest them with, provided that no power be delegated to the said Committee, for the exercise of which, by the articles of Confederation, the voice of Nine States in the Congress of the United States assembled is requisite.

ART. XI. Canada acceding to this Confederation, and joining in the measures of the United States, shall be admitted into, and entitled to all the advantages of this Union, but no other colony shall be admitted into the same, unless such admission be agreed to by Nine States.

ART. XII. All bills of credit emitted, monies borrowed, and debts contracted by or under the authority of Congress, before the assembling of the United States, in pursuance of the present Confederation, shall be deemed and considered as a charge against the United States, for payment and satisfaction whereof the said United States and the public faith are hereby solemnly pledged.

ART. XIII. Every State shall abide by the determinations of the United States in Congress assembled, on all questions which by this Confederation are submitted to them. And the articles of this Confederation shall be inviolably observed by every State, and the Union shall be perpetual; nor shall any alteration at any time hereafter be made in any of them, unless such alteration be agreed to in a Congress of the United States, and be afterwards confirmed by the Legislatures of every State.
