INTRODUCTION

This bibliography has been compiled to aid those wishing to investigate a subject which has received considerable public discussion recently. The list consists of approximately 1200 items from across Canada from the period 1964 to early 1982. Although almost all items mention some aspect of the use or alleged use of excessive physical force by policemen, a few items have been included as follow-ups to larger stories. A case in point is the newspaper treatment of the status of Sydney Brown following the 1978 Waterloo (Ontario) Regional Police investigation. Such items have been included for continuity. Also, because of the large number of articles in the cases of the Halton (Ontario) Region overheated van investigation (Ontario list, January 1979), the Toronto cases involving Evans and Johnson (ca. August/September 1979), and the Ste.-Therese incident (Quebec list, August 1972), some discrimination needed to be applied in these instances. Here the compiler attempted to include all major items from the point of view of the subject of this bibliography. Additional citations on the Johnson and Evans cases in general, for example, could be traced through the Canadian News Index.

Primary arrangement of items is geographical by province and territory, with a general category for broader items. Secondary arrangement is by format, with three types of material distinguished: books and reports, journal articles (including general-interest magazine articles), and newspaper articles. Arrangement of the small number of books and reports and journal articles is alphabetical within each geographical division, while newspaper articles have been listed chronologically for each area to maintain the grouping of stories about particular incidents.

As is evident from an examination of the list, many items discuss cases in which charges of brutality were not substantiated or were not upheld by the courts. The goal of this bibliography was not to list only cases involving substantiated charges, but to list all reports encountered in order to provide a more balanced perspective.

Several libraries, including the Metropolitan Toronto Library and the Centre of Criminology Library, University of Toronto, have been useful in assembling this list.
