The Superintendent of Police was directed to promulgate the following to the Department by General Order:-

Military drills and revolver practice will be held for officers of all grades beginning Monday, January 20, and ending April 30, 1919.

The following described officers will be exempted from attending military drills only:

1. Those doing duty regularly at Headquarters.
2. Those doing duty regularly at station-houses as clerks, or at City Hall or the Public Library and its branches.
3. Those who in the opinion of their respective commanding officers are incapacitated because of injuries or disease; but temporary sickness or injury will serve as an excuse only while it lasts.
4. Those who on the first of May, 1919, shall have passed the age of fifty years.
5. Those excused by the Superintendent for any special reason satisfactory to him.

Commanding officers of Divisions will report to the Superintendent on Monday, January 13, 1919, the following information:-

- (a) Number of men eligible for drill and revolver practice under fifty years of age as in section 4.
- (b) Names of officers and men of any age eligible for revolver practice only.
- (c) Names of officers and men who should be excused from both drill and revolver practice on account of injuries or sickness.

Commanding officers of Divisions may excuse particular men from drills and revolvers practice on specified days when they are needed for important police work, but drills so lost must be taken later.

The attendance at drills and revolver practice by officers above the rank of patrolman will be ordered and regulated by the Superintendent.





Notice is hereby given that on a day in February, 1919, all Reservemen will be required to take a written examination on police rules and general duty. The date and place of the examination and the names of the officers in charge will be announced hereafter.

The Examining Board will mark the papers and report to the Commissioner the percentage secured by each of the men examined. Assuming that their percentages are satisfactory and that their conduct in other respects fits them to be regular patrolmen, and that they have served at least six months, they will be advanced in the order of their original appointment, but the men in each group in accordance with their respective percentages.

Should two or more men of the same group secure the same percentage those particular men will be advanced in the order in which they ranked when certified by the Civil Service Commission.

As a reward for marked excellence the five Reservemen who secure the highest percentages will be promoted at once, if found to be otherwise fit, and provided they have served at least six months.

Any man whose examination is not satisfactory will be passed over, and his continuance in the Department will be doubtful. On the other hand the Commissioner may at any time advance a man out of the regular order for conspicuous fitness or for especially meritorious service.
