The records of Thursday last were read and approved.

The Superintendent of Police was directed to promulgate the following to the Department by General Order:-

It is with regret that I announce the death of Captain Hugh J. Lee of Division 9 who passed away early this morning.

Captain Lee was appointed to the Police Force November 12, 1889, has given faithful and intelligent service in the successive grades through which he passed, and in his death a loyal and efficient officer is lost to the Department, which extends its heartfelt sympathy to his wife.

The Superintendent of Police was directed to promulgate the following to the Department by General Order:-

A police officer injured in the discharge of his duty to the extent that he is unable to report for duty, should at once notify his commanding officer, who shall immediately make a complete investigation. In cases where the injured officer has no possible claim of collection against a third party for his injury, the commanding officer shall so report and the injured police officer shall make application weekly for his pay and shall be placed upon the weekly payroll if the application is approved. If the injured officer has made or intends to make a claim for damages against a third party, the commanding officer shall promptly report such facts with all the circumstances. In every case, the commanding officer shall make a full report of the injury which report shall show whether or not a third party is responsible, both legally and financially, for the injury done.





Police Commissioner Curtis was at his office today and transacted the following business:

The records of Saturday last were read and approved.

In the matter of the complaint made by Captain James F. Hickey of Division 7 against Patrolman Frederick A. Whitten of Division 7 for violation of Rule 40 of the Rules and Regulations of the Police Department, to wit:

CHARGE: NEGLECT OF DUTY.

Specification: In that on the twenty-fourth day of April, 1919, the said Patrolman Frederick A. Whitten failed to pull in any duty calls between the hours of 1.30 a. m. and 3.35 a.m.

It appeared that a hearing was had before a Trial Board, consisting of Captains Forrest F. Hall, Matthew J. Dailey and John J. Rooney, on the second day of May, current, after due notice had been served on the said Patrolman Whitten by giving him a true copy of the complaint. He appeared with counsel and pleaded guilty to the charge and the Board found him guilty as charged in the complaint. The Commissioner approved the finding and with the recommendation of the Board ordered that the said Patrolman Frederick A. Whitten perform two hundred and ten hours' punishment duty.


