General Order concerning sale of liquor - concluded.

be made for violation of the Federal Act of 1913, Section Four, Paragraph Two.

If the President of the United States exercises his authority under the Act before mentioned and removes the restriction on the sale of intoxicating liquor, then any person, firm or corporation holding a license from the Licensing Board for the city of Boston violates neither the said statute nor, so long as he observes the conditions of his license, any state law and will therefore not be prosecuted either in the courts of the Commonwealth or the United States Courts.
