CHARGE: VIOLATION OF SECTION 19 OF RULE 35 OF THE RULES AND REGULATIONS.

Specification: Joining and belonging to an organization, club or body composed of present or present and past members of the force and known as the Policemen's Union, which is affiliated with the American Federation of Labor, an organization, club or body outside the Department and not a Post of the Grand Army of the Republic, the Spanish War Veterans or the American Legion of World's War Veterans.

It appeared that a hearing was had before a Trial Board, consisting of Captains Richard Fitzgerald, John E. Driscoll and John J. When the polls close, the officers detailed for the pur-9. pose will receive the unused and spoiled ballots, registering ballot-box and key thereof, voting lists envelope, signed by the warden and other election officers, receipts for ballots, and stamps for marking spoiled ballots, carry them to the election commissioners' office, and deliver them to some member of the Board of Election Commissioners in person.

10. When the ballots are sorted and counted, the officers detailed for the purpose will receive in the box sent for the purpose the tally sheets and ballots, which box is to be sealed and signed by the election officers. The officers will then bring the box, official return, precinct seal, press return and stamps for marking defective bal-lots to the office of the election commissioners, and deliver same to some member of the Board of Election Commissioners.

11. A copy of these regulations is sent herewith and Commanding Officers will read the same at the several roll calls and impress upon the members of their Divisions the importance of carrying them out. Division Commanders will call to the special attantion of the men in their Divisions the first regulation, which applies to all show window lighting and unnecessary street lighting, particularly advertising signs. They will instruct their men especially to bear in mind

1. That the order applies until due notice is given to the contrary.

2. That the police have no authority to prosecute.

That when the officer observes an apparent 3. violation of the rules and regulations, he should so inform in a polite manner, a responsible person, the proprietor if possible, upon the premises.

4. Should the officer later observe that the conditions have not been remedied or that the violation is upon premises that have been closed, he will report the fact at the end of his tour of duty, and his Commanding Officer will at once forward the report to Headquarters for transmission to the Office of the Fuel Administrator.

This is a very important duty imposed upon the Police Department and it must be impressed upon the men that they must act promptly and energetically. They must promptly report conditions that seem to them in violation of the order continued after they have notified the violator. That is to say, if the officer notifies the occupant of cortain premises that in the officer's opinion he is violating the order and finds the same condition existing when he next comes around on that tour of duty, he must report that fact. Where it is impossible, as in the case of display and outside advertising signs to find the person maintaining the same, or their

agents, report must be made on that Many persons, no doubt, will violate this order through ignor-ance, but if the men of the Force act vigorously and courteously, the number of such violations will undoubtedly rapidly decrease, which will be to the credit of the Department.
