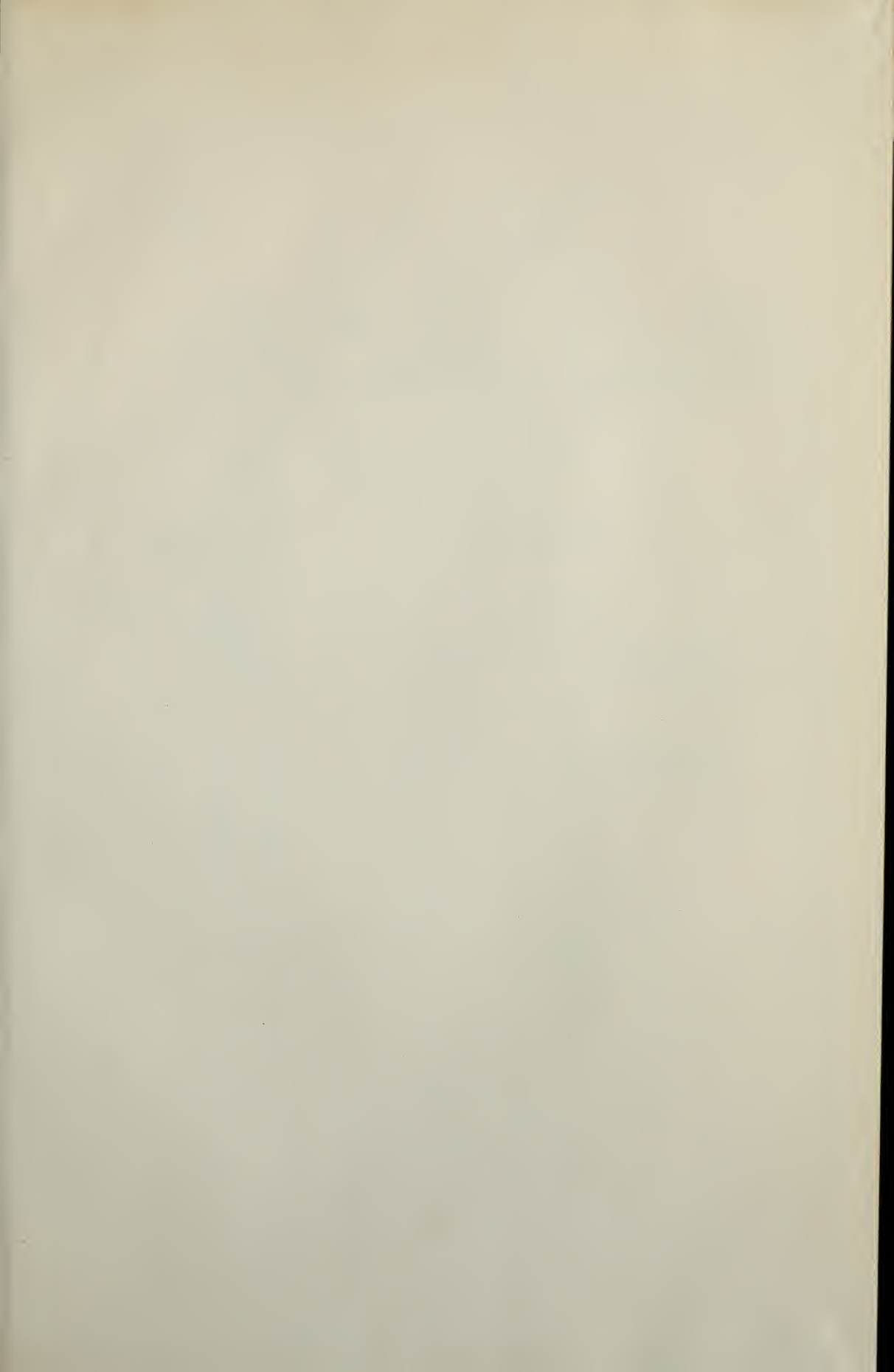

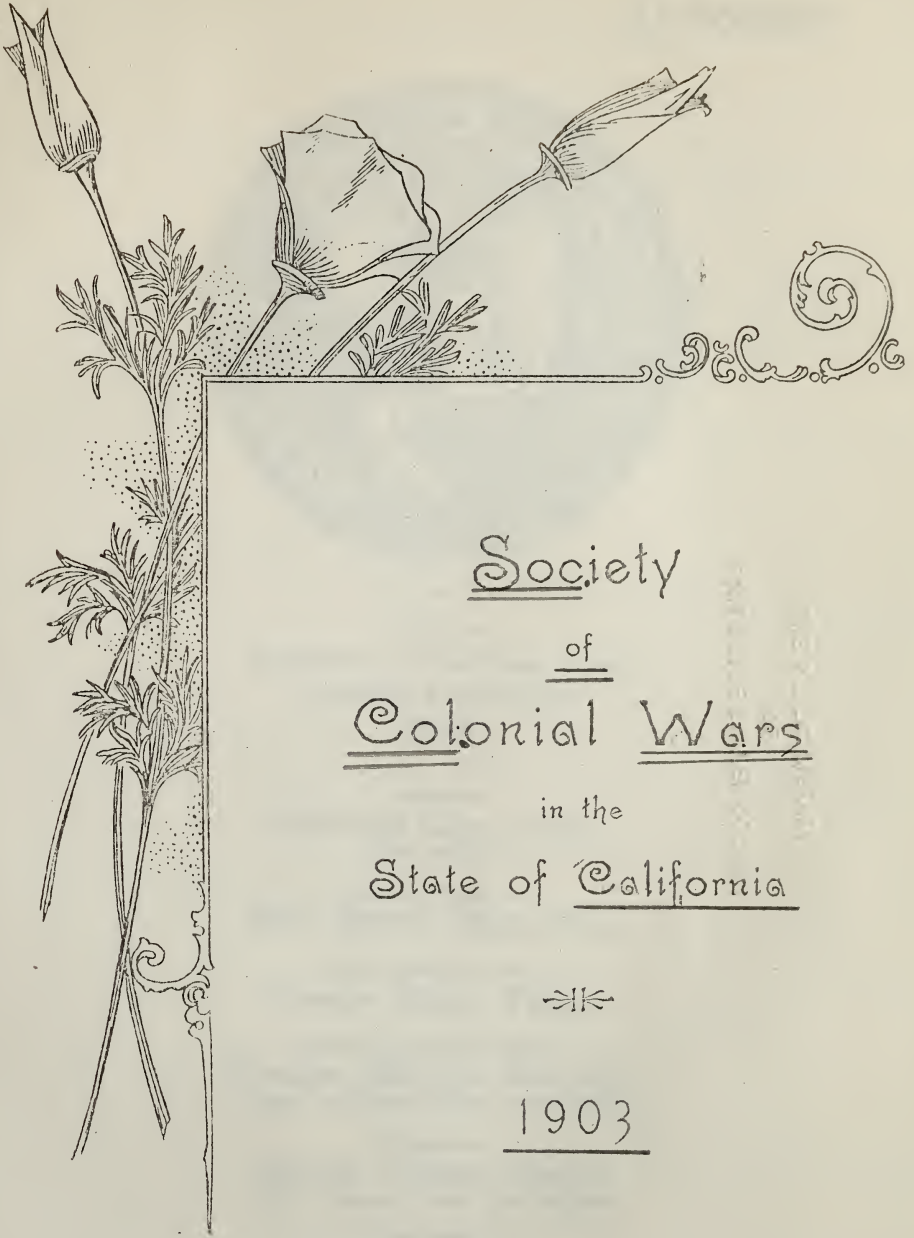

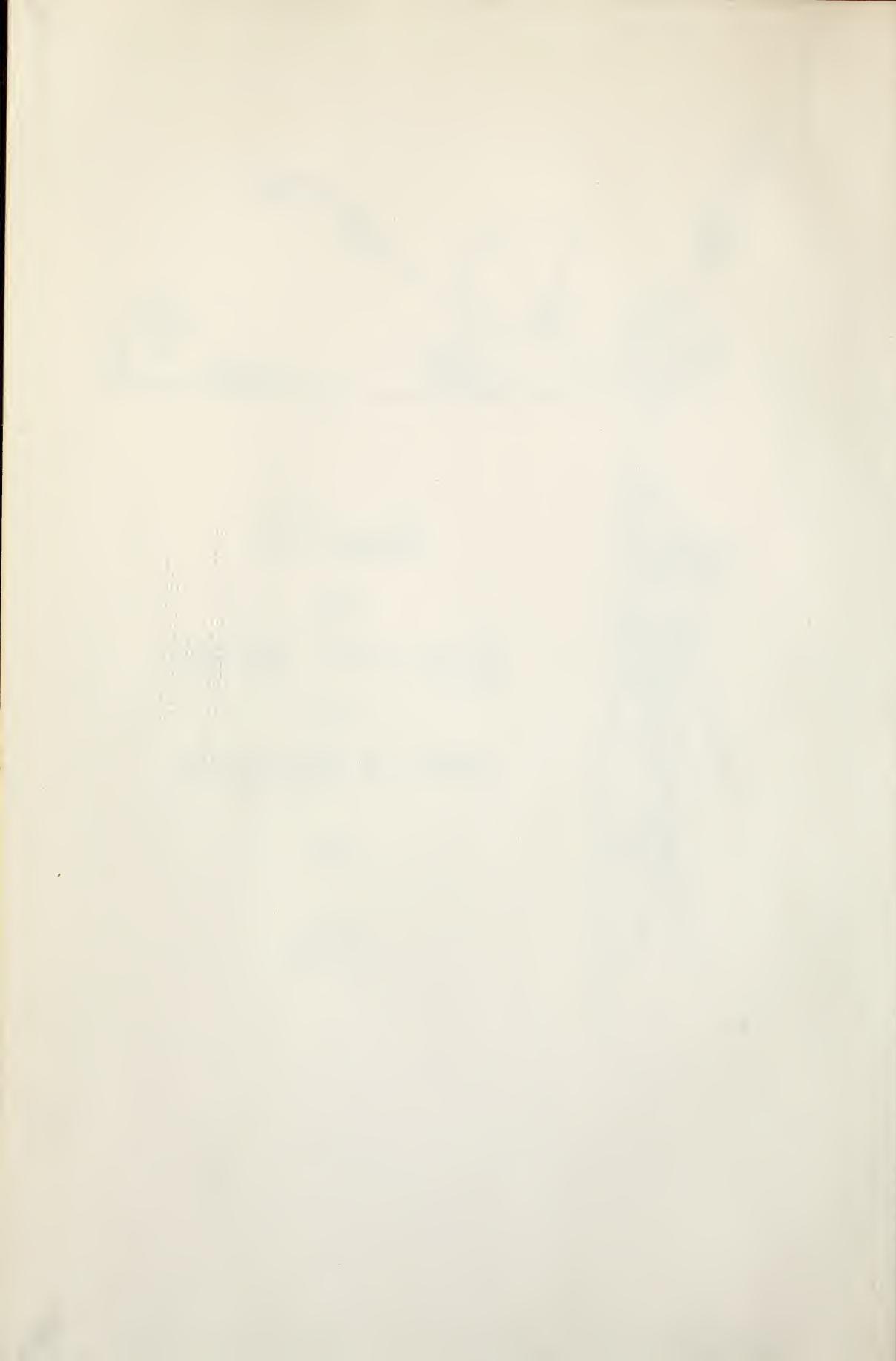

THE LAST ROSTER OF THIS SOCIETY, PUBLISHED IN 1901, SHOWED A MEMBERSHIP OF FORTY GENTLEMEN.

ARTHUR BURNETT BENTON AND DAVID RITTENHOUSE PORTER CORWIN OF LOS ANGELES, AND CHARLES GARDNER LATHROP OF PALO ALTO HAVE BEEN RECEIVED TO OUR FELLOWSHIP, AND WE HAVE LOST TWO; ONE BY DEATH AND ONE BY RESIGNATION, SHOWING AN INCREASE OF BUT ONE MEMBER DURING THE LAST TWO YEARS.

SINCE OUR ORGANIZATION FIVE GENTLEMEN HAVE DIED, VIZ:

HARRY WOODVILLE LATHAM, THE FIRST SECRETARY;

COLONEL WILLIAM ANTHONY ELDERKIN, U. S. A., THE FIRST LIEUTENANT GOVERNOR;

REV. ALFRED LEE BREWER, D. D., A PRESIDENT OF THE SAN FRANCISCO CHAPTER;

CAPTAIN CHARLES LEE COLLINS, U. S. A.;

ELISHA WILLIAMS MCKINSTRY, LL.D., FIRST PRESIDENT OF THE SAN FRANCISCO CHAPTER, AND A MEMBER OF THE COUNCIL.

THE MEMORIALS TO FOUR OF THESE ASSOCIATES, ADOPTED BY THIS SOCIETY, HAVE BEEN PUBLISHED IN THE GENERAL REGISTER.

JUDGE MCKINSTRY DIED AFTER THE PRINTING OF THE REGISTER FOR 1902, BUT THE NEXT REGISTER WILL CONTAIN A TESTIMONIAL TO HIS WORTH AND EMINENT ABILITIES AS A JURIST.

VISIT FROM MR. HOWLAND PELL, OF NEW YORK, VICE GOVERNOR-GENERAL. DURING HIS SOJOURN IN LOS ANGELES THE SOCIETY ENTERTAINED HIM WITH A RECEPTION AND DINNER, AND EXTENDED TO HIM THE COURTESIES OF THE OFFICERS AND RESIDENT MEMBERS.

THE LIMITED REVENUES OF THE SOCIETY HAVE PREVENTED THE COUNCIL FROM ISSUING ANY PRINTED MATTER OF THE CHARACTER WHICH WE RECEIVE FROM THE EASTERN SOCIETIES, AS NEARLY ALL OUR INCOME IS USED FOR THE NECESSARY CURRENT EXPENSES.

FOUR YEARS AGO THE COUNCIL UNANIMOUSLY ADOPTED A RESOLUTION FAVORING THE PUBLICATION OF A HISTORY OF THIS SOCIETY, CONTAINING BIOGRAPHICAL SKETCHES AND PORTRAITS OF ITS MEMBERS, AND OTHER MATTERS OF GENERAL INTEREST. HAD THE SOCIETY CONTINUED TO INCREASE AS RAPIDLY AS DURING THE FIRST THREE YEARS OF ITS EXISTENCE, THE AMOUNTS RECEIVED FOR MEMBERSHIP FEES ALONE WOULD HAVE PAID FOR SUCH A WORK.

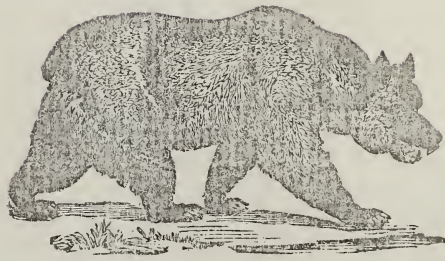
IT WILL COST ABOUT \$400 TO PRINT THE VOLUME UPON THE PLAN SUGGESTED, AND SHOULD IT BE DESIRED BY MEMBERS, IT WILL BE DONE. THE EXPENSES, HOWEVER, MUST BE MET BY VOLUNTARY SUBSCRIPTIONS, AND IF, IN RESPONSE TO THIS STATEMENT, THE AGGREGATE OF THE AMOUNTS PROMISED BY MEMBERS SHALL REACH SAID SUM, THE WORK WILL BE PROSECUTED TO A SPEEDY COMPLETION.

AT THE EIGHTH GENERAL COURT, CONVENED DECEMBER 24, 1902, IT WAS DECIDED TO INCORPORATE THE SOCIETY, AND THE MATTER WAS PLACED IN CHARGE OF THE CHANCELLOR.
