### The Periodic report for the month of November 2011

The humanitarian situation in southern Yemen in November 2011 was characterized by a double suffering between the fear of life and further deterioration of living. The southern citizen has become no longer able to enjoy the right to security of life because of the terrible lawlessness, and unable to enjoy the right of good living because of the supply shortages. This is what increased their concerns and confusion, panting behind what would protect them and realizes their requirements.

These conditions are the result of the absence of "state" presented in its civil institutions, and during its absence, the fundamental rights and freedoms of citizens become vulnerable to blatant violations, and thus undergoing the case of malfunctions and insecure livelihood which make them lose their life's natural elements.

Under such conditions, the fundamental human rights in the south have become a target by the forces of the authorities, the peaceful marches are still under live fire, leading to deaths, injuries, fear and panic, and campaigns of arbitrary arrests are still taking place, in which the detainee is deprived of their most basic rights. Regarding the political and social rights, they have already become in a position of barefaced destruction for years ago, all because of that the southern citizen has expressly declared the right to their freedom and the return of an independent state, the last interaction was in commemoration of their first Independence Day, when they all went out agreeing unanimously to their right to self-determination.

Despite the international community's demand to the Yemeni government to stop its attacks on civilians, we find that its forces were committing more crimes against southern citizens. This happened in the provinces of Aden and Hadramout. Above that, cacophony voices have become loud

to give immunities to the offenders, which mean that the perpetrator can commit more crimes for being sure that they wouldn't be held accountable. This can not be imagined by a human mind. Therefore, any claims of immunity are empty and void, for being contrary to the provisions of Islamic and international law.

The Southern Observatory for Human Rights warns of manipulating the rights of victims of human rights and warns of the consequences of the impunity of perpetrators of such violations, reserving the right to adopt them internationally, and to detect and prosecute the offenders to get their just punishment. These crimes are not in the place to bargain or to make deals with, they are subjected to the celestial and international provisions those are no one allowed to exceed. It's an offense that the blood and sufferance are bargained with. Whoever enables the offender to escape punishment is a partner in crime, so says the justice.

The Southern Observatory calls upon the international community to protect its legal provisions, and to defend the contents of its international agreements relevant to human rights protection, and to take steps to ensure the protection of human justice, and address all of the acts on the abuse of victims of human rights, and invites the international community to commit to the decision of the United Nations Council for Human Rights, on opening impartial and transparent investigation about the human rights crimes, which had been confirmed by the UN Security Council that stressed the need to work on that resolution.

And do not miss the Southern Observatory for Human Rights (SOHR) to welcome for the release the leader of the Southern Movement Mr. Hassan Ahmed Ba'oom of from the Yemeni detainee, to expressing his confidence that his presence among his people will increase the public's resolve and determination of the South to achieve their aspirations towards the independence.

We appreciate the visit of Mr. Jamal Bin Omar Envoy of the Secretary-General of the United Nations to the province of Aden, considering that step in the right direction to enable the people of the South to achieve its aspirations to freedom, dignity and self-determination. Those rights are denied to the people of the south for twenty-one years ago because of the invasion forces of the Yemen Arab Republic to the territory of the Republic of Yemen people's Democratic Republic. We hope that brief by Mr. Bin Omar victory to the cause of the people of the south and enable it to his political rights and civil rights, especially that Ben Omar is a militant international Jealous on human rights and his fundamental

freedoms.

The Southern Observatory for Human Rights was able to monitor and document a number of serious violations committed by the Yemeni regime's forces in November 2011 against southern citizens, including seven cases of extrajudicial killings and twenty-six cases of attempted murder that led to injuries in different degrees, as well as eleven arbitrary arrests. The Observatory has worked to include these violations in its monthly reports filed to the United Nations High Commissioner for Human Rights and other concerned international organizations, while these violations will continue to be a witness to the Yemeni regime's policies towards the citizens of the South, until the day comes that the perpetrators receive just punishment.

### **Extrajudicial killings, ((seven cases)):**

The ink of the UN Security Council Resolution No. 2014 that stipulated in its second paragraph a condemnation to the "continuing violations of human rights by the Yemeni authorities, like to use excessive force against peaceful protesters...", had not dried when these forces continued their violations not through the use of excessive force against the peaceful protesters in southern Yemen only, but even firing live bullets on them, killing some and wounding others. As if it is a blatant challenge to the UN Security Council resolutions, flouting the international position that condemns these acts.

Ali Qassem Al-Shutairi was killed on Thursday, November 24, when the regime's forces opened fire on protesters gathered to denounce the arbitrary destruction of their homes in the area of Abu Harba in Mansoura and Dakah in Mualla in the province of Aden under the pretext of haphazard construction. "Aden Online," website reported that bulldozers reinforced by heavy military vehicles proceeded to demolish the houses on the heads of their occupants after being constructed before 3 years ago, and the authorities did nothing about them, but provided them with water and electricity in an official way.

On Wednesday, November 23, Ahmed Abdullah Muswad died as a result of wounds sustained on Tuesday evening, November 22, due to his exposure to random shots exchanged between unknown gunmen in a street in the city of Mualla of Aden.

An explosive device amid the city of Abyan province, claimed the death

of two citizens and wounded seven on Monday, November 21. Aden News Agency reported their names as follows:

- 1- Mohammed Mustafa Mohamed Al-Jurd.
- 2- Mohamed Abdullah Suleiman Muflih.

According to the student's father, Salim Saeed Bahisami, his son, aged twenty years and studied engineering in India, died on Saturday, November 19 in mysterious circumstances in a political security prison two months after his arbitrary detention. "Mareb Press," the website, reported that the student Salem Bahisami was arrested during his visit to Yemen, and his family confirmed that he was not suffering from any disease.

Family of the soldier, Safer Mohammed Ali Alwan, aged 21 years from Sabeiha in Lahj province, accused Colonel Khaled Assumaini, the commander of the third battalion in the First Armored Division, of killing their son on the evening of Tuesday, November 1, following a quarrel broke out between the soldier and the son of Colonel Assumaini. One of the soldier's family members told "Aden Alghad," website that after the quarrel Colonel Assumaini ordered the soldier to give his personal weapon, an order was rejected by the soldier, and then Assumaini shot him dead.

Attempted murder, leading to serious injuries, ((twenty-six cases)):

In an indifferent way to the lives and blood of the citizens, nor what could the citizens suffer from of permanent disabilities, the Authorities' forces targeted a number of citizens in order to kill them, had it not been for the will of the Almighty, resulting in serious injuries, will be stamped on them for the rest of their lives, for no reason except that they adopt political positions opposite to the trends of the Sana'a regime.

The students Hussein Abdo Bazuhir, Shaker Salem Bayshout and Mubarak Saeed Hawaidi sustained different injuries when Authorities' forces fired live bullets on a student march organized in Sayoun District of Hadrmout Province on Monday, November 28.

The unionist, Mohammed Abdullah Musibli, the head of the Workers Union of Aden Refinery was exposed to an assassination attempt on Monday, November 28, by an explosive device planted in his car. The Web site, "Aden News" said that a violent explosion occurred in his car before he leaving his home in the district of Brega in Aden. Musibli is the

son of the former MP Abdullah Saleh Musibli on behalf of the district of Brega.

Mohammed Badjaalh, an inventor from the southern Hadramout province, was exposed to an assassination attempt on Sunday November 27, when his car was shot while he was driving in the Circle Line of the city of Mukalla. The Aden News Agency reported that the Badjaalh survived the assassination, despite the fact that the bullets penetrated the windshield of the car. Later, dozens of citizens formed a cordon to protect him.

The website, "Aden Alghad," said that local residents in the city of Jaar, Abyan province reported that "al Qaeda members" cut off the right hand of the citizen Saleh Baharima, 35-year-old on the evening of Saturday, November 26, for accusing him of stealing houses in Zanzibar. Aden Life website had already reported a similar incident of cutting off the hand of another young man, called Aikad, on Wednesday, November 23, from the city of Jaar, where that punishment took place in front of the people.

Ahmed Qasim Abdullah, Director General of the Auspices of the Families of Martyrs and Militants of the Revolution in the province of Aden on Saturday, November 26, was wounded in an attack was aimed at him during passing in a street in the district of Sheikh Othman in Aden. The injured Ahmed Qasim Abdullah said in a phone call with Aden Alghad website that: "Armed thugs barricaded my car while I was driving in Sheikh Othman City adjacent to the old police station, then they starting shooting me while my son was with me, I was injured by three gunshot in the leg and transferred to Al-Naqeeb hospital."

Seven people were injured by an explosive package exploded in the city of Mudia in Abyan Province on Monday, November 21, led two citizens to be killed. Their names were reported by Aden News Agency like the following:

The house of Dr. Waed Abdullah Ba'deeb, the member of the Political Bureau of the Yemeni Socialist Party, was exposed on Thursday, November 17, to fire of machine guns. The website "Sada Aden" said that the bullets penetrated the house's windows and walls and some of the rooms with no injuries, except the intimidation of children and women.

The political activist Thuraya Mujamal, the leading figure in the Yemeni Socialist Party was exposed to attempted murder by an unidentified gunman burst into her home city in the province of Al-Houta in Lahej province on Monday, November 14. The Web site, "Aden Alghad," said that an unidentified gunman broke into the home of the activist "Mujamal," stabbing her several times with a knife, while she was performing her dawn prayers, and ran away.

In a random shelling by armed forces on Friday, November 11, on the houses adjacent to the building of the local authority in the city of Mansoura in the governorate of Aden, a number of citizens were injured and their names were reported as follows:

1- Nizar Mahfouz Kaaki 2- Akram Sheikh Mohammed 3- Mahmoud al-Shibh 4 -Adnan Seif 5- Abdul Razzaq Mohammed Elewa 6- the child Amin Abdullah Ahmad.

As a result of firing live ammunition on peaceful demonstrators came out on Thursday, November 10, in the city of Sayoun to condemn the acts of the authorities' forces towards the citizens, the young man, Ahmed Salem Muftah Khairallah, aged 18 years, was shot in the left leg, and another citizen was beaten severely with rifle butts.

### **Arbitrary arrests ((thirteen state)):**

Arbitrary detention has become the favorite task of the regime's forces against the Southern Movement activists, the soldiers conduct this offense with pride and cheerfulness as if they were achieving a victory that perpetuates them to stay on the land of the South. Raid homes without shame of themselves for the suffering of the families and children, the victims of terror and panic. These soldiers do not know that their actions are a subject of hatred generated among the children of the South.

Authorities' forces on Wednesday, 30 November, arbitrarily arrested the journalist Adnan Al-Ajam editor-in-chef of "Al-Omna" southern newspaper and taken to an unknown destination. The Web site, "Aden

Alghad" said that the arrest may have come against the backdrop of his activities in organizing the activities of the anniversary of the Independence Day of the South, noting that the journalist Adnan al-Ajam is one of the journalists adopting the Southern case.

Forces of the Yemeni authorities in the city of Mukalla in Hadramout on Saturday November 26, raided the house of Saeed bin Hazim, an old man, and took him arbitrarily as well as his two sons, Sami and Salim as hostages to exert pressures on the activist in the Southern Movement, Tahir Saeed bin Hazim, who was not at home at the time of the raid. The political activist in the Southern Movement, Fouad Rashid, held the administrator of security the responsibility of these illegal violations, in particular since it comes under the "taking hostages" that is internationally forbidden.

Yemeni security forces on Saturday, November 19, arbitrarily arrested the three Southern Movement activists, Walid al-Sufi, Tariq Mohammed Judaib and Yassin Kulasi, all from the district of Musaimir in Lahj province. The Aden News Agency reported that they were arrested while they were in Sadaka Hospital in Sheikh Othman, for the purpose of treating their children.

Operatives of the Political Security in the neighborhood of Mualla in Aden arbitrarily arrested the political activist known as "Hakim," taking him to the Criminal Investigation Department in Khormaksar on Monday, November 21. As a result, a number of youth organized a protest to condemn this arbitrary detention.

On Thursday, November 17, forces the Yemeni authorities arrested the leader in the Southern Movement, Sheikh Hassan Banan Awlaki, the member of the presidency of the Supreme Council of the Peaceful Movement for the Liberation of the South, in addition to two of his bodyguards named Khaled Saleh Muzahim and Haidara Juneidi, during their presence in the city of Sheikh Othman in Aden.

Citizens of the city of Mukalla in Hadramout with the participation of the leaders of the Southern Movement of different national blocs and civil society organizations and the women's movement and the youth bloc organized a protest of solidarity on Wednesday, February 9, in front of the house of the detained field commander, Hassan Ahmed Ba'oum, the head of the Supreme Council of the Southern Movement, condemning determination the insistence of the regime of Sana'a to keep him detained with his son, Fawaz, in prison in extremely poor health condition,

considering that as a disregard of all human values and defiance of the southern revolution, which Ba'oum is considered its national symbol. The protestors demanded the rapid release of Ba'oum and all the southern political prisoners.

A number of southern political activists who were intending to travel to Cairo to participate in the Southern Conference, were exposed to tyrannical measures and provocative methods at Sana'a Airport on Saturday, November 19. Some of those who were banned from traveling were: Dr. Waed Ba'deeb, Ambassador Saleh Ahmed Yassin, Abdel-Hamid, Abdull-Hameed Talib and Qasim Daoud. The website "Sada Aden" said that Yemeni Security forces seized them in the CID prison in Khormaksar and took their passports.

The Yemeni security forces at Sana'a Airport arrested both of the political activists Abdul Hakim al-Darwish and Ahmed Mohamed Katabi, the former governor of Aden, as they returned from Cairo. They were also obstructed to continue their way to the city of Aden.

### **The suppression of peaceful demonstrations with live bullets:**

Facing the peaceful marches by live bullets is a sign of cowardice in the hearts of soldiers armed to the teeth. If there is no consideration of the legal aspects that prohibit adopting this horrific crime, the moral or even religious sides are not considered in the mindset of these rabbles.

On Thursday, November 10, forces of the Yemeni authorities opened fire on a peaceful march organized by the people of the city of Sayoun in the province of Hadramaut, to protest about the attacks on its citizens. As the citizens erected southern flags, government groups of security forces rushed to remove them, and when groups of people tried to prevent these forces from doing so, nozzles of machineguns were aimed at them, faced by public chants calling for the liberation of the South. Aden News Agency reported that the authorities' forces used excessive force to disperse the demonstrators, which resulted in the injury the young man Ahmed Muftah Khaiallah by a bullet.

In resistance to the youth's role in the city of Mansoura, forces of the Yemeni authorities on Friday, November 11, bombed the houses located near the building of the local authority in the city of Mansoura in the governorate of Aden, using heavy weapons, what sparked panic and fear among residents. People in the city said that these forces resorted to bomb residential buildings using such destructive weapons. The website of

Aden Alghad said that the authorities' forces preceded the attack after the youth of Mansoura tried to repel unknown armed group tried to control the building of the local authority. However, instead of supporting the youth in the protection of the building, they were exposed to attacks authorities' forces, which caused the injury of six citizens among them the child Amin Abdullah Ahmed.

Authority forces used live bullets and tear gas without paying attention to the lives of the citizens to disperse a peaceful demonstration organized by the Southern Movement in Sayoun city in the province of Hadramaut on the evening of Thursday, November 3. The Aden News Agency reported that a state of anger prevail in the province of Hadramout against the backdrop of the adoption of the regime's forces of the style shooting of peaceful marches and the use of excessive force to disperse peaceful protests, which claimed the lives of many people in the province, most recently a young man called "Ba'ayoun."

In the face of the legitimate demands of the doctors, staff and workers of Al-Jumhorya Educational Hospital in the district of Khormaksar, when they staged a sit-in on Tuesday, November 1, to demand their monthly salaries those have not been paid for several months, forces guarding the hospital proceeded to fire live bullets in the air to disperse them. The Web site " Aden Alghad," said that this behavior caused a state of panic for the patients and visitors who condemned this way of treating with the protesters.

### **Demolishing homes of ordinary citizens:**

In a denounced operation, using crews of military, armored vehicles, and the women police, forces of the authorities on Thursday, November 24, proceeded to demolish more than 30 houses to ordinary citizens built three years ago in the Abu-Harba district in Brega, to accommodate families and children, resulting in displacement and in heartbreak by the injustice done to them without regard for their human rights. The afflicted citizens said that they bought land in a formal way from the real owners, and they have the documents to approve that. There are also among whom are displaced people coming from the towns of Jaar and Zanzibar in search of safety.

Without a legal notice, nor a court order issued against them, the Yemeni government forces proceeded to demolish the houses under the pretext that the houses were built "in a random way." According to what the

website "Aden Life" the operation of demolishing was carried out in a brutal manner, in which women and children were dragged from their homes, and the furniture and belongings were looted by the forces of the authorities after the demolition. Those forces were not satisfied by this, but proceeded to shoot at protesters which caused the death of Ali Qasim Shutairi, while he was preventing a driver of a bulldozer from demolishing a house because there was a family inside it, but the soldiers shot him dead.

The afflicted citizens accused who are in charge of this awful operation of receiving large sums of money in bribes from the head of the Economic Establishment, who claims ownership of these lands, for the implementation of this fierce campaign by intimidation and force.

### **Disturbance of tranquility and public safety of the citizens:**

The province of Aden on Saturday night, November 12, lived a fearful night and full of concern among residents, who awakened from their beds to see an unprecedented spread of dozens of armored vehicles and military crews at the crossroads between the districts in a terrible way. The Aden News Agency said that dozens of tanks and armored vehicles had stationed near Caltex traffic circle in the sea route, the airport, Arish crossroad, near the Al-Jumhorya Hospital in Khormaksar, the roads leading to the districts of Mualla and Tawahi, the joints of the city of Sheikh Othman and the city of the Shaab, accompanied by hundreds of heavily armed soldiers equipped with all combat hostilities.

### **Abyan's displaced people call for help:**

We can not miss to mention the suffering of the people of the towns of Jaar and Zanzibar, which are still under the grip of the armed groups. The people of these two cities suffer from the loss of security of lives and from poverty and destitution in their lives, their homes are bombed and they expect to lose their lives and the lives of their families and their children at any moment. What they expect of services of living have forgotten and they can no longer remember, they have coexisted with hunger except that keeps them alive, there is no electricity, water is very rare, no fuel and basic services and communication is absent as well as any little semblance of normal life. Instead, they live in a siege, no one of them can leave except insecure for their life, and no one from outside these towns can visit them. However, the silence around the destiny of

these cities is applied from all local, regional and international levels. They have spent the past six months living under these conditions.

In a letter sent by the people of the two cities to the public opinion: "we hold the remnants of the regime in Sana'a full responsibility for what happens in Abyan province of killing of innocent children, women and elders and the displacement of the population of their towns and destroying their homes and the destruction of their farms, as well as the continuous siege for several months without sin they have committed." The also asked for help and to rescue them from destruction.

The Southern Observatory transmits the distress the people of the region to the ears of all the local and international humanitarian blocs to save their lives, for it is a responsibility lies on everyone without linger or hesitation. The Southern Observatory warns of the possibility of a humanitarian disaster as a result of the suffering of the people of the region, there is no government to sponsor them, humanitarian organizations to contain nor international community to save them. Therefore, we call to a renewed national, regional and international campaign, to help children, women and elders of the two afflicted cities. We call for the existence of protection for the people of the region from those who control it; that turned the cities to wreckage of wild animals feed on the corpses of its people.
