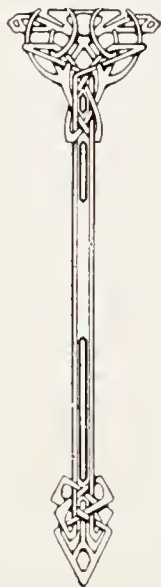

PREFACE

IN harmony with the original purpose and plan, this volume is "a portrait and chronological record of members of the Republican party in Illinois." It is with more than ordinary satisfaction that the publishers send this book forth for public appreciation, for it is believed that never before have been collected, in convenient form for permanent preservation, so many records of men who deserve to rank as typical representatives, not only of the highest aspirations and foremost activities in political life, but also of the best ideals of everyday citizenship. "Republicans of Illinois" is not a directory; was not designed to fill the place of the familiar "year book" and similar compilations, but is a collection of Republicans who fairly represent the high political standards and personnel of the party in Illinois.

Such men as are here represented are the power and substance behind the progress of political destiny; in the keeping of such men are placed the dignity and power of the dominant party in America. Every page of the volume contains a suggestive epitome of the human forces that have directed this government to its unequaled position among the nations of the world. And this collection will not depreciate in interest with time, but will have ever-deepening historic value as these men of the present are succeeded by on-coming generations. How we would value a similar collection of portraits of the men who made the history of our nation one hundred years

ago! So this book, which from its character is sure to be preserved, will always retain a worthy place among the treasury of unique and valued specimens of book craft.

Beneath each portrait is a brief chronological record and characterization, and, although necessarily condensed, these epitomes add immeasurably to the permanent value and interest of the volume. As to quality, a perusal will give convincing testimony that the execution is in all respects worthy of the purpose. The majority of the portraits are recent, having been taken expressly for reproduction in this volume. It has been the aim to give all the portraits in the book the benefit of the highest skill of the engraver's and printer's arts, and to produce a worthy specimen of bookmaking. Utmost care has been employed to secure accuracy as regards the personal records, typewritten copies of the matter intended for publication having been submitted at least once to the persons concerned, and unusual diligence has been exercised in every detail.

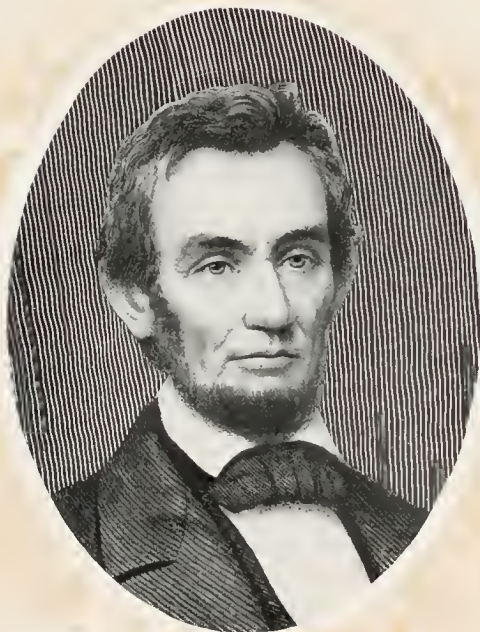

ABRAHAM LINCOLN

Born Hardin Co., Ken., Feb. 12, 1809, died, a martyr, at Washington, April 15, 1865. Reared in Ken., Ind. and Ill., educated himself, was Mississippi flatboatman, railsplitter, captain in Black Hawk war, kept a store, was a practical surveyor; at age of 25 elec. to Ill. Legis., at 27 adm'd to Bar; in 1837 moved to Springfield; elec. to Cong. 1846; cand. against Douglas for U. S. Sen., 1858; elec. Pres. of U. S., 1860, re-elec. in 1864, guided country through the Civil War, and was assassinated at its close.



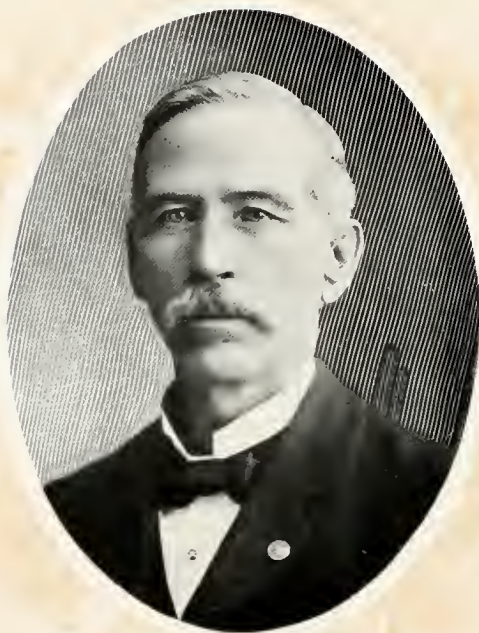
ULYSSES S. GRANT

Born at Point Pleasant, O., Apr. 27, 1822, and died at Mt. McGregor, N. Y., July 23, 1885. Grad. at West Point, 1843, served through Mexican war, left army in 1854, located at Galena, Ill., 1860. Greatest of Civil war leaders, was made lieut.-gen. and comm'ndr. of all Union armies, Mar., 1864; rec'd Lee's surrender, Apr. 9, 1865. Elec. pres. of U. S., 1868, and re-elec. 1872. Toured the world; wrote his "Memoirs." One of the most eminent figures in American military and public life.



SHELBY M. CULLOM, SPRINGFIELD

Born Wayne Co., Ky., Nov. 22, 1829, moved to Ill., 1831. Admtd. to Bar, 1855. Served 4 terms in Ill. Legis., twice as Speaker of the House; elected to Cong., 1864, 1866, 1868; elected Governor of Ill., 1876 and 1880. Has been U. S. Senator from Illinois continuously since 1883, and has been identified with state and national politics and policies since Civil war days, having the longest public career in high offices of any Illinois citizens.



WILLIAM G. COCHRAN, SULLIVAN

Born Ross Co., O., Nov. 13, 1844. Came to Moultrie Co., Ill., 1849; enlisted July 31, 1862, Co. A, 126th Ill. V. I., and mustered out 1865; admitted to Ill. Bar, May, 1879; served in 26th, 39th and 40th Gen. Assemblies, being speaker of special sess. 36th Assem. and of 39th Assem.; elected cir. judge 1897, and re-elec. June, 1903; dept. comm'dr. G. A. R., 1896; pres. Bd. Trus. Ill. Soldiers' Orphans' Home; del. Nat'l. Rep. Conven., Phila., 1900.



JAMES N. BROWN (DECEASED)

Born in Fayette Co., Kentucky, October 1, 1806. Came to Island Grove, Sangamon Co., Ill., 1834; engaged in farming and was the first breeder and importer of Shorthorn cattle in Ill.; member Ill. House, 1840-42-46-53; a colleague of Lincoln in legislature, 1840; introduced the bill and secured its passage creating the Ill. State Bd. of Agriculture, and was elected its first pres., Jan. 5, 1853. Died at Island Grove, Nov. 16, 1868.



WILLIAM KILPATRICK, CHICAGO

Born Glasgow, Scotland, Aug. 19, 1845, and came to U. S. in 1862. Enlisted, Aug., 1862, Co. G, 1st Minn. Mounted Rangers, and in 1863 in Co. A, 2d Minn. Cav.; mustered out, 1866. Located in Chgo., 1867; for 18 months civil service commissioner of Cook Co.; Aug. 1, 1897, app'd by Gov. Tanner sec'y Railroad & Warehouse Commission, and reapp. by Gov. Yates. Affiliated with St. Bernard Com. No. 35, K. T. and Chicago Division No. 1 Order of Railway Conductors.



WILLIAM E. TRAUTMANN, EAST ST. LOUIS

Born near Caseyville, Ill., Aug. 16, 1872. Grad. Law Dept., McKendree College, 1893; grad. Literary Dept. of same, 1895; admitted to Ill. Bar, 1894. Elected to Ill. House of Representatives, 1898, 1900, '02, and '04. Appointed in 1905 U. S. attorney for the Eastern Illinois District. Affiliated with Masons, K. of P., I. O. O. F. and B. P. O. E.



JAMES A. CONNOLLY, SPRINGFIELD

Born Newark, N. J., Mar. 8, 1842. Moved to Ohio, 1848, received academic educ., and came to Charleston, Ill., 1860; entered army, 1862, as major of 123 Ill. Inf., and mustered out, 1865, as brevet lieut. col.; mem. Ill. Assembly 4 years; U. S. dist. atty. 13 years; mayor of Charleston 2 years; elected to Congress from Springfield Dist., 1894, re-elec. 1896. Now engaged in law practice in Springfield, where he has lived since 1886. Mem. of Loyal Legion.



EDWARD C. CURTIS, GRANT PARK

Born Kankakee Co., Ill., Aug. 12, 1865, and was educated in DePauw and Northwestern universities; engaged in banking since 1890, being cashier of Grant Park Nat'l. Bank. Elected state representative, 1894, and was mem. of House until elected to the State Senate in 1904; speaker of the House in 1897. Member Union League, Hamilton, Marquette clubs, Chicago, and mem. Ivanhoe Com'dry, K. T., Kankakee.



JOHN A. LOGAN

Born in Jackson Co., Ill., Feb. 9, 1826, and died in Washington, D. C., Dec. 26, 1886. Grad. Louisville Coll. 1852; served in Mexican war; was mem. of Cong. from Ill., 1859-61; served with distinction in Civil war under Grant in 1862; in Vicksburg campaign in 1863, in northern Georgia under Sherman, 1864; one of ablest supporters of Lincoln for re-election; was in campaign through Carolinas to close of war. Was Ill. Congressman, 1867-71, and U. S. senator, 1871-77, and 1879 till death.



CHARLES G. ECKHART, TUSCOLA

Born New Orleans, La., Dec. 14, 1845. Grad. West Point Military Academy, 1867; in 1873 resigned first lieutenancy in 4th U. S. Artil. and came to Tuscola; admitted to Ill. Bar, 1880, and has since practiced. Del. to Rep. Nat'l. Conven. Chicago, 1884, and at St. Louis, 1896; in 1904 elected for fourth term to Ill. Repub. State Commit., and in 1904 was mem. managing campaign committee.



DAVID R. SPARKS, ALTON

Born near Lanesville, Harrison Co., Ind., Oct. 15, 1823. In 1836 moved with parents to Macoupin Co., Ill., and was reared on farm. Served in Mexican war in Co. I, 5th Reg.; was married Dec. 20, 1848; crossed country to Calif. in 1850. Served nearly two and a half years in Civil war, as capt. Co. L, 3d Ill. Cav.; wounded at Pea Ridge, and resigned command Nov., 1863. Has been in flour milling business 50 consecutive years. Elec. to Ill. House, 1888, and to Senate 1896. Mason since 1855.



ROY OWEN WEST, CHICAGO

Born Georgetown, Ill., Oct. 27, 1868. Came to Chicago, 1889; grad. DePauw University, Greencastle, Ind., 1890; admitted to Bar same year; now senior member law firm West, Eckhart & Taylor; assistant Co. attorney, 1894; city attorney, Chicago, 1895-1897; mem. Cook Co. Board of Review since 1899; pres. 30th Ward Rep. Club, 1894-1901; mem. Cook Co. Central Committee since 1902, managed Gov. Deneen's campaign, 1904, and same year elected chairman Rep. State Committee.



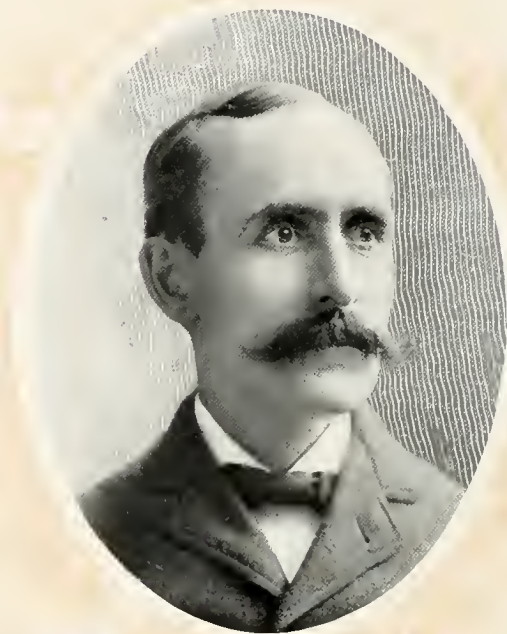
JAMES W. TEMPLETON, PRINCETON

Born at St. Clairsville, O., and located in Princeton in 1863. Was appntd dep'y county cl'k., 1864, and elected Co. cl'k. in 1869; delegate to Nat'l. Repub. Conven., 1872; appntd postmaster Princeton, 1875, serving as such 12 years; mem. State Cent. Commit., 1884-86. In 1894 elected to State Senate from 31st Dist. (Bureau, Whiteside, Stark and Putnam Cos.); re-elec. 1898; in 1902 elected from 37th Dist. (Bureau, Henry and Stark Cos.); was pres. Ill. Commis. to Pan-Amer. Exposition, 1901.



HARRY A. LEWIS, CHICAGO

Born in Berwick, Warren Co., Ill., Aug. 29, 1869. Received a collegiate education and was admitted to the Bar in 1896. Appointed assistant state's attorney Cook Co., 1901, and appointed County attorney for Cook Co., Dec. 5, 1904.



LUMAN T. HOY, WOODSTOCK

Born Alden, Ill., October 28, 1850, and received education Woodstock High School. Engaged in drug business in Woodstock since 1869. Member Board of Supervisors, Woodstock, 1889-1903; app'td. secy. State Board of Pharmacy by Gov. Tanner, 1899, holding position to Feb. 1, 1904; mem. Rep. State Cent. Com. 6 years, elected sec. 1902; app'td appraiser Port of Chicago by Pres. Roosevelt, Jan. 20, 1904, took charge Feb. 1, 1904. Member Hamilton Club and Knight Templar Mason.



EDWIN M. ASHCRAFT, CHICAGO

Born Harrison Co., Va. Aug. 27, 1848. Came to Illinois November, 1865; admitted to Bar, January, 1873, and is senior member of law firm of Ashcraft & Ashcraft. Elected state's attorney Fayette Co., 1873, and removed to Chicago, 1887.



ELBRIDGE HANEY, CHICAGO

Born Dodge Co., Wis., March 15, 1852, and received common-school and academic education. Came to Chicago, 1869; admitted to Bar, September 11, 1874; engaged in practice of law until November, 1893; elected judge circuit court for one term, 1893, re-elected, June, 1897; appointed judge superior court, Jan. 11, 1904. Member Union League, Chicago Athletic, Washington Park, Hamilton and Marquette Clubs. Taken active part in politics for many years.



C. H. BROWN, BATAVIA

Born in Batavia, Illinois, May 24, 1853, and obtained common-school education. Assistant postmaster, Batavia, 9 years; railway mail service, 1881-2; private secretary to Wm. M. and J. S. Van Nortwick, 1882-1900; elected mayor of Batavia, 1896; appointed postmaster, Batavia, 1900 and re-appointed 1904; member Board of Education 12 years. Member I. O. O. F., K. of P. and M. W. A.



RICHARD J. OGLESBY (DECEASED)

Born Oldham Co., Ky., July 25, 1824. Came to Decatur, Ill., at age of 12; was carpenter's apprentice, farmed and studied law. Was 1st lieut. Co. C, 4th Ill. Inf., in Mexican war, and later went to Calif., returning in 1852; was Scott pres. elector; ran for Cong., 1858; elec. to State Sen., 1860, but resigned and was made col. 8th Ill. 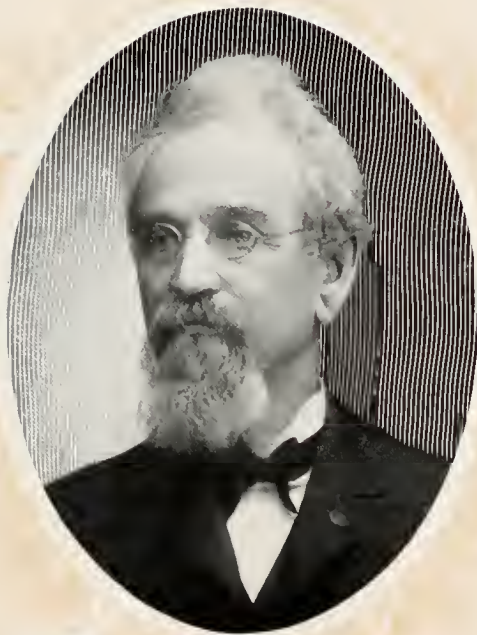
RICHARD YATES

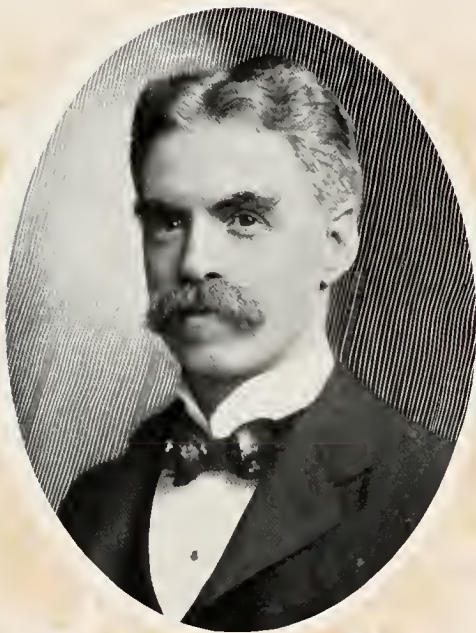
CHARLES S. CUTTING, CHICAGO

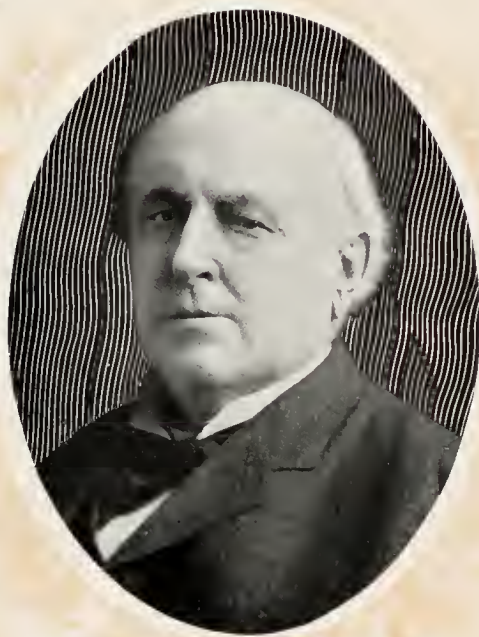
WALTER M. PROVINE, TAYLORVILLE

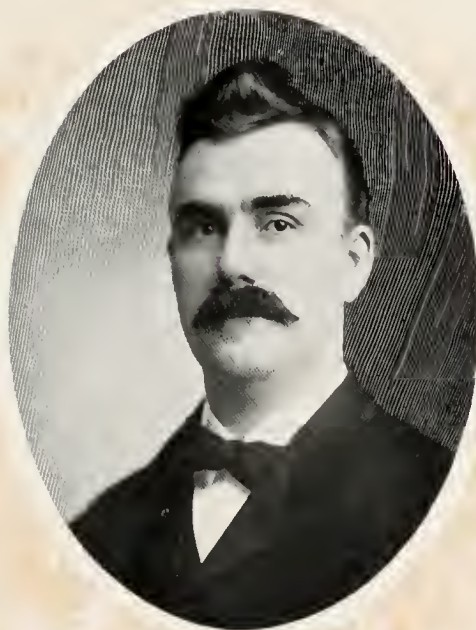

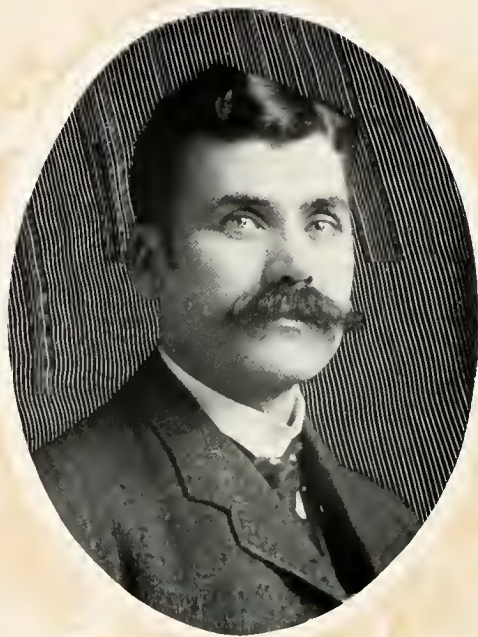
ROBERT SHERMAN HAMILTON, MARISSA

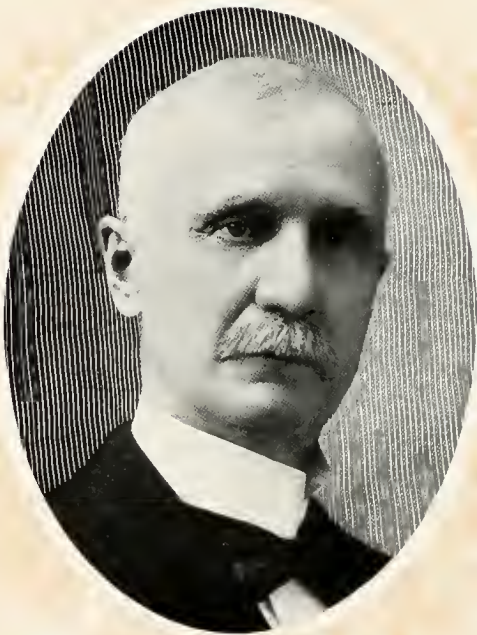
JOHN H. LEWIS, KNOXVILLE

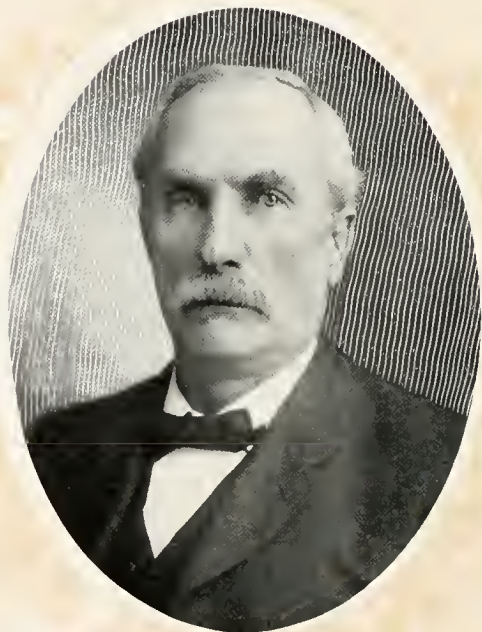
LOUIS A. CONSTANTINE, AURORA

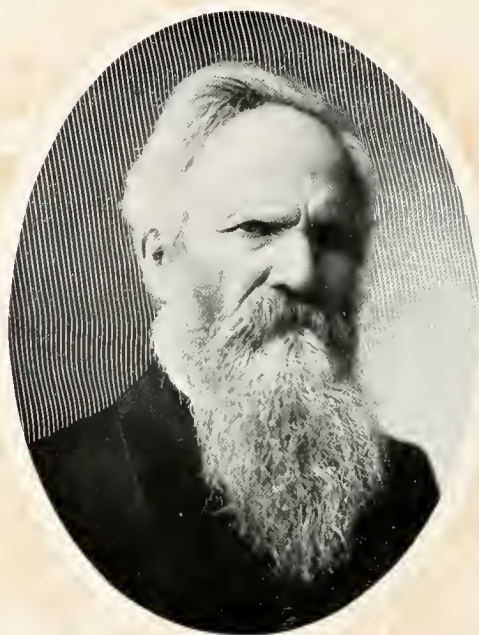
ZEPHEDE R. WINSLOW, CHICAGO

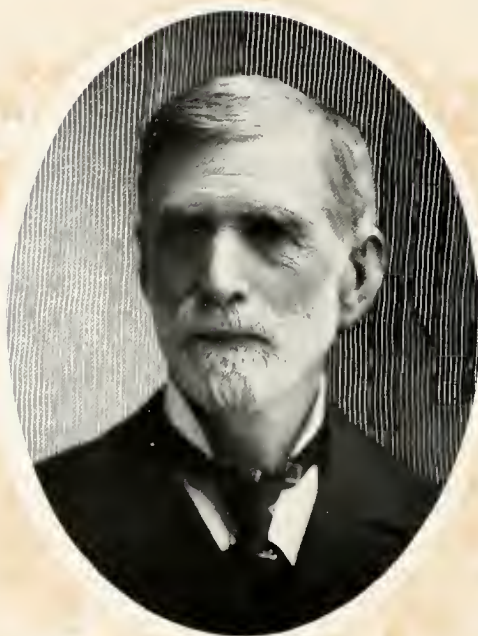
EDWARD I. ROSENFELD, CHICAGO

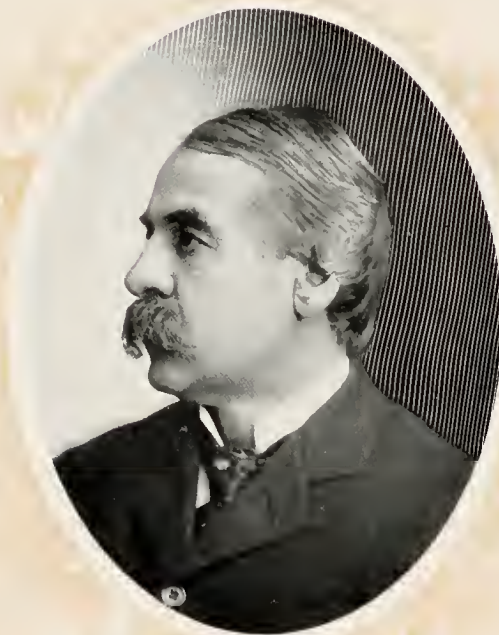

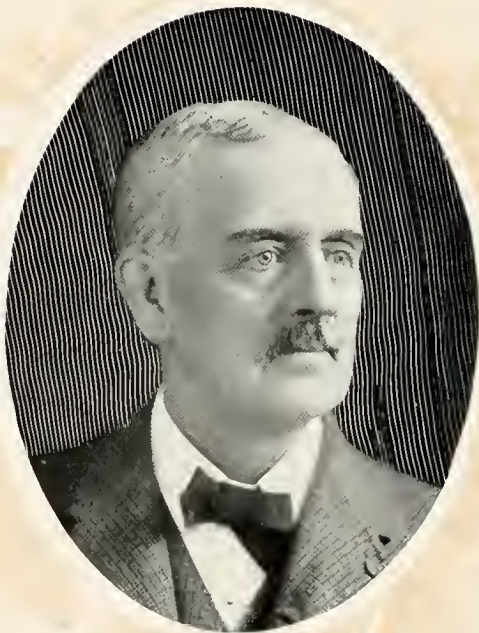
JOHN W. BELMONT, CHICAGO

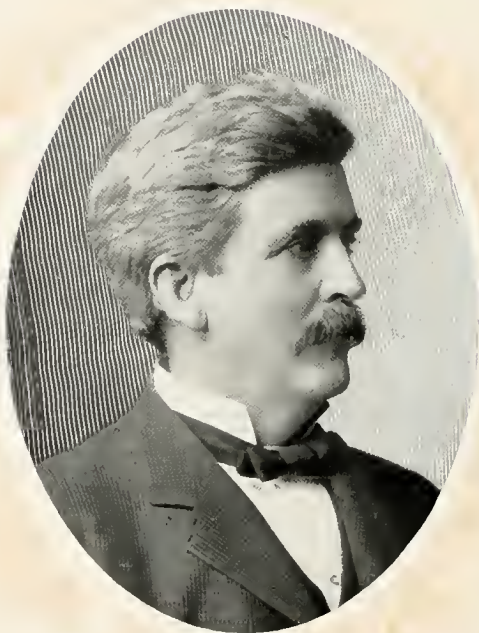
ARTHUR B. CODY, CHICAGO

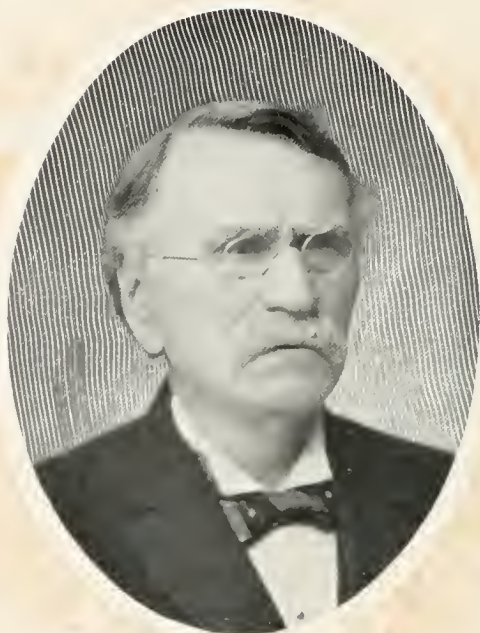
W. W. WHEELLOCK, CHICAGO

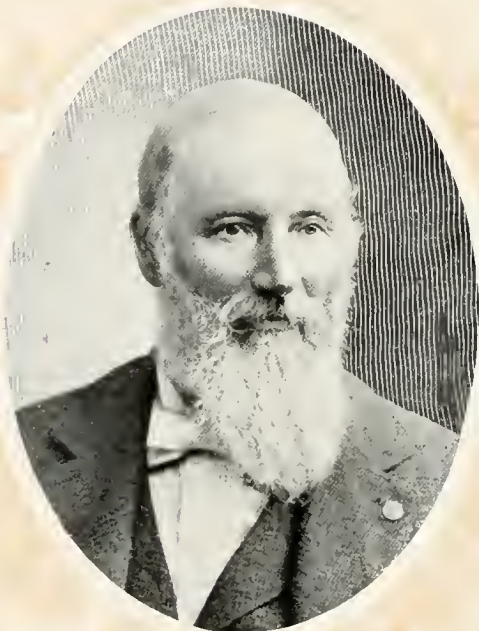

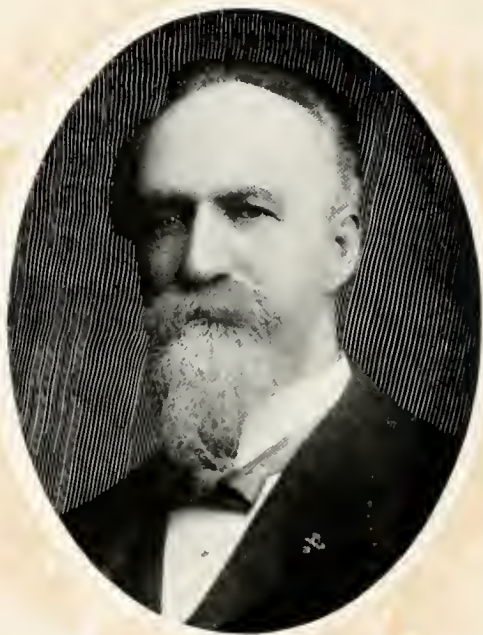
CHARLES H. SMITH, AURORA

JAMES A. SEXTON (DECEASED), CHICAGO

Born in Chicago, Jan. 5, 1844. In the Rebellion 1861-65, being mustered out with rank of lieutenant colonel. Many years a member of firm Cribben, Sexton & Co., stove manufacturers, from which he retired 1898. Presidential elector 1884. Appointed postmaster of Chicago, 1889, serving over five years. Elected commander-in-chief G. A. R., 1898. Died in Washington, D. C., Feb. 5, 1899.



JOEL A. MONTAGUE, MATTOON

Born Licking Co., O., June 1, 1845. Attended Denison Univ., Granville, O.; came to Mattoon, Jan., 1867, and in mercantile business there until May 22, 1893, when he and J. H. Clark organized Mattoon State Savings Bank, and was cashier and vice-pres. of same till elected pres. in June, 1903. Voted for Grant in 1868, and has always been Republican; affiliates with Masons.



ANDREW E. SHELDON, PAXTON

Born in Sweden, Oct. 3, 1845, came to Paxton direct from his native land in 1873, was engaged in the shoe business in Paxton, 1873 to 1894, was appointed postmaster by Pres. McKinley, Feb., 1898, and reappointed by Pres. Roosevelt, June 10, 1902. Affiliates with the M. W. A.

WILLIAM H. BISSELL (DECEASED)

Born in Yates Co., N. Y., April 25, 1811, died at Springfield, Ill., Mar. 15, 1860, nine months before expiration of term as 11th gover. of Ill. and first Republican incumbent of that office. Came to Ill. in early life, studied law, elec. to Legis. in 1840 as a Democrat, served as colonel in Mexican war, then twice elected by Democrats to Congress, and in 1856 nominated for governor as an anti-Nebraska man and elected. By profession he was a physician.

HOWARD O. HILTON, ROCKFORD

Born Atchison Co., Kan., Nov. 2, 1863, and obtained common school education. Came to Rockford in 1888, and has since been in newspaper business, having founded the *Republic* in 1890 and been its political editor since, except for 4 years; 1897-1901, was state canal commissioner, appointed by Gov. Tanner; was mem. State Repub. Commit., 1894-98, and mem. Exec. Commit.

EDWARD A. GARDNER, PAXTON

Born Westmoreland Co., Pa., Dec. 29, 1861; was educated in common schools, at Markle (Pa.) Academy and Paxton Normal and Collegiate Institute; taught country schools 3 years, was principal of graded schools 7 years; came to Paxton in 1881; was elected county supt. of schools, 1890, and re-elected 1894, '98 and '02. Is past commander Mt. Olivet Com'dry No. 38, K. T., Paxton, and a mem. Oriental Consistory, Chicago.

FRANK ROCKWELL, ST. CHARLES

Born Kane Co., Ill., Nov. 20, 1861. Graduated at St. Charles High School, 1878, attended Northern Ind. Normal 2 years, and taught 12 years, being principal St. Charles schools 10 years. Was asst. postmaster St. Charles during Cleveland's term, and app'ntd postmaster by Pres. McKinley, May 6, 1898, and reapp'ntd by Pres. Roosevelt, June 10, 1902. Mem. M. W. A.

HENRY M. MERRIAM, SPRINGFIELD

Born in Tazewell Co., Illinois, August 31, 1865. Educated in common schools and Shurtleff College, Alton; came to Springfield, 1887, and has since been engaged in banking, now assistant cashier Illinois National Bank; elected president Sangamon Club, Springfield, 1904.
