## EXPLANATION OF THE PLAN.

---

The Arabic numbers running through the whole genealogy are to show the number of each individual; and by the aid of them the connection of every person is seen at a glance. A number set at the end of a person's name, if lower than his regular number, shows that that person is first named at that regular number in the series, but if higher than his regular number, shows that immediately after that number in the series he is named again, and some further account of him or his descendants is there given. The Roman numerals are only employed to show the number of children belonging to the same particular family. By means of these numbers the account of all those individuals and families which are broken off and recommenced at some higher number (as the greater part necessarily must be) can be traced backward or forward with ease and facility, and by the use of these numbers any corrections or additions of individuals or families may be made at the end, and appear plain and intelligible. b is generally put for born, m for married, d for died, and a for aged.



## THE FOGG FAMILY.

---

THE name of FOGG appears to be of great antiquity in England, and Wales. Some by that name were from the county of Lancashire, near the borders of North Wales, and settled in the county of Kent, in the reign of Henry I, or about the year 1112 or '15, or about fifty years after the Norman conquest; some of whom settled in the town of Ashford in that county (which is about 54 miles from London) in the reign of Henry IV, or about 1400. There was a Sir John Fogg who founded a College in Ashford, and died there in 1490; his son Sir John Fogg resided there; his will is dated November 4, 1533, by which he appoints Edward Lee, Archbishop of York, overseer of his estate. There was also a Sir Francis Fogg at Ashford, who acquired the manor Repton, by his marriage with a co-heiress of the Valoigns; these families were of high standing and of much consequence for many ages, but they are now entirely extinct in Ashford, and perhaps in the county. Calamy gives an account of a Rev. Robert Fogg, an ejected minister in 1662, in North Wales, who from some traits in his disposition we might reasonably suppose was nearly related to some (by that name) who early settled in this country.

### FIRST GENERATION.

(1) But the common progenitor of most, and perhaps all by that name in this country was SAMUEL FOGG, of Hampton, N. H. According to tradition, three brothers by the name of FOGG emigrated from Wales to this country prior to the middle of the 17th century; two of them, Samuel and Robert or Ralph are said to have settled in Hampton, and the other in Rhode Island. Of the one settled in Rhode Island (if there was one) we have no knowledge. Robert or Ralph is supposed



ed to have lived and died unmarried. But Mr. Felt speaks of a Ralph Fogg in Salem among the first settlers of that town, but says that he returned to England.

At what precise time Samuel Fogg emigrated to this country is unknown, but he was evidently among the very early, if not the first settlers of Hampton, in 1638. He married first Anne Shaw, of Hampton, the 12th day 10 month, 1652. She died about 1661; he married his second wife, Mary Page, of that place, about 1662. He died at Hampton April 16, 1672. His widow, Mary, died March 8, 1699, aged 56 years. He was a farmer, owned a farm in Hampton, on which he lived and died. He was early a member of the congregational church in that place, and probably Anne his first wife; his second wife joined it May 29, 1698. His children were

Of these families, children and descendants of Samuel Fogg (2), Seth Fogg (6), and James Fogg (7), we have no further definite account, but they seem to have spread themselves over a considerable portion of New England and some other parts of the country.

Daniel Fogg (6), son Samuel (1), was about 12 years of age, at the time of the death of his father in Hampton, subsequently he learned the trade of a Blacksmith, and soon after settled at Black Point, in Scarborough, Me., where it is supposed he married Hannah Libby about 1684, and where he received





several grants of land of the town. He left Scarborough at the breaking up of that settlement by the Indians, about 1690. He then returned and settled in Portsmouth, N. H., as tradition says, on an Island belonging to that town, in Piscataqua River, where he remained until about 1700, when he removed, and settled in Kittery, (now Eliot), on a farm by him then purchased adjoining the River, between Frank's and Watt's Forts, which is still in possession of his descendants. Here he resided until the time of his death, in 1755, aged 95 years.—He was one of the seven original members of the Congregational Church in Eliot, at its organization, June 22, 1721. His wife died between 1730 and 1735. His children were

JAMES FOGG (39,) son of James (38,) married Anne Remick, in 1756. The incidents, which it is said led to their acquaintance were somewhat romantic. She resided on what is called Eliot Neck, near the margin of the river. As he was passing in a Boat up the Piscataqua one moon-light summer evening, his attention was arrested by the sound of the voices of a group of young females near the banks of the river, who were serenading the people as they passed on the river; the charms of the voice of one in particular forcibly impressed his attention, who on subsequent enquiry appeared to be Miss Remick; at which time a more intimate acquaintance commenced, which ultimately led to their marriage. She is said to have been remarkable in her youth for her personal attractions, and in later



years for discretion, economy, and benevolence, and all the various duties of a wife and a mother. They joined the church in Berwick, where they had settled, in 1781. She died there April, 1783. He married for his second wife widow Mary Twanbly, about 1800. He died in Wolfsborough, N. H., while on a visit to his daughter, in 1805, a 73. His children, all by his first wife, were

## THE HILL FAMILY.

THERE were several persons by the name of HILL in Eliot prior to 1700, one of whom was SAMUEL HILL. It is supposed that he was a native of the place, and that he was a son of

# THE MOODY FAMILY.

---

(1) MR. WILLIAM MOODY, the principal progenitor of the name in New England, came, according to the best accounts that can be obtained, from Wales, in 1633. He wintered in Ipswich, in 1634, and removed to Newbury with the first settlers of the place, in the spring of 1635. Tradition asserts that they landed on the north bank of the river, about one hundred rods below the spot where the bridge now stands. Here Mr. Moody was admitted a freeman, and received a grant of ninety-two acres of land. He, as well as his three sons, was of considerable note, both in the ecclesiastical and civil affairs of the town. The names of William, Samuel, and Caleb Moody, often occur in the various committee's of the church, from which we may infer that they were not only pious men, but also possessed much practical wisdom and general intelligence. There is a tradition that William Moody was a Blacksmith, and that he was the first person in New England who adopted the practice of shoeing oxen to enable them to walk on ice.\* His wife's name was Sarah. His children were

Joshua Moody (3), son of William (1), graduated at Harvard College, in 1653, and was ordained as the first congregational minister of Portsmouth, N. H., in 1671, where he had previously been some years preaching, and was subsequently minister of the first church in Boston, from May 23, 1684, till 1692, and died in Boston, July 4, 1697, in the 65th year of his age. He was greatly opposed to the fanaticism, which in his time prevailed relating to Witchcraft. He ranked high among the puritan ministers of those times. He married, it is said, first a Collins, and second widow Ann Jacobs, of Ipswich, who survived him. One of his daughters named Martha, married Rev. Jonathan Russell, of Barnstable. Another, Sarah, married Rev. John Pike, of Dover, N. H. His son Samuel Moody, graduated at Harvard College, in 1689, and was settled as minister of Newcastle, N. H., and was subsequently a military officer at Falmouth, Me. He was grandfather of Joshua Moody, Esq., and Doctor Samuel Moody of Portland, Me.

Caleb Moody (4), son of William (1), married Sarah Peirce, Aug. 24, 1659, who died Aug. 25, 1665. He married for his second wife Judith Bradbury, Nov. 9, 1665, who died Jan. 24, 1700. He died in Newbury, Aug. 25, 1698, a 61. His children were

He married Edmar Gale, eldest daughter of Stephen Gale, Esq., of that place, April 24, 1792. She was born Sept. 5, 1772. He died at Sanbornton, Jan. 11, 1835, a 65, his widow died at Brookfield, N. H., June 15, 1836, a 64. He carried on the business of iron foundry in Sanbornton, hoe and scythe making, and oil making, very extensively, and was also much employed in business for the town and county, and was seven years a member of the New Hampshire Legislature.

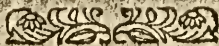
