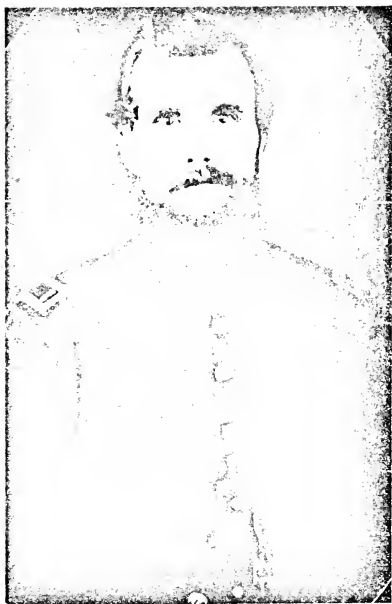

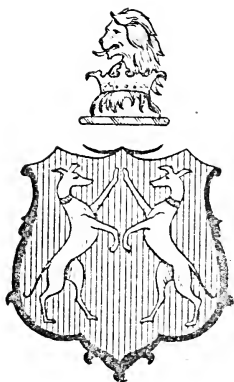

Coons, who gave me the privilege of searching the books in the vault for records and copying wills and other matter (mentioned elsewhere). I am indebted to James William Doggett for his foresight in helping to preserve the history of our line of the family by giving that history to Mr. Samuel B. Doggett.

To Mrs. Taylor of the Newberry library, Chicago, who was very helpful and extended many courtesies; to the librarians in the Library of Congress, Washington, D. C.; to the good people of Culpeper, Virginia, and Hillsboro, Ohio, who were tireless in their efforts to find the desired information; to Green's notes of Culpeper, Virginia; to "Grandpa" Richards for preserving and leaving to me the old book he used as justice of the peace, from 1839 to 1870, which I found years later to contain the only autographs of my grandfather, Arnstead Doggett; to our dear aunt, Mary Sargent, who is past eighty years of age and the only living member of her father's family, and who has patiently answered letter after letter, in giving the desired facts regarding her family. To all these, I am deeply grateful.



I have conscientiously endeavored to put in the proper place every fact given me by each member of the family. ## DOGGETT HISTORY

The earliest authentic history we have of the Doggett family is of Thomas Doggett, whose history was published in London, England, in 1908. He is mentioned in the Britannica Encyclopedia, in vol. 8, 381a: "Thomas Doggett (d. 1721), London, English actor born in Dublin, made his first appearance in London, 1691. He is highly spoken of, both as a man and an actor. He founded modern boat racing on the Thames and awarded a prize to the winner; it is known as Doggett's coat and badge, in honor of Hanover, and in commemoration of his majesty, King George's happy accession to the British throne. The prize was a red coat with a large silver badge on the arm, bearing the white horse of Hanover.

"The race was rowed annually on the first of August by six young watermen, who were not to have exceeded the time of their apprenticeship by twelve months. The first contest took place in 1715. The race is rowed each year, but under modified conditions. The money paid for these prizes is from a fund left by him. He is frequently referred to in the 'Tattler' and 'Spectator'."





Vol. 23, 783c: "Thomas Doggett, the founder of modern boat racing. It is controlled now by the fishmonger's association."

Vol. 4, 99d: "In 1715, Thomas Doggett founded a race which is still rowed in peculiar sculling boats straked and with sides flaring up to the sill of the row lock."

The *Americania Encyclopedia* states: "Doggett's coat and badge, a prize for a rowing match on the Thames, which takes place every year on August 1. The course extending from London Bridge to Cadigon Pier, Chelsea. The first prize is an orange colored waterman's coat and a silver badge representing the white horse of Hanover, and to this have been added other prizes, the first prize being also augmented. The match is open to six young watermen recently out of their apprenticeship. It was instituted by Thomas Doggett, a native of Dublin and a popular actor in the early part of the eighteenth century, who left a bequest for the purpose of founding the prize in commemoration of the accession of King George, August 1, 1715. Dibden's ballad opera 'The Waterman' is based upon this rowing contest."

A number of books on the Doggetts in America have been published. The Doggett-Daggett history, whose



author is Mr. Samuel B. Doggett of Boston, contains 686 pages and is well illustrated, the frontispiece showing eleven coats-of-arms, known to have been given members of the Doggetts in the past. This book gives the lines of descent as clearly as it is possible to trace them—east and south, north and west. A very large number of the people answering to this name live or have lived in Massachusetts. It is believed John Doggett came to Salem, in that state, with Winthrop between June 12 and July 2, 1630. And from him came most of the Massachusetts line. Mr. S. B. Doggett's history is in the Library of Congress, Washington, D. C., and in the Newberry library, Chicago, where it may be seen. Other Doggett histories to be found in these libraries are: "The Doggetts of Chicago," "The Doggetts of Keokuk (Iowa)", and in Ohio "The Doggetts of Highland and Ross Counties" in county histories.

Mr. Samuel B. Doggett found Rev. Benjamin Doggett of Lancaster, Virginia, to have been the founder of the Virginia lines of the family. He came to America from Ipswich, England, previous to 1670, the year is not known. From a Virginia magazine devoted principally to tracing facts of the past, we found, "In 1670 the vestry of Trinity Parish, in the county of Lancaster, presented Rev. Benjamin Doggett



to officiate in the two churches," and the state papers of Colonial Virginia, vol. LX, No. 410, mentions the fact that he bought a plantation. He founded White Chapel church and was its rector until he died in 1682. He was buried in front of the pulpit. This church was also known as Christ's church, and later it became known all over the country as King Carter's church. The family of William Ball, from whom Mary Ball Washington, the mother of George Washington, was descended, were contributors to White Chapel. They settled in Lancaster county from England in 1650. Mrs. Pryor, in her book, "The Life and Times of Mary Ball Washington," states that many of the old graves stones near the ruins of White Chapel bear the name of Ball.

The full text of the will of Rev. Benjamin Doggett is given in the Doggett-Daggett history; it was taken from Gen'l Ct. will book No. 2, p. 37, Lancaster, Virginia. He willed to each of his sons—Benjamin, Richard and William—one hundred acres of land; to his daughter Jane, who had remained in England, twenty shillings; to his daughter Ann fifteen hundred pounds of tobacco (it being legal tender at that time in Virginia) she received considerable other property. He directed that his children should be registered in Christ's church; he debarred his son Benjamin any



share of the cattle because he had a good "stock" already of his own. Of his books he said: "My books to be apraised, a great chest to be bought, ye books to be packed up and sent for England to be sold." He named his appraisers and executors, and left to the latter twenty farthings to buy the mourning rings. His will was probated January, 1682.

The early Virginians were called cavaliers. It is not possible to trace the family in unbroken lines from the founder to the present generation, and the only method for obtaining any record of some of the families is through court or military papers. One of the strong dominating characteristics of the Virginia Doggetts seems to have been patriotism, but that began with Thomas Doggett in London in leaving his estate to his king rather than his descendents. George Doggett was commissioned a lieutenant in 1741. From the Journal of the House of Burgesses, Virginia, we find Richard Doggett claimed pay for his slave Nelson who had been tried and convicted of felony. Nelson was put in prison, the door was broken open and Nelson was not heard from again. Richard asked eighty pounds from the public; he received the amount after appearing before the House of Burgesses for a number of years. The journal also states he enlisted thirteen recruits for the Virginia militia and paid the





bounty money for them. It seems his spirit of patriotism led him to forget Virginia's right to enlist its soldiers. The claim was refused, but he presented it year after year until it was paid. Later he was made a captain of a regiment in the last war between Great Britain and France, and went to his regiment from Charlotte county, Virginia, March 6, 1780. The inventory and appraisement of his estate as produced by his brother George was found to consist of one negro boy named Med, who was valued at sixty pounds (\$350). The inventory was signed the nineteenth day of November, 1781.

From a book issued by the department of commerce and labor, which we found in the historical department of the Chicago public library, we read the list of Doggetts in the first census of Virginia, 1782-85, to be in Lancaster county:

- Ann Doggett, two persons, no building.
- Elmour Doggett, one white person, one dwelling, one other building.
- Mary Ann Doggett, four persons, no buildings.
- John Doggett, five persons, one dwelling, four other buildings.
- William Doggett, Jr., six white persons, six black.
- William Doggett, nine white persons, eight black.
- Elmour Doggett, one white person, two black.
- George Doggett, one white person.
- John Doggett, three white persons, four black.



In Mecklinburg County:

John Doggett, thirteen white persons, five black.

Benjamin Doggett, eleven white persons, four black.

The will of Joel Doggett of Culpeper, Virginia, who was the father of Captain Richard and of George Doggett, gave his wife a child's part of his estate, to dispose of as she should choose. His will was signed in 1802.

Bushrod Doggett seems to have been a man of considerable means. His land had formerly belonged to Lord Fairfax. It had been granted by him to William Tapp, who sold it to Bushrod Doggett. It comprised three hundred and fifty acres and is near the town of Culpeper. His will was signed April 1, 1791. His wife died soon after and his two sons, Joel and George, sold part of the land and the house to James Pendleton.

George Doggett sold September, 1779, to Thomas Brown for the sum of one hundred and seventy-three pounds and fifteen shillings, "current money of Virginia, one parcel of land estimated to contain 200 acres, part of the tract granted to Andrew Brown by Lord Fairfax."

Bushrod Doggett owned twelve slaves at the time of his death; they were sold and an equal share with a share of the real estate was given to each of the five



daughters. His son George, his daughter Sarah Ann Byers and her son founded the Doggett family in North Carolina, going there in about 1800. Mr. Micajah Doggett, the historian, claims that all people in the state of North Carolina by the name of Doggett are the descendants of these three persons.

The Culpeper court records show that George Doggett and his wife Ann sold 509 acres of land to John Rixey April 22, 1803. The transaction was witnessed by Burkett Davenport and James Pendelton. George Doggett's wife was a sister of Major Yancy of Culpeper. George was the son of Bushrod.

The first battle of the revolution fought on Virginia soil, December, 1775, was commanded by — Stevens, afterwards General Stevens of Culpeper. It was the battle of Great Bridge by the Culpeper Minute Men, of whom John ~~Hancock~~ of Roanoke, Virginia, said in the United States senate, "They were raised in a minute, marched in a minute, and disappeared in a minute." This was literally true of many of them.

The Richmond state library has given out this statement: "Virginia furnished 26,678 men in the continental line, 30,000 in state troops, militia, and so forth—56,678 altogether—and only 35,000 have been made known. Of the Doggetts who appear on the known list are: Benjamin, Clem, Elmer, Elmour,

Randolph



George, Joel, James William and Richard. The name of Chatton Doggett, whom one history states was a lieutenant in the regiment in which George Doggett served, does not appear on the known list. He was in Captain Henry Hill's company. Their company met the British prisoners at Burgoyne's surrender and guarded them to Albemarle barracks.

We found twenty-one Doggetts listed on the deed book in Culpeper, and copied many of the wills and other interesting matter. Josiah Carter married Betty Doggett, daughter of William Doggett, July 24, 1753. The inventory at his death amounted to seventy-six pounds, sixteen shillings, three pence. It included five painted plates, a punch bowl, a pair of silver clasps, and four pounds weight of books.

William Steptoe and Joanna Doggett received the consent of James Doggett to their marriage October, 1772.

John McTyre and Molly Doggett November 21, 1782.

Thomas Mott and Winifred Doggett February 21, 1782.

James Doggett married Ann Brown December 10, 1788.





William Doggett married Mildred Brown March 18, 1819.

Judy (Judith) Doggett and John Jones were married in Culpeper February 20, 1813. Judy was a sister of Armstead Doggett. They later moved to High'land county, Ohio.

The war of 1812 found loyal subjects among the Doggetts. Armstead Doggett entered service in the Fifth regiment, Virginia militia, March 31, 1813, was discharged October 14, 1813. Served again as second corporal in Captain Charles C. Allen's company of infantry, First (Crutchfield's) regiment, Virginia militia from August 4 to December 17, 1814.

Thomas Doggett served in the Second infantry from November 14 to October, 1815.

Other Doggetts mentioned in the histories of 1812 are: George, a brother of Armstead, served in Captain Anderson's company in Virginia; Coleman, Samuel, Dennis, Benjamin (drummer, Lancaster), Charles, James, William, Lemuel, Griffin, Benjamin, Spencer.

During the Civil war some Doggetts carried the stars and stripes, and some the stars and bars.

The son of Nellie Doggett, a daughter of Elmour Doggett, was General Joseph E. Johnston of Harpers



Ferry. He was congressman from Virginia after the war and was the author of "Narrative of Military Operations."

The ambition of the Doggetts has not been wholly to shoulder the gun, nor to be land proprietors.

Rev. Naphtalie Daggett was one of the early presidents of Yale College. Kate Doggett was an American reformer and a scientist (1835). Simeon Doggett was an American Unitarian clergyman and educator (1765-1852). Daniel Seth Doggett (1810-1880) was a bishop of the Methodist Episcopal church in Virginia and an author. David Daggett was an American jurist, educator and statesman (1764-1851). Oliver Elsworth Daggett was an American Congregational clergyman and an author (1810-1880). Brig. Gen. Aaron Simeon Doggett was from Maine.

Laurence Locke Doggett, educator, born Manchester, Ia., December 22, 1864. Author *History Y. M. C. A.*, vol. 1, 1896.

Many others who have achieved success with high honors are mentioned in the Doggett-Daggett history. As shown in that history the names Doggett and Daggett were originally the same. The occupation of most of the present generation is that of farming.

The father of Armstead Doggett (4) was James Doggett of Culpeper, Virginia. The father of James (3)



was George Doggett (2) of Lancaster and Culpeper, Virginia, whose will is here given. Rev. Benj. Doggett, the founder, is given the numeral 1. The court records of Spottsylvania county show that Robert Slaughter of Orange county, Gent, sold to George Doggett of Lancaster county, planter, 470 acres in Spottsylvania county, October 5, 1736.

It is probable he is the one referred to as receiving the commission of lieutenant in 1741.

Will of George Doggett, grandfather of Armstead Doggett, in whose honor this book was compiled:

The will is recorded in Will Book "A", page 186, in the county clerk's office in Culpeper, Virginia.

In the name of God amen. I George Doggett of the Parish of St. Marks in the county of Culpeper being indisposed in body but thanks to God of as sound mind and memory as usual, and knowing the uncertainty of this Life Do make and ordain my last will and Testament in Manner and form following (to wit) Principally and first I recommend my soul to Almighty God Hereby hoping through the merits of Jesus Christ to obtain Pardon and remissions of all my Sins and enjoy everlasting Felicity, and my Body I commit to the earth (from whence it came) thorein to be decently Interred in a Christian like manner and as for such worldly Estate with which it hath Pleased God to Bless me I dispose of as follows (viz) I give and Bequeath to my Son Chatwin Doggett and his ossing forever one tract of Land containing one hundred and sixty four Acres Lying in Lancaster County as also one Negro Boy Named Daniel But it is my will that in case my said son Chatwin should Die before he arrives at Lawful age and without issue of his Body then the



said Land shall go to my son Thomas Doggett and his Heirs and assigns forever I give to my son Thomas Doggett one negro Boy named Harry.

I give to my Daughters Sarah Ann Reynolds and Margaret Scroggin each the sum of ten shillings and all the remainder of my Estate after my Funeral charges and just Debts are paid I lend to my Beloved wife Ann Doggett during her natural Life and after her deceased to be equally divided between all my children except Sarah Ann Reynolds And Margaret Scroggin aforesaid who I do not intend shall have any more of my Estate than what they have already received and tho ten shillings each above mentioned.

It is my will and Desire that my Estate shall not be appraised.

Lastly I do nominate constitute and appoint my beloved wife Ann Doggett executrix and my son Thomas Doggett Executor of this my last will and Testament and I do Hereby revoke all former Wills by me made and Do declare this only to be my last Will and Testament In Testimony where-of I do here unto set my hand and seal this 6th Day of January in the year of our Lord One Thousand Seven hundred and fifty Eight.

Liberty being reserved for Thomas Doggett the other executor therein named to join in the probot when he shall think fitt

We know nothing more of the boyhood life of Armstead Doggett than the record given above. Armistead is the name of a prominent old Virginia family, and



the name was spelled in this way in the old Doggett family Bible. We do not know how Armstead Doggett spelled it, in both signatures we have he uses the initial, A. Doggett. The younger members bearing that name seem to have left off the i, and the war department at Washington, D. C., have done the same. The record from that department shows that Armstead Doggett served in the war of 1812 as a private in Lieutenant John Lampkin's company of infantry, Fifth regiment, Virginia militia. He is shown to have entered service March 31, 1813; to have been transferred to Captain Edwards' company, same regiment, May 6, 1813, and to have been discharged October 14, 1813. The records also show that he served in said war as second corporal in Captain Charles C. Allen's company of infantry, First (Crutchfield's) regiment, Virginia militia, from August 4 to December 17, 1814. He is shown to have been appointed corporal August 22, 1814.

These two services entitled him to two bounty land warrants, for eighty acres of land for each service. Both warrants were left at his death to his widow. The record from the general land office at Washington, D. C., shows that warrant No. 55164 for eighty acres was located at Milan, Missouri, June 18, 1857, and was patented June 10, 1879, and that warrant No.





25993, for eighty acres, was located July 23, 1868, at Dakota City, Nebraska, and was patented March 13, 1871.

The history of Highland county, Ohio, makes this mention of him: "Armstead Doggett came to Hillsboro about 1828, and as a skillful workman established himself in a large and profitable business manufacturing saddles for men and women." The date is wrong, it is more likely to have been 1816, for he was married in Hillsboro in 1818.

Another mention in that history is: "Eagle Spring was a great place in those days for social enjoyment, and of course a great favorite; so much so, that when Col. A. Doggett opened his tavern, where the Parker house now stands, in 1826, he named it for the spring, the Eagle hotel." In that hotel all of his children were born, and in a later hotel on the same site his granddaughter Ella. So well was the hotel built that timber from it was used in the construction of one of the residences on Catherine Street, Hillsboro, when the old hotel was replaced by another of brick and stone and is still a good building. In a photograph gallery we found, in 1914, on exhibition a very large hand-made shingle marked, "From the old Doggett house".



The author of the Highland county history was Daniel Scott, Esq. One who knew Armstead Doggett and his family well, and were near neighbors, speaks of his ability along many lines. This lady, Mrs. Dr. Smith, has long been one of the distinguished women of Hillsboro. She is now ninety-one years of age, but with clear mind and memory of the old days she described his appearance, as tall and fine looking. No portrait of him is known, and only two of his autographs. These were found in a book kept by Squire William Richards while justice of the peace. In one, dated March 2, 1839, Armstead Doggett brought suit against B. Martin for a debt of \$9.50. He acknowledged the receipt; the justice fee was thirty-five cents, the constable fee twenty cents.

Armstead Doggett (4) and Mary (Polly) Allison were married in Hillsboro, Ohio, September 10, 1818. Armstead died there December 27, 1847. His wife lived until the spring of 1856, with her son John Allison Doggett. Their children were:

Cary Armstead Doggett at the age of twenty-three enlisted on June 6, 1846, in Captain Knife's company, second regiment, Ohio volunteers, in the Mexican war, and was discharged June 22, 1847. On account of his service he was pensioned under certificate number 5814. The above was obtained from the pension department at Washington. In the historical department of the public library of Chicago and in the Library of Congress we found the following: "Company C, second regiment, Ohio volunteer infantry, Cary A. Doggett, age 23, enlisted and mustered in





Mexican war June 6, 1846, mustered out with company June 22, 1847, at New Orleans, by S. Churchill as mustering officer, went in as sargeant and remained such during service. David Irick was the captain and George Morgan colonel. This company was organized at Camp Washington, near Cincinnati. They left Cincinnati for Mexico, the journey to the enemy's country consuming three weeks. The regiment lost during its period of service six killed, two drowned, and sixty died of disease. On reaching Mexico the company was garrisoned at Camargo, which city was the supply depot of Gen. Taylor's army, at the head of navigation of the Rio Grande on the main branch of the Rio Juan. On the twenty-fourth of March they began a march early in the morning which lasted until the next morning, then after one hours' rest and halt they started again. They met the enemy at Aqua Fria. From his headquarters at Buena Vista, May 16, 1847, Brigadier Gen. Wool wrote in part to the Second and Third Ohio: 'The Second and Third Ohio will return to their homes with the consciousness that they have done great credit to their state, rendering good service to their country, and that they bear with them the hearty good will and sincere admiration of the companies and commander. Signed, Brigadier Gen. Wool, Irwin McDowell, A. D. C., Samuel Stewart,



Cary A. Doggett, Allen Creed, Manker Lewis, Wilson Creed, Overman Levi, Joe Greenfield.' Tedrow and Peyton Cowan were the soldiers from Highland county, Ohio.

From the Ohio history of the "First regiment, Ohio Vol. cavalry, in the Civil war", we cut what we consider of first interest to the descendents of Cary A. Doggett. "Company H was from Highland County. It being the first organization of its class raised in the state. There was great anxiety manifested to join its ranks. This fact enabled the recruiting officers to discriminate largely in the selection of men. It may well be doubted whether more applicants were ever rejected from a similar organization in the service, or if a nobler band of men in physical development could possibly have been selected from the Yeomanry of the great state of Ohio. All the companies of the regiment except A and C (which were sent to West Virginia and did not join the regiment until January, 1865), were sent to Louisville, Ky., December 9, 1861. This was the nucleus of that host of cavalry which under the leadership of Generals Stanley, Crook, Mitchell, McCook, Kilpatrick, Garrard, Long, Minty, and Wilson achieved such triumphs for the country and fame for themselves. . . . The story of the cavalry of the southwest is a record of heroic achievement unsurpassed in the



annals of that history. . . . . It took the advance in the column moving towards Columbia and were with Gen. Thomas' division at Pittsburg Landing. It participated in the advance on Corinth. (The compiler of this history has the letters her father wrote from there.) . . . . . Company H was in service until after the fall of Atlanta. . . . . They were mustered out and paid off at Columbus, Ohio, on the twenty-eighth of September, 1865. Company H was organized in Hillsboro by Captain Martin Buck; Cary A. Doggett, first lieutenant; Robert R. Waddell, second lieutenant. On June 20, 1862, Cary A. Doggett resigned on account of typhoid fever and a light attack of smallpox at the same time. David A. Roush was made first lieutenant in his place. Cary A. Doggett was subsequently appointed a special deputy provost marshal of the sixth district of Ohio and discharged April 3, 1865. The later fact we obtained from the pension department at Washington. In this capacity his service was the same as on the battlefield. (His life long friend, Major Joseph Marley who later for many years was in the land commissioner's office in the capitol building at Lincoln, Nebraska, was the provost marshal)." He was baggage master on the B. & O. R. R. after that until 1872, when he moved on a farm. Later he took



land in Weld County, Colorado, and founded the town of Hyde. He died in 1887, and is buried in Hyde.

## GEORGE, SR.

George Washington Doggett, the fifth son of Armstead and Mary Doggett, served his country as second lieutenant in the Sixth and Eleventh regiments of Ohio cavalry, and the First independent battalion, Ohio volunteer cavalry. His captain was Peter W. Vanwinkle. His colonel William R. Lloyd, and the lieutenant colonel William O. Collins. They were with the western army, and for a time were stationed at Fort Kearney, Nebraska. At home he was a farmer and stockman, especially in the raising of fine horses.

He died in Ohio, June 8, 1883. Later his family moved to Gibbon, Nebraska (1885). His widow and oldest son Henry, who has been marshal of the town for seven years, live together.

The Hillsboro, Ohio, Gazette of June 26, 1908, published a story of the forties, when Walker Doggett was foreman in the office. After closing the story the writer (whom we do not know) asked permission to briefly mention a few of the men of those early days, in these words: "For instance, Cary, John and George Doggett, men cast in heroic mold, tall, straight, with faces like an open book, absolutely fearless, with arms of steel, bodies of hickory and whalebone. In all my life I have never known their superiors in those traits that make men great. \* \* \* \* \* Like the Doggett boys he was a dead shot and a magnificent horseman."
