GEORGE THE FIFTH, by the Grace of God of the United Kingdom of Great Britain and Ireland and of the British Dominions beyond the Seas King, Defender of the Faith, Emperor of India, Sovereign and Chief of the Most Distinguished Order of Saint Michael and Saint George ; To all to whom these presents shall come, Greeting.

WHEREAS by Letters Patent under the Great Seal of the United Kingdom of Great Britain and Ireland, bearing date at Westminster the Twenty-seventh day of April, 1818, His Majesty King George the Third did Create and Constitute an Order of Knighthood to be called by the name of "THE DISTINGUISHED ORDER OF SAINT MICHAEL AND SAINT GEORGE," and did by the said Letters Patent Ordain and Declare that the said Order should be governed by Statutes and Ordinances to be from time to time Made, Ordained, Altered, and Abrogated by His Majesty, His Heirs and Successors, Sovereigns of

the said Order, at His and Their Will and Pleasure ;
 And whereas His said Majesty by His Statutes
 issued thereunder on the Twelfth day of August
 in the same year did make provision for the said
 Order under the Name, Style, and Title of "THE
 MOST DISTINGUISHED ORDER OF SAINT MICHAEL AND
 SAINT GEORGE :"

And whereas by further Letters Patent issued
 under the Great Seal of Our United Kingdom
 of Great Britain and Ireland, bearing date at
 Westminster the Thirty-first day of December, 1850.
 Our Royal Grandmother, Her late Majesty Queen
 Victoria did Ordain, Direct, and Appoint that the
 Order of Knighthood so instituted by Her Royal
 Grandfather and Predecessor King George the
 Third should thenceforth be known and described
 by the Style and Designation of "THE MOST
 DISTINGUISHED ORDER OF SAINT MICHAEL AND SAINT
 GEORGE," and that the said MOST DISTINGUISHED
 ORDER should be constituted in the manner therein
 set forth :

And whereas in pursuance and in exercise of
 the power vested in Him as Sovereign of the MOST
 DISTINGUISHED ORDER OF SAINT MICHAEL AND
 SAINT GEORGE, Our Royal Father, His late Majesty
 King Edward the Seventh, did Make, Ordain, and
 Establish certain Statutes bearing date the Twenty-
 sixth day of May, 1909, in the Ninth Year of His
 Reign, for the Government of the said MOST
 DISTINGUISHED ORDER, wherein power was reserved
 to Us, Our Heirs and Successors, of Altering or

Abrogating the same, or of Adding thereto, and Explaining any particular therein, by a notification thereof, Sealed with the Seal of the said Most DISTINGUISHED ORDER, which Alterations and Explanations were to be taken as part and parcel of the said Statutes :

And Whereas by a certain Additional Statute bearing date the Thirtieth day of December, 1910, in the First Year of Our Reign, We did prescribe the pattern and size of the Insignia to be worn by the Grand Master, Officers, and Members of the several classes of the said Order and did alter the manner in which the Officers of the Order wear their Badges :

Recites Additional Statute of 30th December, 1910.

And whereas We are minded to increase the number of Ordinary Members of the Third Class or Companions of the said Order and to Make certain Amendments in the aforesaid Statutes :

Now, THEREFORE, in pursuance and in exercise of the power so vested in Us by the aforesaid Letters Patent and Statutes, and in order to enable Us to carry this Our Will and Pleasure into effect, We do hereby Abrogate the aforesaid Statutes of the Twenty-sixth day of May, 1909, so far as they are repugnant to or inconsistent with the following Statutes, and the same are Abrogated accordingly, but without prejudice to anything done thereunder ; and in lieu thereof, We, by these Presents Sealed with the Seal of the said Order, do Make, Ordain, and Establish the following Statutes and Ordinances :

Abrogates the Statutes of 26th May, 1909.

Style and
Designation.

I. It is Ordained that this Order of Knighthood shall as heretofore be Styled and Designated in all Acts, Proceedings, and Pleadings, as "THE MOST DISTINGUISHED ORDER OF SAINT MICHAEL AND SAINT GEORGE," as Ordained in the aforesaid Letters Patent bearing date the Thirty-first day of December, 1850, and by no other Style or Designation.

Order to consist of
Sovereign, Grand
Master, and Three
Classes of Mem-
bers.

II. It is Ordained that the said MOST DISTINGUISHED ORDER shall consist of the SOVEREIGN, GRAND MASTER, and Three several Classes of Members, namely, KNIGHTS GRAND CROSS, KNIGHTS COMMANDERS, and COMPANIONS, as in the aforesaid Letters Patent is provided.

Sovereigns and
Chiefs.

III. It is Ordained that We, Our Heirs, and Successors, Kings and Queens Regnant of Our United Kingdom, are and for ever shall be Sovereigns and Chiefs of this MOST DISTINGUISHED ORDER, to whom doth and shall belong all power of Annulling, Interpreting, Explaining, or Augmenting these Statutes and every part thereof.

The Grand Master
and First or
Principal Knight
Grand Cross.

IV. It is Ordained that a Prince of the Blood-Royal, being a descendant of the body of His late Majesty King George the First, or such other Exalted Personage as We, Our Heirs and

Successors, may hereafter appoint, shall hold and enjoy the dignified Office of Grand Master of this MOST DISTINGUISHED ORDER and shall be the First or Principal Knight Grand Cross of the same. And it is Ordained that it shall be his especial Duty to enforce the due observance of the Statutes and Ordinances of this MOST DISTINGUISHED ORDER.

Duty of Grand Master.

V. It is Ordained that the Three Classes of Members of this MOST DISTINGUISHED ORDER shall be Styled and Designated respectively.

Designation of the Three Classes.

KNIGHTS GRAND CROSS,

KNIGHTS COMMANDERS, and

COMPANIONS.

VI. It is Ordained that the Ordinary Members of the First Class, or Knights Grand Cross, of the MOST DISTINGUISHED ORDER OF SAINT MICHAEL AND SAINT GEORGE shall be One Hundred in number.

Ordinary Members of the First Class to be 100 in number.

VII. It is Ordained that the Ordinary Members of the Second Class, or Knights Commanders, of the said Order shall be Three Hundred in number.

Ordinary Members of the Second Class to be 300 in number.

VIII. It is Ordained that the Ordinary Members of the Third Class, or Companions, of the said Order shall be Seven Hundred and Twenty-five in number.

Ordinary Members of the Third Class to be 725 in number.

Royal Princes may
be appointed Extra
Knights Grand
Cross.

IX. It is Ordained that it shall be competent for Us, Our Heirs and Successors, to appoint at Our Pleasure any Princes of the Blood-Royal, being descendants of the body of His Majesty King George the First, to be Extra Knights Grand Cross, and such Members of the Royal Family as have already been appointed Extra Knights Grand Cross shall continue to be and are hereby declared to be Extra Knights Grand Cross of the said MOST DISTINGUISHED ORDER.

Honorary Mem-
bers.

X. It is Ordained that the Honorary Members of the said MOST DISTINGUISHED ORDER shall consist of Foreign Princes and Persons upon whom We, or Our Royal Grandmother or Our Royal Father and Predecessor, have conferred, or We, Our Heirs and Successors, may think fit to confer, the Honour of being admitted into the said MOST DISTINGUISHED ORDER, and every such Honorary Member shall be additional and not included within the numbers of Ordinary Members prescribed for the several Classes.

Qualifications of
Ordinary Members:

XI. It is Ordained that the Persons to be admitted as Ordinary Members of this MOST DISTINGUISHED ORDER shall be such Subjects of Our Crown, whether natural born or naturalized, in the United Kingdom of Great Britain and Ireland or in any portion of Our Dominions beyond the Seas, or in the countries under Our Protection, as may have held or shall hereafter hold High and Confidential

Offices, or may have rendered or shall hereafter render Extraordinary and Important Services to Us and to Our Empire within or in relation to any part of Our said Dominions or the countries under Our Protection, or who may become eminently Distinguished therein by their Talents, Merits, Virtues, Loyalty, or Services, and such others of Our said Subjects as by important and loyal Services in relation to the Foreign Affairs of Our Empire have merited or may hereafter merit Our Royal Favour; or any persons who now are or hereafter may be appointed Officers of this MOST DISTINGUISHED ORDER.

Services in Oversea Dominions, &c.
Foreign Services.
Officers.

XII. It is Ordained that of the said Ordinary Members, Seventy Knights Grand Cross, and Two Hundred and Ten Knights Commanders, and Five Hundred and Eight Companions, shall be persons who have rendered Services, or have become Distinguished within or in relation to any part or parts of Our Dominions beyond the Seas or countries under Our Protection; and Thirty Knights Grand Cross, and Ninety Knights Commanders, and Two Hundred and Seventeen Companions shall be persons who have rendered Services in relation to the Foreign Affairs of Our Empire.

Number of Members of each class to be appointed for Services in Oversea Dominions, &c., and for Foreign Services.

XIII. It is Ordained that the persons who have been admitted or whom We may hereafter think fit to admit into the First, Second, or Third

Additional Members.

Classes of the said Order in recognition of their meritorious services to Us and to Our Empire in connexion with Military Operations are and shall be Additional Members of those Classes, and shall not now or hereafter be included within the number of the Ordinary Members allotted to such Classes, and that any vacancy, from whatever cause arising, among such Additional Members so appointed shall not be filled up

Status of Additional Members.

XIV. It is also Ordained that the Additional Members so appointed shall have Rank and Place among the Ordinary Members of their respective Classes according to the dates of their respective Appointments, and that the Statutes of the said Order shall in all matters and things apply in the same manner to the said Additional Members as to the Ordinary Members of the said Order.

Precedence of Knights Grand Cross.

XV. It is Ordained that in all solemn Ceremonials and in all other Places and Assemblies whatsoever the Knights Grand Cross of this MOST DISTINGUISHED ORDER shall have Place and Precedence next to and immediately after the Knights Grand Commanders of Our MOST EXALTED ORDER OF THE STAR OF INDIA; that the Knights Commanders of this Order shall have Place and Precedence next to and immediately after the Knights Commanders of Our said MOST EXALTED ORDER OF THE STAR OF INDIA; and that the Companions of this MOST DISTINGUISHED

Precedence of Knights Commanders.

Precedence of Companions.

ORDER shall have Place and Precedence next to and immediately after the Companions of Our said MOST EXALTED ORDER OF THE STAR OF INDIA.

And it is further Ordained that the Extra Knights Grand Cross of this MOST DISTINGUISHED ORDER shall rank among each other according to the Order of their Precedence, next after the Grand Master of this MOST DISTINGUISHED ORDER, and that the Ordinary and Honorary Members of the Order shall rank in their respective Classes according to the dates of their respective appointments.

Precedence of Extra Knights Grand Cross.

Precedence of Honorary Members.

XVI. Touching the Habits and Decorations of this MOST DISTINGUISHED ORDER, it is Ordained that Our Habits and Robes as Sovereign of the said MOST DISTINGUISHED ORDER shall be of the same materials and fashion as are hereinafter appointed for the Knights Grand Cross, save only with those alterations which may befit and distinguish Our Royal Dignity; and it is further Ordained that the Grand Master, or such other Person as may be appointed by Us, Our Heirs and Successors, to officiate for Us at Investitures or other solemn Ceremonials of the Order, shall, if he is a Knight Grand Cross of this MOST DISTINGUISHED ORDER, wear at such Investitures or other solemn Ceremonials similar Robes and Insignia to those which We Ourselves should wear if We were personally present thereat.

XVII. The Badge of the Grand Master of this MOST DISTINGUISHED ORDER shall be a Gold Cross of fourteen points forming seven arms, enamelled White, edged with Gold, having on one side thereof, in the Centre within a Circle, Azure, whereon is inscribed the motto "AUSPICUM MELIORIS ÆVI," in letters of Gold, a Representation of the Archangel Saint Michael, holding in his dexter hand a Flaming Sword, and trampling upon Satan, and on the reverse within the said Circle and Motto, a Representation of Saint George on Horseback, and in Armour, with a Spear encountering a Dragon; between the arms seven Carved Gold Monograms "M.G." with Gold Crowns above; the whole surmounted by a Chased Gold Tudor Crown. The Badge shall be suspended from the Collar or Riband of the Order, around the neck.

Mantles.

XVIII. The KNIGHTS GRAND CROSS shall upon all great and solemn occasions appointed by the Sovereign wear mantles of Saxon Blue Satin, lined with Scarlet Silk and tied with a Cordon of Blue and Scarlet Silk and Gold, having two Tassels of the same colours attached. On the left side of the Mantles there shall be embroidered a Representation of the Star of a Knight Grand Cross of the said MOST DISTINGUISHED ORDER, which shall be composed of Seven Rays of Silver, between each of which shall issue a small ray of Gold, over all, the Cross of

Star.

Saint George, Gules ; and in the centre of the said Star within a Circle, Azure, whereon is inscribed in letters of Gold the motto "AUSPICIUM MELIORIS Motto on the Star. ÆVI," a Representation of the Archangel Saint Michael, holding in his dexter hand a Flaming Sword, and trampling upon Satan. And We do further Command that on all other occasions whatsoever the Knights Grand Cross shall wear the Star of the said MOST DISTINGUISHED ORDER upon the left side of their coats or outer Garments ; and that they shall also wear on all days usually termed "Collar Days," a Collar composed Collar. alternately of Lions of England royally crowned, of Maltese Crosses, and of the Cyphers S.M. and S.G. ; having in the centre of the said Collar Our Imperial Crown over two Winged Lions, passant guardant, each holding in his fore paw a Book and Seven Arrows ; and at the opposite end there shall be two similar Lions ; all of which shall be of Gold, excepting the Crosses, which are to be enamelled White, the whole linked together by small Gold Chains. To the said Collar shall hang the Badge of the said MOST DISTINGUISHED ORDER, Badge. which shall be a Cross of fourteen points, enamelled, Argent, edged, Gold, having on one side thereof in the Centre within a Circle, Azure, whereon is inscribed in letters of Gold the motto "AUSPICIUM Motto on the Badge. MELIORIS ÆVI," a Representation of the Archangel Saint Michael, holding in his dexter hand a Flaming Sword, and trampling upon Satan, and on the reverse, within the said Circle and Motto, a

Representation of Saint George on Horseback and in Armour, with a Spear encountering a Dragon, which Badge shall be ensigned by Our Imperial Crown, Gold. On all other occasions the said Knights Grand Cross shall wear the said Badge suspended to a richly-watered Saxon Blue Riband, of the width of Four Inches, with a Scarlet Stripe, passing from the right shoulder to the left side. And for the Greater Honour and Dignity of the Knights Grand Cross, it is hereby declared that it shall and may be lawful for them upon all occasions to bear and use Supporters to their Arms; and We do by these Presents Direct and Command Our Garter Principal King of Arms for the time being to grant Supporters to all Knights Grand Cross of the said MOST DISTINGUISHED ORDER. The said Knights Grand Cross shall also surround their Armorial Ensigns with the Collar, Circle, and Motto hereinbefore described, and suspend thereto a Representation of their Badge.

XIX. The KNIGHTS COMMANDERS shall wear around their necks a Riband of the same colours as the Riband of the Knights Grand Cross, of the breadth of Two Inches and pendent therefrom the Badge of the Order, which shall be of the same form and appearance as the Badge appointed for the Knights Grand Cross, but one size smaller. They shall also wear on the left side of their Coats or outer Garments, a Star composed of four

Rays, thereon a small Cross of eight points in Saltire, Argent, surmounted by the Cross of Saint George, Gules, and in the centre, Argent, within a Circle, Azure, whereon is inscribed in letters of Gold the Motto "AUSPICIUM MELIORIS ÆVI," a Motto on the Star.
 Representation of the Archangel Saint Michael, holding in his dexter hand a Flaming Sword, and trampling upon Satan. They shall surround their Armorial Ensigns with the Circle and Motto Armorial Ensigns.
 aforesaid, and suspend thereto a Representation of their Badge.

XX. The COMPANIONS shall wear the Badge or Companions.
 Small Cross of the said MOST DISTINGUISHED ORDER, which shall be of the same form and appearance as the Badge appointed for the Knights Com- Badge and Riband.
 manders, but smaller, pendent to a Riband of the said MOST DISTINGUISHED ORDER, of the breadth of One Inch and a half, the said Riband being attached by a buckle to the left breast of their Coats or outer Garments. They shall suspend a Representation of their Riband and Badge from the lower part of the Escutcheon of their Armorial Armorial Ensigns.
 Ensigns.

XXI. In the event of any Member of the said Return of Insignia
 MOST DISTINGUISHED ORDER resigning, or being on resignation,
 degraded from his dignity as a Member of the degradation, or
 same, or of any Officer resigning or being degraded promotion.

from his Office, he shall forthwith return his Insignia or Badge ; and on the promotion of a Member of the said MOST DISTINGUISHED ORDER to a higher class therein, he shall likewise immediately return the Insignia previously worn by him to the Secretary of the said MOST DISTINGUISHED ORDER.

Insignia of Promoted Members to be returned.

XXII. On the promotion in the said MOST DISTINGUISHED ORDER of any Member thereof, the Secretary of the said MOST DISTINGUISHED ORDER shall take the necessary measures for obtaining possession of the Insignia theretofore worn by such Member ; and as soon as he shall receive the same he shall forthwith deposit such Insignia with the Chamberlain of Our Household. On the promotion in the Order of any Member thereof who may be in any place within Our Dominions beyond the Seas, or in any country under Our Protection, the Officer administering the Government thereof shall immediately obtain possession of the Insignia theretofore worn by such Member, and transmit the same to the Secretary.

Ceremony of Investiture.

XXIII. It is ordained that on the day of the Investiture of a Knight Grand Cross or Knight Commander, the Sovereign, wearing the Robes and Insignia of the said MOST DISTINGUISHED ORDER, shall be attended by such Knights Grand Cross and by such Officers of the said MOST DISTINGUISHED

ORDER as can conveniently be assembled, habited in their Mantles and wearing their Insignia. The Person to be Invested shall then be introduced into the Presence of the Sovereign, between the two Junior Knights Grand Cross in attendance, preceded by the King of Arms, bearing the proper Ensigns upon a Velvet Cushion, when the Sovereign shall proceed to confer the Honour of Knighthood upon the person so nominated a Knight Grand Cross or Knight Commander of the said MOST DISTINGUISHED ORDER, if he have not previously received the said Honour, and shall then Invest him with the Ensigns of the said MOST DISTINGUISHED ORDER in the following manner :

Knighthood of

The Sovereign will invest the new Knight Grand Cross or Knight Commander with the Riband and Badge, and will deliver to him the Star of the said MOST DISTINGUISHED ORDER ; and the Prelate or in his absence another Officer of the said MOST DISTINGUISHED ORDER shall pronounce the following Admonition :

“ Receive the Ensigns of a Knight Grand
 “ Cross [or Knight Commander] of the Most
 “ DISTINGUISHED ORDER OF SAINT MICHAEL
 “ AND SAINT GEORGE. They shall serve as
 “ Evidence of your great Merit, Virtue, and

 “ Honour of God, to the Service of His Majesty

 “ Britain and Ireland and of the British
 “ Dominions beyond the Seas, and for the
 “ Defence thereof.”

An Officer of the said MOST DISTINGUISHED ORDER shall then present the new Knight Grand Cross or Knight Commander with a copy of the Statutes of the said MOST DISTINGUISHED ORDER, on his receiving which the Ceremony of his Investiture will be complete.

Warrants for

 conferring
 Knighthood.

XXIV. It is further Ordained that it shall be competent for Us, Our Heirs and Successors, by a Warrant or Warrants under Our or Their Sign Manual, countersigned by one of Our or Their Principal Secretaries of State, and sealed with the Seal of this MOST DISTINGUISHED ORDER, in any case to authorize some Distinguished Officer in Our or Their Service, or other Person, to perform in Our or Their Name and on Our or Their Behalf, the Ceremony of Investing Knights Grand Cross or Knights Commanders with the Insignia of their respective Dignities, and further to confer upon them in Our or Their name and on Our or Their behalf the honour of Knight Bachelor of these

Realms. Provided always that the Officer or Person so appointed to perform the Ceremony shall have been empowered by Letters Patent to confer that honour. It shall also be competent for Us, Our Heirs and Successors, to permit the Ceremony of Investiture to be dispensed with. And We Reserve to Ourselves, Our Heirs and Successors, by Our or Their Warrant or Warrants made as aforesaid, to Permit and Authorize the Person or Persons not invested by Us, Our Heirs and Successors, or on Our or Their Behalf, to wear the Insignia and enjoy the Privileges appertaining to their respective Dignities, including the use and enjoyment of the distinctive Appellation of a Knight Bachelor of these Realms, in as full and ample a manner as if they had been invested by Us, Our Heirs and Successors, or on Our or Their Behalf. But it is expressly Ordained that nothing herein contained shall be construed or interpreted to authorize any Knights Grand Cross or Knights Commanders of this MOST DISTINGUISHED ORDER who shall not have been invested by Us, Our Heirs and Successors, or on Our or Their Behalf, with the Insignia of their respective Dignities to assume the distinctive Appellation of a Knight Bachelor of these Realms without having been duly authorized in manner aforesaid to use such Appellation.

XXV. And it is Ordained that the Seal of Seal. this MOST DISTINGUISHED ORDER, as appointed by His Majesty King George the Third, and

having thereon Two Escutcheons, that on the Dexter Side bearing a Representation of Saint Michael trampling upon Satan, and that on the Sinister Side bearing a Representation of Saint George on Horseback and in Armour, with a Spear encountering a Dragon, and over the said Escutcheons, the Motto "AUSPICIUM MELIORIS ÆVI," the whole within this circumscription, "SIGILLUM ORDINIS SANCTI MICHAELIS ET SANCTI GEORGII," shall continue to be the Seal of this MOST DISTINGUISHED ORDER, and that the Statutes of the said MOST DISTINGUISHED ORDER shall be sealed by and with the said Seal.

Members may be Degraded for Treason, &c.

XXVI. It is Ordained that if any Knight Grand Cross, Knight Commander, or Companion of this MOST DISTINGUISHED ORDER be convicted of Treason, Cowardice, Felony, or of any Grave Misdemeanour derogatory to his Honour, as a Knight and a Gentleman, or if he be accused of any such Offence and does not, after a reasonable time, either surrender himself to be tried for the same or justify or excuse himself to the satisfaction of the Sovereign, he shall forthwith be Degraded from the said MOST DISTINGUISHED ORDER, by an Ordinance Signed by the Sovereign and Sealed with the Seal of the said MOST DISTINGUISHED ORDER, and thereupon his Name in the Register shall be erased. And it is hereby Declared that the Sovereign shall be the sole Judge of the

Conduct or Behaviour which may require the Expulsion of the offending Member from the said MOST DISTINGUISHED ORDER; and that it shall at all times be competent for the Sovereign to restore to the Order any Person who may have been Degraded, if circumstances render it just and expedient so to do.

And restored to the Order.

XXVII. It is Ordained that the following Officers shall be appointed to this MOST DISTINGUISHED ORDER; that is to say, a PRELATE, a CHANCELLOR, a SECRETARY, a KING OF ARMS, a REGISTRAR, and a GENTLEMAN USHER OF THE BLUE ROD, which Officers shall rank among each other in the above order.

Officers.

XXVIII. The PRELATE shall be appointed by Us, Our Heirs and Successors. 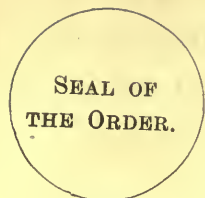

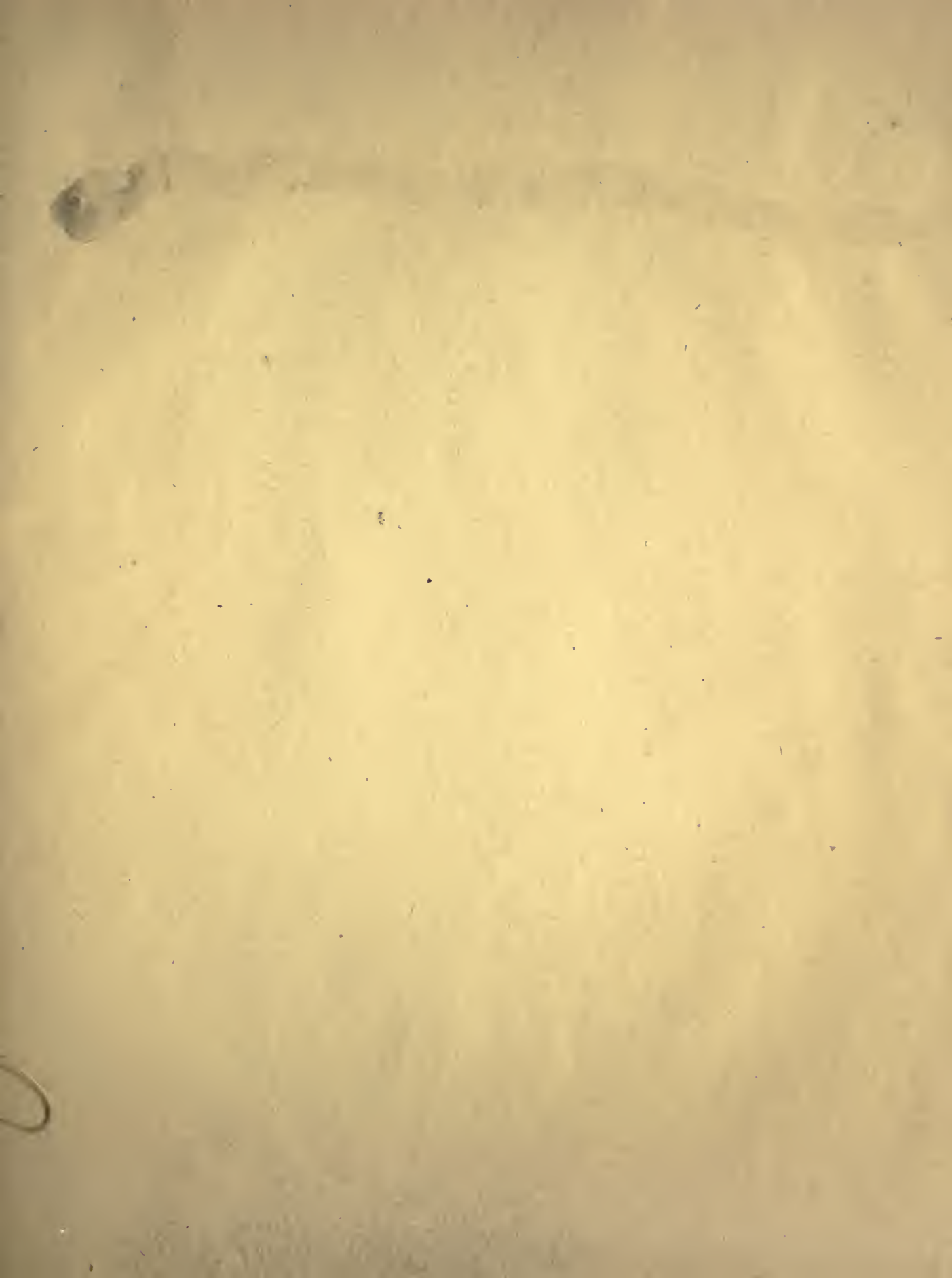
