INNER TEMPLE.

THE earliest admissions at this Temple are those in 1571, contained in the original book, from which the first 46 pages are missing.

At this period, Students certified to have been in Commons two years, and during that time to have kept the exercises of the house, paid all dues, and been of good behaviour, by the Principal and Reader for the time being of any Inn of Chancery, were admitted on payment of 20s. only. A general admittance fee was £3 6s. 8d. A special admittance fee was £6 13s. 4d., unless upon favour; then less, as the Parliament might determine. Sons of Benchers and nominees of Readers were admitted without payment of any fees, and were excused from Commons and Vacation Lectures. During this part of the 16th century but few Students were called to the degree of Barrister for professional advantages.

Francis Gawdy, Esq., Treasurer.

Half-brother of Sir Thomas Gawdy. Called to the Coif, 1577; Queen's Serjeant, 1582; Judge of Queen's Bench, 1588; Chief Justice of Common Pleas, 1605.
Died, 1606.

RICHARD BRERETON, Eccleston, Cheshire.

Born, 1549. Died, 1613. Married Maud, daughter of Peter Hurlston, Esq., of Picton, by whom he had a son and heir, John, et. 40, in 1613.

JOHN WASHBOURNE, of Wichenford, Worcestershire.

Born 1548; son of Anthony Washbourne, Esq., of this place. He died 1632, having been in the Commission of the Peace for Worcestershire 60 years, and twice Sheriff of that County. It is recorded of him "that he was the best continual housekeeper and the best beloved gentleman in the County." Nash ii. 460.

RICHARD JOHNSON, London.

WILLIAM CAMDEN, Yoxall, Staffordshire.

Author of The Britannia. Born at Lichfield, 1551; died November 9th, 1623. BRIAN CROWTHER, Bedston, Salop.

Eldest son of Thomas Crowther. A Member of the Bar in the Courts of the Marches at Ludlow, and in South Wales.

WILLIAM BAKER, Modbury, Devon.

JOHN WAKEMAN, Beckford, Gloucester.

Eldest son of Riehard Wakeman, Esq., and nephew of the first Protestant Bishop of Gloucester. He died in 1625, at Beckford, where he practised as a Chamber Counsel.

THOMAS LEIGHTON, Wattlesborough, Salop.

Eldest son of Sir Edward Leighton, M.P., one of Queen Elizabeth's Privy Council. Married Elizabeth, daughter of Sir William Gerard, Lord Chancellor of Ireland. He was M.P. for Salop, 39 Eliz.; Captain of the Trained Bands of that County, and died A.D., 1601. This family, originally of Leighton, obtained Wattlesborough by a marriage with one of the co-heiresses of John Burgh, temp. Edward IV., and Sir Baldwin Leighton, Bart., is his lineal descendant and the owner of Wattlesborough.

EDWARD SUTTON, Byshton (in Colwich), Stafford.

WILLIAM GRIFFITHS, London.

JOHN KNIGHTON, Beyford Bury, Herts.

Buried 7th May, 1585; left a son and heir, Sir George Knighton, seated here, who died 1613.

Godfrey Ffoljambe, Barlborough, Derby. Son of Henry Ffoljambe, of that place.

ROBERT BELL, Leighton (Bromswold), Hunts.

EDWARD CARR, Sleaford, Lincoln. Created a baronet, 1611. Died 1616. GILES RISDON, Parkham, Devon.

Born February, 1551. Son of Giles Risdon, whose family were settled at Parkham from the reign of Edward I. until 1760. Sir S. Northcote is the representative of their heiress.

JOHN HARE, London.

Born 1546. Son of John Hare, Citizen of London. Called to the Bench, January, 1591; Treasurer, 1605. M.P. for Horsham, 1587. Buried at Totteridge, 1613. His eldest son was created Lord Coleraine, in the Peerage of Ireland, 1625. (His widow married the Earl of Manchester).

ROBERT CRANMER, Aslewton, Notts.

JOHN GRIFFITHS, London.

WILLIAM PARRY, London.

JOSEPH HOLLAND, Apsham, Devon.

A younger branch of the family of Holland, descended from the Dukes of Exeter of that name, was seated at Apsham, *Hodië*, Topsham, until the latter part of the 17th century.

HENRY GAWDY, Claxton, Norfolk.

Eldest son of Sir Thomas Gawdy, Justice of Queen's Bench, 1574-88. Sheriff of Norfolk, 1592 and 1608; M.P. for that county, 1597-1603; created K.B. at the coronation of James. Married Elizabeth, daughter of Robert Warner, of Milden Hall, by whom he had a son and heir, Sir Robert. He died 1620, et. 73.

THOMAS GAWDY, Claxton, Norfolk.

A younger son of Sir Thomas Gawdy.

THOMAS EYRE, Hassop, Derby.

Ancestor of Francis Eyre, 5th Earl of Newburgh.

THOMAS FOSTER, Hunsdon, Herts.

Called to the Bench 1594; Reader, 1596; S. L., Easter, 1603; Justice of Common Pleas, November, 1607. "A grave and reverend Judge, and of great judgment, constancy, and integrity." (*Croke's Rep.*) Buried at Hunsdon, May, 1612.

THOMAS GAWDY, Harlestone, Norfolk.

Son of Thomas Gawdy, of Harlestone, who died 1556. Great losses by law suits obliged him to sell his estate in 1582 to Mr. Justice Gawdy, and to engage in commercial pursuits.

JOHN WILLIAMS, London.

JOHN CARPENTER, Canterbury.

November, 1572.

Richard Lone, Esq., Treasurer.

GILBERT TICHBORNE, Tichborne, Hants.

Second son of Nicholas Tichborne, Sheriff of Hants, 1 Edward VI. The eldest brother of this student was created a Baronet, 1620.

NICHOLAS ROSCARRACK, Roscarrack (in Endellion), Cornwall.

In 1581 committed as "a Popish recusant" to the Tower. In 1586 the Lieutenant-Governor (Sir Owen Hopton) petitioned for his release "upon his bond to be at all times forthcoming when called for, and that he had been five years a prisoner, and in debt to the Lieutenant-Governor to £140."

RICHARD PULESTON, Alington, Denbigh.

Was father of John Puleston, of Emrall, one of the Justices of the Common Pleas during the Commonwealth.

MATHEW DOWDALL, Drogheda.

WILLIAM VENNER, Crewkerne, Somerset.

EDWARD BULSTRODE, Upton, Bucks.

Son of Thomas Bulstrode, Esq., of this place, born 1550; died 1598. Sheriff of Bucks, 1584. Married Cicely, daughter of Sir John Croke.

NATHANIEL PARTRIDGE, London.

MILES EYRE, Batheaston, Somerset.

THOMAS RIVET, Cretingham, Suffolk. Son and heir of James Rivet, a Bencher.

THOMAS SMYTH, Hough, Cheshire.

A son of Sir Thomas Smyth, of that place. Died, s. p.

LEDIGAR VALENTINE, Ipswich, Suffolk.

ROBERT LANGTON, Lowe, Lancashire.

WILLIAM COPWOOD, Totteridge, Herts.

THOMAS COCKAYNE, Ashbourne, Derby.

Son of Sir Thomas Cockayne. This ancient family was seated in Ashbourne from the reign of Henry III.

GEORGE NEDHAM, Wymondley, Herts.

Son of John Nedham, Esq., of Wymondley Priory; born 1557; died 1626. He married Margaret, daughter of Edmund Style, and left a son John, seated at Welwyn.

WILLIAM GRADBAGE, Tybenham, Norfolk.

THOMAS FITZWILLIAM, Derry, Northamptonshire.

WILLIAM TOWSE, Hengeham, Norfolk.
M.P. for Bramber, 1586. Called to the Bench, 1594.

THOMAS NORRIS, Congham, Norfolk.

THOMAS STOWELL, Cothelston, Somerset.

REGINALD CARTER, Brill, Bucks.

THOMAS GAWEN, Wells, Somerset.

EDWARD COKE, Mileham, Norfolk.

The famous Chief Justice of England, who was born February, A.D. 1551-2. Eldest son of Robert Coke, Esq., of Boughrood Manor, in the parish of Mileham, and a Barrister of Lincoln's Inn. Chosen Recorder of Coventry, 1584. Called to the Bench, 1589.

LANCELOT STOUGHTON, Stoke, Surrey.

Born 12th November, 1554; son of Thomas Stoughton, the descendant of a family which had been seated at Stoke, from the reign of Stephen. M.P. for Guildford in 27, 28 and 35 Elizabeth. Knighted 1611. Died December, 1615, leaving a large family.

BENJAMIN ISAAC, Nympton Bishop, Devon.

ARTHUR CORRY, Stratton, Dorset.
Practised in Ireland; made a Serjeant in 1594.

George Fortescue, Filleigh, (in North Tawton,)
Devon.

EDWARD SMYTH, Hough, Cheshire.

A younger son of Sir Thomas Smyth. Died unmarried.

RICHARD POWER, Curraghmore, Waterford.

JAMES GRIFFITHS, London.

MORGAN CLIVE, Llanidloes, Montgomery.

WALTER HELE, Neston, Devon.

He purchased the Estate of "Gnaton," in Newton Ferrers, temp. Elizabeth, and his descendants enjoyed it until the last century.

Richard Lone, Esq., re-elected Treasurer.

STEPHEN THEOBALD, Seale, Kent.

Son of John Theobald, whose father, Richard Theobald, Secondary of the Queen's Remembrancer in the Exchequer, purchased the manor. Died 8th July, 1619, leaving two daughters, his co-beiresses.

RICHARD BRERETON, Tatton, Chester.

Son and heir of Geoffrey Brereton, Esq. He married 1572, Dorothy, daughter of Sir Richard Egerton, of Kidley, and died s. p. 1598. He bequeathed his Estates to Lord Chancellor Ellesmere.

THOMAS BYSSHOP, Henfield, near Steyning, Sussex.

Ryse Kemys, Kevanmabley, Glamorgan.

Third son of David Kemys, Esq. Died 1609. His son, Nicholas, the Royalist Governor of Chepstow Castle, was created a Baronet, 1642.

Francis Palmes, Lindley, York.

The last male descendant of a family seated here from the 13th century, to whom this student placed a curious monument in Otley Church, tracing their pedigree from that period. WILLIAM BUCKLEY, Derby.

EDWARD COMERFORD, Callan, Kilkenny.

CUTHBERT REYNOLDS, Watford, Herts.

"One who followed his studies, and kept the ordinary exercises for the Bar in the Inne and abroad."—Per Periam Justice. B. 1590.

EDWARD BOWCHER, London.

RICHARD GREY, Segenhoe, Beds.

Segenhoe Manor is in the parish of Ridgmont. In 1450, Reginald Lord Grey was created Lord Grey, of Ridgemont. Lysons states that the family possessed Estates here until 1573.

GEORGE FOREST, Myddleham, York.

CHRISTOPHER SAVILE, Coowould, York.

DAVID OWEN, Malloyd, Merioneth.

JOHN FITZWILLIAM, Milton, Northampton.

Second son of Sir William Fitzwilliam, of Milton, Lord Justice of Ireland. Adopting the military profession he attained the rank of Captain, and died unmarried in Ireland.

ANTHONY HALS, Efford, Devon.

This place was the seat of the Hals family until after the Restoration.

Anthony Bradshawe, Bradshawe, Derby.

Fourth son of William Bradshawe. Settled at Belper and afterwards at Holbrook, in his native County, where he died A.D. 1614, leaving a numerous issue.

BAPTIST HICKES, London.

Son of Robert Hickes, a wealthy mercer, who lived in St. Pancras-lane, Cheapside, and raised a considerable Estate. He had three sons—Michael, a Secretary to Lord Burleigh; Francis, and Baptist who joined his father in business, and by his extensive dealings with the Court for his rich silks and commodities brought from foreign parts, acquired immense wealth; was knighted by James I., and created in 1628 Baron Hickes, of Ilmington, and Viscount Campden with remainder to his son-in-law Edward, Lord Noel. He built Hicks' Hall, in London, and a stately mansion at Chipping Campden, County Gloucester. A tomb of rare excellence, the workmanship of Messrs. Stone, exists in Campden Church to his memory. He died October, 1629, at. 78.

NICHOLAS DOBBYN, Waterford.

EDMUND FETTIPLACE, Childrey, Berks.

Son of Edmund Fettiplace, (whose grandson was created a Baronet, 1661). This family purchased the Estate in the reign of John.

RICHARD RIGBY, Wrightington, Lancaster.

MORICE LEWYS, Festiniog, Merioneth.

WILLIAM LIGHTFOOT, London.

THOMAS DRANER, London.

ROWLAND BROUGHTON, London.

JOHN BRADSHAWE, Lye, Staffordshire.

EDMUND WOODRUFFE, London.

CONON PARSONS, Kemerton, Gloucestershire.

Son of John Parsons, of this parish. Born 1560. Died 1630. Married Elizabeth, daughter of Richard Wakeman, of Beckford. His eldest son, John, born 1586, purchased the rest of the parish *circ*, 1609, and these Estates are now enjoyed by his lineal descendant, Rev. John Hopton *olim* Parsons.

THOMAS BEEKE, White Knights, Berks.

His descendants were seated during many generations at Hartley Court, near Reading.

WILLIAM ANTHONY, Pinhow, Devon.

ROGER DOWNES, Potshingley, Cheshire.

Son and heir of Laurence Downes. He served with the army in Ireland, and died 44 Elizabeth, leaving a son and heir, Laurence.

Hugh Winnington, Northwych, Cheshire.

Eldest son of Robert Winnington. He obtained the Manor of Armitage by devise from Thomas Winnington, of Cranage, in the same county.

CHARLES JOHNSON, London.

ROGER MANWOOD, Sandwich, Kent.

Son of Thomas Manwood, and nephew of Chief Baron Manwood.

WILLIAM FORD, Nethersale, Leicester.

November, 1574.

Thomas Bromley, Esq., Treasurer.

JOHN PARKER, Baldock, Herts.

EDWARD PARRY, Wallingford.

Son of Thomas Parry, Esq., of the College, in this town.

HENRY BOWCHER, Maldon, Essex.

Called to the Bench, May, 1596.

JOHN BROUGHTON, Broughton, Salop.

Brother of Richard Broughton, admitted to this Inn 1568, and appointed in 1590 second Justice of Chester. He had another brother, Hugh Broughton, a very eminent Hebrew scholar, hence called "Rabbi Broughton." He died, s. p., 1586.

WILLIAM FITTON, Gawsworth, Cheshire.

(Grandson of Sir Edward Fitton,) settled at Awne, in Ireland. His grandson was Lord Chancellor of Ireland, 1687, and created by James II. Baron Fitton, Lord Gawsworth.

THOMAS CHURCHAR, Chiddingley, Sussex.

Second son of Thomas Churchar. Practised at Guildford.

THOMAS FYTCH, Great Yeldham, Essex.

EDMUND PRIDEAUX, Holdsworthy, Devon.

Second son of Roger Prideaux. Sheriff of that County. 1608. Called to the Bench, May, 1596. Treasurer, 1609. Created a Baronet, 1622. Died, 1628.

RICHARD MEDLICOTT, Shrewsbury, Salop.

This family were of commercial repute in this town, temp. Elizabeth.

EDMUND FARRAND, London.

GEORGE GAWDY, Claxton, Norfolk. Fourth son of Sir Thomas Gawdy.

EDWARD TURVILLE, Croft, Leicestershire.

GEORGE LYTTELTON, Groveley, Worcestershire.

This Estate was purchased by Sir John Lyttelton, one of the Council of the Marches, and devised by him in 1590 to his nephew, the present Student, who was M.P. for Droitwych, 1586-92. WILLIAM STONEHOUSE, London.

EDWARD LYTTELTON, Munslow, Salop.

Second son of Rev. John Lyttelton, Rector of the parish. Descended from the celebrated Judge. He was knighted; was of the Council of the Marches; and Chief Justice of North Wales, 1621. His eldest son was Lord Keeper, and created Baron Lyttelton, of Mounslowe. His only daughter married her cousin, Sir Thomas Lyttelton, Bart., from which union have descended the Barons Lyttelton, of Frankley, whose title became extinct in 1779, and the present Lord Lyttelton, whose title was created 1794.

WALTER WYNTER, Brecon.

Only son of Andrew Wynter, whose brother, Sir William Wynter, was Lord High Admiral.

WILLIAM WASHBOURNE, Wichenford, Woreester.
Born 1551; second son of Anthony Washbourne, Esq.

WILLIAM MALLORY, Papworth St. Agnes, Hunts.

JOHN WISE, Pentonville, Middlesex.

JOHN MOLFORD, Chulmleigh, Devon.

GEORGE MORE, Loseley, Surrey.

Eldest son of Sir William More, M.P.; born 1553; M.A. of Corpus College, Oxford; Sheriff of Surrey and Sussex, 1597; M.P. for Guildford and Surrey, 1586-1628. He acquired the special favour of Queen Elizabeth, by whom he was knighted, and who augmented his Estate by a grant of Lordship of Godalming. He was Treasurer to Henry, Prince of Wales; Chancellor of the Order of the Garter; and Lieutenant of the Tower. In 1603 he entertained the King and Queen at Losely, and in 1606 the King was again his visitor; in 1617 Charles, Prince of Wales, was his guest. He died 16th October, 1632, leaving four sons and five daughters.

HENRY KNEVET, Radford Semele, Warwickshire.

Son of Richard Knevet. Born 1551. Succeeded to this Estate in 1558 and sold it in 1591.

JOHN FLUDE, London.

JOHN TOYE, London.

SIMON HEYNES, London.

Francis Hamond, Wokingham, Berks.

EDWARD CARLETON, Beeford, York.

November, 1575.

Francis Smyth, Beccles, Suffolk.

STEPHEN PYEND, Leeds, in East Sutton, Kent.

THOMAS TRAFFORD, Bridgetrafford, Cheshire.

Son and heir of William Trafford, Esq.; appointed in 1603 Receiver of Revenues in North Wales and Cheshire for life. Died 1627.

HENRY JACKMAN, London.

HENRY CROKE, Chilton, Bucks.

Second son of Sir John Croke, M.P. for Bucks, 1572. He died unmarried before 1647.

GEORGE CROKE, Chilton, Bucks.

Third son of Sir John Croke. Called to the Bench November, 1597; Justice of the Common Pleas, 1624; of King's Bench, 1628.

EDMUND LUCYE, Broxbourne, Hertford. Knighted. Died 1606.

GEORGE SOUTHCOTT, Shillingford, Devon. Son of John Southcott. Died 1631.

JOHN WYSEMAN, Canfield Hall, near Dunmow.

Son of John Wyseman, Esq. Died 1602. He was succeeded in his Estates by his son Edmund, of whom the following anecdote is related by *Morant*: "He was a soldier, and follower of Robert, Earl of Essex, whose antimely death, occasioned partly by a prevalent faction at Court, and partly by our Edmund's negligence in not delivering in time a letter from Lord Essex to the Queen, so grievously afflicted him, that he solemnly vowed never to go to bed any more. He caused a tree to be cut out in the shape of a bolster and pillow, on which he afterwards slept. He died in 1646."

RICHARD CARR, Glympton, Oxon.

THOMAS BROWNE, London.

ALEXANDER BRETT (Sir), White Stanton, Somerset.

In 1604 several Castles, Manors and Estates, escheated by the attainder of Sir Walter Raleigh, in the Counties of Somerset and Dorset, were granted to Sir A. Brett for the maintenance of Lady Raleigh, her son, and family."—State Papers.

GEORGE BRETT, White Stanton, Somerset.

RICHARD BRADDON, London.

EDWARD MOUNTFORD, Feltwell, Norfolk.

Second son of Osbert Mountford. Knighted 1603. In 1604 he obtained the King's licence to travel for three years.

HENRY BATTE, Birstall, Leeds.

RALPH BULKELEY, Smetonwood, Cheshire.

November, 1575.

RICHARD NICHOLS, London.

WILLIAM CHILDE, Pensax, Worcester.

Son of William Childe, Esq., of Northwick. Sheriff of Worcestershire, 1600.

WALTER CHAMBERLAYNE, Shirburn, Oxon.

HENRY SMITH, London.

FRANCIS THROCMORTON, London.

Eldest son of Sir John Throcmorton, Chief Justice of Chester; executed in 1584 for treasonable attempts against Queen Elizabeth, and in favour of the Queen of Scots.

PHILIP PYNE, Eastdown, Devon.

The family of Pyne were in possession of Estates in this parish in the reign of Edward III.

THOMAS LAWTON, Lawton, Cheshire.

Third son of John Lawton; called to the Bench, 1597.

NICHOLAS BYNGLEY, Honington, Warwickshire.

ANTHONY DYOTT, Lichfield.

Son of John Dyott, a barrister. Called to the Bench, June, 1599; M.P. for Lichfield, 1601, 1603, 1614.

EDWARD MALLORIE, London.

EDWARD STOTT, London.

HENRY MEERE, Sherborne, Dorset.

Collector of the Bailiwicks of Fineshade and Grimscot, in Northamptonshire. Died in 1608. MATHIAS CLAVER, Whaddon, Bucks.
Son of Marmadake Claver, of Foscot. Died 1612.

RICHARD MERIFIELD, Crewkerne, Somerset.

RICHARD LOVES, Ogbury, Devon.

THOMAS STRICKE, Limerick.

EDMUND WYNCHE, London.

HENRY KNYVET, Ashwelthorpe, Norfolk.

Fourth son of Sir Thomas Knyvet; Sheriff of Norfolk,

1579.

John Wynne, Gwyder, Caernarvon. Knighted. Died 1621.

BENJAMIN MARLER, Crayford, Kent.;

JOHN WYOTT, Braunton, Dorset.

WILLIAM LEWIS, Presadneth, Anglesea.

RICHARD OGLE, Pinchbeck, Lincoln.

TRISTRAM FARLEY, York.

JOHN FFERNE, Uttoxeter. Second son of Sir John Fferne, of Temple Belwood.

GEORGE CAPELYN, Southampton.

WILLIAM ASHBY, Lowesby Hall, Leicestershire.

Eldest son of Edward Ashby, Esq. He went to Scotland as Ambassador to James VI., and died in that post, 1589, s. p.

WILLIAM WALTER, Harforde-West-

RICHARD WENMAN (Sir), Witney Park, Oxon.

Son of Sir Richard Wenman, Sheriff of the County, 1563.

His eldest son was created Viscount Wenman, 1628.

JOHN GLASIER, Chester.

James Theobald, Seale, Kent. Younger son of John Theobald, of this place.

THOMAS FOWLER, Otham, Kent.

ROBERT DILLINGTON, Knighton, Hants.

JOHN ROBERTSON, Kelham, Notts.

ROWLAND PARRY, Dulas, Herefordshire.

Son of John Parry. He succeeded to the Estate, and left a son named Stephen, who was in possession when the Civil Wars commenced.

MARTIN TICHBORNE, Westisted, Hants.
Fourth son of Nicholas Tichborne, M.P. for Hants.

THOMAS FELTHAM, Weston, Suffolk.

WILLIAM WROTHE, Islington.

THOMAS WILLIAMS, Stoforde, near Ivybridge, Devon. Second son of Thomas Williams, Esq., M.P. for Exeter, and Speaker of the House of Commons, who died 1566.

Robert Wythe, Esq., Treasurer.

John Lone, Sevenoaks, Kent. Son of Richard Lone, Esq. (a Bencher). 178

- CHARLES MORGAN, Skenfrith, Monmouth. Third son of Philip Morgan, of the Wayn.

 Son of Thomas Hatche. Both members of the Western

 Circuit.

 Son of Godan Foster. Died 1605.

EDWARD FIELD, Battle, Sussex.

JOHN HURLESTON, Picton, Cheshire.

Son of Richard Hurleston. Died November, 1593, leaving a son and heir named John, with whose descendants this Estate continued until 1734.

BENJAMIN JONES, London.

RICHARD HORNYHOLD, Blackmore Park, Worcester. Younger son of John Hornyhold, Esq., who was heavily fined as a Popish recusant.

JOHN WYTCHCOTT, London. B. 1590.

RANULPH BRERETON, Eccleston, in Wettenhall, Cheshire.

Second son of John Brereton. Died cœlebs.

Son and heir of Sir George Bromley, Chief Justice of Chester, who acquired the Estate of Hallon by marriage. The only child and heiress of this Student married William Davenport, and her descendants have since been owners of Hallon, in Worfield.

Francis NewPort, Eaton (Constantine), Salop.

Son of Thomas Monke. Practised as an Attorney in this place.

GEORGE EATON, London. 291

RICHARD LEE, Lee, Chester.

Eldest son of Richard Lee, of Lee and Darnhall; was knighted. Died April, 1627, leaving a son and heir, Henry, by whom Lee Hall was sold to Sir Henry Delves.

EDWARD STANHOPE, Shelford, Notts.

Youngest son of Sir Thomas Stanhope, Sheriff of Notts and M.P. for that county, 1584. He married Ellen, daughter and heiress of Robert Walshall, of Lancaster. From his uncle, who was created Lord Stanhope, the Earls of Chesterfield are descended.

JAMES MORLEY, London.

HENRY BROMLEY (Sir).

Son and heir of Lord Chancellor Bromley. He was seated at Holt Castle, in Worcestershire; M.P. for that County. He was Sheriff of his County in 1606, and took a very active part in the apprehension of persons in Worcestershire implicated in the Gunpowder Plot.

MICHAEL FOUNTAYNE, Aylesbury, Bucks.

NICHOLAS COLLETT, Southwark.

Philip, Earl of Arundel.

Born 1557; only child of the fourth Duke of Norfolk and the heiress of the Fitz-Alans. He was the first Earl of the family of Howard, and "led a life of frivolity previous to 1580, when he entered the Temple, and withdrew from the frivolities of the Court." He was attainted in 1589, and died in the Tower, 1595.

THOMAS, Lord Howard, of Walden.

Created in 1603 Earl of Suffolk. Died 1626. Eldest son of the fourth Duke of Norfolk and his second wife, the daughter and heiress of Lord Chancellor Audley.

JOHN LYTTELTON, of Frankly.

M.P. for County of Worcester. Attainted and his Estates forfeited for aiding the insurrection of the Earl of Essex. On the accession of James, the property was restored to his widow, Muriel, daughter of Lord Chancellor Bromley, and their eldest son was created a Baronet in 1618.

HENRY GYLL, Peldon, Essex.

Julius Cæsar (Sir), London.Judge of the Admiralty, 1584. Called to the Bench, 1590.Master of Rolls, 1614. Died 1636.

"The Exchequer House in Droitwich was built about 1581, and hath this inscription:—

To the building of thys place, Thomas Wythe, by Godd'ys grace, Gaff nobles 22 and 10, Wherefore Cryste keep him for ever—amen."

JOHN TRACY, Toddington, Gloucestershire.

Son of Sir John Tracy; M.P. 1596; and Sheriff of the County, 1609. Created, 1642, Viscount Tracy, of Ratheoole, in the peerage of Ireland. The Tracys have been seated at Toddington since the reign of Henry II., and it is the chief residence of their representative—Lord Sudeley.

GERALD LOWTHER, Lowther, Westmoreland.

Second son of Sir Richard Lowther, Sheriff of Westmoreland, 1588. Justice of the Common Pleas at Dublin, 1610-24. B. 1590.

Eldest son of Thomas Threele, of Loxwood. He settled at Bexhill, where his descendants lived during several generations.

Son of Robert Buxton of this place; M.P. for Horsham.

I heare also that there "remayne at this present in yor disposition certayne "chambers, by reason that it hath pleased God to call "some of yor fellowshippe to his mercie, and by cause "I know that it wold be a good means to draw him "to the applying of his book, if he were provided "of such a chamber in the house, I am further to "pray yor good wills that he may have one of them. "These yor courtesies I shall take very thankfully, "and be ready to requite them to you all, and to "eche of you by the best meanes I may. Soe trusting " of your friendly reguard herein, I leave you to the "most mercifull protection of the Almightie. Ffrom "Eely Place in Holborne, the 8th of October, 1590.
