## INTRODUCTION

The two short London Chronicles here printed are both preserved amongst the Collections of John Stow in the British Museum, and both illustrate (though in very different degrees) the manner in which he composed his History of England, beginning with his *Summary of English Chronicles* and ending with his better known *Annales*.

The first and much the more important is copied in *Harley MS.* 540 ff. 7-21, partly in Stow's own writing and partly by another hand. At the beginning it is stated to be 'copied out of Myster Lordynges booke.' Who Mr Lordyng was I cannot say. But his book was probably a copy of one of the old Chronicles of London, as the four brief notes, with which the Chronicle in the *Harley MS.* begins, seem to indicate. It would be quite in accordance with custom for a later owner to have entered at the end of the original Chronicle from time to time a continuation of his own. This is the character of the main Chronicle here printed for the years 1523 to 1555. Really there are two separate Chronicles, entered no doubt in the original by two different owners. The first is for the years 1523 to 1540; the second for 1548 to 1555. For the intervening years 1540 to 1548 the names of the mayors and sheriffs, with a single bald note under 1543-44, had been entered, possibly by the writer of the second Chronicle. These two Chronicles of *Harley MS.* 540 are clearly of different authorship, having nothing in common save for certain indications that the writers of both were of anti-Protestant feelings.

The chief interest of the earlier Chronicle (1523-1540) consists in the fact that it formed the principal source for Stow's narrative in the first editions of his *Summary of English Chronicles* published

in 1565 and 1566. It is somewhat amusing to find that Stow was, for matters almost within his own memory, copying so slavishly from a written Chronicle, at the very time when he was censoring Grafton for having made an unfair use of his own printed work.<sup>1</sup> It is true that Stow added for these years a little from Hall, but the early editions of the *Summary* are substantially a mere reproduction from the Chronicle here printed. In the subsequent editions of the *Summary* in 1570 and 1575, and still more in the final history as given in the *Annales*, Stow drew much more freely on other sources. A great deal of matter contained in this Chronicle was thus gradually dropped. Meantime something had been borrowed by Holinshed without any specific acknowledgement of his source. It is thus necessary to recognise that the successive editions of Stow's *Summary* are deserving of more attention than they have commonly received.

Though Stow for the most part followed the Chronicle very closely, his departures from his original in some places are noteworthy. The original contains certain matter, which, when Stow wrote thirty years later, it would not have been judicious to repeat. Under 1528-9 a reference to the "selling of Martin Luther's books" is omitted.<sup>2</sup> So also is that to the burning of Tyndal's books in Nov. 1530. More remarkable is the omission of the reference to Catherine of Aragon 'a blysyd lady and a good,'<sup>4</sup> and of the pathetic story of the two women, who 'fortified theyr saying still to die in the quarell for Queen Catherine's sake.'<sup>5</sup> On the other hand it is to be noted that the Chronicler had not recorded the proclamation of the king's supremacy in 1534, passed over Anne Boleyn's wedding and the birth of the princess Elizabeth, and even the birth of Edward VI; the omission to mention the suppression of the monasteries under 1537-8 may also be due to anti-Protestant sympathies, which the writer feared to express. Through Stow the Chronicle is several times quoted by Holinshed;

as for the events of 1534-5, for the procession on 11 Nov. 1535, the jousting at Westminster on 29 June 1536, the penance of Thomas Newman on 12 Nov. 1536, and the execution of the Vicar of Wandsworth on 8 July 1539.<sup>1</sup>

For the most part the Chronicle consists of brief notes, probably written down immediately after the events to which they relate. Executions, penances for heresy, and incidents of civic history furnish the principal staple of the narrative. Passages of more moment, which may be mentioned, are the reference to Queen Catherine noted above, the description of the prosecution of the Maid of Kent,<sup>2</sup> the long account of the procession on 11<sup>th</sup> Nov. 1535,<sup>3</sup> and the curious notice of Thomas Cromwell's alleged parentage.<sup>4</sup>

The chronology of the Chronicle calls for some explanation. The note<sup>5</sup> that 'this boke doth accoumpte ye yere to begyn at Novembar,' was probably inserted by Stow, who did not recognise that the years were mayoral not regnal. But the numbers of the years as given in the text have been frequently altered, the original numbers having been a year earlier ('xvj.' for 'xvij.' etc.). The explanation probably is that the original writer put down the mayor, who held office in April 1509, as the mayor for the 'first year of Henry VIII.' Thus the mayor and sheriffs for 1509-10 would have been entered as those for 2 Henry VIII; and Thomas Baldry would have appeared under 16 Henry VIII, though he really held office 1523-24 in the 15<sup>th</sup> and 16<sup>th</sup> regnal years. The dates as given in the text are the corrected ones; they follow the most common custom of the London Chronicles and of Stow's *Summary*, in accordance with which the first mayoral year of Henry VIII was that of the mayor, who took office on 29<sup>th</sup> October 1509.

The second Chronicle for 1548-55 is distinguished from the first by its much greater fulness in matters which it describes, and by less attention to trivial incidents. Partly for these reasons, and

partly because Stow, from whatever cause, made much less use of it, it is of far more interest. Stow had by this point reached a time well within his own recollection, and may consequently have depended less on written memorials. When he first wrote, moreover, events of such recent happening required discreet handling. When later on he expanded his history, he had at his disposal the manuscript *Chronicle of Queen Jane and Queen Marie*<sup>1</sup>, and also as it would appear a copy of Charles Wriothesley's *Chronicle*. Thus he not only made less use of our Chronicle from 1548 to 1555 in his *Summary*, but also omitted more of what he had at first borrowed, when he came to write his *Annales*.

The Chronicle opens with a long account of the disturbances of 1549. The description of the rising at Exeter is followed fairly closely by Stow. The story of the sparking of Thame and Rycote, as here given, seems to be novel, and the account of Kett's rebellion differs from that given by Stow.<sup>2</sup> The first arrest of Somerset,<sup>3</sup> and the story of Captains Charles and Gambold,<sup>4</sup> are given without any particular additions to other accounts. Most of the history of 1550-52 appears in a very similar form to that adopted by Stow in his *Summary*.<sup>5</sup> Of the events which attended the accession of Queen Mary we get an independent and interesting account of which Stow made little use.<sup>6</sup> Wyatt's rebellion is described freshly, as by one who wrote from his own knowledge; the most notable new point being the story of how Wyatt managed to get into Fleet Street without being recognised.<sup>7</sup> There is a good deal of detail on the subsequent incidents of the spring of 1554, but with nothing that calls for comment till we reach the trial of Nicholas Throckmorton,<sup>8</sup> where the sufferings of the stalwart jurors, who would not find him guilty, are told at more length than elsewhere. The arrival of Philip of Spain is described with

some small details of interest.<sup>1</sup> Gardiner's sermon at Paul's Cross on 2<sup>nd</sup> December, 1554,<sup>2</sup> is summarised in a manner which shows that the Chronicle consists of notes, perhaps written down on the spot, until the bells 'made such noise that I could not understand three words together.' Of this, the most interesting passage in the whole Chronicle, Stow made no use at all. So far as I can discover no other writer gives so minute an account of Gardiner's sermon. The Chronicle ends with the death of Gardiner in November, 1555. But the history of the last eleven months includes nothing of importance, which cannot be found elsewhere. The description of the flood in October, 1555,<sup>3</sup> shows how Stow used this Chronicle in his *Summary*, but discarded it in the *Annales*. The use of the Chronicle by Stow, and the points in which it differs from other contemporary records are illustrated sufficiently in the footnotes to the text. Except where otherwise noted the *Summary* is quoted from the edition of 1566 (which here differs little from that of 1565), and the *Annales* from the edition of 1605. (Stow's own final and authoritative text).

The brief City Chronicle for 1547 to 1564 is of a different character to the previous one. *Harley MS.* 530 ff. 105-110, whence it comes, consists of short historical notes written early in the reign of Elizabeth. The first note is for the 54<sup>th</sup> year of Henry III taken from Fabyan. Other notes of fourteenth century history follow from Froissart. A notice of Wiclif is borrowed from John Bale. On f. 107 comes a note, which is worth quoting as a characteristic specimen :—

"Mr. Hall writeth the batayle of Egyncorte to be in the 4 yere, & I do think it gode to referr the redar to m<sup>tr</sup> hall, who writeth of it at large takyn owt of the frenche cronicle made by enguyron,<sup>4</sup> who did write ymmediatly after frosard."

On f. 108<sup>ro</sup> there are a few notes on the reign of Henry VIII. The last alone is of any interest :—

“ In the 25 yere the statute was made for the selling of flessch by waight ; toke effect the first day of August. ” <sup>1</sup>

There then begins the more regular and original Chronicle here printed. <sup>2</sup> The writer, unlike the authors of the previous Chronicle, seems from his notices on religious matters to have been a Protestant. There are a few entries of political matters. But the more interesting part of the Chronicle consist of notes, which would appear to have been made by a London merchant trading abroad. They relate chiefly to incidents and disasters at sea : to captures of French and Spanish ships : to the pirate Strangwyshe; and to the naval warfare off Newhaven, or Havre, in 1563-64. The reference to an exploit of John Hawkins in the autumn of 1563 seems to be novel. Other entries on the rate of exchange with Antwerp, and on prices, also indicate that the writer was interested in commerce. Two amusing notes are of the rainy season of 1563, which caused such a dearth of hops that beer was brewed with broom and bay-berries, and of the abundance of fruit in the following summer. The statement as to the causes which led to the English intervention at Havre in 1563, appears to have been borrowed by Stow for his own narrative in the *Annales*.

Apart from its contents this Chronicle has a certain interest as illustrating how long the practice of keeping written records in the form of civic Annals persisted with London citizens.

The notes folowyng wer copied out of Myst'. Lordynges boke.

## Richard y<sup>e</sup> seconde

The iij<sup>de</sup> yere of his reygne y<sup>e</sup> galyottis of Spayne w<sup>t</sup> othar small shippis cam a land at Gravesende, & robbyd & brent y<sup>e</sup> moaste parte [of y<sup>e</sup>] towne.

The xvij. yere of Richard y<sup>e</sup> second y<sup>e</sup> heresies of John Wycklyffe began to spryng in England.

## Henry y<sup>e</sup> fourthe

Y<sup>e</sup> xj. yere of his reygne began y<sup>e</sup> alaye of goulde: & y<sup>e</sup> kyngs sons betyn in y<sup>e</sup> Chepe.

## Henry y<sup>e</sup> vij

The first yere of his reyne y<sup>e</sup> crosse in Chepe was new buyded, Hughe Bryce beyng mayre.

The xij of his reygne y<sup>e</sup> wedercoke of Powlls was new made.

## Henrie y<sup>e</sup> viij

This boke dothe accowmpte y<sup>e</sup> yere to begyn at November, but yt dothe not begyn tyll Aprill next foloyng, which is to be noted.<sup>1</sup>

Y<sup>e</sup> xv. yere of Henrie y<sup>e</sup> viij, Tomas Baldry beyng mayre, was y<sup>e</sup> lady Hungarford and hir man hangyd at Tyburne.<sup>1</sup>

The xvj. yere of his reyne y<sup>e</sup> castell of Grenewyche was buyldyd. Y<sup>e</sup> same yere, y<sup>e</sup> xvij. daye of June, was creatyd at Brydewell Henrie, y<sup>e</sup> kyngis bastard, duke of Richemont & Somersete, & earle of Nothyngham, highe steward of Englande, warden of all y<sup>e</sup> marches agaynst Scotlande, hyghe admyrall of y<sup>e</sup> sea, highe Justice of all y<sup>e</sup> kyngs parkes, chaces, mayrynes, & forestis from Trent to Scotland, & hyghe steward to y<sup>e</sup> byshope of Yorke & Doram.<sup>2</sup>

The xvij. yere of his reygne, y<sup>e</sup> xj. day of februarie, beyng shroffe sondaye, v. men of y<sup>e</sup> Stilaard dyd penaunce, iij. of them bare fagotes at Powles, & ij. of them bare taperes. And an awsten fryar callyd doctor Barns of Canbryge bare a fagot at Powles y<sup>e</sup> same daye. The same yere y<sup>e</sup> vj. day of September was proclamyd of goulde y<sup>e</sup> frenche crowne iij.s. vj.d., y<sup>e</sup> halffe noble iij.s. ix.d., y<sup>e</sup> angell noble vijs. vj.d., and y<sup>e</sup> riall xj.s. iij.d., & so every pese affter y<sup>t</sup> valewe.<sup>3</sup>

The xvij. yere, Thomas Seamar mayre, of his reygne, y<sup>e</sup> iij. day of Julii, y<sup>e</sup> lorde cardenall rode thorowe Chepe, & so toward Fraunce<sup>4</sup>; & y<sup>e</sup> xv. day of y<sup>e</sup> same monythe was one Harman drawyn from Newgate to Tyburn, & there hangyd for qwynynge of falce golde.<sup>5</sup> And in y<sup>e</sup> same yere in Julii & in August was y<sup>e</sup> slewcys made in Fynsbery fylde to convaye y<sup>e</sup> yll watars ovar y<sup>e</sup> towne dyche by pypes of lede in to y<sup>e</sup> Temes.<sup>6</sup> In y<sup>e</sup> same yere was great skarsnes of breade at London, & all England, y<sup>t</sup> many dyed for defaut therof: & y<sup>e</sup> bread cartes y<sup>t</sup> came from Stratford to London were mett by y<sup>e</sup> way at Myll ende by y<sup>e</sup> citisens of London,

The xix. yere, of his reygne, James Spencer mayre, y<sup>e</sup> first day of Novembar, my lord cardinall w<sup>t</sup> y<sup>e</sup> Ambasadours of Fraunce wer at Powles, & ther was proclaymyd a generall peace betwene kyng Henrie of England & Francys y<sup>e</sup> frenche kyng duryng theyr lyves, & a xij. monythe & a day afftar. <sup>2</sup>

The viij. day of Novembar iij. scolers of Cambryge, & one Fostar a gentyllman of y<sup>e</sup> cowrte bare ffagotts at Powlis for heresy. <sup>3</sup>

for heresy. The vj. day of September one John Skotte, wodmonger, dyd penaunce in Chepe and othar placis of y<sup>e</sup> citie, goynge in his shurte, bare leggyd & bare fottyd, and a proclamacion made at y<sup>e</sup> Standard, at Ledyn hall, & at Grace churche vpon misde-meanor agaynst y<sup>e</sup> mayre & y<sup>e</sup> aldermen w<sup>t</sup> y<sup>e</sup> shrives. <sup>1</sup>

The xviiij. day of October was y<sup>e</sup> cardynall dyschargyd of his chauncelourshype, & y<sup>e</sup> kynge seasyd all his goods & his place at Westmystar : & y<sup>e</sup> xxv. day of y<sup>e</sup> same monythe he went from Yorke place to Ashehere <sup>2</sup> w<sup>t</sup> xxx. persones & no more, & ther to abyde tyll he knew furdar of y<sup>e</sup> kyngs pleasure. day of Novembar iiij. men, whose names were, Thomas Somar, John Pursar, Tyndall, & a prentys on London brydge, they rode from the Towre of London w<sup>t</sup> papars on theyr heades vnto y<sup>e</sup> crosse in Chepe, & ther was made a great fyar & theyr bokes brent.<sup>1</sup> The v. day of Aprylle was a coke boylyd in a cawdren of brasse in Smythefylde for y<sup>e</sup> poysonyng of y<sup>e</sup> byshope of Rochestars servant.<sup>2</sup> At mydsomar y<sup>e</sup> constables rode in y<sup>e</sup> watche. The xiiij. day of Julii maystre Lacie servant was hangyd in Fynsbery fylde for y<sup>e</sup> morderyng of a mayde, & for y<sup>e</sup> robyng of this sayd mistar Lacie.

The xix. day of August y<sup>e</sup> byshope of Norwyche brynt a master of Arte callyd Thomas Bylneye. The xxij. day of October Paytmer, a merchant & a glyssyar, bare fagotis at Powles.<sup>4</sup>

Y<sup>e</sup> neste day y<sup>e</sup> gray fryars, & y<sup>e</sup> monkes of y<sup>e</sup> Chartarhosse put downe.<sup>1</sup> The xxij. day of Novembar was Lambart<sup>2</sup> byrnt in Smythe fylde. The xxiiij. day of Novembar was iij. buchars, & a woman bare fagotts at Poles. one Wynslowe, & one called Holmes<sup>1</sup> were drawn, hanged, & quartered at Tyborne from y<sup>e</sup> Tower of London for y<sup>e</sup> insurreccion made in y<sup>e</sup> west partes, as appeareth in y<sup>e</sup> yere before.

Also y<sup>e</sup> vj.<sup>th</sup> of ffebruary, a.<sup>o</sup> R. E. vj.<sup>ti</sup>, iiij<sup>to</sup>, the duke of Somerset, wh. as aforesayd beyng lord protector proclaymed traytor & com- mytted vnto y<sup>e</sup> Tower, was nowe delyuered out of y<sup>e</sup> Tower, & y<sup>e</sup> same nyghte supped w<sup>t</sup> y<sup>e</sup> erle of Warwyke at y<sup>e</sup> shreffes called mr. Yorke.<sup>2</sup>

Also vppon Mondaye, beinge y<sup>e</sup> tenth daye of ffebruary afforesayde, one Bell, a Suffolke man was drawn from y<sup>e</sup> Tower vnto y<sup>e</sup> Tyburne, & ther hanged & quartred, which as they sayd was for a newe insurreccion, wh. he w<sup>t</sup> certayne other of his com- plices moved in Suffolke & in Essexe.<sup>3</sup>

Be it remembered y<sup>t</sup> y<sup>e</sup> xxvj.<sup>th</sup> of Aprill, anno R. E. vj.<sup>ti</sup> quarto, y<sup>e</sup> towne of Bulloyne was yelden vp vnto y<sup>e</sup> french kynge, & hys capitaynes tooke y<sup>e</sup> possession, which was so greate comforte & joye to y<sup>e</sup> ffrench men, y<sup>t</sup> as some sayd at ye entrye in to y<sup>e</sup> towne many of them kneled downe & kyssed y<sup>e</sup> stones of y<sup>e</sup> stretes.<sup>5</sup>

Be it also remembred y<sup>t</sup> vppon ffryday, beyngē y<sup>e</sup> xxiiij.<sup>th</sup> of Aprell, a dutcheman was burned in Smythfilld for heresy, whose detestabell heresy was of y<sup>e</sup> inequalitye betweene God y<sup>e</sup> father, & God y<sup>e</sup> sonne.<sup>1</sup>

Be it also remembred y<sup>t</sup> vppon ffryday, beinge y<sup>e</sup> viij. of Maye, a proclamacion was made in London y<sup>t</sup>, from & after y<sup>e</sup> last daye of August then next ensewyngē, shylllynges of y<sup>e</sup> valewe of xij.d. shuld be currant but ix.d., & a grote for iij. pence. By reason of wh. proclaymacion ensewed great death<sup>2</sup> of all thynges ; for y<sup>e</sup> people, coueytinge to rayse y<sup>e</sup> losse of theyr money vppon soche kynd of wares or victualles as they occupied, dyd dayly inhaunse & encrease y<sup>e</sup> prises both of wares & victualles, most miserably oppressyngē y<sup>e</sup> poore.<sup>3</sup>

Note also yt vpon frydaye, beyng y<sup>e</sup> vij<sup>th</sup>. daye of Nouember y<sup>e</sup> quene of scottes<sup>2</sup> rode throughe Chepesyde w<sup>t</sup> a greate companye of englishemen waytyng on her, after she had lyen iiij. dayes in y<sup>e</sup> byshope of London's palace besydes Poules church.

Note further y<sup>t</sup> vpon Tewesdaye y<sup>e</sup> first of December y<sup>e</sup> duke of Somerset was areyned at Westmynster hall, & was then & ther acquyted of treason, but he was condempned of felonye by vertue of acte of parlyamente made agaynst conventicles & vnlawfull assemblies.<sup>3</sup>

Note, y<sup>t</sup> vppon Fryday, beinge y<sup>e</sup> xxvj<sup>th</sup>. of ffebruary, one sir Raffe a Vane, & on sir Myles Partryge were both hanged [at] y<sup>e</sup> Tower hyll vppon y<sup>e</sup> gallowes, & sir Mihell Stanhope & sir Thomas Arundell were beheaded vppon y<sup>e</sup> skaffold ther : all wh. foure were condempned by vertue of y<sup>e</sup> acte of vnlawfull assembles as accessaryes to y<sup>e</sup> duke of Somerset.<sup>1</sup>

Note, y<sup>t</sup> vppon good Frydaye y<sup>e</sup> xv<sup>th</sup>. of Aprell y<sup>e</sup> parlyament was cleane dyssolued & broken vpp, wherin were many goodly lawes & statutes ordeyned & stablyshed.

byshope of London, made a sermon at Poules crosse,<sup>1</sup> & ther declared y<sup>e</sup> twoo systers, y<sup>e</sup> lady Mary, & y<sup>e</sup> lady Ellisabeth were both basse borne, & ther fore were not naturall chylidren vnto kyng Henry y<sup>e</sup> eyghte, but borne incest : by reason wherof y<sup>e</sup> lawes both of y<sup>e</sup> reallme & also y<sup>e</sup> ciuille lawe doth not allowe or permite any soche chylidren so borne : & for y<sup>e</sup> same shewed y<sup>e</sup> wordes of y<sup>e</sup> ciuile lawe.

And vpon Thursdaye, beinge y<sup>e</sup> 21 of Julii, y<sup>e</sup> duke of Northumberland havynge receyved y<sup>e</sup> sayd proclamacion from y<sup>e</sup> lordes, he returned y<sup>e</sup> same nyghte to Cambridge, & ther proclamed her grace quene of England; & y<sup>e</sup> same nyghte after he was layed in his bede y<sup>e</sup> garde came & seased vppon his weapons & his body & tooke hym in charge: & y<sup>e</sup> next day y<sup>e</sup> lord erle of Huntyngton, y<sup>e</sup> lorde Graye, & dyuers other, & y<sup>e</sup> capeteyne of y<sup>e</sup> gar[de]<sup>1</sup> also were arested by y<sup>e</sup> quenes commaundement.

And vppon Sunday, beinge y<sup>e</sup> 22 daye of Julye, as it was sayd, dyurse of y<sup>e</sup> lordes of y<sup>e</sup> counsell here rode towards her grace. Vppon Tewesdaye, beinge y<sup>e</sup> xxv<sup>th</sup>. day of July in y<sup>e</sup> feast of sainte James thapostell, aboute iiij. of y<sup>e</sup> clocke at afternone thes persons followynge were broughte as prysoners into y<sup>e</sup> Tower of London, y<sup>t</sup> is to saye y<sup>e</sup> duke of Northumberland, y<sup>e</sup> erle of Warwyke his sonne, sir Ambrose Dudleye his sonne, & Harry Dudley his sonne, therle of Huntyngton, & y<sup>e</sup> lorde Hastings his sonne, one [ ] Sandes<sup>2</sup> a prest of Cambrydge, who had preched in Cambrydge in all condycions & rather worse than y<sup>e</sup> bishope of London, Sir John Gaates capteyne of y<sup>e</sup> garde, & Harry Gaates his brother, Sir Androwe Dudley, & sir Thomas Pallmer.

And y<sup>e</sup> morrow after, beyng Wednysdaye y<sup>e</sup> 26 of July,<sup>3</sup> ther were broughte into y<sup>e</sup> Towre the prisoners folowynge, The lord marques Northeampton, The byshope of London, Rydleye, sir Richard Corbyt knyght of Suffolke, & a serchar of Gravesende called Harmonde. Thes came in at Allgate. And y<sup>e</sup> same nyght y<sup>e</sup> two cheff Judgys of England, y<sup>e</sup> lord Mountagwe, cheff judge of y<sup>e</sup> comon place, & syr Rogar Cholmley, cheffe justice of y<sup>e</sup> kyngs benche were bothe comytted to y<sup>e</sup> Towre. And neverthesse they were sone delyveryd, beyng fynynd at serten somes of money.

Vpon Fryday y<sup>e</sup> xxviii. day of Julii the duke of Suff., Mster. Cheeke, whiche was y<sup>e</sup> kynges schole-mastar, w<sup>t</sup> divers othar, were comytted to y<sup>e</sup> Tower.

Vpon Thursday, beyng y<sup>e</sup> thyrd of August, y<sup>e</sup> quenes grace, ladie Marie, came aboute vij. of y<sup>e</sup> cloke at nyght vnto y<sup>e</sup> Towre of London, & vpon her awayted a great number of soldyours, some in blewe, some in white & grene, & some in Redde cottés, & a ix. C. shott of ordynaunce was shott of y<sup>e</sup> Towre.

And at hyr entrynge into hir great chamber y<sup>e</sup> bishope of Wynechester, doctour Gardemar, y<sup>e</sup> duke of Northeffolke, & y<sup>e</sup> douches of Somerset, & myster Courtneye, sonn to y<sup>e</sup> marquess of Exceter, had theyr pardon grauntyd vnto them by hyr graces owne mouthe.

Vppon Sattarday, beyng y<sup>e</sup> v. of August, y<sup>e</sup> byshope of London, doctour Bonar, who hadd lyen in y<sup>e</sup> Marchallse aboute v. yeres, was delyveryd & set at lybertie. And doctour Tunstall, byshope of Duresme, was also delyveryd out of y<sup>e</sup> Towre.

Vppon Twesdaye, y<sup>e</sup> viij. of August, y<sup>e</sup> corps of kynge Edward y<sup>e</sup> vj. was buryed in y<sup>e</sup> churche of sent Petar at Westmyster. And y<sup>e</sup> nyght before ther was placebo & dyrige sayd in latyn before y<sup>e</sup> quene w<sup>t</sup> yn y<sup>e</sup> Towre : & this present Twesdaye ther was a messe of requiem songe in latin before y<sup>e</sup> quene by y<sup>e</sup> byshope of Wynechester w<sup>t</sup> in y<sup>e</sup> Towre.

On Twesdaye beyng y<sup>e</sup> xxij. daye of Auguste, The Duke of Northumberland, sir John Gaates, & buskynned Palmer were all thre behedyd vppon y<sup>e</sup> skaffolde at y<sup>e</sup> Towr hyll.

The xxvij. of August, beyng Sondag, y<sup>e</sup> bakesyde of y<sup>e</sup> highe altar of Powles churche beyng made up w<sup>t</sup> brike some what above an altar but not clearly fynyshed, ther was hyghe masse songe in lattyn w<sup>t</sup> bothe mattyns & evensonge lykewyse in lattyn. And dyvers churches in London had y<sup>e</sup> lyke servyce.

third in y<sup>e</sup> myddes of Gracious streate made by y<sup>e</sup> Florentynes were all made w<sup>t</sup> gattes to passe throghe, & y<sup>e</sup> buyldynges wer very highe statlye. And so hir grace passyd forthe vnto Westmyster, & as she passyd by Pawles a certayne duche man stode vpon y<sup>e</sup> wetharcoke w<sup>t</sup> a flagge in his hande, & ondar hym vpon y<sup>e</sup> crosse a skaffolde w<sup>t</sup> flaggs, & ondar y<sup>t</sup> vpon y<sup>e</sup> ball an othar skaffolde w<sup>t</sup> flaggs & streamers.<sup>1</sup>

Vpon Sunday, beyng y<sup>e</sup> fyrste day of October, y<sup>e</sup> quenes grace was crownyd at Westmystar, & before here went all y<sup>e</sup> byshoppes w<sup>t</sup> myters & croysers, & y<sup>e</sup> clerks syngyng y<sup>e</sup> servyce all in lattyn.

Vpon Thursdaye, beyng y<sup>e</sup> v. day of October, y<sup>e</sup> barge of Gravesend by greate mysfortune of a catche comyng vpon hir was ovarthrowne and aboute fortye persons drownyd<sup>2</sup>: our lord be merciful to them.

On Monday, beyng y<sup>e</sup> xxiiij., on wednysday y<sup>e</sup> xxv., & Fryday, beyng y<sup>e</sup> xxvij. day of October, were certayne dysputacions in y<sup>e</sup> longe<sup>3</sup> chapell at y<sup>e</sup> northe doore of Paules concernyng y<sup>e</sup> transubstanciacion, but no thyng throughely determynyd.<sup>4</sup>

Thomas Whit, marchaunt tayloure, mayie, y<sup>e</sup> xxviiij. of Octobar, 1553.

Vpon Fryday y<sup>e</sup> iij. day of Novembar, 1553, y<sup>e</sup> aforesaid douche-man, who stode vpon y<sup>e</sup> wethercoke at y<sup>e</sup> queens rydyng thrughe London, dyd set up y<sup>e</sup> wetharcoke of Poules agayne vpon y<sup>e</sup> crosse, whiche he had causyd to be amendyd w<sup>t</sup> a brode rownde vane set vpon y<sup>e</sup> tayle to thend y<sup>t</sup> she myght turne w<sup>t</sup> every wynde, & even y<sup>e</sup> same day he stroke downe both y<sup>e</sup> skafoldes, whiche he before had made agaynst y<sup>e</sup> queens comyng.

Vpon Wednysday y<sup>e</sup> viij. of Novembar an obyt was kept in Poules

for doctour Dolman, & vpon Thursday y<sup>e</sup> ix. of Novembar y<sup>e</sup> byshope of London songe y<sup>e</sup> masse hymselfe.

Vpon Monday, beynge y<sup>e</sup> xiiij. day of Novembar, The archebyshope of Cantourbery, the lord Robert Dudleye, the lord Guyylforde Dudley, husband of y<sup>e</sup> lady Jane pretendyd quene, the lord Henrie Dudley, youngest sone of y<sup>e</sup> sayd thre Dudleyes, and y<sup>e</sup> sayd lady Jane y<sup>e</sup> pretendyd queene, were all v. arreygnyd at y<sup>e</sup> Guylde hawll vpon highe treason, & so cast & adiudgyd to be drawne, hangyd, & quarteryd.

Vpon Satterday, beynge y<sup>e</sup> xxv. of Novembar, & y<sup>e</sup> yere of our lord 1553, Anno I. Regyne Marie, at vj. of y<sup>e</sup> cloke at night S. Katheryns lyghts were cryed aboute y<sup>e</sup> battylments of Paules steple, whiche had not ben many yeres before. <sup>1</sup>

Vpon Tewesdaye or Wednysdaye y<sup>e</sup> v. of Decembar, y<sup>e</sup> parlyament was dissolyd, wherein was repeallyd ix. servall actes, viz. for mariage of priestes, y<sup>e</sup> legitimacion of prestis children, y<sup>e</sup> receyvyng of y<sup>e</sup> sacrament in bothe kyndes, y<sup>e</sup> makyng of deacons & pristis, the vniformytie of devyne prayer, the pluckyng downe of altars, Roods, & Images, the observacion of holydayes & fastyng dayes, w<sup>t</sup> ij. othar actes.

Vpon y<sup>e</sup> 14 day of Januarye, 1553, y<sup>e</sup> lord chauncelour w<sup>t</sup> othar of y<sup>e</sup> counsell declaryd openly vnto y<sup>e</sup> queens Maiestie howsheolde y<sup>t</sup> ther was a mariage concludyd betwene hir grace & y<sup>e</sup> kynge of Spayne,<sup>2</sup> whiche was y<sup>e</sup> fyrst tyme it was certainly knowne abrode.

Aboute y<sup>e</sup> xxv. day of Januarie, Anno 1553, anno primo Regine Marie, began y<sup>e</sup> comocion in Kent, y<sup>e</sup> cheffe captayns wherof was sir Thomas Wyat & one syr Henrie Illisleye<sup>3</sup> : but it was sayd y<sup>t</sup> lorde Cobham had taken parte w<sup>t</sup> y<sup>e</sup> queene : the cause of theyr

comocion (as y<sup>e</sup> brute went) was because they woulde not be subiecte to y<sup>e</sup> kynge of Spayne: for thappesyng where of ther was a great nombar of men made out of y<sup>e</sup> citie of London, & all y<sup>e</sup> companyes chargyd ther w<sup>t</sup>.

And vppon Candelmas day, beyng Frydaye & y<sup>e</sup> ij. day of Februarie, all y<sup>e</sup> aldarmen of London & y<sup>e</sup> inhabytauntes of every warde were y<sup>e</sup> whole day in harnes for feare of y<sup>e</sup> aforesayde Rebels, who as it was sayd approchid: & my lord mayre was at Ledyn hall w<sup>t</sup> a great number of men in harnesse, whiche were apoyntyd forthe by y<sup>e</sup> companyes of y<sup>e</sup> citie, double so many as before, for wher y<sup>e</sup> marchaunt taylours at y<sup>e</sup> fyrst tyme armed xxx. at this tyme they armyd lx. &c.

Vppon Saterdag, beyng y<sup>e</sup> iij. day of February, y<sup>e</sup> morow after Candelmas day, s. Thomas Wyatt, who had lyen at Grenewitche by y<sup>e</sup> space of ij. nyghts & a daye, cam sodeynly aboute one of y<sup>e</sup> cloke at aftar none into Sothewarke w<sup>t</sup> his band of men, whose sodayne comyng drave y<sup>e</sup> citizens into great feare so that they were fayne to close vp y<sup>e</sup> gatte on y<sup>e</sup> brydge, & cutt downe y<sup>e</sup> draw brydge & let it fawll in to y<sup>e</sup> watar, & all men ran to harneys for y<sup>e</sup> deffence of y<sup>e</sup> citie. The aforesayd shrovetewesday, beyng y<sup>e</sup> vj. day of Februarie, early in y<sup>e</sup> mornynge y<sup>e</sup> sayd syr Thomas Wyate removyd all his people & theyr ordynaunce all save one pece, & went vnto Kyngston, & ther beyng sumwhat resysted at y<sup>e</sup> last he by entreatie passyd y<sup>e</sup> brydge, whiche brydge was by hyme & his foarcyde & made, for y<sup>e</sup> brydge y<sup>t</sup> before was ther was cutt downe or he cam: & then he marchyd to London wardes a bowght xij. of

Vpon Monday, beyng y<sup>e</sup> xij. day of Februarie, y<sup>e</sup> lorde Gylforde Dudley, forthe sonne to y<sup>e</sup> duke of Northumbarland, hosband to y<sup>e</sup> lady Jane, pretendyd quene, was behedyd at y<sup>e</sup> Towre hyll : and y<sup>e</sup> sayd day lady Jane, y<sup>e</sup> pretendyd queene, was behedyd y<sup>e</sup> same day w<sup>t</sup> in y<sup>e</sup> Towre. Aboute two days afore y<sup>e</sup> duke of Suffolke w<sup>t</sup> one of his brythern, whiche before fledd to Lester, ther to rays

y<sup>e</sup> people ther to ayd syr Thomas Wyat, was brought in to y<sup>e</sup> Towre of London.

Vpon y<sup>e</sup> sayd Monday, beyng y<sup>e</sup> xij. of Februarie,<sup>1</sup> y<sup>e</sup> lord Courtney, therle of Devonshire, who was delyveryd out of y<sup>e</sup> Towre at y<sup>e</sup> queens entrynge, as is afore sayde, was nowe agayne comytted vnto y<sup>e</sup> Towre. The same Monday ther were gallowes to y<sup>e</sup> number of xvij. payre sett vp in dyvers placis of London : as two in Chepesyde, wherof one was beyond y<sup>e</sup> cross towarde Poules, & thothar almoast at y<sup>e</sup> great conduyte : at dyuers of y<sup>e</sup> gates othar.

Vpon Wednysday folowyng, beyng y<sup>e</sup> xiiij. day of Februarie, ther were vj. persons hangyd in Chepe syde vpon y<sup>e</sup> two payr of galowes. And vpon thothar gallowes in othar placis of y<sup>e</sup> citie to y<sup>e</sup> nombar of fiffyte<sup>2</sup> persons, whiche wer of y<sup>e</sup> Londoners y<sup>t</sup> were set out by y<sup>e</sup> citie and rane away from y<sup>e</sup> duke of Northfolke vnto Wyatt, & wer taken in y<sup>e</sup> fylde vpon ashewednesday.

Also y<sup>e</sup> Sondag before,<sup>3</sup> Captayn Bret w<sup>t</sup> xxv. more wer layd in a cart in Sothewarke by ser Robert Sothewell, shrive of Kent, y<sup>e</sup> whiche wer asygnyd to be executyd in dyver placis in Kent, but many of them were aftarward pardonyd.

Vpon Thursday, beyng y<sup>e</sup> xxj.<sup>4</sup> day of Februarie, y<sup>e</sup> remaynante of y<sup>e</sup> sayde rebels, whiche hadd bene emprisonyd, some in Newgate, some in the Countars, some in Sothewarke, & some in seynt Petars chirche at Westmystar in dyvers chapells ther, whiche wer to y<sup>e</sup> number of xij. score persons or more, were brought to y<sup>e</sup> crosse in Chepe, where y<sup>e</sup> quenes mercifull pardon was declaryd vnto them to theyr great confortes.<sup>5</sup>

And vpon Fryday, beyng y<sup>e</sup> xxij.<sup>1</sup> of Februarie, the duke of Suffolke was beheaded at y<sup>e</sup> Towre hyll.

Vpon Thursday, beyng y<sup>e</sup> viij. day of Marche, tharchbisshope of Cantorbery, y<sup>e</sup> byshope of London, Nycholas Rydleye, & fathar Latymer were brought out of y<sup>e</sup> Towre, & sent vnto Oxforde, ther to remayne vntyll y<sup>e</sup> queens comyng thethar at y<sup>e</sup> parlyament, beyng appoyntyd to begyn vpon y<sup>e</sup> Monday aftar lowe Sunday, y<sup>e</sup> iij.<sup>2</sup> day of Aprill; & y<sup>e</sup> tearme also was apoynted to be kepte at Oxford lykewysse.

Vpon Saturday, beyng y<sup>e</sup> xvij.<sup>3</sup> of Marche, y<sup>e</sup> lady Elisabeth, doughter of quene Anne Bulleyne, was comytted vnto y<sup>e</sup> Towre.

Wheras y<sup>e</sup> parlyament & tearme were bothe appoyntyd to have bene kepte at Oxenforde, it was now reiournyd vnto London by proclaymacion, and began at Westmynstar y<sup>e</sup> second day of Apryll, beyng Monday.

Vpon Wednysday, beyng y<sup>e</sup> xj. of Aprill, sir Thomas Wyat, capitayne & ryngledar of y<sup>e</sup> sayd Rebels, was behedyd at y<sup>e</sup> Towr hyll.

Vpon y<sup>e</sup> xxvij. day of Apryll one Nicholas Thokmorton,<sup>4</sup> a gentylman, was arraygnyd at y<sup>e</sup> Gyldhall as accessarye vnto Wyats conspiracie, & vpon his quest were chosen dyvers sytysyns, one was Whetstone,<sup>5</sup> haberdashar, Emanuell Lucas,<sup>6</sup> marchant taylor, Watur Yonge, Mst. Baskerfylde, Symon Lowe, Wyliam Bankes, Mstar. Poyntar, Mst. Martyn, and fowr othars, whiche dyd acquyt hym, and shortly aftar sent for before y<sup>e</sup> connsell, & ij. of them sent to y<sup>e</sup> Towre, y<sup>e</sup> rest were sent to y<sup>e</sup> Flete.

Vpon Fryday, beyng y<sup>e</sup> xvij. day of May, one Wylyam Thomas, a gentylman who had bene clarke of y<sup>e</sup> counsell, who had bene w<sup>t</sup> Wyat, and allso detarmynyd to have slayne y<sup>e</sup> quene w<sup>t</sup> a dagar,

was drawne from y<sup>e</sup> Towre of London to Tyborne, & ther hangyd & quarteryd.

Vpon Satarday, beyng y<sup>e</sup> xix. day of May, y<sup>e</sup> lady Elizabeth was brought out of y<sup>e</sup> Towr, & so conuayed by watar vnto Rychemonde, & from thence y<sup>e</sup> next day she went to Wyndsore, & so by my lord Wyllyams to Rycote in Oxenfordshire, & from thens to Wodstoke, where as it was sayd she shuld remayne.<sup>1</sup>

The fyrste<sup>2</sup> day of June y<sup>e</sup> gallowsys in London were commandyd to be takyn downe, whiche thyng was done accordyngly.

And aboute y<sup>e</sup> sayd fyrst<sup>3</sup> day of June ther was grauntyd by acte of comon counsell a fvytyn & a halfe to be levyed of y<sup>e</sup> citezens for y<sup>e</sup> gyldyng of y<sup>e</sup> crosse in Chepe, & for makynge of pagauntes agaynst y<sup>e</sup> comynge of y<sup>e</sup> prynce of Spayne; & ther vpon skaffolds were made aboute y<sup>e</sup> crosse, & werkemen set a werke for makynge of y<sup>e</sup> pagauntis.

Vpon Sunday, beyng y<sup>e</sup> xv. day of July, 1554, & anno Regine Marie secundo, a yonge wenche<sup>4</sup> of y<sup>e</sup> age of xvj. or xvij. yeres dyd open penaunce at Poules crosse, standyng vpon a skaffolde all y<sup>e</sup> sermon tyme, & confessyd hir falte openly: that she beyng intysed by lewde counsell had<sup>5</sup> counterfetyd certayne speaches in an house in Aldarsgate strete, about y<sup>e</sup> whiche matar y<sup>e</sup> people were wondarfully molested, some saynge y<sup>t</sup> it was a sprite that spake in a wall, some one thyng, some an othar: on this manor she vsed hir selfe, she lay in hir bed, & whistelyd in a strange whystell made for y<sup>e</sup> nones, then was ther (as she confessyd) vj. falce knaves,<sup>6</sup> whos names she ther declaryd, confederyd w<sup>t</sup> hir, whiche toke vpon them

to entarprite what y<sup>e</sup> spryt spake, expressynge certayn sedycius<sup>1</sup> words agaynst y<sup>e</sup> queens hyghnes.

Vpon Satarday, beyng y<sup>e</sup> xxj. of Julii, ther was great Joye & tryoumpth made in London w<sup>t</sup> bonffiyars & ryngynge for y<sup>e</sup> salffe landynge of y<sup>e</sup> prynce of Spayne, who came on land vpon Thursday at nyghte, y<sup>e</sup> xix. of Julii.

Vpon Wedenseday, beyng saynt James day y<sup>e</sup> xxv. day of Julii, at Wynchestar y<sup>e</sup> prynce of Spayne was married vnto y<sup>e</sup> queens maiestie.

Vpon Sunday, beyng y<sup>e</sup> xxix. day of Julii, one doctour Harpefeld<sup>2</sup> preachyd at Powles crosse, and after he had made his proposycion he exortyd all men to become newe men bothe in mynd & doynge, for so myche (sayd he) as I have newe thyngs to declare vnto you and therefore y<sup>e</sup> must become newe, for accordynge to Christis saynge no man puttythe newe wyne into olde vessyles etc.; and thervpon he declaryd vnto y<sup>e</sup> people y<sup>e</sup> style in maner folowynge: fyrst I command vnto.....<sup>3</sup> Philipp and Marye by y<sup>e</sup> grace of God kynge & quene of England, Faunce, Napyles, Jerusalem and Irlande, defender of y<sup>e</sup> faythe, prynces of Hyspayne & Cicile, archedukes of Austrie, dukes of Mylayne, Burgoyne, & Brabant, countes of Ausborow,<sup>4</sup> Flaunders & Tiroll: & then procedyd forthe w<sup>t</sup> his prayer.<sup>5</sup>

Vpon Lamas day, beyng y<sup>e</sup> fyrst of August, y<sup>e</sup> proclamacion was made consernynge y<sup>e</sup> sayd style in y<sup>e</sup> forenone, and at aftar none y<sup>e</sup> same styлле pryntyd bothe in Englisshe & in lattyn, was set up in dyvers placis of the citie.

And vpon Satterdaye, beyng y<sup>e</sup> xvij. day of August,<sup>6</sup> y<sup>e</sup> kynge

& y<sup>e</sup> quene bothe togethar w<sup>t</sup> ij. swerdes borne before them passed ovar London brydge from Suffolke place in Sothewarke, wher they had lyene y<sup>e</sup> nyght before, and so rode bothe togethar thurgh y<sup>e</sup> citie. And at Gracious strete y<sup>e</sup> house of y<sup>e</sup> Stylyard at theyr cost made a sumptuous & a large pagaunte fowr square w<sup>t</sup> stones of dyvars sortis. And at y<sup>e</sup> Stokes<sup>1</sup> was a great pagaunte made at y<sup>e</sup> cities cost declarynge y<sup>e</sup> nobyltye of iiij. Phyllypes,<sup>2</sup> whiche have excellyd in vertue, & praysynge ye kynge for y<sup>e</sup> fyfthe. At y<sup>e</sup> lytyll conduite was y<sup>e</sup> whole genelogie of y<sup>e</sup> quenes maiestie & y<sup>e</sup> kyngs, brought from Edward y<sup>e</sup> thyrde, fathar to John of Gaunte : and at y<sup>e</sup> weste ende of Poules y<sup>e</sup> kynge & y<sup>e</sup> quene bothe alyghtyd and entryd into y<sup>e</sup> churche, & so into y<sup>e</sup> qwyre, wher they entryd into ij. traversys made for them. And afttar rode forthe. And round abowte y<sup>e</sup> conduyte in Fletestrete was a large & a fayre greate pageaunte w<sup>t</sup> turrets & dyvers other thyngs, And at y<sup>e</sup> gatte at Temple barr was a longe declaracion of y<sup>e</sup> prayse of y<sup>e</sup> kynge, w<sup>t</sup> a bryffe rehearsall of all y<sup>e</sup> sayd pagauntis.

Not,<sup>4</sup> y<sup>t</sup> from y<sup>e</sup> 10 day of October vntyll y<sup>e</sup> xvj. day a greate preparacion was made in Smythefylde for y<sup>e</sup> spanyards to bayte y<sup>e</sup> bull aftar y<sup>e</sup> maner of Spayne, called Juga de Tauro, vpon sainte Lukes day, & a great frame for an house newe sett vp ther ; and vpon y<sup>e</sup> even of saynt Luke, beyng y<sup>e</sup> xvij. day of October, it was knowen y<sup>t</sup> y<sup>e</sup> same pastyme shulde be put of, so y<sup>t</sup> all y<sup>e</sup> preparacion for this tyme was voyde.

Vpon sent Lukes day, beyng Thursday y<sup>e</sup> xvij. day of October,

Aboute iij. dayes past y<sup>e</sup> viij. quest men, whose housys were seasyd by y<sup>e</sup> shreves, (as is afore sayd) were asygned to pay y<sup>e</sup> thyrd parte of a M. markes, & so had ther houssys delyveryd agayn into thandis of theyr wyves, all whiche thyngs was done (as it was sayd) by y<sup>e</sup> kynges meanes & procurement : but yet were not they delyveryd ont of pryson.

receyvynge this his holynes *benediccionem in one vnytie*,<sup>1</sup> and confes-  
syng our faultes be glad and joyfull to receyve remyssyon. In dede  
(quod he) this reverend father my lorde cardynall is come to rayse  
and awake vs all, wher in I exclude not my selffe, for I confesse I  
have fallyn and am therefore sory w<sup>t</sup> them that be sorye, but as for y<sup>e</sup>  
kyng & y<sup>e</sup> quene they stode stedfastly allways & nede not to be

The parlyament endyd aboute y<sup>e</sup> xxij.<sup>2</sup> day of Januarie.

Vpon Fryday, beyng y<sup>e</sup> xxv. day of Januarie, generall procession<sup>3</sup>  
was through Chepesyde downe y<sup>e</sup> one and vp thothar, y<sup>e</sup> byshope  
of London, w<sup>t</sup> many ohtar bysshopes, beyng mytryd, & y<sup>e</sup> byshope  
of London goynge vndar a canapie: and at nyght by y<sup>e</sup> comaunde-  
ment of y<sup>e</sup> lord mayre & y<sup>e</sup> aldarmen bonefyars were made thrwge  
out y<sup>e</sup> hole citie w<sup>t</sup> bells ryngynge solomly; all whiche thyngs wer  
done for Joye of y<sup>e</sup> restorynge of y<sup>e</sup> trewe & catholyke relygyon,  
and for y<sup>e</sup> abolysshment of schismes and heresyas.

Vpon Monday, beyng y<sup>e</sup> fowrthe of Februarie, one [John]<sup>4</sup>  
Rodgers, vycar of sent Sepulchres, was burnyd in Smythefelde.

Vpon Monday, beyng y<sup>e</sup> 18 of Februarie, y<sup>e</sup> byshope of Ely, callyd doctour Hethe,<sup>1</sup> w<sup>t</sup> y<sup>e</sup> vycounte Broune,<sup>2</sup> and dyvers othar well apparyld rode forthe of y<sup>e</sup> citie towards Rome.<sup>3</sup>

Vpon Thursedaye in y<sup>e</sup> night, beyng y<sup>e</sup> xiiij. of Marche, y<sup>e</sup> Image of a byshope,<sup>4</sup> whiche was newly sett vp of late ovar y<sup>e</sup> dore of sent Thomas of Acars, was shamefully mangled, y<sup>e</sup> heade & y<sup>e</sup> ryght arme beyng cleane smyttyn of : y<sup>e</sup> whiche Image ones before this tyme had y<sup>e</sup> hede lykewyse stryken of, and was aftarwarde newly set vp, and nowe eft sones broken.

Vpon Saterdag in y<sup>e</sup> mornynge, beyng y<sup>e</sup> xvj. day of Marche, a wevar whiche dwellyd in Shordyche was burned in Smythefylde for heresy.<sup>5</sup>

Vpon Eastarday, beyng y<sup>e</sup> xiiij. day of Aprill, 1555, a certayne desperate person w<sup>t</sup> a wood knyffe woundyd a priste, as he was mynestryng the sacrament in sent Margaretes church at Westmystar, vnto y<sup>e</sup> people : of whiche wounde y<sup>e</sup> pryest was in great daunger of deathe, the church of sent Margaretis was imedyatly shut in, and no more servyce don.<sup>6</sup>

Vpon sent Marks even, beyng Wednesday & y<sup>e</sup> xxiiij. day of Aprell, y<sup>e</sup> sayd desperate persone, whiche hurte y<sup>e</sup> priest at Westmystar, was burnyd for heresy at Westmystar in sent Margaretes church yarde.

Vpon Tewesdaye, beyng y<sup>e</sup> vij. day of Maye, a certayn lewd heretyke called Tolly,<sup>7</sup> a pultar, who aboute x. days past had bene hangyd for robberye, & had ben buryed betwen Charinge crosse &

1547-1564

K. Edward the 6. Hobilthor.<sup>1</sup> mayor

A° 2.

This yere the kynges ship named the menyon did take a grete spaynysh shyp in the nare sease mannyd weth scott & halff ladyn w<sup>th</sup> costly goods.

The 15 day of May doctor Smyth<sup>2</sup> of Oxforde, y<sup>t</sup> did rede the dyvynite lector at Whitingdon colege, did recant at Poulis crosse.

Doctor Langriche,<sup>3</sup> archdeacon of Cleffand in Yorkeshire, did willfully lepe out of the cloyster of saint Magnus into the Temse, willfully drownyd hymself yn y<sup>e</sup> month of May.

A° 2° J. Gressam,<sup>4</sup> mayor.

In the latter end of Januarii was soche vehement windes that damaged sore the western barges, & y<sup>e</sup> lade barges from London to Grauysende to London: a grocer of this citie, his wyfe, his seruant all were drownyd in a whery, sauynge the seruant & one of y<sup>e</sup> whery men.

In the latter ende Februarii one of the kynges bregendynes did

take in the nare sease a frenche galeye, browght her into the ryuer of Temse.

In the sermons at saynt Mary Spittel the prechars invayed agaynst the masse. <sup>1</sup>

In June the bysshop of Winchester was comytted to y<sup>e</sup> Towre.

### A<sup>o</sup> 3. Hamcott, <sup>2</sup> mayor.

Ther were dyuerse rebellions yn sondry placis of y<sup>e</sup> realme : the mayor & citizens of Exciter manfully kept y<sup>e</sup> city from the rebelles of Deuonshire, till thei w<sup>t</sup> in were almost famyshed.

This yere was partyes put yn by the nobilite of this realme for the safegard of the kinges royall person, but praysed be God it was gentilly quieted.

500 souldiers of Arde <sup>3</sup> com nere to Guysnes purposyng to had a great boty of catell ; but ther were resisted by the men of Guysnes, & of y<sup>e</sup> men were 50 prisoners takyn, and 103 of them slayne.

### Hill, mayor.

A<sup>o</sup> 4<sup>o</sup> trynnyte terme was reiournyd to myhelmas, ffor that the gentylnen shuld kepe the people quyete w<sup>t</sup> owt comosion. This mayor was a gode mynystre of Justice, & a grete ponysshre of adultery.

In a<sup>o</sup> 5 be reson that o<sup>r</sup> mony was so base the exchange to Andwarp was vnder 17 s. the li.

In May there cam a hoie to London w<sup>t</sup> Holond chese, whiche was solde for 2 d the lb., and that after the rate of Essex chese vj. s. the way.

## Quene Mary.

When the bisshop of Win., chaunceler, did mynyster the othe to Justices of this realme he wolde not mynyster to Justice Halis,<sup>1</sup> ffor he sayde he had to talke w<sup>t</sup> him in maters of religion.

The ix. of September y<sup>e</sup> archebyshop of Cauntorbery and M<sup>r</sup> Latymer wer comytted prisoners to the Tower.

## T. Whight, mayor.

A<sup>o</sup> 1<sup>o</sup>. the 13 of Nouember the lady Jane, before proclaymyd qwene, & the archebyssshop of Cauntorbery wer araigned at the gwyld hall ffor treson, & shortly after she was beheded at the Tower hill.

In Feuerer the archebyssshop of Cauntorbery, doctor Ridleye, & M<sup>r</sup> Latymer were remouyd from the Tower to Oxford.

Ironmonger.<sup>2</sup>

In Marche died Julius,<sup>3</sup> bisshop of Rome, for whom y<sup>e</sup> qwene caused a solem funerall seruice to be done at Powlis.

In the iij. yere the qwen did remyt the first frute of X<sup>th</sup>s.

Garett,<sup>4</sup> mayor.

Doctor Gardynar, bisshop of Winchester & chaunceler died.

v. Shipes of Brystow ladin w<sup>t</sup> marchandise owt of Spayne were takyn by 7 ships of war of Fraunce.

In the tyme of the raigne of this qwene there were burnyd, and som also that died in prison for religion, lityll vnder or ouer 2040 men & women.

In the begynnyng of Julii iij. shipes of this citey comyng from Andwarp ladin w<sup>t</sup> riche marchandise were takyn by Scottes and Frenchemen, whiche were estemyd to be better worth than 20000 li.

## Hewet, mayor.

A<sup>o</sup> 2<sup>o</sup> the qwene did send ij. of her ships to the see to take a pirate namyd Strangwysh,<sup>2</sup> who w<sup>t</sup> his ij. ships & ij. other capitaynes w<sup>t</sup> owt makyng of any resistance did yelde.

## Chestar.

There was so grete scarsety of corne that y<sup>e</sup> mayor & citizens made prouyson for wheat & rye 30000 q<sup>rs</sup> from beyond the se.

## Harpour, mayor.

The occasion whervppon the qwene did send to New hauyn was the lorde Vidame, capitayne of New hauyn, & the bayly of Roen,<sup>3</sup> the treasurer of Deep<sup>4</sup> offered the forsayde townys to the qwenes

### Lodge, mayor.

A<sup>o</sup> 5<sup>o</sup> in Marche all the English marchantes w<sup>t</sup> ther goodes & shipes wer arested al Burdeus.

The men of Plymmoth did take 14 brettysse ships w<sup>t</sup> salt & wyne.

The men of Seaton & legis from the towne of Deepe did take 15 crayers to New hauyn w<sup>t</sup> vitayll at sondry tymes.

A man of Plymmoth namyd Hawkins, <sup>2</sup> did take a French ship comyng from Gynys wholely ladyn.

A crayer of Rye w<sup>t</sup> 30 men in her did take a ship in Deep rode, & if there had bene more men they might haue takyn one other ship.

A passenger of Douer sayling to Dunkirk was takyn by a hayne of Diepe comyng owt of Cales, & conuayed to Calies, & there put them to their ransom.

The forsayde hayne was well knowen to y<sup>e</sup> men of Douer, that he was a comen saylor betwene Diepe and Cales : Thes men of Douer w<sup>t</sup> a crayer well mannyd lay in wayte for hym shortly after betwen Bolen and Cales, & did take him ladyn w<sup>t</sup> canuas & hows-olde stuff to Dales, whiche was to them a gode recompence.

In this somer did fall so greate aboundance of rayne in Zeland that hops were so scant that they were solde in London for liij. s. iiij. d. the C. ; & some bere breuars practised to brew w<sup>t</sup> brome & some w<sup>t</sup> bay beries.

### John Whight, mayor.

to hasty, ther myght have takyn many mo : the brytons had 4 men of warre for theirre waffters, but whan thei did see so grete a flete of englyshe men of war they fled.

A<sup>o</sup> 6, in the begynnyng of December was so greate lyghtenyng & horrible thonder that the lyke was not seen w<sup>t</sup> the remembrance of any man lyuyng.<sup>1</sup>

Remember the monstrous fysshe.<sup>2</sup>

In the month of July sesed the plage, that did begin the last yere.

In the 30 day of August it was enacted that all soche as wolde sell their waris, plate or howsold stuff to theirre most aduantage, for the paying of o<sup>r</sup> dettes or elles for the fordell of orphans, sholde bring the same waris &c. to Ledyn hall on Monday & Friday, there to be solde to them that wolde gyue most for it.<sup>3</sup>

In this yere was browght to y<sup>e</sup> citie great plente of frute, for ther cam in one market in to Southwark<sup>4</sup> cartes w<sup>t</sup> frute, in to Graschirche strete xiiij. cartes, besids a greate qwantytie that was browght on horsbacke, in panyers and dossars : this contynuyd the moste parte of the somer.
