The Vermont Society of Colonial Dames has been saddened by the passing of two recording secretaries during the calendar year of 1977 -- Florence Howard Lawson on January 28th and Frances Morrison Weston, October 25th. We mourn the loss of two devoted members and we dedicate this annual report in their memory.

The annual meeting of the Board of Management was held in a room off the lobby at Middlebury Inn at 2 p.m. on September 14, 1977 with ten members answering the roll call conducted by Mrs. Walter Adams, First Vice-President. Mrs. Harold Durgin presided at the meeting.

The reports of officers followed, all were accepted as read and corrected.

The Treasurer, Mrs. H. E. Whitney, reported total assets of \$1,938.90 as of July 1, 1977. The Auditor's report showed all accounts in good order.

Motion by Mrs. Simonds, seconded and passed, that all of these names be accepted.

The usual Index has been secured by the Librarian and placed in the library at Montpelier.

A book entitled "Independence Must Be Won" by Phillip Viereck is to be placed in the library at Cornwall. It is written in a way that is within the understanding of children.

Voted to reimburse Mrs. Lois Burke for this book.

Index to Knowlton Genealogy, 1897, Charles Stocking, to be purchased at a cost of about \$25.

Mrs. Altorfer made the motion, voted and passed that a book be placed in Brooks Memorial Library in Brattleboro in memory of Florence Lawson, Mrs. Simonds to choose the book.

Mrs. Simonds recommended that the President and Treasurer decide matters concerning the Savings accounts.

Mrs. Altorfer moved that a new record book for the secretary be secured and so voted.

Mrs. Simonds moved that each year the list of elected officers be sent to the Hereditary Register in Phoenix, Arizona before October 20 and so voted. This was done immediately following this meeting.

A delightful tea was held in the spacious home of Mrs. Chester Way, Court Square, at 3:30 p.m. We are all grateful to a most gracious hostess.

At 6:30 p.m., we partook of a most delicious banquet at Middlebury Inn. Following the banquet, Prof. Glenn M. Andres of Middlebury College presented a program concerning the history of the town of Middlebury and the architectural designs of many of its early dwellings, illustrated with slides.

The 80th annual and business meeting of the Society was held at Middlebury Inn on September 15, 1977, the President, Mrs. Harold Durgin, presiding, at 9:30 a.m. The invocation was offered by Mrs. Stuart Simonds and the Pledge of Allegiance by Mrs. Albert F. Gollnick, Sr. Mr. David Beach, Manager of the Inn, welcomed the group and Mrs. Chester Way responded.

The Credentials Committee reported 27 members present. The meeting adjourned at about 11:00 a.m. when some of the members went on to the DAR State Conference in Burlington.
