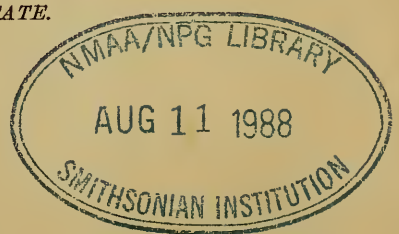

Wilstach, it is provided that if our daughter, Anna Gertrude Wilstach, should die before me, leaving no child, nor the issue of any child, to survive her, that then his estate shall be paid and disposed of as I shall by my last will and testament appoint; and as it has pleased God to remove our dear daughter, Anna Gertrude, from this life, leaving no child to survive her, nor issue of any child, Be it remembered that, by virtue of the said power so given to me, and in exercise thereof, and by force and virtue of every other power and right me enabling, I, Anna H. Wilstach, of the city of Philadelphia, do hereby make this my last will and testament, and revoke all other wills by me heretofore made, and do hereby appoint and dispose of all the estate of the said William P. Wilstach, deceased, and all my own estate and all the estate I have the power to will, as follows:

I give and bequeath unto my niece, Laura H. Dade, my largest solitaire diamond ear-rings and diamond bracelet, also my pearl-colored satin dress and point lace trimmings and shawl and parasol, fan and cape; all of which are of the same pattern, with monogram "A. H. W.;" I also give and bequeath to her the sum of one thousand dollars.

I give and bequeath unto my niece, Emma F. Henderson, my cluster diamond brooch; my diamond ring, containing three diamonds; my cameo ear-rings and brooch; my camel's square hair shawl, scarlet centre, small border; and I also give and bequeath to her the sum of one thousand dollars.

to erect a secure Art Gallery in said park for the exhibition of pictures and works in the Fine Arts, on a plan similar to the new building for such exhibition at Dresden in Saxony, to be so built as to admit of extension with the increase of funds without impairing the harmony of the edifice or destruction of any portion of the original building; but if there should be a suitable permanent building left in said park after the Centennial celebration of 1876, in which pictures mentioned below may be received and preserved distinctly from other collections, so as to be known as the "Wilstach Collection," then the erection of another building may be omitted, and donations shall be accepted for said collection, and invited by the said Commissioners. To the said

city, but to be under the custody and control of the said Fairmount Park Commissioners, I also direct all my paintings, pictures and statuary, including those of my late husband, to be given and transferred to the said city for said purposes and placed in the "Wilstach Collection." Their exhibition shall be public, under regulations to be established by the said Fairmount Park Commissioners; and as soon as practicable shall be gratuitous, and the opening thereof shall be as soon after my decease as a gallery can be provided for their reception.

All the said fourth of said residuary estates not expended in erecting such hall of art, and the whole if no such hall shall be required to be built out of said fund, shall be kept invested in lawful investments by the said Fairmount Park Commissioners, subject to the jurisdiction of the courts having control of testamentary trusts; and the income thereof shall be by them applied to the purchase of pictures, paintings and statuary for said collection, always keeping in view the purpose of obtaining objects of the highest skill and beauty, that they may be the source of pleasure and the means of cultivation and refinement of the tastes of the people, be pure in sentiment, and never minister to vulgarity and vice.

Provided, however, that if the principal should exceed the sum of one hundred thousand dollars, then the excess over that sum may be used for the purchase of works of art. I direct my executors to

require from the said Fairmount Park Commissioners, in this behalf acting for the city of Philadelphia, to take their receipt, and resolutions promising a compliance with these terms and conditions.

The remaining one fourth part of the said trust estates I direct to be paid as follows :

[*Item.*—*One tenth part thereof to be divided between the children of my late husband's uncle, Dr. Charles F. Wilstach, and the children of his aunt, Johanna Dungan, each child to take an equal amount one with another, share and share alike ; the issue of such of them as may be deceased to take such share equally as his, her or their parent would have taken had he, she or they been living.*]

[*Item.*—*One other tenth part thereof to be divided between the following societies and organizations, namely, " The Union Benevolent Association of Philadelphia," " The Indigent Widows' and single Women's Society," now located on Cherry St. near Eighteenth St., The School of Design for Women, now located at the southwest corner of Filbert and West Penn Square, The Academy of Natural Sciences of Philadelphia, now located at the corner of Broad and Sansom streets, city of Philadelphia, The Baptist Missionary Union for foreign missions, The Baptist Home Missionary Society in the United States of America, The Baptist Publication Society, The Evangelical Society of la grand Lign, prov-*

SECOND CODICIL.

Dated June 9, 1876.

I Anna H. Wilstach do make this as a codicil to my last will and testament.

Item 1.—I direct my Executors to pay my funeral expenses and also to have my burial lot at South Laurel Hill put in perfect order and to have erected suitable stones, and inscriptions carved on the monument which is already there, the expense thus incurred to be paid from the funds of my estate, and in addition thereto I give and bequeath to Conrad B. Day in trust, the sum of one thousand dollars (\$1000) to invest in undoubted security, the interest of which he is to use for the purpose of keeping in repair the said lot at South Laurel Hill, and upon the death of Conrad B. Day I give to the Pennsylvania Company for Insurances on lives and granting Annuities the care of said investment of one thousand dollars, and direct that they expend the interest of the same for the aforesaid purpose of keeping in repair my said lot and improvements at South Laurel Hill.

There is no collateral inheritance tax on this Item.

Item 2.—I give and bequeath to the Picture Gallery which shall become the legatee of the bequest designated in my will "second one fourth part of my estate" all my books on Art, and books containing works of Art, engravings Photographs including my "Dresden Gallery" also all catalogues of various galleries in Europe, and this country, all to be kept with the "Wilstach collection."

Item 3.—I give and bequeath to my maid Lettie Gibson two hundred dollars in addition, to the legacy of one hundred dollars, already bequeathed to her.

Item 4.—[*I direct that the Legacy of five thousand dollars, which I have directed in my will, to be paid to William Miller is to be so paid on condition that his deportment be such as to enable me to keep him in my employ until the time of my death; and I further direct that said legacy of \$5000, shall not be paid to him until one year after my decease and then, on condition of his being a member of a Total Abstinence Society: otherwise the said five thousand dollars, shall be a part of my residuary estate:*] I further direct that any sums of money owing to me by William Miller at the time of my decease, may be a free gift to him.

THIRD CODICIL.

I give and bequeath to Lettie Gibson now living with me the sum of five thousand dollars, \$5000, I give and bequeath to Andrew Volkert now living with me, four thousand dollars, \$4000, [*and to Mary Fin I give two hundred, \$200*], all on condition of good conduct and faithfulness to me on their part while I live. I direct that my residence No. 1733 Walnut Street, Philadelphia be in the care of my niece Mary C. Griffith, for a suitable period after my death, and that she, with my nephew Richard H. Griffith, superintend the removal of the furniture (in the house at the time of my death) for auction or otherwise, as I do not wish a sale on the premises, And to see that the premises are in good condition, my executors to pay all expenses. I confirm my said will, except as altered by my codicils. Witness my hand and seal this first day of August 1881.

FIFTH CODICIL.

Dated February 13, 1883.

This is a codicil to my last will & testament, which is dated the 31st day of July, A.D. 1873.

Item 1st.—In my codicil, dated 9th day of June, 1876, item first, I direct my executors to put my lot, with improvements, at Laurel Hill in perfect order, and to have erected suitable stones, etc. I now, in this my codicil, direct that if the monument or stones in said lot at Laurel Hill become in any way defaced or imperfect, it is my will that they be replaced by perfect stones, & that the monument shall be of a substantial material upon which the weather will not have a damaging effect. It may be that granite will be the most suitable, as requiring less attention in the future. The expense of these improvements to be paid from my estate—in no way interfering with with the one thousand dollars directed to be invested as a permanent fund; the interest to be used for the purpose of keeping lot and stones in perfect repair.

I am informed that the collateral inheritance tax is not applicable when money is left for the care & improvement of burial lots.

The erasure on this line is made by myself on this date.

Item 2d.—Having, during my life, built a church as a memorial of my daughter Anna Gertrude Wilstach, I now direct my said trustees to appropriate, as an endowment fund, the amount intended to build said memorial church, as directed in my will dated 31st of July, 1873, namely—The one 10th parts of the remaining one fourth part of the said trust estate, the interest thereof to be expended for the benefit & use of said Memorial Chapel, situated at the southwest corner of Spruce & 22d streets, in the city of Philadelphia.

Item 3d.—I give and bequeath to Conrad B. Day, in addition to the legacy already bequeathed to him, the sum of twenty thousand dollars.



Item 4th.—I give and bequeath to Walter Shipley and to Alice Shipley, son and daughter of my friend Thomas Shipley, one thousand dollars each.

Item 5th.—To Gertrude Wilstach Henderson, daughter of William H. & Adelaide B. Henderson, I give and bequeath one thousand dollars.

The erasure on this line is made by myself on this date.

Item 6th.—If either of the intended legatees of this my will shall die during my life, as has my sister Martha J. Chilton & Daniel P. Bussier, I direct the legacies intended for such legatees, had they survived me, to remain as a part of my estate, to be distributed by my Executors as such.

Item 7th.—If any one shall attempt to break my will or shall interfere with the provisions, or *attempt* to interfere with them, directly or indirectly, or will endeavor to defeat the intentions of the testator of it, I direct that any such person or persons shall forfeit any and all right to any legacy intended for them, & which they would otherwise have received. It shall be as though their name or names had not been mentioned in my said will.

Item 8th.—I ratify and confirm my last will and testament, dated 31st day of July, 1873, except so far as I may have by any codicil or codicils altered the same; & I confirm my codicils of different dates by me made.

Item 9th.—I ratify and confirm the appointment of Conrad B. Day as my executor, and, in the place of the Rev. James Wheaton Smith, who was named in my will as one of my executors, [*I now appoint John G. Reading, now residing at No. 2226 Walnut Street, in the city of Philadelphia, to be my executor in the place of said James Wheaton Smith, my executors now being Conrad B. Day & John G. Reading, both*] residents of the city of Philadelphia, state of Pennsylvania.

SIXTH CODICIL.

Dated April 29, 1886.

This is a codicil

To my last Will and Testament, which is dated July 31st, 1873. In said will I directed my executors to appropriate an amount sufficient to build a Protestant Episcopal Church, as a Memorial of my daughter Anna Gertrude Wilstach, unless, during my life, I should build it myself. In a Codicil to said will, dated the 13th day of February, 1883, Item 2, I stated having built said church, thus making the bequest in my will, dated July 31st, 1873, for that purpose, null and void, I directed that the interest of one 10th parts of the remaining one fourth part of said trust estate referred to, is to be expended for the benefit and use of said Memorial Chapel. Desiring to further endow the said the Holy Trinity Memorial Chapel, to secure for it future aid towards its support, I give and bequeath to the Girard Life Insurance Annuity and Trust Company of Philadelphia the sum of one hundred thousand dollars in trust, and also give to the same company, the Girard Life Insurance & Trust Company of Philadelphia, to hold in trust the bequest before-mentioned, of the one 10th parts of the remaining one fourth part of the said trust estate, to invest and keep invested the same, and after deducting commissions therefrom, ^{the} said commissions not to exceed two and one half per cent., ^{to} pay the interest thereof to the churchwardens & vestrymen of the Church of the Holy Trinity, who now have the care of the Chapel—so long as they continue to control its temporal affairs. If their care & control ceases, then to the Wardens and Vestrymen who shall be appointed to succeed them as officers of the Memorial Chapel; said interest is to be used in payment of the salary of the Clergyman who shall officiate at the Chapel stately, and for other necessary expences of said Memorial Chapel; said interest is to be paid semi-annually. I prefer that the Clergyman who shall officiate at the Chapel shall be entirely independent in ecclesiastical work of the Chapel, as are the Rectors of other Episcopal Churches, subject for advice

& aid to the Wardens of the Church of the Holy Trinity, unless the Chapel shall at some future time become an independent Church. I prefer that so long as the present Wardens & Vestrymen live—they will continue to have the care—as they have in the past. I direct the collateral inheritance tax on the foregoing bequests to be paid out of my residuary estate.

Will

In my \wedge dated 31 of July, 1873, I made a bequest to the Beth Eden Baptist Church to aid in extinguishing its debt. Since that time I have given to said Church the amount needed to extinguish the then remaining indebtedness. I hereby annul the legacy made to the Beth Eden Baptist Church.

I hereby annul the legacy of \$200 to Mary Fin. I direct that in every instance of the removal by death, during my life, of any to whom I have bequeathed legacies, annuities, &c., the Principal of all such bequests shall be distributed by my *executors as a part of my residuary estate.*

As the bequests to my nephew Robert J. Henderson are inoperative for the above reason, namely, because of his death during my life, I desire to make provision for his children who may survive me. For this purpose I give & bequeath to Thomas Shipley (who is the Trustee of my fathers estate), and at his death to the Pennsylvania Company for Insurances on Lives & Granting Annuities, the care, as Trustee, of thirty thousand dollars, to invest and to keep invested the same, and after deducting commissions, said commissions not to exceed two and one half per cent., to pay for the use of the children of Robert J. Henderson who shall survive me, share & share alike, the interest of said \$30,000. The yearly interest to be paid half yearly, without deduction of the Collateral inheritance taxes, said taxes to be taken from my residuary estate. If either of these legatees have attained the age of 21

years, or as they shall attain that age, the share of \wedge any such an one shall be paid to him or her, or any one whom they may delegate to receive it.

I direct that Harris J. Chilton is to deduct from and pay out of the bequests which I have made to him, six hundred dollars per annum to his wife, Annie H. Chilton, for her separate use, each year that she shall live, to be paid to her half-yearly.

I give and bequeath to Lettie Gibson, who now is living with me, seven hundred dollars, which in addition to what I have already bequeath'd to her will make six thousand dollars. I give and bequeath to Andrew Volkert, who is now living with me, one thousand dollars, which in addition to what I have already bequeath'd to him will make five thousand dollars; both of these bequests on condition of good conduct & faithfulness to me while I live. I direct that the collateral inheritance taxes on all the foregoing bequests, and on all future bequests to individuals or persons, shall be paid out of my residuary estate.

In a codicil to my will, said codicil being dated 9th day of June, 1876, I directed that the \$5000 bequeath'd to William Miller be paid on certain conditions named. I now annul that bequest to William Miller, and instead thereof bequeath to him \$100 if he shall outlive me.

In my will dated 31st day of July, 1873, I directed that as often as either of the annuitants for whom provision was made shall die, then the Principal from which his or her annuity is derived (that is to say, the sum of which the annual sum is the interest) shall be given to & equally divided between certain legatees which I then named. In the years since these bequests in my said will were made, several of the legatees have died, and as a consequence the amount of Principal resulting therefrom is very much larger than when the will was made—or than I supposed it would be when I made provision for the disbursement of the Principal derived, on account of the death of the annuitants. Many of the societies & associations named in this Item in my codicil are provided for later in my will & codicils. I now annul the Item disposing of the Principal from

which the annuities to deceased legaties is derived—and direct my executors to incorporate it into, and as a part of my residuary estate.

I give and bequeath to the Trustees of the Philadelphia Protestant Episcopal City Mission \$12,000 to enable those having charge of the Home for Consumptives to erect and furnish a Cottage for the use of Consumptives, upon ground donated by William Bucknell, Esqr., at Chestnut Hill, unless during my life I build a Cottage for that purpose. I give for the use of said Home \$1000.

I give to St. Christopher's Hospital for Children \$1000.

I give to the Children's Hospital, situated on 22d. Street below Walnut, \$1000.

I give to the Protestant Episcopal Hospital in Philadelphia \$5000.

I give to the Industrial Home for Girls, now situated on South 10th street, of which Samuel C. Perkins, Esq., is now the president, \$1000.

I give to the Young Men's Christian Association of Philadelphia \$10,000.

I give to the Womans Christian Association of Philadelphia \$1000.

I give to the Pennsylvania Industrial Home for blind women \$1000.

I hereby annul the bequest to the Evangelical Society of La Grand Lign, in the province of Quebec, Canada.

As the health of my friend John G. Reading has become somewhat impaired, probably from overwork, I decide to

relieve him of additional care, and therefore appoint the Pennsylvania Company for Insurances on Lives and Granting Annuities to be executor in the place of Mr. Reading, with Mr. Conrad B. Day, who was my first appointee. My executors now are Conrad B. Day and the Pennsylvania Company for Insurances on Lives and Granting Annuities. I ratify and confirm my said last will and testament dated 31st of July, 1873, except so far as I may have altered, by any codicil or codicils, the same. And I ratify and confirm any codicil or codicils by me heretofore made. Witness my hand and seal this twenty-ninth day of April, A.D. one thousand eight hundred and eighty-six, 1886.

SEVENTH CODICIL.

Dated March 7, 1890.

This is a Codicil to my last will and testament which is dated the 31st day of July, A.D. 1873. After my will was made, Eli K. Price, Esqr., advised me not to make another will, But to make codicils thereunto, as I may consider requisite, because of changes which may occur after my will was made, or for any alterations I may desire to make. I believe, he was considered good authority. I now add another, to those already made.

Since my will was made, partial and in some instances entire, changes have been made in the organization of many of the Societies & charitable institutions named in my said Will. On Page 10 item styled, "The one other tenth part of the one fourth part," is composed of bequests to various charities. I now *annul*, the bequest in this item, preferring to change, in some instances, the character, of the bequests. On Page 8. my Will reads, "remainder of said estate, & estates including the estate of the said W. P. Wilstach deceased, or residue thereof, my executors shall pay apply and dispose of in manner following. That is to say, one fourth part thereof, to one Institution, and one other, fourth part thereof, to another. I now *annul*, these bequests, preferring to bequeath fixed amounts to legatees. And I direct, that the share of my estate, intended in my Will of 1873, to be expended in payment of these bequests, being the "one fourth part of the remainder," before referred to, shall be used in payment of future bequests to various charities & other objects, some of which, I will now designate. I give and bequeath to the Contributors to The Pennsylvania Hospital of Philadelphia, Ten thousand dollars. To the Apprentices Library Company of Philadelphia, Ten thousand dollars. To The Union Benevolent Association of Philadelphia Ten thousand dollars. To The Protestant Episcopal Mission of St. Simeon, located at the N. W. cor. of Lehigh Avenue & 9th street. In the care of the Rev. Edgar Cope, To augment the fund subscribed, for the erection of a

church as a Memorial, of the late Bishop Stevens, Ten thousand dollars. If sufficient in amount, be subscribed for this purpose, namely the building fund, before this bequest becomes operative, I direct that it be used for other departments of the church work of St. Simeon.

I direct that provision be made for payment of these and other bequests, out of the funds resulting from changes made by Codicil on Page 8. of my Will 1873. And by *annulling* the payment of, "one other tenth part," on Page 10, second item and from sources, because of changes, made by codicil or codicils. I desire to emphasize the item, in my codicil of April 9th [29] 1886, in which I *annul* former bequests in my will dated July 31st 1873. on Page 7. to certain legatees. I direct my Executors to incorporate *all principal* derived from bequests to *deceased legatees*, into, and, as a *part* of the *general*, fund of my estate, which may be in my possession at the time of my death. I direct that the collateral inheritance tax on the foregoing bequests shall be paid out of my residuary estate.

I give to the Home Missionary Society of Philadelphia, on Arch Street below 6th \$9000, which in addition to \$1000, bequeathed to it, in my will of 1873, will make Ten thousand dollars. The *interest*, of which, is to be expended for the use of the society, under the direction of W. H. Lucas Esqr, who is its Treasurer. I give to the School of Design for Women, at the Cor. of Broad & Master streets, five thousand dollars. I give to the Home for Incurables, at 48th & Woodland Avenue, \$5000. I give to the Bedford Street Mission \$1000; to the Moyamensing Soup Society \$1000. to the Kensington Soup Society \$1000. I give to The Hahnemann Hospital, the President, of which is the Hon. W. B. Hanna, Ten Thousand dollars. I give to the Sunday Schools of the Holy Trinity Memorial Chapel, to increase their efficiency, Five thousand dollars. I give to the Southern Home for destitute children \$5000, to the Church Dispensary of Southwark \$1000. to the University Hospital \$5000. to the Industrial Home for Blind Women, Powelton & Sanders Aves. \$4000. which, in addition

to \$1000 bequeathed in my codicil April 9th [29] 1886, will make Five thousand dollars. I give to the Working Home for Blind Men, 31st & Lancaster, \$5000. I give to the Hospital of the Protestant Episcopal Church, Front Street & Lehigh Avenue, \$5000, which in addition to \$5000 devised by codicil, April 9th [29] 1886, will make Ten thousand dollars. I give to the Home for Aged Couples, at Francis near 17th street, \$2000. I give to the Church Home for Children, situated at Baltimore Avenue, and Grey's Lane, \$5000. I give to The Home of the Merciful Saviour for crippled children, No. 440 Baltimore Avenue, in the care of Mrs. Robert Innes, Ten thousand dollars. To the Poor fund of the Church of The Holy Trinity, \$500. I direct that the collateral inheritance tax on the foregoing bequests be paid out of my residuary estate. +

Item.—I confirm the item on Page 5 in my will, dated July 31st, 1873, appointing the Pennsylvania Company for Insurances on Lives and Granting Annuities Trustee, to take the care of the Annuities to my Nieces & Nephews. The only change being the addition of eight hundred dollars per annum to each of them (with the exception of Mary C. Griffith), to whom *was* bequeathed in my Will of 1873 \$1200. As it *now* is, I give to Laura H. Dade, & to Emma F. Henderson, & to Gertrude Henderson, children of my brother Samuel J. Henderson, and to each of the children of Mary H. Bussier, namely, Anna Shumway & Adelaide Henderson, and to each of the children of Sarah Griffith, namely, Alfred P., Samuel H., Warren G., & Mary C. Griffith, twelve hundred dollars per annum. This to Mary C. Griffith does not change *her* bequest, but makes the others equal in amount to what she had before. I give to each of the children of M. J. Chilton, namely, Harris J. & Anna Chilton, twelve hundred dollars per annum to each of my said nieces & nephews, for & during their natural lives, which I direct shall be paid semi-annually, without deductions for collateral inheritance taxes; said taxes to be paid out of my residuary estate. I annul the item on Page 7, in my will of July 31st, 1873, disposing of the principal derived, on account +

 of the death of the annuitants, of the bequests last named, and direct that, as often as either of the said annuitants die, then the principal from which his or her annuity is derived, that is to say, the sum of which the said annual sum is the yearly interest, shall be given to & equally divided between The Philadelphia School of Design, The Hospital of the Protestant Episcopal Church, The Protestant Episcopal City Mission, for the use of The Home for Consumptives, the Memorial Chapel at the S. W. Cor. Spruce and 22d streets, & The Pennsylvania Hospital at Pine & 8th.

Item.—I give and bequeath to Ralph Henderson, son of my nephew Robert J. Henderson, Ten Thousand dollars. I give to each of the children of my niece Anna Shumway, namely, Daniel, Harry, Edward & Carrie, and to each of the children of my niece Adelaide Henderson, namely, William, George, Louisa & Gertrude W., one thousand dollars. This to Gertrude is in addition to \$1000 bequeathed to her in my codicil of Feby., 1883. And if it happen that she comes in possession of these bequests before she attains the age of twenty years, I desire her Mother to invest the same, & to use the interest thereof for her use. I direct that the collateral inheritance tax on the foregoing bequests be paid out of my residuary estate.

Item.—I give & bequeath to Andrew Volkert, now living with me, sufficient, in addition to bequests I have already made to him, to make my entire bequest to him six thousand dollars, on condition of good conduct & faithfulness to me while I live. Otherwise, this bequest reverts to my general estate. I direct that the collateral inheritance tax on this bequest be paid out of my residuary estate.

Item.—I give & bequeath to Annie H. Chilton, wife of Harris J. Chilton, of Baltimore, Md., for her own use, ten thousand dollars, without deduction for collateral inheritance tax; said tax to be paid out of my residuary estate.

Item.—I give to Lettie Gibson, now living with me, sufficient, in addition to what I have already bequeathed to her, to make the entire bequest seven thousand dollars, on condition of good conduct and faithfulness to me while I live. I direct that the collateral inheritance tax on the foregoing bequest be paid out of my residuary estate.

I desire that my executors kindly advise Lettie Gibson in the management of the legacy to her. It may be well to transfer to her seven thousand dollars, already invested in good & safe securities, as she has no experience in investing. I desire her to retain this principal of \$7000, using the interest only. This, of course, is optional with herself.

Item.—I direct all bequests made to my nephew Harris J. Chilton & my niece Anna Chilton are to be paid to them in annuities; the principal being bequests made in my will & codicils. I direct my executors to give to The Girard Life Insurance, Annuity and Trust Company of Philadelphia, in trust, the Principal of each bequest, to my said nephew & niece, Harris J. & Anna Chilton, the said bequests to be separate one from the other. They, the said company, to invest and keep invested in safe securities the Principal of all bequests I have made to them, and to pay to each of them the interest of his or her Principal semi-annually, after having deducted therefrom commissions; said commissions not to exceed two and one half per cent. I direct that the said Harris J. and Anna Chilton are to have the power to *dispose of*, by *will*, the *Principal* from which these annuities are derived. I direct that the collateral inheritance tax on the foregoing, if not already so ordered, shall be paid out of my residuary estate.

Item.—I direct my residence, No. 1733 Walnut Street, to be occupied, for at least a few months after my decease. If my niece, Mary C. Griffith, or my niece, Anna Chilton, or *both* nieces desire to reside in it some months after my decease, it is my wish that they do so; and that Lettie Gibson & Andrew Volkert have an oversight of the premises; and after a suitable

length of time has elapsed, I wish the furniture to be removed, under the supervision of my nieces & Lettie & Andrew, for sale by auction. I do not wish a public sale on the premises. I also wish them to see that the premises are in *good condition*; my executors to defray the expense thereof.

Item.—After mature deliberation, I have decided it best for The Holy Trinity Memorial Chapel to have, as far as possible, a fixed amount to aid in its support. And to that end I *annul* the item in my will, dated July 31st, 1873, on Page 11, designated “the five one tenth parts of the one fourth part,” and *instead thereof*, I direct my Executors to pay to The Girard Life Insurance, Annuity and Trust Company of Philadelphia, to hold in trust, the bequest of one hundred and fifty thousand dollars. The said company to keep *invested* the same. Which, in addition to one hundred thousand dollars already bequeathed to said company, for the use of the said Chapel, by codicil dated April 9th [29], 1886, will make two hundred and fifty thousand dollars. The said company to keep these bequests invested; and after deducting commissions therefrom, the said commissions not to exceed two & one half per cent., to pay the interest thereof to the Church Wardens & Vestrymen of The Church of the Holy Trinity who have the care of the Holy Trinity Memorial Chapel, so long as they continue to control its temporal affairs. If this ceases, then to the Wardens & Vestrymen who shall be appointed to succeed them as officers of the said Holy Trinity Memorial Chapel. The said interest is to be used in payment of the salary of the clergyman who shall officiate at the said chapel statedly, and for other necessary expenses of the said Memorial Chapel; ^(annually) said interest is to be paid semi-annually. I direct that the collateral inheritance tax on the foregoing bequests & legacies be paid out of my residuary estate.

Item.—I *annul* the bequest, on Page 10 of my will of 1873, of “one tenth part of one 4th part of said trust estate,” to be divided between the children of my husband uncle, Dr. C. F. Wilstach, & the children of his Aunt, Mrs. Dungan, both

of whom are deceased. I direct that instead of this contingent bequest, which I *annul*, The sum of thirty thousand dollars shall be divided between the said children of Dr. C. F. Wilstach and John L. Dungan, the only child of Mrs. Dungan. The one to take with the other, share & share alike, in equal amounts, the issue of such as may be deceased to take such share as he or her parent would have taken had he or she been living. I direct that the collateral inheritance tax on the foregoing bequests be paid out of my residuary estate.

Item.—I state for the information of any who may be interested, that the memorandums on the margin of my will were written by myself, being notes of changes made thereunto by codicils, & are for the convenience of my executors. I will also state that I have made erasures, and replaced letters or words. All of which has been done *before* my codicil was signed.

Item.—I give and bequeath to the city of Philadelphia, all my Paintings, Engravings, Statuary, Photographs, Books on Art, and catalogues of various Galleries in Europe & America. Also my Books denominated "Dresden Gallery," containing engravings of the Paintings in the Dresden Galleries, in Dresden, Saxony, and all works of art owned by me at the time of my decease, in trust, nevertheless, to, for and upon the following uses, intents & purposes, To wit: To place the said paintings, Statuary, Photographs and works of Art in the possession and under the control of the Commissioners of Fairmount Park, to be placed by them in Memorial Hall, in Fairmount Park, there to be preserved by them, & taken care of & kept in good order, as the nucleus or foundation of an Art Gallery for the use and enjoyment of the people. The Collection to be kept together, and known and designated by the name of "the W. P. Wilstach Collection." And I direct my Executors to transfer to the Commissioners of Fairmount Park, in like manner in Trust, the one other fourth part of the residue and remainder of the said estate and estates, which said sum shall be *invested* in good and lawful securities by the said Commissioners of Fairmount Park. And the *interest* accruing therefrom shall

be used for the maintenance of said Art Gallery, in keeping the same in good order & condition, and providing of competent care-takers, as may be necessary to carry out, to its full and complete extent and meaning, the design I have in view in making this devise and bequest for the founding and sustaining an Art Gallery in Fairmount Park for the use & enjoyment and benefit of the public. The balance of the income from said investment fund, not required for the proper care and maintenance of the Gallery, shall be used for the increasing of the collection, in such manner as the said Commissioners of Fairmount Park may deem best. The said commissioners of Fairmount Park to make rules and regulations in regard to the use & enjoyment of said collection as will best conduce to the end intended. My will is, and I hereby direct, that the said City of Philadelphia shall, within six months after my Will & Codicils shall have been either in part or in the whole admitted to probate, signify their acceptance of this trust, devised and bequeathed, and the trust hereby created, by ordinance duly passed to that effect; and in case of failure on the part of said City so to accept, then I give, devise and bequeath the property and money given, devised & bequeathed by this Article, to the "Pennsylvania Museum and School of Industrial Art," in the same manner, in trust, for the same uses, intents and purposes as herein above designated, in the same manner and to the same extent as if the "Pennsylvania Museum and School of Industrial Art" had been named herein in the first place instead of the said City of Philadelphia & Commissioners of Fairmount Park; provided, however, that the limitation of time for the acceptance of this bequest and trust by the "Pennsylvania Museum and School of Industrial Art," in case the said City of Philadelphia shall decline to accept the same, is extended for six months next succeeding the expiration of the six months herein above limited for the acceptance by the City of Philadelphia of the same.

Having annulled the bequests on Pages 7, 8, 10, 11, 12 & 13, consisting of "parts and shares," I now direct that my

Executors shall pay, apply and dispose of all the rest, residue and remainder of the said estate and estates which at the time of my decease shall belong to me, including the estate of the said William P. Wilstach, in the following manner, that is to say: Two one fourth parts thereof to be divided equally between my nieces and nephews here named—Mary C. Griffith, Alfred P. Griffith, Samuel Henderson Griffith, Warren G. Griffith, Anna Shumway, Adelaid Henderson, Harris J. Chilton & Anna Chilton. My nieces & nephews here named to take share & share alike one with another, the issue of such as may be deceased to take only such share and portion as his or her or their parent would have had and taken had he, or she or they been living. One fourth part I have directed to be used for additions to my Art Gallery. One other fourth part of the rest and remainder of said estate I direct shall be divided equally between the Howard Hospital, cor. Broad and Catherine streets, and the Holy Trinity Memorial Chapel, Cor. Spruce and 22d Streets, & The Philadelphia Protestant Episcopal City Mission for the Home for Consumptives, at Chestnut Hill, to build cottages if needed, & the Hospital of the Protestant Episcopal Church, & The Union Benevolent Association, & The Young Mens Christian Association. The share of this bequest to the memorial chapel I direct shall be paid to the Girard Life Insurance, Annuity & Trust Company, they to add it to the fund already bequeathed to them, and in like manner to invest the same, & pay the interest thereof to the officers having charge of said chapel, in like manner as directed in the former bequests to the same.

I direct that the collateral inheritance taxes on all bequests be paid out of my residuary estate. I ratify and confirm my last will & testament, dated July 31st, 1873, except so far as I may have, by codicil or codicils, altered the same. And I ratify and confirm any codicil or codicils by me heretofore made, excepting as changed by this codicil.

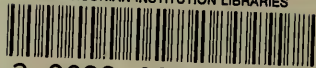
