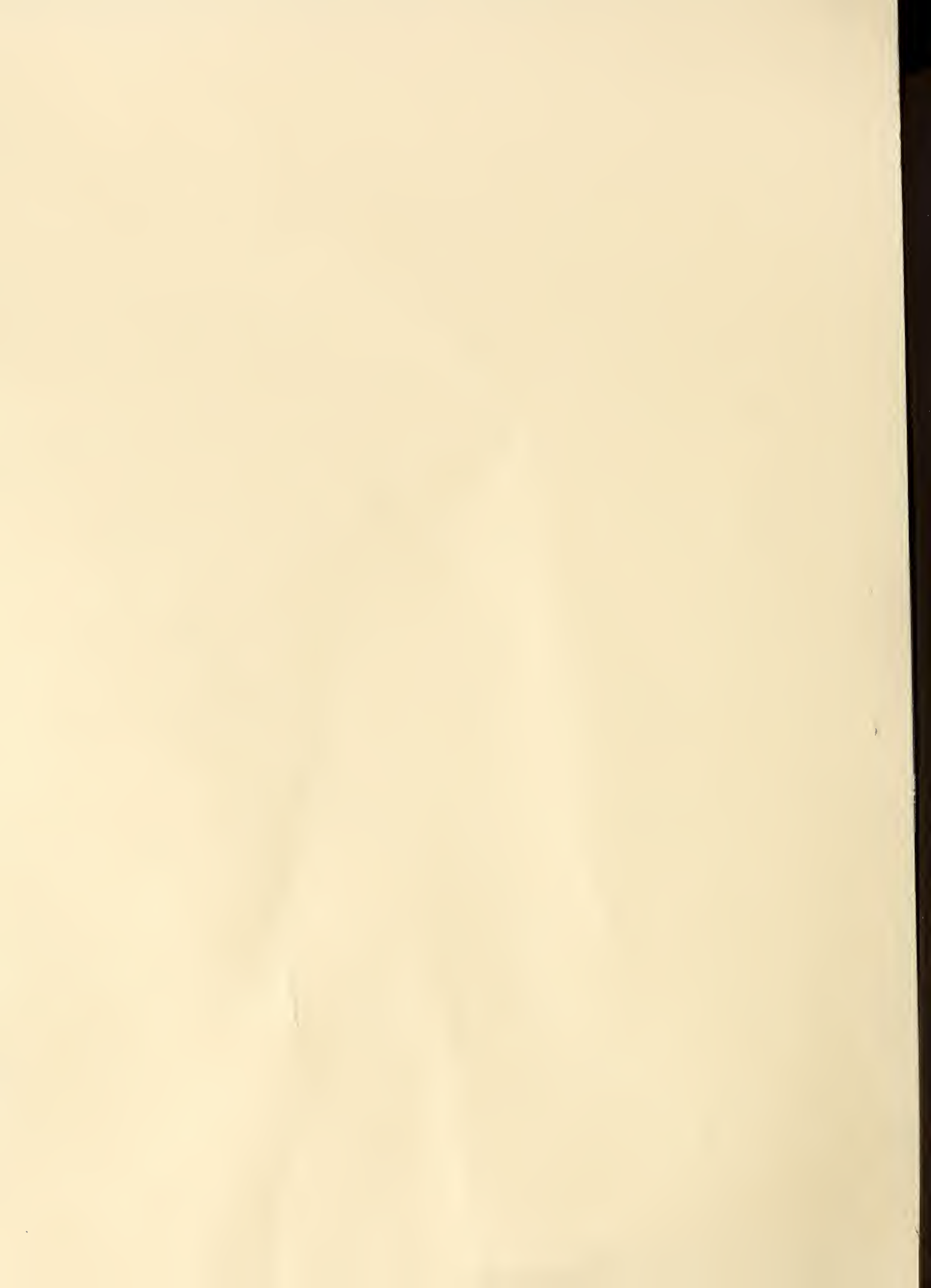

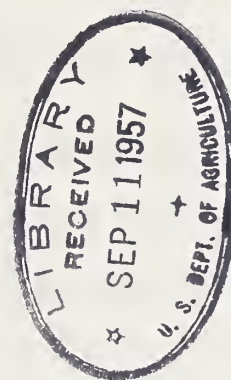

INSPECTION OF FRESH FRUITS, VEGETABLES AND NUTS

Inspection service for fresh fruits, vegetables and nuts is available in the markets named below and at all points which can be conveniently reached from them. Inspection is also available at shipping points in all States with which cooperative agreements providing for this work have been entered into on behalf of the Department, pursuant to authority contained in any Act of Congress. Requests for inspection in receiving markets should state the kind of product, the car or truck number and location, the name of the receiver, the delivering carrier, and the particular facts concerning the type of inspection desired. Any prospective applicant may obtain the address of the office nearest the place where the commodity to be inspected is located by addressing an inquiry to Fresh Products Inspection Service, Agricultural Marketing Service, Fruit and Vegetable Division at any of the following places: (1) U. S. Department of Agriculture, Washington 25, D. C.; (2) Room 602, 139 Centre Street, New York 13, New York; (3) Room 1160, 610 South Canal Street, Chicago 7, Illinois and (4) Room 739 Appraiser's Building, 630 Sansome Street, San Francisco 11, California.
