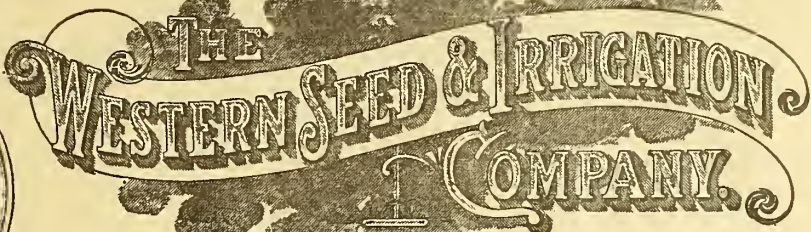

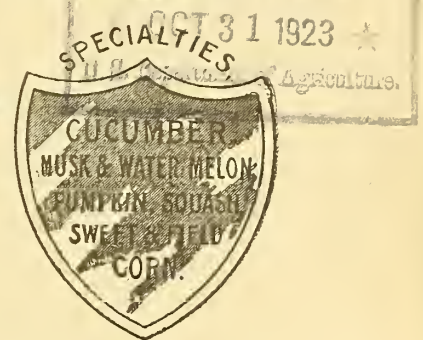

TERMS—VINE SEEDS, by Draft (with exchange) payable 60 days from date of invoice, to be accepted and mailed upon receipt of seed, or 1 per cent discount for Cash 30 days from date of invoice.
