**WITNESSETH:**

1. Seller agrees to sell and deliver and Purchaser agrees to accept and pay for the varieties of seed in amounts, at the prices as set forth, and subject to the terms and conditions herein provided.
2. The Braslan Seed Growers Company, Inc., warrants to the extent of the purchase price that seeds sold are as described on the container within recognized tolerances. Seller gives no other or further warranty, express or implied.
3. All orders are subject to por-rata delivery in event of partial or total crop failure, or for any other cause, such as, fire, damage by elements or any acts beyond our control.
4. TERMS: f.o.b. shipping station subject to 1½% discount for payment within 30 days from date of invoice 60 days net on approved credit.
5. Bags or special containers are charged at cost.
6. QUOTATIONS OPEN TO WITHDRAWAL WITHOUT NOTICE.
7. Should at any time the financial condition of the purchaser become unsatisfactory to the seller, purchaser agrees upon receipt of written notice to that effect and upon demand of the seller to pay for the seeds prior to shipment less usual discount.
