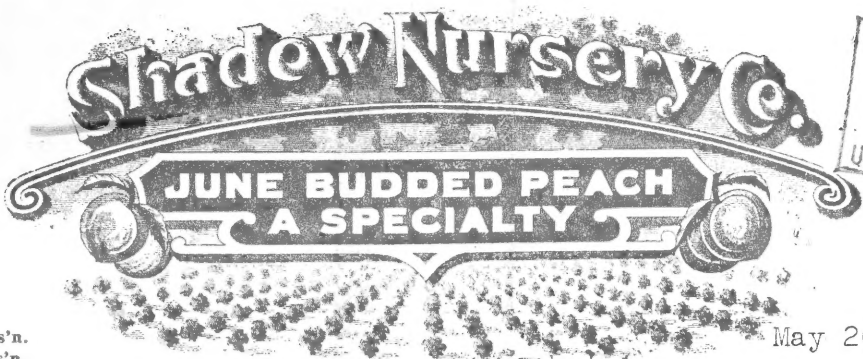

WILL YOU BE IN THE MARKET FOR ANY JUNE BUDDED PEACH TREES FOR FALL 1953?

Each year before we begin budding, we write to a list of Orchardists for this information which will be of great benefit to us, giving us an idea of the varieties, number and grades wanted. Should you have a SPECIAL VARIETY or STRAIN you want propagated, we will do this and cut budwood from your orchards.

All budwood used is of known parentage, propagation is under close supervision. For three generations SHADOW GROWN TREES have stood the test of time. It is possible I may be in your locality soon and would be most happy to call on you.

Our SPECIAL CONTRACT PROPOSITION will save you money over the regular fall quotations later on in the season. All bookings are recorded in rotation as received and shipped in same rotation. Extreme labor conditions, scarcity of seedlings for budding and production costs force us first to confine our propagating to early bookings and contracts. Many planters were unable to find JUNE BUDS the past season. We have available or have made arrangements for budwood of the following varieties, however some budwood is limited.
