To provide information and guidance to enable the citizens of Montana, both rural and urban, to understand and properly cope with the many and varied insect problems that confront them.



MAJOR ACCOMPLISHMENTS SUMMARIZED

Assisted in research activities and informed the public on insect damage problems.

Prevented the spread of disease in bee colonies through inspection and minimized strife within the industry through territory regulation.



Apiary Regulation Program

Supervise the registration of bee colonies and allotting territory on the basis of industry approved regulations.

 Prevent through inspection, isolation and education the spread of disease among bee colonies.

Advise present and prospective beekeepers in their problems.

Cooperate with other states in the inspection of bees in interstate shipment to prevent the spread of disease.
