CONSTITUTION AND BY-LAWS

— OF THE —

Bent County Cattle and Horse Growers' Ass'n.

ADOPTED AT THE ANNUAL MEETING

April 6, 1885.

PREAMBLE.

Realizing the fact that the interests of all persons growing cattle or horses in Bent County are identical, and the further fact that said interests can be more thoroughly and profitably advanced by organization than by individual effort.

Therefore, to perpetuate this Association, we adopt the following

BY-LAWS:

SECTION 1. This association shall be called the Bent County Cattle & Horse Growers' Association.

SECTION 2. The officers of this Association shall consist of a President, two Vice Presidents, a Secretary and a Treasurer, and said officers shall constitute a Board of Directors who shall hold their office for the period of one year or until their successors are duly elected and enter upon the duties of their office.

SECTION 3. The President shall preside at all meetings. One of the Vice-Presidents shall preside in the absence of the President.

The Treasurer shall receipt for, and pay out all monies of the Association on vouchers signed by the President and countersigned by the Secretary, and shall make a report of all business transacted by him at each annual meeting.

The Secretary shall keep all records of the Association, the minutes of each and every meeting, a true and accurate account of all monies paid to the Treasurer and perform such other duties as the Board of Directors may direct and shall receive for his services the sum of one hundred dollars per annum.

SECTION 4. The meetings of this Association shall be held quarterly on the 2d Wednesdays in the months of January, April, July and October of each year, provided that a majority of the Board of Directors may call a meeting at any time, whenever in their judgment it may be necessary.

SECTION 5. The election of officers shall take place on the 2d Wednesday in April of each year at the office of the Secretary in the town of West Las Animas, and any vacancy which may occur shall be filled at the next regular meeting, and until such meeting the Board of Directors shall have power to fill the same by appointment.

SECTION 6. At each annual meeting there shall be elected three members who shall, with the Board of Directors form a committee on assessments, and whose duties it shall be to make all assessments necessary to pay any indebtedness of this association, and such assessment shall be levied pro rata per head on all cattle or horses belonging to the members of this Association, provided, that no assessment shall exceed three cents per head.

SECTION 7. All elections for officers or membership in this Association shall be by ballot.

SECTION 8. The admission fee for membership shall be five dollars and the annual dues shall be two dollars per annum and no member shall vote at any annual meeting unless said dues are paid.

SECTION 9. Any person who may desire to become a member of this Association shall present his application to the Secretary in writing, accompanied by the recommendation of at least two members of this Association, which application shall be presented by the Secretary at the next regular meeting and if two-thirds of the members present shall vote in favor of receiving said application, then said person shall become a member of this association by signing the By-Laws and paying the usual dues.

SECTION 10. Any member of this association may withdraw and have his name stricken from the Roll by notifying the secretary in writing and paying all dues or assessments up to the date of acceptance of the same by the association, which shall be at the next regular meeting; and any member of this association may be expelled by a two-thirds vote of all the members voting at any regular meeting.

SECTION 11. Any person or company who shall be assessed or who may be in arrears for dues, and who shall have been notified by the secretary in writing, that said assessment or dues have not been paid, and who shall refuse or neglect to pay the same within the period of thirty days after said notice is given, then said person shall cease to be a member of this association and his name shall be stricken from the roll. Provided that at the next regular meeting thereafter, said person may present himself and show cause why his name should not be so stricken from the roll, and if good cause be shown, then, said person may be reinstated by a two-thirds vote of all the members present at such meeting.

SECTION 12. All members of this association shall be entitled to one vote, and in case of a tie vote then the president shall cast the deciding vote.

SECTION 13. A written proxy approved by the Board of Directors as genuine, may be voted at any meeting of the association.

SECTION 14. The regular order of business shall be:

- 1st. Calling the Roll.
- 2nd. Reading the minutes of last meeting.
- 3rd. Election of new members.
- 4th. Unfinished business.
- 5th. Report of officers.
- 6th. Election of officers.
- 7th. Election of Assessment Committee.
- 8th. General business.

SECTION 15. The By-Laws of this association shall not be annulled, added to or amended except at the annual meeting, which shall be on the 2d Wednesday in April of each year, and then only by a two-thirds vote of all the members present.

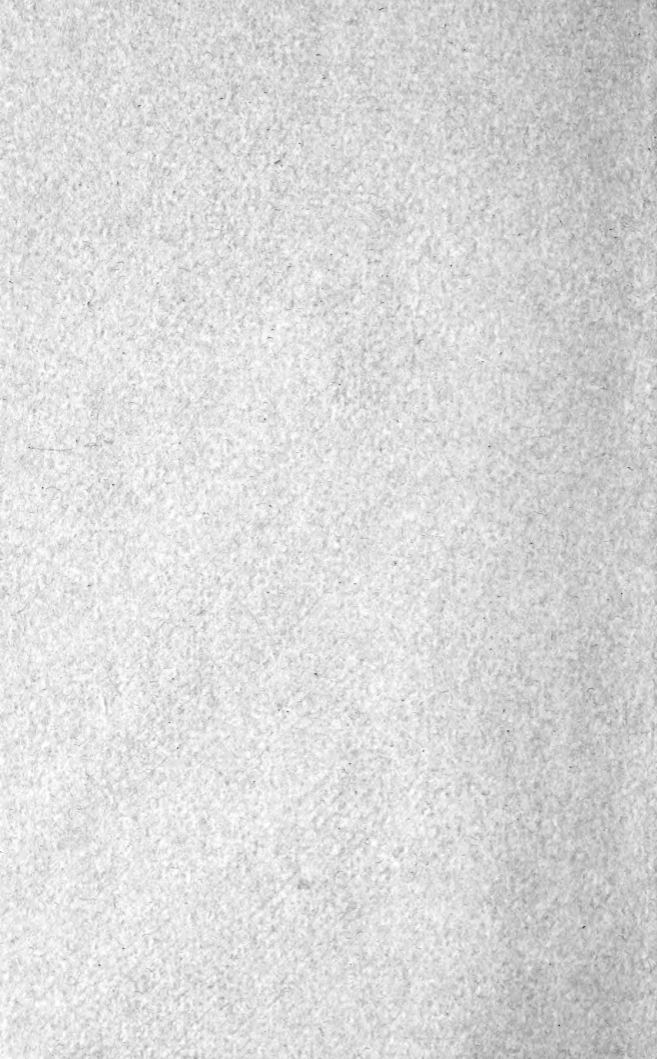


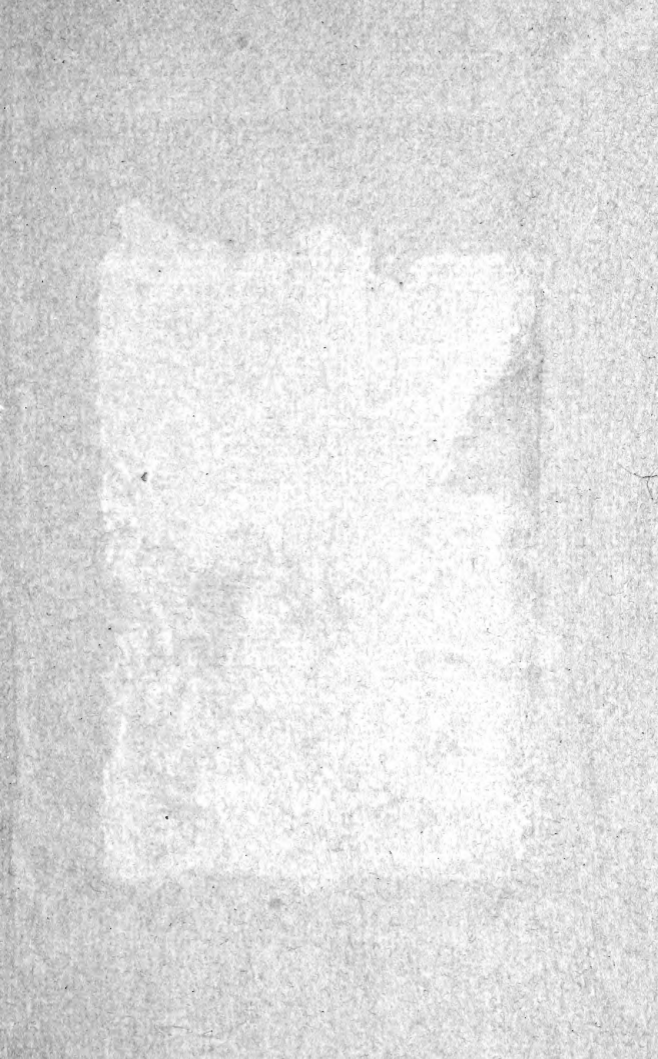
