

### **INTRODUCTION**



When first asked what environment means to them, students most often reply with references to the natural environment. 'Water', 'trees', 'birds', 'animals', 'mountains', 'lakes', etc. are the most common. With more time to consider and following discussion with other students, the question elicits responses related to quality: air pollution, water pollution, smog, overcrowding, hunting, and litter often head the list.

With time and more extensive study students and their teachers soon see that environment can incorporate just about anything and becomes synonymous with 'surroundings'. One could argue then, that good education is environmental education.

However, to get more of a handle on the term, Alberta environmental educators and the government agencies involved in supporting them have accepted the following definition:

Environmental Education is that branch of education which seeks to develop a population that is aware of and concerned about the environment and its associated problems, and which has the knowledge, skills, attitudes, motivations and commitment to work individually and collectively towards solutions to current problems and the prevention of new ones. The term 'environmental education' would seem to single out Alberta Education and Alberta Environment as the responsible government agencies.

Alberta Education - responsible for the education of children in the province.

Alberta Environment - responsible for the environment.

However, several other departments and agencies are also responsible for elements of man's interaction with the physical environment. Consequently, they have, through education and information programs, found themselves involved in environmental education.

This booklet is a guide to environmental education services within the Alberta government. A dozen departments or agencies are identified. Together, they provide a wide array of support to environmental education: from print material to audiovisual service; from field trip sites to teacher/leader inservice.

In contacting these agencies for information it is extremely important to define exactly what you are looking for. Requesting publications lists is one good way to know exactly what materials are offered. A good companion resource to this guide is the **Environmental Fact Seeker's Guide** (available from Alberta Environment). This provides stepby-step assistance in defining what you need to know in researching an environmental topic.

# **ALBERTA AGRICULTURE**

#### Responsibilities

Alberta Agriculture serves the people of Alberta by providing leadership and assistance to the agricultural community to ensure the continuing economic and social health and growth of this basic industry.

#### **Environmental Education**

With the major responsibility for the agricultural environment, Alberta Agriculture has a vital role to play in environmental education. This responsibility is met through a variety of direct and indirect educational support mechanisms. The audience addressed by these programs, materials and services are varied and include the schools.

#### **Environmental Education Programs** and Services

Alberta Agriculture provides educational programs by providing agriculturally related courses offered at various levels of institutions. The department provides staff as well as other resources for use in schools. Staff would be pleased to be invited to classrooms to discuss how agriculture relates to the subjects or topics being studied. More informal but extensive opportunities are provided for environmental learning through the provincial 4-H program. The diversity of "clubs" within the program make most environmental concerns appropriate and relate well to both the outdoors person as well as to those concerned with "indoor" activities.

# **ALBERTA CULTURE**

#### **Responsibilities**

This department preserves, studies, and interprets Alberta's cultural and historic resources for the benefit of all Albertans. Although the majority of the department's work involves historic and cultural aspects of the man-made setting, the natural environment is studied and interpreted.

#### **Environmental Education**

As with some other departments there are no direct responsibilities as far as institutional involvement is concerned. They provide resources in the form of educational programs at the Provincial Museum and ten historic sites, consultant services, and a number of publications and audio-visuals. Alberta Culture is involved to a high degree in education generally as they attempt to show the citizens of Alberta the cultural riches of their province.



# Environmental Education Materials and Services

Resources offered by Alberta Culture provide good support for those interested in environmental education. Topics researched by Alberta Culture include paleontology, archaeology, history, historic sites, and natural history.

# **ALBERTA EDUCATION**

#### Responsibilities

To promote and support an effective system of primary and secondary education in Alberta.

#### **Environmental Education**

Environmental education is viewed by this department as an inportant component of the education of Alberta students. Areas for incorporation of environmental topics and issues are evident throughout the entire curriculum, kindergarten through grade 12.

# **Environmental Education Programs and Services**

Alberta Education supports environmental education by providing release time, through local boards, for teachers to pursue professional development in this area. As well as release time with pay, the department provides substitutes for those teachers.

Monies have also been set aside through the Education Opportunities Fund to promote environmental education.

### ALBERTA ENERGY AND NATURAL RESOURCES

#### Departmental Responsibilities

This department is responsible for the administration and management of Alberta's energy and natural resources: energy, minerals, forest, public lands, and fish and wildlife.

These responsibilities include advice to the Minister on policies and programs of energy and renewable resources, the two major sectors of the department. The Energy Resources Sector applies sound management practices to ensure the largest and most efficient recovery of a depleting resource as well as maximum royalty revenues for the province. The Renewable Resources Sector is charged with the efficient development and planned reforestation of Alberta's forests, the management of public lands, and the management of the fish and wildlife resources for the continued benefit of the province. # **ENERGY CONSERVATION BRANCH**

#### **Responsibilities**

The Energy Conservation Branch is responsible for the development and implementation of awareness, information and education programs emphasizing the wise use of energy.

#### **Environmental Education**

Education information efforts within this branch that support environmental education at the elementary school level are narrowly confined to the topic of energy conservation which may be translated to "avoiding waste".

# **Environmental Education Programs and Services**

- 1. School Programs: A number of programs have been developed for the school population. These include:
  - (a) The School Visitation Program involving visitation and in-class presentation to students;
  - (b) **The Teacher Professional Development Program** - involving participation at conferences, conventions, and professional development days to introduce materials and techniques to support energy conservation instruction;
  - (c) **The Sleuth Kit Program** provides a curriculum support kit for use at the grade six level; and,
  - (d) The Curriculum Support Materials Program

     which attempts to develop new curriculum support materials.

These programs emphasize involvement by elementary school students.



- 2. General Public Programs: The branch is also involved in educating the general public with regards to energy conservation. These include:
  - (a) **The Alberta Energy Savers Program** attempts to provide publications aimed at homeowners that will assist in their energy conservation undertakings; and,
  - (b) **The Home Energy Savers Workshop Program** - provides homeowners with a free two-hour workshop and presentation to introduce some important concepts in energy conservation in the home.

# FISH AND WILDLIFE DIVISION

#### **Responsibilities**

The primary responsibility of the Fish and Wildlife Division is to manage the fish and wildlife resources of the province to obtain the greatest benefit and enjoyment for all Albertans.

#### **Environmental Education**

The mandate of this division as it relates to environmental education is to develop and maintain an effective province-wide fish and wildlife conservation education program.

Although the division attemps to reach a general audience a major emphasis is on the formal education system through grades K - 12.

Fish and Wildlife has attempted to meet the needs of the educational community by working directly with educators and in some cases with Alberta Education in the development of resources.

# **Environmental Education Programs and Services**

The division has many reports, brochures, and audio-visual materials that would be of assistance to educators and youth leaders.

Two programs are of special note:

(1) **Project Wild:** an instructional program aimed at grades K-12 that attempts to outline the importance of wildlife to the environment and to man. The program includes a manual and a plan for inclusion into the **Alberta Program of Studies**.

Teachers must take part in an in-service program offered by the division prior to being provided with the print materials.





(2) Hunter Education Program: a training program which assists the participants in understanding the important role of modern regulated hunting in wildlife management and conservation. The topics covered include outdoor survival, safety and hunting ethics, wildlife identification, and the legal responsibilities of hunters in Alberta.

The training is made available through a network of volunteer instructors working with the division. Resources available include a comprehensive support materials.

Outdoor Hunter Education camps are available to participants of the program. These camps are located at:

# ALBERTA FOREST SERVICE

#### **Responsibilities**

The Alberta Forest Service is responsible for the management of Alberta's forest lands to ensure a perpetual supply of benefits while maintaining a forest environment of high quality.

#### **Environmental Education**

Education programs within the Alberta Forest Service are conducted within a framework of environmental concern for issues and problems within a broad societal context. Credibility of programs are enhanced by involving environmentally concerned citizen groups and professional organizations in a consultative process. These groups include the Alberta Wilderness Association, the Alberta Camping Association, and the Environmental and Outdoor Education Council (Alberta Teachers Association).

#### **Environmental Education Materials and** Services

The Alberta Forest Service supports environmental education through its sponsorship of the Junior Forest Warden and Junior Forest Ranger Programs. The goals of these programs are to develop appreciation, awareness, respect, and wise use of the forest environment through outdoor adventure and experiential programs.





At present the print materials that are used by these two groups are undergoing a complete revision. The new manuals and support materials will be available late in 1984.

The department is also responsible for the Long Lake Outdoor Education Training Centre which develops leadership skills of the membership of the Forest Warden and Forest Ranger programs and their adult instructors. For more information please contact:

# ALBERTA ENVIRONMENT

#### **Responsibilities**


This department is responsible for promoting a balance between resource management, environmental protection and the quality of life. This role is achieved through interdepartmental government planning of policies, programs, and services.

#### **Environmental Education**

The interaction of man and his activities within the physical environment is the basis of the broad understanding that Alberta Environment endeavours to attain in its educational program. The program is developed with the process "awareness-to-action" in mind.

The initial program level focuses on simple awareness of man's interaction with the environment. In formal education this is defined by attempts to encourage students and their teachers/leaders to learn in and about the out-of-classroom environment. As the process advances, programs attempt to bring about an understanding of the multitude of variables involved in environmental issues. This is coupled with the attempt to improve personal decision-making and problem-solving skills needed to make informed choices in situations affecting the environment.

Programs are developed with the knowledge that other provincial agencies are responsible for education within a variety of natural resource and service areas that integrate with Alberta Environment's responsibilities. Acting on such knowledge has provided for numerous co-operative efforts.



#### **Environmental Education Programs and** Services

Through the Communications Division and the Environmental Education Resources Branch material is developed on three levels: **awareness**, **issues**, and **core programming**. In addition, program service is offered through leadership development.

#### Awareness

Programs at this level include all departmental reports, brochures, and audio-visual materials included in the **General Publications List**, (updated annually).

For the teacher and youth leader the department has developed and distributed more than 200 activities and programs that assist the teacher in taking children out of the classroom for learning experiences. Though the list of these materials has been withdrawn the content of the activities is still available through workshops.



The **Workshop Network** represents a group of consultants on contract to Alberta Environment who present workshops on environmental awareness activities. At present, the department is involved in developing further awareness material that informs the public about various aspects of the environment and about the department's mandate in particular.

#### Issues

Environmental issues develop from the value position that individuals take on activities of man in the environment. issues programs are developed by the department so that citizens can develop an understanding of how attitudes and values affect decisions about the environment. Each program highlights one issue area.

Specific programs available include: **The Mosquito Kit** on pesticides, adaptable to grades 4-12.

**Environment Views: Uses in the Classroom**, adaptable to grades 9-12. Other program topics are presently being considered.

#### **Core Program**

Programs developed at this level focus on meeting specific needs within the school curriculum and may, in future, be prepared to meet the needs of non-school groups.

Programs presently being developed include: Solid Waste Environmental Education Program, (SWEEP), grades 4-12.

Water Quality Monitoring Education Program - Biology 20-30.

**Water Literacy Program** - Grades 4-12 (in preparation). Other program topics are being considered.



#### **Audio-Visual**

Audio-visual material is available to teachers, leaders and the public in conjunction with the programs outlined above. A general audio-visual service is not available.



### **OPERATIONS AND MAINTENANCE DIVISION**

#### **Responsibilities**

The division is responsible for the overall operation, maintenance and conservation of provincial parks, recreation areas, and wilderness areas for the enjoyment and safety of visitors.

#### **Environmental Education**

Through the visitor services program the division provides for environmental education in many parks throughout the province. Park and/or regional personnel provide consultation services, workshops, and resource material to teachers and other group leaders. Park group use facilities are available for environmental education programs.

# Environmental Education Materials and Services

The most important contribution to environmental education is the provision of parks and facilities. Facilities and services vary from park to park. Some parks have brochures, others have background resource material, while a few have personnel who conduct teacher workshops and assist with programs. # **OUTDOOR RECREATION SECTION**

#### Responsibilities

The Outdoor Recreation Section has direct responsibilities in the outdoor recreation delivery system. These responsibilities include assisting municipal recreation systems and provincial recreation associations in the development of outdoor recreation programs, outdoor recreation leaders and the development and operations of provincial recreation associations. In general, the outdoor recreation section promotes the involvement of Albertans in the outdoors.

#### **Environmental Education**

Environmental education is supported by this section within the context of an outdoor recreational environment. Direct support is provided through leadership development, direct funding, material development and support services.

# **Environmental Education Programs and Services**

The responsibilities of the section manifest themselves in many important ways in terms of environmental education. The section operates the Blue Lake Centre near Hinton. This facility provides leadership and outdoor skills programs. It also has specialized training programs for teachers which link outdoor and environmental education to the curriculum.





**Outdoors Alberta** is a mobile program which takes new games, sports techniques, and new developments in recreation to rural areas of the province that might not normally have the chance to be exposed to them.

Some of this section's direct support is to the projects and conferences of the Environmental and Outdoor Education Council of the Alberta Teachers' Association.

The division has also supported the development of the **Rodeo Unit**, an environmental education program for use in Alberta's schools.

### ENVIRONMENT COUNCIL OF ALBERTA

#### Responsibilities

The Council is required by the Environmental Council Act to carry out an ongoing review of government policies and programs. This is accomplished by several means, including the public hearing process with the subsequent report and recommendations, investigations by research staff, and through the retention of consultants on some issues.



#### **Environmental Education**

The educative function of the Environment Council of Alberta stems from its mandate to conduct a meaningful dialogue with the public on a wide range of environmental issues. The Council educates both the public at large, and the government, through the continuous exchange of information. This exchange involves contact between the government and the public through the Council's Public Advisory Committee. It also derives from Council-produced reports and information bulletins on environmental issues.
