PREFACE.

Sometime since, at a family re-union, held at the home of Col. Ephraim Burket, on the old homestead farm, in Sinking Valley, Blair county, Pennsylvania, the subject of the history of the Burket family, and the descendants of Peter Burket, deceased, was discussed.

It appeared that no history of the Burket family was known to exist, and that no complete record of the descendants of Peter Burket was in the possession of any of the members of his family. It was thought best to endeavor to complete a record of the latter, and steps were taken to that end.

The work has proven much more difficult than was anticipated, and has, therefore, taken a much longer time than it was thought possible.

It is believed the information given is correct, and is likewise as complete as it was possible to obtain it. Should there be any errors or omissions, they have been unintentional, and I will be glad to be advised of them in order that the proper corrections may be made.

The blank pages are intended to be used in completing the further family history as it may become necessary.

PURCHASE OF THE BURKET FARM.

On April 16th, 1793, John Penn the younger, and John Penn the elder, by their attorney Anthony Butler, sold to James Stuart 375 acres and 39 perches of land located in Tyrone township, county of Huntingdon (afterwards Blair county) State of Pennsylvania (being part of the late proprietaries manor of Sinking Valley) for 370 pounds, 12 shillings and 1 penny current money of Pennsylvania in specie, in addition to which, said James Stuart was to pay a quit rent of one (1) peppercorn on the first day of March of each and every year thereafter, forever if demanded.

The deed of conveyance for this land is recorded in Huntingdon county, in deed book D, page 117, June 16th, 1793.

On March 19th, 1802, the said James Stuart, of Mt. Joy township, county of Adams, State of Pennsylvania, and Elizabeth his wife, sold to Peter Burgart of Manheim township, in York county, Pennsylvania, the above referred to 375 acres and 39 perches of land, for 2000 pounds, lawful money of Pennsylvania; the deed of conveyance to Peter Burgart is recorded in Huntingdon county, deed book H, page 535, July 31st, 1802; A. Henderson being the Recorder.

The tract of land above referred to includes the Burket farm, which has now been in the possession of the Burket family for almost a century and is located in Sinking Valley, Tyrone township, Blair county, Pennsylvania. The title for the land of the Burket farm, included in the above tract, passed from Peter Burket, Sr., to his son Peter Burket, and from his estate into the hands of the latter's son Ephraim Burket, who still resides on the old homestead.

THE BURKET FAMILY.

There seems to be no records in the possession of any of the Burket family giving any history as to the antecedents of Peter Burgart, Sr.

Peter Burgart, Sr., was born June 25th, 1766, and was a farmer residing in Manhime township, York county, Pennsylvania. He married Elizabeth Harnish of the same county, who was born about 1767; the date of their marriage is unknown. They removed to Sinking Valley about 1802. Peter Burgart died July 19th, 1823, aged 57 years, and his wife Elizabeth died May 6th, 1841, aged 74 years. They are both now buried in the Lutheran cemetery in Sinking Valley, although they were at first buried in the cemetery on the homestead farm.

To them were born the following children, although the members of this family are not mentioned in the order of their birth, and some corrections may be necessary in order to make this part of the record complete. Their children were:

Jacob Burket, of Brookville, Pa., the father of Dr. G. W. Burket, of Tyrone, born July 28th, 1789, and died July 26th, 1880.

Peggie, wife of Abraham Good, of Smicksburg, Indiana county, Pennsylvania.

Sallie, wife of David or George Mong, of Clarion, Pennsylvania, died November, 1881.

Peter Burket, born January 17th, 1793, and lived for many years on the homestead farm in Sinking Valley, where he died January 20th, 1867.

Samuel Burket, of Tuckahoe Valley, who lived near Fostoria, Pennsylvania.

Barbara, wife of George Crane, of Missouri.

Nancy, wife of John Spanogle, Warriorsmark, Pennsylvania.

John Burket, of Warriorsmark, Pennsylvania.

David Burket, of Shirleysburg, Pennsylvania.

DESCENDANTS OF PETER BURKET.—(2ND.)

Taking up the history of Peter Burket, the son of Peter Burgart, Sr., who was born near Hanover, in York county, Pennsylvania, January 17th, 1793, and who, as far as is known, came to Sinking Valley about the year 1802. He was married January 11th, 1816, to Mary Fleck the daughter of George Fleck, and a sister of David and Henry Fleck, of Sinking Valley, who was born in the year 1797. One child, George Fleck Burket, was born to them on May 7th, 1817. Mary Fleck Burket, the first wife of Peter Burket, died one week after the birth of her son George, on May 14th, 1817, in the 20th year of her age, and is buried in the Sinking Valley Lutheran cemetery.

SECOND MARRIAGE.

Peter Burket was married the second time on April 23rd, 1818, to Barbara Neff, of near Petersburg, Huntingdon county, Pennsylvania, who was born November 19th, 1795, and died March 19th, 1833, aged 37 years, and is buried in the Sinking Valley Lutheran cemetery. Barbara Neff was a daughter of Jacob and Barbara Neff (Barbara Kauffman before marriage). Jacob Neff died July 15th, 1834; his ancestors came to Pennsylvania from Switzerland in the days of William Penn. He came from Lancaster county about 1786. His wife Barbara Neff died September 21st, 1822.

The following children were born to Peter Burket and wife by his second marriage :

Benjamin Burket, June 19th, 1832, who died May 4th, 1840, and is buried in the Sinking Valley Lutheran cemetery.

THIRD MARRIAGE.

Peter Burket was married the third time November 28th, 1833, to Catharine Keller, of Canoe Valley, Huntingdon county, Pennsylvania, who was born April 10th, 1791; she was a daughter of Michael and Mary Keller (Mary Cummer before marriage) who came from near Reading, Pennsylvania, in 1807. One son was born to this marriage, David Keller Burket, October 18th, 1834, who died at the old homestead September 25th, 1853, and is buried in the Sinking Valley Lutheran cemetery.

DEATH OF PETER BURKET AND WIFE.

Peter Burket died January 20th, 1867, aged 74 years and 3 days. His third wife, Catharine Keller Burket, died April 17th, 1872, aged 81 years and 7 days; both are now buried in the Sinking Valley Lutheran cemetery, although both were at the time of their death buried in the family burying ground on the farm. In August, 1893, their remains together with those of all other persons buried there were removed and buried in the cemetery named.

CHILDREN OF PETER BURKET.

BY FIRST MARRIAGE.

(1) George Fleck Burket, born May 7th, 1817, died at Tipton, Iowa, at 2 o'clock p. m., December 23rd, 1891, aged 74 years; he married Catharine Spitler, of Warriorsmark, born October 16th, 1813, and died at 10 o'clock a. m., December 23rd, 1891, four hours previous to the death of her husband, aged 78 years. Five children were born to them, information relative to which will be found under the head of "Family Histories of Children of George and Catharine Burket."

BY SECOND MARRIAGE.

(2) John Neff Burket, born December 8th, 1818, died near Dixon, Illinois, January 3rd, 1865. He married Mary,

a daughter of Henry Fleck, of Sinking Valley, and no record has been furnished as to the time of her death. They removed to Illinois. Eleven children were born to them.

(3) Peter Burkett, born December 5th, 1820, died at Tipton, Iowa, September 14th, 1874, aged 53 years, and was buried in Inland cemetery, Cedar county, Iowa. He was married to Elizabeth Eberle, at Shavers' Creek, Huntingdon county, Pennsylvania, January 15th, 1852. She was born March 22nd, 1823, in Petersburg, Huntingdon county, and died at her home in Tipton, Iowa, after a year's illness, June 9th, 1881, aged 58 years, and is buried in Inland cemetery, Cedar county, Iowa. Six children were born to this marriage.

(4) Jacob Neff Burkett, born October 19th, 1823, died at Washington, D. C., February 28th, 1883, and is buried at Gettysburg, Pennsylvania. Was married in Carlisle, Cumberland county, Pennsylvania, May 27th, 1845, by Rev. John N. Hoffman, to Mary A. Chritzman, of Gettysburg, who was born April 20th, 1824, and who resides at Washington, D. C. Ten children were born to this marriage.

(5) Mary Burkett, born November 1st, 1825, died at Altoona, Pennsylvania, March 28th, 1856, aged 30 years, and is buried in the Sinking Valley Lutheran cemetery; she was married June 10th, 1845, to George W. Patton, of Sinking Valley, who was born in Woodcock Valley, Walker township, Huntingdon county, Pennsylvania, September 6th, 1817, and who died in Philadelphia, March 7th, 1882, aged 62 years, and is buried in Fairview cemetery, Altoona, Pennsylvania. Three children were born to this marriage. After the death of Mary Burkett, George W. Patton was married a second time, December 19th, 1861, to Emma J. Hawkesworth, daughter of George and Susan Hawkesworth, of Altoona, Pennsylvania, who was born at Lebanon, Pennsylvania, August 24th, 1834. Two children were born to this marriage. Mrs. Emma J. Patton resides at Philadelphia, Pennsylvania.

(6) Henry Fleck Burkett, born September 15th, 1827,

still resides in Illinois; on July 18th, 1848, he was married to Mary Jane Crawford, a daughter of Armstrong Crawford, of Sinking Valley, who was born June 18th, 1830. Ten children were born to this marriage.

(7) Colonel Ephraim Burket, born February 7th, 1830, is still living on the homestead farm; he was married October 27th, 1857, to Mary Harnish, a daughter of Samuel and Susanna Harnish, of Canoe Valley, Huntingdon county, who was born March 28th, 1835. Six children were born to this marriage. He served during the war as a Lieutenant in the 116th Regiment, Pennsylvania Volunteers.

(8) Benjamin Burket, born June 19th, 1832, died on May 4th, 1840, and is buried in the Sinking Valley Lutheran cemetery.

BY THIRD MARRIAGE.

(9) David Keller Burket, born October 18th, 1834, died on September 25th, 1852, and is buried in the Sinking Valley Lutheran cemetery.

FAMILY HISTORIES.

In the Spring of 1852, Peter and Elizabeth Burket moved to Lee county, Illinois, and located on a farm four miles southeast of Dixon. In the Spring of 1873, they moved to Tipton, Cedar county, Iowa. Their children were as follows :

(1) Warren Hewitt Burket, born April 19th, 1853, died October 9th, 1884, is buried in Fleck graveyard, Lee county, Illinois.

(2) Winfield Worth Burket, born March 8th, 1855, died September 7th, 1864, aged 9 years, 8 months and 29 days, is buried in Fleck graveyard, Lee county, Illinois.

(3) John Eberle Burket, born August 23rd, 1856, in Lee county, Illinois, married Julia Escher, daughter of John and Freidreka Escher, of near Tipton, Iowa, May 27th, 1884. At present he is located at Paso Robles, California, and is engaged in the furniture and undertaking business. They have two children, the elder a son, Harold Escher Burket, born November 11th, 1891, at Pierce, Nebraska; the second a daughter, Emma Elizabeth Burket, born October 12th, 1895, in Paso Robles, California.

(4) Homer Kauffman Burket, born May 19th, 1858, in Lee county, Illinois, married to Ella Viva Gibson, daughter of Rev. Josiah Gibson, D. D., and Elviva Gibson, on May 19th, 1885, at Creston, Iowa. At present they are located at Lincoln, Nebraska, where he holds the position of Treasurer in the Nebraska Central Building and Loan Association. They have two children, the elder a son, John Gibson Burket, born February 16th, 1886, at Creston, Iowa. The daughter, Ethel Burket, born March 4th, 1888, at Creston, Iowa.

(6) Theodore Neff Burket, born March 17th, 1863, in Lee county, Illinois, was married to Fannie Rose Streeter, daughter of A. J., and Susan Streeter, of New Windsor, Illinois. They reside at Lincoln, Nebraska, where he holds the position of Vice-President in the Nebraska Central Building and Loan Association.

George W. Patton, after being engaged in business at Blair and Union Furnaces, removed to Altoona, in 1853, and was chosen the first Chief Burgess of that borough, in 1854. In 1861 he was appointed Post Master of Altoona and served eight years in that position. In 1871 he was elected Associate Judge for Blair county, for a term of five years. Subsequently he removed to Philadelphia, where he died March 7th, 1882.
