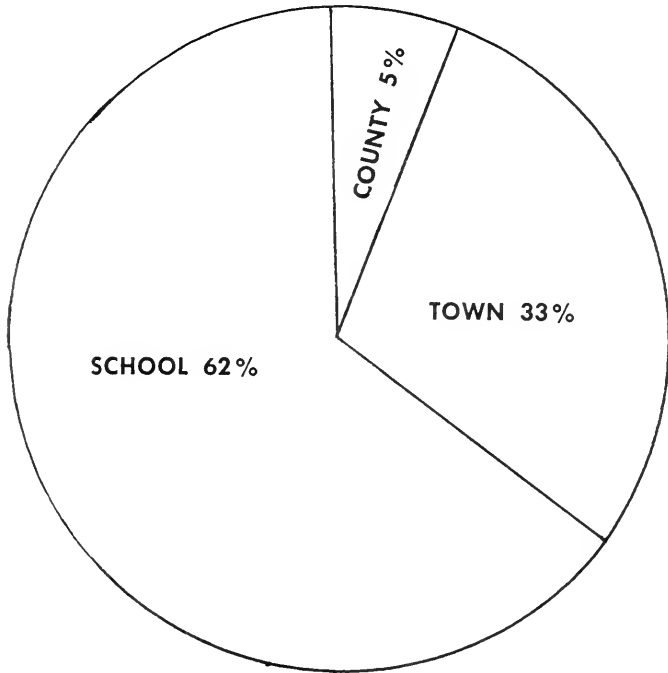

# W A R R A N T

## STATE OF NEW HAMPSHIRE

### Town of Newmarket

To the Inhabitants of the Town of Newmarket in the County of Rockingham in said State, qualified to vote in town affairs.

You are hereby notified to meet at the Town Hall in said town on Tuesday, the 9th day of March, 1971, to act on the following subjects:

(POLLS WILL BE OPEN FROM 10:00 A.M. TO 6:00 P.M.)

1. To choose all necessary Town Officers for the ensuing year.

2. To raise such sums of money as may be necessary to defray town charges for the ensuing year; as may be necessary for General Government including Town Officers' salaries and expenses, election and registration, town buildings, for the protection of persons and property, including the Police Department, for health and sanitation, vital statistics, general expenses of the departments, for education and the public library, for charities, including decoration of soldiers' graves, for recreation, for cemeteries, for indebtedness to other governmental divisions and to pay all other necessary charges arising within said Town.

3. To see if the Town will vote to authorize and empower the Selectmen to borrow money for necessary expenditures; in anticipation of the collection of taxes.

4. To see if the Town will vote to allow a discount of two percent (2%) on all taxes except poll and head taxes, if paid within fifteen days after receipt of bill.

5. To see if the Town will vote to accept the budget as submitted by the Budget Committee.

6. To see if the Town will vote to pay members of the Fire Department Ninety-Seven Dollars (\$97.00) in addition to that required by law. (Recommended by the Budget Committee).

7. To see if the Town of Newmarket will appropriate the sum of Six Hundred Dollars (\$600.00) for the Great Bay School Building Fund. (Submitted without recommendation).

8. To see if the Town of Newmarket will appropriate the sum of One Thousand Dollars (\$1,000.00) for the Newmarket Day Care Center. (Submitted without recommendation).

9. To see if the Town of Newmarket will authorize the Selectmen to withdraw the sum of Twenty-Nine Thousand Dollars (\$29,000.00) from the Fire Department capital reserve fund for the purchase of a new fire pumper truck. (Recommended by the Budget Committee).

10. To see if the Town will establish a town Conservation Commission as set forth in R.S.A. 36-A.

## ANNUAL PROGRESS REPORT OF THE SELECTMEN

The Selectmen respectfully submit to the Citizens of the Town of Newmarket, a summary of projects that were undertaken during the past year and **their** status to date.

The sewerage treatment plant went into operation during the month of July. Open House for the public's inspection of the plant was held December 6, 1970 — many townspeople took advantage of this and received a guided tour of the plant.

The water department, with the public works crew, extended the water main on Bay Road.

During the year the town purchased a new police cruiser, a new tractor and backhoe, and a snow blower.

This year's T.R.A. work was on Langs Lane, with some work being done to remove the ledge outcroppings on Bay Road.

The Lamprey Street drainage project was started and is about 85 % complete.

The fuel oil and gasoline accounts for the town were let out to bid. The low bidder this year was H. R. Haines Co., Inc.

The highway crew finished the drainage and sidewalk work on South Main Street and should be complimented on a good job.

The Town purchased Beaulieu's Little League Park after a Special Town Meeting was held June 23, 1970.

The Selectmen's Meetings are held on the first and third Tuesday of each month. We welcome anyone who wishes to attend these meetings.

Submitted herewith is the report of an examination and audit of the accounts of the Town of Newmarket for the fiscal year ended December 31, 1970, which was made by this Division in accordance with the vote of the Town. Exhibits as hereafter listed are included as part of the report.

One of the enclosed audit reports must be given to the Town Clerk as part of the permanent records.

#### **SCOPE OF AUDIT**

Included in the examination and audit were the accounts and records of the Board of Selectmen, Treasurer, Tax Collector, Town Clerk, Public Library, Municipal Court, Special Sewer Construction Fund and Trustees of Trust Funds.

#### **Analysis of Change in Financial Condition:**

### **Comparative Statements of Appropriations and Expenditures**

#### **Estimated and Actual Revenues:**

(Exhibits A-3 and A-4)

Comparative statements of appropriations and expenditures, estimated and actual revenues for the fiscal year ended December 31, 1970, are presented in Exhibits A-3 and A-4. As indicated by the Budget Summary (Exhibit A-4), a revenue deficit of \$13,403.10 less a net unexpended balance of \$3,497.02 resulted in a net budget deficit of \$9,906.08.

## Statement of Long Term Indebtedness:

(Exhibit I)

A statement of the outstanding long term indebtedness of the Town as of December 31, 1970, showing annual debt service requirements, is contained in Exhibit I.

### AUDIT PROCEDURE

The accounts and records of all town officials charged with the custody, receipt and disbursement of public funds were examined and audited in accordance with generally accepted auditing standards, and accordingly included such tests of the accounting records and such other auditing procedures as were considered necessary in the circumstances.

Verification of uncollected and unredeemed taxes was made by mailing notices to delinquent taxpayers as indicated by the Tax Collector's records. Consequently, the amounts of uncollected and unredeemed taxes as indicated in this report are subject to any changes which may be necessitated by the return of verification notices.

### GENERAL COMMENTS

#### Current Surplus:

The current surplus (excess of total assets over current liabilities) of the Town decreased by \$24,950.07 during 1970, from \$40,031.97 to \$15,081.40, as shown herewith:

We again recommend that the Selectmen review the Tax Collector's lists of uncollected taxes and abate such items



included therein which are known or appear to be uncollectable.

In addition, the Tax Collector should execute tax deeds to the Town for any real estate in which tax redemptions are in default after the two year redemption period allowed by law has expired.

**Conclusion:**

The provisions of Chapter 184 of the Laws of 1955 require that the auditors' summary of findings and recommendations (letter of transmittal) shall be published in the next annual report of the Town. Publication of the Exhibits contained in the audit report is optional, at the discretion of the Board of Selectmen.

We extend our thanks to the officials of the Town of Newmarket for their assistance during the course of the audit.

A pump has been installed and a temporary well house has been built around the pump, motors, electrical units, heater and on August 11, 1970 the pump was put into motion. Since that time, the pump has run twenty-four hours a day at the rate of 140,000 gallons per day.

We plan to utilize this well for the balance of the year before developing a gravel packed well.

Periodical checks by the N.H. Water Supply & Pollution Control Commission have proved to be satisfactory.

The following water extensions were made during the year and were totally paid by the property owners.

2600 feet 6" Cast Iron Pipe — Off New Road

500 feet 6" Cast Iron Pipe — Pine Street

100 feet 6" Cast Iron Pipe — Off Bay Road

The Newmarket Fire Department responded to 54 emergencies during the past year with the zest and enthusiasm found only in the call departments. The speed and readiness of such a group is tempered by training and experience of its members. Our townspeople are comforted with the knowledge that the department offers such dependable swift service. The department is faced with the problem of keeping abreast of the times. The only truck recognized by the N.H. Board of Underwriters is the 29-year-old pumper which must soon be replaced.

The department officers have been checking types of pumpers owned by neighboring towns in an effort to decide which is best suited for use here.

The Underwriters determine the minimum with which a truck may be equipped then the department decides additional optional items. A 1000 gallon pumper appears best suited for Newmarket. Funds accumulating in the Fire Department capital reserve are the basis for this purchase.

Department purchases last year included a new Scott Air Pack, 500 ft. 2½ inch hose and the new pump for the Chevrolet tanker.

Permits are necessary for outdoor burning when the ground is not snow covered, these may be obtained by phoning 659-3286, 659-3216, and 659-5827. Permit burning must be done before 9:00 a.m. and 5:00 p.m.

Two meetings were held with the New Hampshire Department of Economic Development, and a Comprehensive Plan for the Town of Newmarket was initiated. The State of New Hampshire, in cooperation with the University of New Hampshire, will conduct a survey on housing requirements, low rent, and housing for the elderly, subdivision of land regulations, and revised area maps.

One meeting was held with the Water Commission to discuss the present and the future water expansion program for the Town of Newmarket.

George Griswold and George Stevens were appointed to represent Newmarket at the Strafford Regional Planning Commission.

The Planning Board received and approved eight applications for Subdivision of Land.

Planning Board meetings are scheduled on a regular monthly basis, on the first Tuesday at 7:30 p.m. in the Court Room of the Town Hall. The public is invited.

by sportsmen, boating enthusiasts and the development of new housing.

Give us a strong indication of the future role Newmarket will be faced with in a few short years.

The Planning Board feels that now is the time to guide and plan so that the Town will benefit fully from any activity in this area.

We recommend that the Selectmen insert an article in the Town Warrant asking that a Conservation Committee be appointed.

The Planning Board is currently working on a Comprehensive Plan with the State and a hired planning consultant, and the board feels further recommendations at this time would be premature.

State-wide emergency telephone and radio alert, for test purposes only.

May-June . . .

Summer weather bulletins issued informing of procedure on severe thunder storms and strong winds.

July-August . . .

Program papers prepared and sent to Concord for approval.

September . . .

Hurricane information sent out by State Civil Defense, same as last year.

October-November . . .

All radiological instruments checked out and those not working turned in for replacements.

December . . .

A revised Town Civil Defense plan sent to Concord, to keep us on the surplus list. Civil Defense obtained two blankets and an emergency light for the Sno-Rollers' Rescue Unit.

For twelve years, since I have been Civil Defense Director, my total appropriated budget has been 12,300. Of this, \$2,400 was paid to the State Distributing Agency for surplus that was worth \$53,110. The remaining \$9,900 was used for operating expenses and local programs to make the Town of Newmarket eligible for surplus. So we can say that for \$12,300 we have received surplus worth \$53,110. This is money well spent.

It is hoped that during the next year much progress will be made toward furthering our housing program.
